

# WTMPA, Tech join forces for energy development Area may benefit from alternative energy projects

Private individuals have asked WTMPA, of which Floydada is a member, to join with them in development of various sources of energy--be it wind, coal, natural gas, or biomass in an effort to secure future electricity for the member cities. The announcement was made in a Lubbock press conference Wednesday morning.

The group, Republic Power Partners LP, will also partner with Texas Tech and their outstanding research capabilities.

"This has the potential for bringing projects to our area that will provide a wonderful economic boost," said Floydada City Manager Gary Brown.

The project includes generation of power through wind, biomass, clean coal and other thermal energy sources and the transmission to provide a balanced, consistent source of electricity for local use, as well as selling surplus power by 2015 into the Electric Reliability Council of Texas (ERCOT), which controls 85 percent of the state's electrical load.

If the project goes forward, the cities and WTMPA will have access to these competitively priced sources of electricity after 2019 and the opportunity to become a center of surplus clean energy production. These benefits include the ability of Texas Tech to become a world leader in the research and development of enhanced wind energy technology.

WTMPA, the Lubbock Economic Development Alliance constructing a wind superhigh-(LEDA), Texas Tech University and Republic Power Partners and we're excited that the High have had extensive discussions to identify a significant economic development project to benefit the WTMPA service area.

"This agreement is the first step in an exciting project that has no public risk yet has tremendous potential for public benefit," said Tom Martin, mayor of Lubbock. "This will not raise taxes or electrical rates for Lubbock, Brownfield, Floydada or Tulia residents because it's a publicprivate partnership financed with private money that will not put the member cities at financial risk."

With this agreement, Republic Power will now seek to raise private money to finance studies to confirm the feasibility of the project, engineering and design work and secure a long-term power purchaser, said George Bayoud, partner with Republic Power. "We're confident that this will be an important and innovative energy project not only for the High Plains but for the state overall," he said. "When completed, it will significantly enhance renewable energy diversification in Texas."

The feasibility studies are expected to be completed no later than 2011.

"We're very pleased to move to the next step with this project," said Gary Brown, president of WTMPA. "All the entities involved have been working on this agreement for more than a year to make sure that it's beneficial to the High Plains area."

The project has enormous economic development potential for the area, said David Alderson, chairman of LEDA. "America is way to develop renewable en Plains will play a big role in the success of that superhighway," he said.

# FAQs about alternative energy

### What is the project?

Republic Power Partners LP and the West Texas Municipal Power Agency (WTMPA) are entering into a development agreement to determine the feasibility of building and transmitting power. The analysis will include studying the viability of building up to 4,000 megawatts of generation of power and evaluating several technologies such as wind, biomass, natural gas and certain clean coal technology. The analysis will also assess the transmission system required by the generation to provide a balanced, consistent source of electricity.

## What is the next step for this project?

Republic Power Partners LP will seek to raise approximately \$40 million from private investors to fund studies to confirm the feasibility of developing the project. The studies will be completed no later than 2011. Republic Power Partners will provide the funds for any feasibility, environmental, preliminary engineering and design, legal and financial and other reports that may be needed to secure financing for the project's construction should the project be found to be feasible. Republic Power will also seek to secure a long-term purchaser of surplus power.

### How much will the project cost?

Preliminary analysis indicates that the entire project including the maximum amount of generation could cost about \$8 billion. of the energy generation and transmission, as well as develop jobs for suppliers to the project. It will help establish Lubbock and the High Plains as the leader for developing clean energy production and will confirm Texas Tech as a world leader in wind science. The positive impact of this project will be felt in the High Plains area for years to come.

### How much energy will be produced?

The goal is to have up to 4,000 megawatts of generation in wind, biomass and other more traditional sources of energy. Although Lubbock County has grown by 18,000 in the past seven years, this is more generation than the WTMPA needs in the near term, which means that surplus power can be sold to generate additional revenue. The project will also provide a secure energy source for businesses and industry considering relocating to the High Plains.

### Why not just focus on wind energy?

The objective of this project is to create an efficient, secure and reliable portfolio of energy sources for WTMPA member cities. Wind is a renewable resource and highly desirable, but there are times when the wind doesn't blow, even in the High Plains, which then requires other sources of energy to reliably meet the needs of residents and businesses in the WTMPA service area.

### What is the plan for the energy?

One objective to be studied is the ability to sell surplus generation into ERCOT, which controls 85 percent of the state's electrical load and 75 percent of Texas' land area. It is expected that this would provide additional revenue to WTMPA and pay for the project's construction.

# Eagle project helps locate names on Wall of Pride

Bryan Cooper, 18 year old son of Brenda Poole and the late Paul Cooper, did the Lockney area residents a big favor when he chose to index the name tiles on Lockney's Wall of Pride for his Eagle Scout project.

The Wall of Pride, under the direction of Lockney High School Art Teacher Lisa Mosley, was completed in the fall of 1993. Five thousand pounds of clay was used to make the tiles for the wall.

An Eagle Scout project has to be beneficial to the community where the scout lives. "I was

looking for a project, when I remembered several people telling me they had trouble locating their tiles on the wall. That gave me the idea," said Cooper.

He continued, "I had help and encouragement from scouting buddies, Patrick Doucette, Jonathan Sustaita, and Danny Huggins. Mom really encouraged me and kept me on track. Combined, it took a total of 160 hours of labor to complete the three water proof index volumes, build and install the podium, and to repair and recap the damaged west wall. I had an original plan, but changed it. It took four or five

days longer than I thought."


The 667 page volumes include pictures of each tile and an index set up on a grid system with rows being labeled A-Q and columns being labeled 1-171. Names are arranged in alphabetical order according to.last name in most cases, except where only the first name is recognizable or where names were switched in the database.

The 4 1/2' tall 2' wide podium, constructed of treated 2" x 6" lumber, was designed with a storage area for two of the three in-

## **TEA releases accountability ratings**

August is such a busy month for schools across Texas. Students are just about to return to school as well as teachers, and Friday night football games are about to light up in just about every Texas community.

But August has also become there is another piece of information that is released by the Texas Education Agency: school accountability ratings.

These ratings give communities and school leaders the opportunity to see where their school measure up statewide, and if

education by state standards. Schools are given a rating of Exemplary, Recognized, Academically Acceptable or Academically Unacceptable according to

performance. The accountability system is based on three base standards: To determine ratings under the standard accountability procedures, the 2008 accountability rating system for Texas public schools and districts uses three base indicators:

• Spring 2008 performance on the Texas Assessment of Knowledge and Skills (TAKS), • the Completion Rate I for the class

schools are providing a quality of 2007, and • the 2006-07 Annual Dropout Rate for grades 7 and 8.

> This year, both Floydada Independent School District (FISD) and Lockney Independent School District (LISD) were rated overall as Academically Acceptable. Only one school in the district scored higher, which was Lockney Elementary earning a mark of Recognized.

Sometime ago, we sold the Hesperian-Beacon. The new owners of the paper have been kind enough to ask that the column, then known as "The Lamplighter", continue to run. We will oblige, happily so, but we will note that the column continues as an opinion piece, and the views reflected therein will not necessarily reflect the views of the new owner. We have our own views of world and national politics, and we're too old, and have seen too much water run under the bridge, to change now.

Whatever name the column will now bear is entirely in the hands of the new editors, which I understand includes The Childress Index, Floyd County Hesperian-Beacon, The Post Dispatch, Hall County Herald, Knox County News, and the Hollis (Okla.) News. As I indicated earlier, in the last column we wrote, we wish them well and we will do whatever we can to help.

We do not wish this column to be known only as a place to go when obituaries are in order. However, sometimes someone passes from the scene that bears mention. Lord knows, we have written plenty of them over the years. Once in a while, someone goes away that merits a few extra words. Such a person was Anne Armstrong, the scion of the Armstrong Ranch, some 25,000 acres "south of Kingsville and north of Raymondville" in South

Texas. She was a good, strong, woman whose stint in politics. was colored by her tenure as a ranch woman. She died recently of cancer in a Houston hospital. Her husband, Tobin, a former appointments secretary for Governor Bill Clements, preceded her in death. Tobin was one of those guys who served as an almost unpaid helper to Clements, until he had enough and went back to the ranch.

Anne was not one of those bra-burning females. She was a good, strong woman who ran the ranch in her husband's absence. She served the United States as Ambassador to the Court of St. James, in London, and, as far as I ever heard, served the position admirably. There was even a picture of her entertaining the future King of England on the ranch. She was, always, one of those Texas women that men could be proud of, and one, for awhile, that Texas women too could be proud of too.

I well remember the day she came to my office and let me know she was leaving the Reagan campaign. She was most apologetic about the situation (one of her daughters had gotten involved with a situation at Southern Methodist University and her husband, Tobin, wanted her back at the ranch, post haste), whereupon she said "and I wouldn't respect him if he didn't, and if he were not a man." I have never

forgotten that comment.

Anne and I went back a ways. She was instrumental in my going to work for the United States Information Agency when the government was headed up by Richard Nixon and I was Administrative Assistant to former Sen. John Tower. We had a pact, so to speak, wherein I would write to her from various parts of the world, and the missives would be saved and utilized later. Little did either of us know, at that time, what lay ahead. Even politics got in the way. I was forbidden to say anything about what transpired as long as it involved our own agency or those agencies we worked with. That completely closed any thought of utilizing "inside information" until years passed. Since then, even the USIA is no longer in existence, and the CIA has had an untold number of different Directors.

The entire Armstrong Ranch was synonymous with the people who worked it. A "Major Tom" was a factor in where the ranch's money and influence ended up. He was of tremendous help to the senator, and the senator didn't even know it.

I well remember one time when we ran out of money and a few of us went to the ranch to ask help from "Major Tom." As we were flying back to Austin, I asked, somewhat casually, how the King Ranch's new operation

was going in Australia. I knew there was some connection between the two ranches, but I did not know what it was. Major Tom was most forthcoming. Everything was going just fine, he said. It was turning out to be a good investment, as long as the ranch did what the government wanted them to do, particularly now that the Japanese had gotten interested in the Australian ore they were using to make automobiles. He even told me the name of the Japanese companies involved, just in case I wanted to make some investments myself. He said then that "you better write this stuff down son". Which I did on a newspaper laying in the plane, and promptly forgot it. He added "the reason I know this is because I sit on the board of the King Ranch"

Public Utility Commission of Texas have encouraged the development of a balanced energy portfolio that includes a significant component of renewable energy, such as wind and biomass. The PUC of Texas has recently made a significant commitment to enlarge the ERCOT transmission system to accommodate an increase in wind generation, including new generation in the High Plains. This project will be especially attractive because it combines large amounts of wind energy, which is an intermittent resource, with traditional generation that will provide the stability and reliability essential to a secure power system. The cost of this transmission capacity will be recovered through the price of the power sold, Consumers will not be asked to pay for it separately.

# Applications for emergency farm loans are being accepted

Applications for Emergency Farm Loans for damages and losses are being accepted at the Farm Service Agency (FSA) office located in Floydada and Crosbyton, Texas, for production and physical losses for the following Secretarial Natural Disaster Determinations:

\* S2692-July 2, 2008 based on damages and losses caused bay drought on January 1, 2008 and continuing through March 2, 2009 and

\*S2702-July 16, 2008 based on damages and losses caused by drought on January 1, 2008 and continuing through March 16, 2009

Crosby County is one of ten (10) contiguous counties in Texas recently named by the Secretary of Agriculture eligible for loans to cover part of actual production losses resulting from the damages and losses caused by fires and high winds.

Farmers may be eligible for loans up to 100% of their actual losses or the operating loan needed to continue the agricultural business, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest is 3.75 percent.

As a general rule, a farmer and Crosbyton, Texas are open must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan. Farmers participating in the Federal Crop Insurance program will have to consider proceeds from those programs in determining their loss.


Applications for loans under this emergency designation will be accepted until January 15, 2009 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possible over into the new farming season.

FSA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who meet U.S. Citizenship requirements and to farming partnerships, corporations or cooperatives in which U.S. citizenship requirements are met by individuals holding a majority interest.
