

## Single-vehicle accident kills Floyd County farmer

Tuesday night, Sept. 30, 2008, Floydada farmer Louis Paul Lloyd lost his life after losing control of his pickup.

According to local Texas Department of Public Safety officials, the accident happened on U.S. 62 in the north-bound lane approximately one mile south of Floydada at a curve. The exact location of the wreck was called in by off-duty DPS officer Marty Lucke around 10 p.m.

Witnesses after the accident

where it had rolled through construction zone barrels and across a caliche pile. According to the DPS report, Lloyd was not wearing his seatbelt and had been thrown from the vehicle.

Toxicology reports have not been completed, so Texas DPS does not yet know whether alcohol was a factor in Tuesday night's accident.

Also, the DPS reported Lloyd's left rear tire was found blown out.

The incident is still under investigation to discover the cause

Floyd County 4-H'ers along with 4-H'ers across the nation are celebrating 2008 National 4-H Week, Oct. 5-11. Throughout this entire year 4-H'ers from across Texas have been celebrating 4-H in Texas as it reached the 100th

year Centennial Celebration. For those who may not know, 4-H is a national youth organization open to any youth ages 9-19. To highlight its strength, you may not have known that 4-H is the nation's largest youth orgater nization with over 6.5 million

members across the country. You may also ask, "What do you do in 4-H?" 4-H offers projects in over 50 project areas. Projects range from aerospace to fishing and photography. We like to use the phrase "whatever your interest, 4-H offers a project for you."

Currently Floyd County's largest projects include: Shooting Sports (rifle and archery), Food and Nutrition, Clothing, 4-H Record Books, Swine and Photography - just to name a few. Here in Floyd County we are big on total family involvement. We also have an active Floyd County 4-H Parent/Leaders Association which serves as a leadership body for the total Floyd County 4-H program.

Here in Floyd County we currently have 97 members. Floyd County currently has two 4-H clubs, one in Floydada and one in Lockney. Each club holds monthly meetings run by their elected club officers. All you have to do is complete a 4-H enrollment form and you are signed up. You may receive your enrollment form by dropping by the Floyd County AgriLife Extension Office at 110 S. Wall (annex building on the east side of the courthouse) in Floydada or call 983-4912 and we will mail you one.

With participation in 4-H you can achieve a lot. In Floyd County we offer an Awards program based on your participation. Each year at our County 4-H Achievement Banquet we award Floyd County 4-H Jackets to those junior and intermediate 4-H'ers who have obtained 85 points and to senior 4-H'ers who have obtained 100 points.

Additionally, 4-H offers many summer camping opportunities such as Leadership Camp, Electric Camp, SpecTra and Prime Time camps. For those camps,

## **Courtroom Activities**

Three first time DWI offenders waived their rights to an attorney and pleaded guilty on Tuesday, Sept. 9, 2008, to the charges brought against them."

Beatrice Luna, 49, pleaded guilty to her June 9, 2008, charge of driving while intoxicated.

Also charged with his first DWI offense on June 9, 2008, was Vincente Guzman. He also waived his right to an attorney and pleaded guilty.

The third DWI offender was Josephine Perez Garza, 49. She was charged with her first DWI on May 15, 2007.

All three, Luna, Guzman and Perez were sentenced to six months in jail - probated two years, and ordered to pay a \$600 fine and \$301 in court costs, as well as being required to participate in an education program.

Courtroom activities for Sept. 24 and 25, 2008, included several charges of "theft of \$20 or more, less than \$500." Individuals charged were Ricardo Vasquez, Jr., Michelle R. Owens, Theresa Sutton and James Lee Carver.

Other recent entries in the court docket were as follows:

charged with his second DWI offense on Aug. 13, 2008, was advised of his rights to an attorney, but chose to waive his rights. Lopez pleaded guilty to the charge. He was found guilty and sentenced to 10 days in jail along with a one year driver's license suspension and court costs of \$301

On Aug. 13, 2008, Eulalio Lopez had been charged with evading arrest. Lopez waived his right to an attorney on Sept. 9, 2008, and pleaded guilty to the charge. The court found him guilty and sentenced him to 60 days in jail and payment of \$301 in court costs.

On Sept. 9, 2008, the July 9, 2008, charge of a DWI against Eulalio Lopez was also brought before the court, but the charge was dismissed.

Marciano Trejo San Juan had • Miguel Chairez, charged with a speeding appeal from J.P. court dismissed on Sept. 9, 2008.

5-Star Superior rating earned

1-4 from Aug. 7, 2008. On Sept. 8, the court granted a continuance until Oct. 7, but the order was dismissed on Sept. 30, 2008.

Dustin Ochoa's June 3, 2008, possession of marihuana charge was brought before the court on Sept. 9, 2008, as well. He waived his right to an attorney and pleaded guilty to the charge of possessing equal to or less than two ounces of marihuana. Ochoa will spend six months in jail, be fined \$600 and pay \$301 in court costs

Keevin Drew Gregg was granted a continuance on the April 1, 2008, DWI, second offense, charge on Sept. 18, 2008.

On Sept. 9, 2008, Billy Joe Luna, 26, was found guilty of criminal mischief committed on Dec. 18, 2007. Luna had pleaded guilty after waiving his right to an attorney. He was sentenced to six months in jail, probated for two years, and must pay a \$600 fine, make restitution in the amount of \$160.68 and pay \$301 in court costs. Luna's probation was revoked on Sept. 16 and he was sentenced to 90 days in prison.

Also, an assault charge from Sept. 25, 2007 against Luna was

Curtis E. Miller, Jr., 26. pleaded guilty to the second DWI charge against him. He was convicted of the July 23, 2008, incident and sentenced to nine months in jail, probated two years, a \$750 fine, \$301 in court costs, suspension of his driver's license for six months and will be required to take a repeat offenders DWI education program.

After waiving his right to an attorney, Alejando Flores Arrendondo, charged with possession of marihuana on July 9, 2008, pleaded guilty. He was found'guilty on Oct. 7, 2008. The court assessed 46 days in jail and court costs of \$301.

On July 9, 2008, Victor Arturo Lara-Quinonez was charged with DWI. Oct. 7, 2008, he waived his right to an attorney, pleaded guilty and was found guilty by the court. Lara-Quinonez was sentenced to 180 days in jail, probated two years, must pay a \$600 fine and \$301 in court costs, as well as completing a required education program.


Jerry Melton Powell was charged on June 23, 2008, of assault. On Oct. 6, 2008, the charge was dismissed.



According to the Texas Department of Agriculture, here are some facts for those who knock us small-town folk to consider:

• Texas is the second-largest agricultural state in the United States, accounting for about seven percent of the total U.S. agricultural income.

• The food, horticulture and fiber industry is the second-largest industry in the state and generates \$73 billion a year for the economy.

• Texas is the fifth-largest wineproducing state with more than 155 wineries and 220 commercial vineyards, producing more than two million gallons of wine. The Texas Hill Country Viticultural Area is the secondlargest Viticultural Area in the United States, covering 15,000 square miles.

• Eighty percent of the land in Texas is in some form of agricultural production.

• Ninety-two percent of Texas' agricultural operations are still run by individuals or families.

• Although agriculture employs one out of every seven working Texans, less than two percent of the population is involved in dayto-day farming or ranching.

• Texas farmers grow more than 60 different commercial fruit and vegetable crops.

• Texas ranks first in the nation in the number of cattle and

Rural America is sometimes calves, accounting for 15 percent an afterthought. It's wrong, but of the U.S. total. The Lone Star State also is the top producer of cotton, sheep, wool, goats, mohair and horses. The state's top crops also include vegetables, citrus, corn, wheat, peanuts, pecans, grain sorghum, hay and rice.

• Besides livestock and crops, the state's agriculture industry includes timber/forestry, aquaculture, bees/honey and nursery/ greenhouse.

• Texas is the third largest exporter of agricultural commodities. Texas' top agricultural exports are live animals and red meat; cotton and cottonseed; hides and skins; wheat and products; and feeds and fodder.

• Each Texas farmer grows enough food and fiber for 128 people - 94.3 in the United States and 33.7 abroad.

• Texas' 1 million horses, representing approximately 15 percent of all horses nationwide, makes the state a leader in the United States. Texas also leads the nation in the number of registered American Quarter Horses, American Paint Horses, Appaloosa horses and American Miniature Horses.





Sorry about that.




### Lockney Jr Varsity Longhorns gore Mustangs, 14 - 7





### **Conservation reserve program payments begin today**

County Executive Director for USDA's Farm Service Agency today announced that starting today USDA will begin issuing \$139,882,022 in Conservation Reserve Program (CRP) payments to eligible producers in Texas. More than \$1.7 billion in CRP payments are being made on 34.7 million acres across the country.

"The Conservation Reserve Program works cooperatively with America's farmers and ranchers to conserve and preserve the soil and water that we, and numerous wildlife species, depend on for survival," said McDonald. "These payments represent an investment in the nation's land that will pay dividends in the form of a cleaner environment today and for our grandchildren."

The payments announced today are annual rental payments earned on the 3.9 million acres enrolled in CRP for fiscal year 2008 in Texas, including acres enrolled in the Continuous Sign-Up Program. Texas currently has 24,974 CRP contracts on 18,132 farms. The number of contracts is higher than the number of farms because producers may have multiple contracts on a single farm. /

Other CRP payments are made throughout the year, including a

Michael C McDonald, Floyd 50 percent reimbursement of expenses for establishing cover and incentive payments for enrolling eligible conservation practices, such as wetland restorations and conservation buffers. This voluntary program helps agricultural producers safeguard environmentally sensitive land. Producers enroll in CRP and plant long-term,

resource-conserving covers to improve water quality, control soil erosion and enhance habitats for waterfowl and wildlife. In return, USDA provides producers with rental payments. CRP contract duration is from 10 to 15 years. Land to be enrolled must be either highly erodible, contribute to a serious water quality problem,

provide important wildlife habitat or provide substantial environmental benefits if devoted to certain specific conservation uses. #### Cotton Market Weekly A service provided by Plains Cotton Cooperative Association

At the end of a week fraught with insecurity on the U.S. financial front, cotton futures on the New York Board of Trade settled mostly higher Thursday. The buoyancy was attributed to merchant short covering which bucked widespread commodity weakness due to a bearish demand picture and a stronger U.S. dollar.

"In another classic example of cotton's inclination for the contrary, prices began to rally with values improving steadily throughout the day Thursday, as the rest of the financial world melted down on fears that the U.S. Congress would again fail to pass a bailout bill," a trader explained.

However, most analysts agree that the current sentiment in the cotton market, and in just about every other market for that matter, is very pessimistic. Buyers seem to have gone on strike while owners of inventories and investments are liquidating them in a desperate rush to cash. The economic picture is affecting cotton prices as the International Cotton Advisory Committee (ICAC) this week attributed the 10-cent drop in the Cotlook Index during September to the U.S. financial system crisis. The ICAC also expects world cotton production to decline by six percent to 113 million bales in 2008-09 due mainly to competition from alternative crops. The production drop is driven by the United States, but the 2008-09 crops also are expected to be smaller in Turkey, Brazil, and

Egypt. Cotton production increases are foreseen in Australia and Pakistan.

World mill use is expected to decline only one percent in 2008-09 to 120 million bales, according to the ICAC. The decline is attributed to slower global economic growth and higher prices of cotton relative to polyester. In addition, the committee pegs 2008-09 world cotton stocks at 50 million bales, down 11 percent, with the largest decline in stocks expected to take place in the United States.

In other news, USDA reported net export sales of U.S. cotton totaled 110,400 bales in the week ended Sept. 25. The figure was 56 percent lower than the previous week and 50 percent lower than the four-week average. Turkey, Indonesia, Thailand, and China were the week's top buyers. Market observers were slightly disappointed in the department's numbers.

Export shipments of 232,500 bales were up five percent from one week before, but down four percent from the four-week average. Primary destinations included China, Indonesia, Turkey, and Mexico.

Meanwhile, spot cotton sales were slower as well. One local analyst said the spot cotton market was "as dead as a hammer" this week. Producers in Texas, Oklahoma, and Kansas sold only 26 bales online in the week ended Oct. 2 versus 131 bales the previous week.

Sales in the cotton market may remain slow for a period of time. In fact, a number of market observers say cotton futures will continue to follow outside market sentiment until some financial stability returns. Others go as far as saying that fundamental and technical information mean nothing to cotton's current price and direction. However, many still hope next week's supply/demand report from USDA will provide some support to the cotton market.

#### Report shows women less likely to life insurance

In these tough economic times, families may be putting themselves at greater risk by placing more value on the man of the house. Women are less likely than men to have life insurance, and if they die their families could be thrown into financial chaos.

"I think underinsuring the female, whether she is a working or stay-at-home Mom makes no more sense than underinsuring the male. There are just too many uninsured couples putting their families at risk," says Beth Wood, Assistant Vice President, Business and Women's Markets at Massachusetts Mutual Life Insurance ...Company (MassMutual).

It may be difficult for families to discuss the sensitive issue of life insurance, but MassMutual has developed a Family Risk Discussion Guide to help families begin the conversation.



"According to the latest figures from the Bureau of Labor Statistics, almost two-thirds of today's families depend on two incomes to make ends meet. If you died suddenly, could your family maintain their standard of living - pay off debt, save for college and set aside money for retirement - on your husband's income alone? Probably not," says Marvin H. Feldman, president and CEO of the LIFE Foundation.

Life insurance generally pays a tax-free, lump sum benefit if the person who is insured dies while the policy is in force. In its most recent findings, LIMRA reports only 36 percent of women are protected with group life insurance at work and only 40 percent have their own individual policies. LIMRA also says women who do have life insurance on average have much less coverage than men.

"If a working woman dies or becomes disabled and cannot

work or take care of the family, her husband may have to cut ba his hours to stay at home or hire someone to care for the children - and that makes financial matters worse," says Wood. If a family loses the benefit of a working mother's salary and she is uninsured or underinsured, her husband may be forced to pay bills by dipping into his retirement funds or using money he and his wife had saved for their children's education. Disability income insurance is also available to replace a portion of lost income if an insured is disabled or too sick to work. Women who do not work outside the home also bring extraordinary value to the family, says Wood. According to the May 2008 Mom Salary survey from Salary.com, a stay-at-home mom brings \$116,805 in services to the family each year - from cooking and cleaning to shopping, shuttling children around and a range of other domestic duties. "If something were to happen to a stay-at-home mom you would still have to replace her contribution to the household. She may not work outside the home but she works inside the home and the cost to pay someone to do what she does is huge," says Wood.




