Stoerner named Citizen of the Year

The Lockney Chamber of Commerce honored Martin Stoerner, Saturday night, as the Citizen of the Year.

The Chamber also recognized Joe Marks as Fireman of the Year. Matt Williams presented the surprised Stoerner with the traveling trophy and praised Stoerner for his work with the youth.

"He sees children as the future leaders of our communities," said Williams.

Williams told the audience that Stoerner has been involved in leadership functions of Boy Scouts and has been instrumental in community and UIL athletic programs, and the local FFA chapter.

Stoerner is a past recipient of the Honorary Chapter Farmer Degree.

He is a lifetime member of the American Angus Association and has served in leadership roles on several area agricultural boards such as Farm Bureau, Floyd County Stock Show Association and Plains Cotton Growers.

Stoerner, and his family, have sponsored a boy to attend American Legion Boys State for the past 13 years.

He has served on the Trinity Lutheran Church Council for over 20 years and is the current president, and charter member, of Floyd County Friends.

Stoerner has been married to his wife, Robin, for 26 years. They have two sons, Heath, and Justin.

Chamber President Preston Belt reviewed the past year and the work of the chamber. "We had a very successful Old Fashioned Saturday," said Belt. "We didn't have our local stock show this year, but chose to donate the money we would have used to the Lockney Businessmen and Farmers and to the Rabbit Show. "The Chamber maintained the Christmas decorations and put them up and also maintained an internet site.

"For the first year we gave money to the farmer who brought in the first bale of cotton, and we sponsored a sports radio broadcast."

Caitlann Wiley provided the musical entertainment for the evening. A 6th grader at Lockney Junior High School, the very talented Caitlann is the daughter

of Melody and J.H. Lane, and a member of Cactus Kids.

Steve McLean, pastor of W. College and 3rd Church of Christ, was the guest speaker. McLean entertained the crowd with the humorous stories of 'Ol Man Lister in the small town of "Ponder Point". McLean said the characters in his imaginary town of Ponder Point were very much like the characters in a small town like Lockney.

McLean's 'Ol Man Lister always had a wise answer to life's problems and a suggestion for how to lead a better life.

"He is called 'Ol Man Lister because he is 'old', and well---no one knows his first name," said McLean.

Retiring Chamber President Preston Belt turned the gavel over to incoming president, Sharon Hunt.

FBC dedicates building

Members and guests celebrated the dedication of Floydada's First Baptist Church, March 9, three days short of the 3rd anniversary of the fire that destroyed the Sunday School building and damaged the sanctuary.

An estimated 600 people crowded into the sanctuary to praise and thank God for the new building which is now officially opened for Sunday School classes and fellowship. Former members and staff members were also in attendance.

FBC Pastor Anthony Sisemore encouraged his congregation to look to the future. Time and energy have been poured into the reconstruction of the church building, and now members are being motivated to pour their time and energy into community evangelism.

Guest speakers, Dr. Travis Hart, pastor of First Baptist Church in Plainview and David Seay, editor and chief of Mature Living magazine, also encour-

aged the members to "witness" and "include" people in the community.

Mateo Rendon, of the Baptist General Convention of Texas, gave the church special recognition from Executive Director Charles Wade.

Members of the church have been meeting for Sunday School and fellowship in various locations around town since the devastating fire in 2000. Rev. Sisemore is excited about the church being able to come back together and fellowship. "It is difficult to be separated," said Sisemore. "It will be good to be able to fellowship together again."

Fellowship will be a lot easier now inside the church's new "fellowship center" which also doubles as a gymnasium. The "center" will seat 396.

Wide hallways now connect the worship center with the "education and administrative complex". An elevator takes you to a basement and 15 classrooms.

Fourteen classrooms and a large and secure nursery are upstairs with the library, chapel and parlor, a large commercial kitchen, offices, conference rooms, pastor's office and study, and reception area.

The beautiful library currently holds 7,000 books and has the capabilities to expand to a 10,000 volume library.

The library is open to the public from 8:30 a.m. - 5:00 p.m., Monday through Friday.

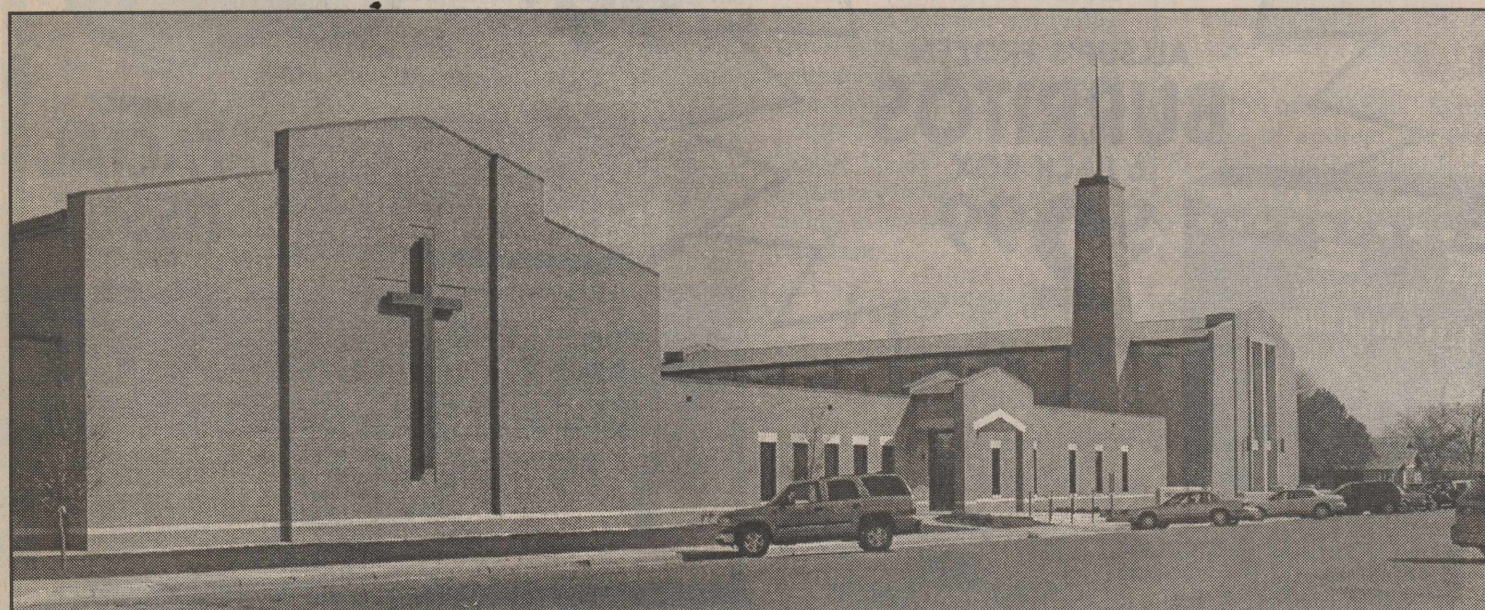
The Parlor/Chapel, with beautiful stained glass windows, will be used for small weddings, small funerals, anniversary celebrations, birthdays, showers, etc.

The new addition is 40,000 square feet of space. Although this is smaller, compared to the space the church used to have, the appearance is of a much larger church. "The space is much more efficient and usable," said Sisemore.

Member cities of Mackenzie Water Authority call for tough cuts

The governmental bodies of Floydada, Lockney, Tulia, and Silvertown, have joined together to insist on tough reorganization in the Mackenzie Water Authority-including the resignation of the Authority's General Manager, Tom Davey.

With the cost of operations climbing and water allotments

dropping, the cities have voted individually to call for significant cuts in operational costs.

Each city is represented by two board members, who are part of the Mackenzie Water Authority Board. Lockney is represented by Robert McDonald and Kenneth Tate. Floydada is represented by Jeffrey Johnson and

Gary Carthel.

Floydada City Council met March 6, and Lockney Council met March 10 to approve issues they want their board representatives to present to the Mackenzie Water Authority management.

Thirteen issues have been agreed upon by the member cit-

ies and will be discussed at the April Water Authority Board meeting.

The requests made will be:

- (1) The resignation of General Manager Tom Davey.
- (2) Hospitalization Insurance be limited to Employee only--no dependent coverage.
- (3) Van Breedlove be asked

to accept the General Managers position in the Operations and Maintenance Department, but that his job description as Plant Supervisor and Maintenance Supervisor be kept in place. The Manager salary will be reduced from \$45,000 to \$35,000.

- (4) Restrictions on water usage by the Cities be removed.
- (5) All salary increases put in place beginning in the current budget year of 2002/2003 be rolled back to the 2001/2002 budget year.
- (6) That a new Personnel Policy be adopted. Christmas bonuses be set at \$200 per year. Holiday pay will be at time and

a half.

(7) Budget cuts suggested by Business Manager be kept in place and refunded to the Cities.

(8) Before any future budgets are passed that they be presented to each City Council by their respective Mackenzie Board members, at least 30 days prior to the passing of said budget.

(9) The employee in charge of Recreation be license to work in Water Supply to fill in as needed under the direction of the Plant Supervisor

(10) Only schooling and licensing that is required by law to hold a position, will be compensated by the Mackenzie Water Authority. Any other type of Schooling desired will be on the employee's time and expense.

(11) Excessive personal use of company vehicles is strongly discouraged.

The Cities also requested that as of October 1, 2003, two employee positions in Water Supply Department be eliminated, and all salaries be reduced by 20%--but not to fall below a base salary of \$25,000 (not including the General Manager).

"The cities agree that it would be better to not shut down the

plant completely--if we can get the costs significantly cut down," said Lockney Mayor Roger Stapp.

Lockney pays 16.28%--or \$181,000, of the total Water Authority Costs per year.

Floydada pays 31.75%, which is approximately \$360,000 per year.

Tulia picks up 42.95% and Silverton pays 9.02%.

One of the concerns from the member cities has been Silvertons lack of alternate water supply.

When the cities were discussing the future of the Authority a study was implemented to see if the current water lines could be used to pump water from the other member cities to Silverton.

"Silverton can't get by without outside water," said Floydada City Manager Gary Brown. "But, Tulia has said they can sell water cheaper to Silverton than Mackenzie is selling it to them now."

"We all feel the Authority can be run more efficiently," said Stapp. "There are 8 full time employees there now--with a total salary and benefit package of \$432,000 a year.

"We have studied the exten-

sively and we believe only 3 employees are needed to pump 1 million gallons a day--which is what we will be getting.

"We have no desire to see the lake dry up--our plan would help the lake last longer by pumping only 1 million gallons a day," said Stapp.

"The expenses have to be cut back to make it feasible for us to pay for it," said Brown.

When asked why the cities would want to have restrictions on water usage removed, Brown said, "The cities decided to see if the lake would continue to have a constant level of water or if the water level would decline. There is a certain amount of evaporation going to happen and the cities might as well use the water as see it evaporate. The more water the cities use the cheaper the cost per thousand gallons of water used."

"We can't make our board representatives vote this way," said Stapp. "However our position is very strong and it is our intention that the board members support us in the 13 requests we have made."

"These are drastic suggestions but our citizens cannot be asked to pay more for less," said Brown.

Museum News

Dr. Donald Blakeslee from Wichita State University, Wichita, Kansas, joined by volunteers and students, will return to Floyd County Friday, March 14 and Saturday, March 15. The group of archeologists will be doing more work at the Jimmy Owens Site in Blanco Canyon for a week during spring break.

The Museum will host a book signing for Dr. Richard Flint of Villanueva, New Mexico on Friday afternoon, May 23. Dr. Flint will be signing his latest book, "Great Cruelties Have Been Reported", about the 1544 Investigation of the Coronado Expedition. Under a 1997-98 Fulbright grant, Flint did research in Sevilla, Spain, which culminated in this book. Dr. Flint and his wife Shirley Cushing Flint, also a historian, are among the foremost authorities on the Coronado expedition. The afternoon will also be the Museum's Open House preceding the Floyd County Pioneer Reunion on Saturday, May 24. Refreshments will be served during Open House and everyone is encouraged to attend.

Visitors to the Museum in the last three weeks were from the States of South Dakota, Utah, California, Michigan, Oklahoma and numerous towns in Texas.

The family names researched include Keene, Willis, Fawver, Gamblin and Lasater. One couple had flown from Utah to use the materials in the Mary Lou Bollman History and Genealogy Center. Two ladies, one Texico, New Mexico and the other from Amarillo, spent two days in the Museum last week using the research materials. More local residents are becoming aware of the vast history that is available in the Museum. Questions are received daily pertaining to family history or when a certain event took place.

The 1950 Study Club from

Floydada met at the Museum on Tuesday night, March 4. Nancy Marble presented a program on Teas and Carolyn Jackson told about the Museum history and the Mary Lou Bollman History and Genealogy Center. The group was most complimentary on the accomplishments made by the Museum staff and volunteers.

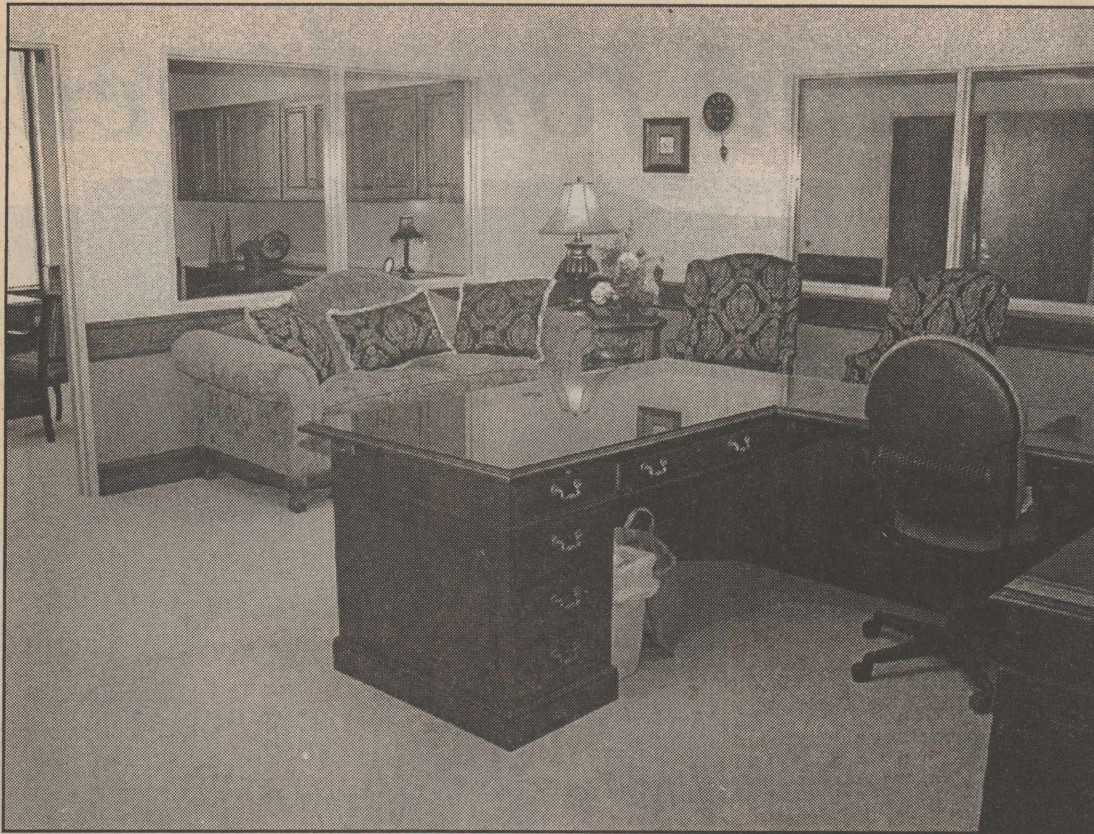

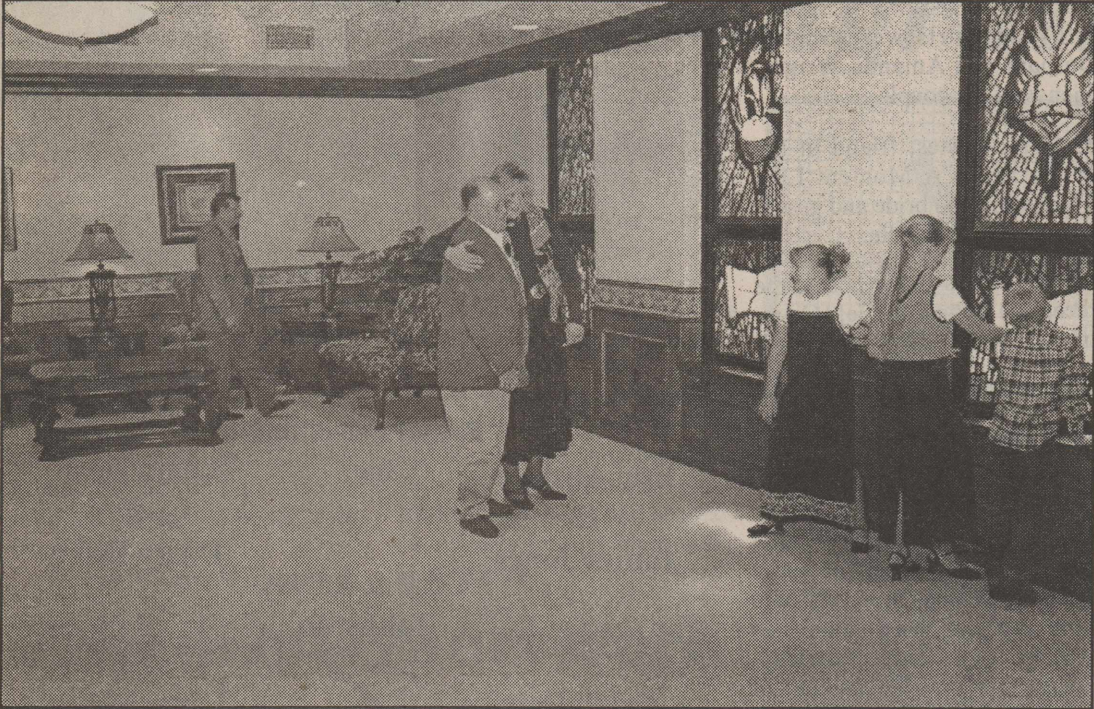

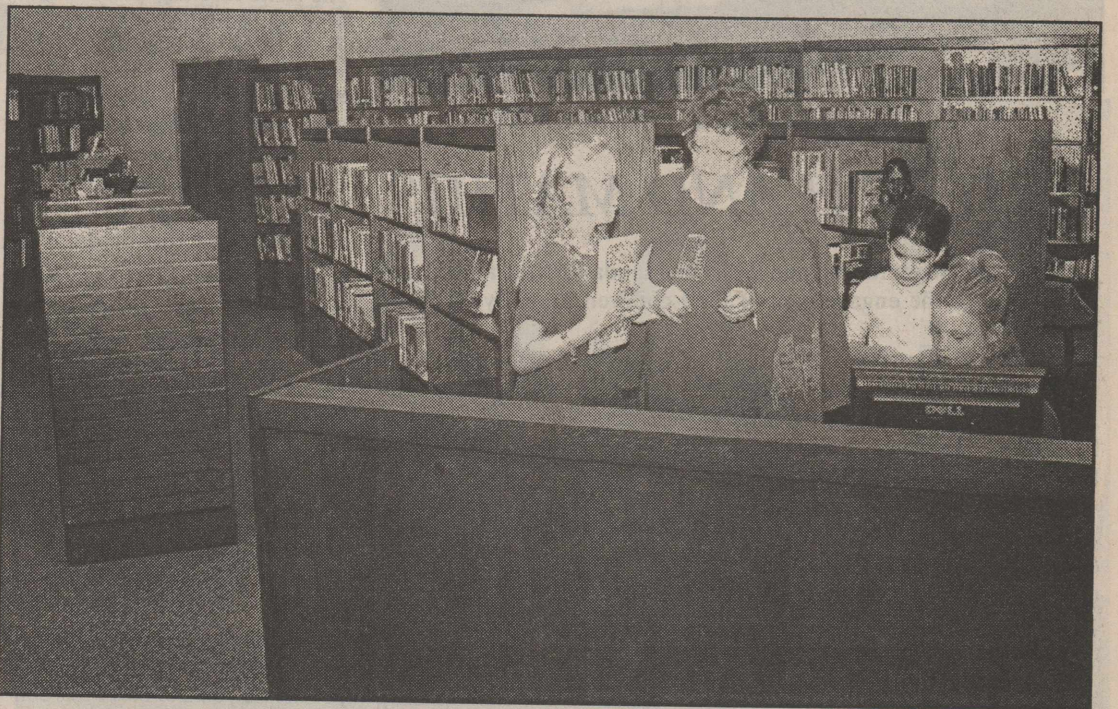

County eligible for emergency preparedness funds

The Floyd County Commissioners met Monday, March 10, and unanimously approved an acceptance letter for eligible funds for a Domestic Preparedness Assessment by SPAG.

Judge William D. Hardin read a letter from SPAG which stated, "The Domestic Preparedness Assessment is to be submitted by April 11, 2003 to remain eligible for funds to be distributed for training and equipment. Your county (Floyd) is eligible to receive \$2,966.59 in funds."

The letter also stated, "Each county in the State of Texas is required to have a Basic Emergency Operations Plan submitted and approved by the Division of Emergency Management in Austin no later than December 31, 2003."

In other matters, the commissioners approved the appointment of nine new members to the 2003 Floyd County Grievance Committee. They are: Lenda Clark, Neta Marble, Thelma Thompson, Barbara D. Lackey, Darlenea Robertson, Eddie Smith, Beverly Harrison, Jerry A. Cawley and Jon Labaume.

The commissioners also appointed nine members to the Floyd County Historical Commission. They are: Chair: Nancy Marble; Members: Joyce Williams, June Sherman, J.D. Copeland, Olive Hinton, Carolyn Jackson, Donnell Gowens, Carol Reese and Connie Bertrand.

On the commissioners' agenda was the consideration of a lease with the Floyd County Fair Board to construct a Weights and Measures pad at the old Fair Grounds in Lockney. Due to the lack of the lease document being available, the commissioners unanimously postponed any action on the item. Commissioner Lennie Gilroy requested the lease item be placed again on the next commissioners' regular agenda.

Five farm contracts were approved by the commissioners. They were in Precinct No. 1, filling of a hole and levelling the ground for soil conservation on the Helen Bertrand farm of Floydada; and in Precinct No. 2, cleaning out a waterway two miles east of Sterley by Harold Ford, filling in a washout area for soil conservation south of Lockney by Edwin Teeter, cleaning out a waterway 13 miles north of Lockney by David

Frizzell, and opening a waterway three miles south of Aiken by Mike Buchanan.

The commissioners approved the transfer of \$32,000 from the Road and Bridge Fund to be divided equally among the four precincts.

The February, 2003 Financial Report presented by Floyd County Treasurer Elva Martinez was unanimously approved by the commissioners. The report showed a Beginning Balance of \$350,054.91 with Receipts of \$225,677.03. Transfers In were \$157,514.02 and Transfers Out were \$162,664.02. Disbursed Funds were \$167,196.27 leaving a Balance of \$419,073.87.

FNB displays art work

The First National Bank of Floydada invited the junior high and high school art classes to exhibit during the month of March. March is National Youth Art Month and exhibits of this kind will be found all over the United States in honor of the young talent and future artist of this nation.

Due to limited space and the many wonderful pieces of art created in the art classes we are only able to display examples of what we have covered in class. Some assignments are basic to the curriculum because that particular project easily meets the state guidelines. So, when you see projects similar to what you may have seen before please remember that each child is unique and their creation is their own.

This exhibit has everything from Op art to basic still life drawings. Art styles are introduced and a variety of approaches to using the many mediums and techniques are assigned as we cover the art elements and principles of design. For example, one lesson in the eighth grade is called "The Visual-Verbal Pun" because we talk about the definition of a pun and how we recall visual images in our mind. The student then selects a word that they can visually illustrate so that the viewer will know the word just by looking. You will also see several examples of contour figure drawing. A student poses for the rest of the class and during a time of only fifteen minutes that student is drawn from different viewpoints in the room.

Art is offered to students for credit all four years of high school and for students interested in pursuing art or art related subjects in college. Advanced Placement is offered for college credit, but art can be taken just for fun or to be used as a hobby in adult life and not just for the purpose of college. High school art covers the basics, but also provides a student the opportunity to improve and to expand experiences in a media or subject area of choice. Advanced Placement centers on studio and portfolio development allowing the student to grow and strive for a style and to master an area of concentration. Examples of high school art and work from AP portfolios are present in this exhibit.

The gifted and talented class at the junior high planned and arranged a school wide project based on the coral reef. All students and classes were invited to participate in this endeavor. We

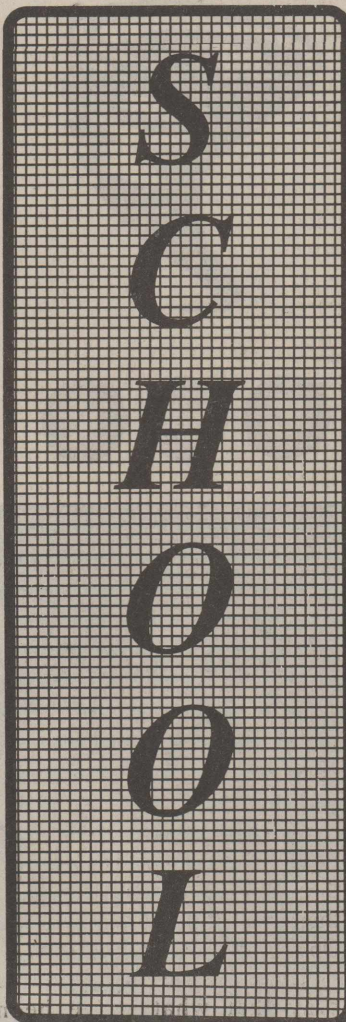
had way too many projects to display but have put together a small part of our work to give a sample of "the big picture".

As the first semester found students researching the ocean, the junior high art student had the liberty of developing a creative and fantasy side to the ocean. Looking at documentation found in the Natural History magazine that displayed falsified studies on ocean life and remembering many make-believe stories about the ocean, we began our projects.

The eighth grade students designed patterned fish used for a printmaking unit and then in clay construction and even again in copper tooling. They made up an ocean tourist company and created a key chain to sell. The ocean project was concluded as they made origami fish mobiles.

The seventh grade students also designed display cards for a fictitious company and made their "shrink art" key chains based on their imaginary fish designs. They made watercolor paintings based on their fish drawings and at the same time learned many new watercolor techniques. Papier-mache, their big project, resulted in several very large fish, and even two mermaids escorted by a merman. The seventh grade students were proud of their efforts and many worked after school and even during the Thanksgiving holidays to ensure they were finished in time for the exhibit. It was especially rewarding to see parents involved and supportive of the student work and making sure their child completed the assignment.

Talent, well, we have a lot of talent. Sometimes it is overlooked because we get so busy with ballgames and academics but Floydada ISD has talent. The state recognizes the need for students to develop creative and higher level thinking skills and I believe this district has also seen a need for this direction. The fine arts is a way to instill creative thinking and a way to encourage a student's use of imagination and problem solving for life skills. At this time the district is busy reconstructing a room at high school for the high school art classes. The junior high is concerned about obtaining a showcase so that we might display student work in all subject areas. Caring about the whole child and offering a well-rounded education is what our district is striving to do. Knowing that the "extras" keep kids interested and offering a variety of electives is a goal of Floydada ISD.

Twenty-five other students were also inducted for the spring semester. The society is counseled by Dr. Lori Copeland, instructor of education for the Irvin School of Education.

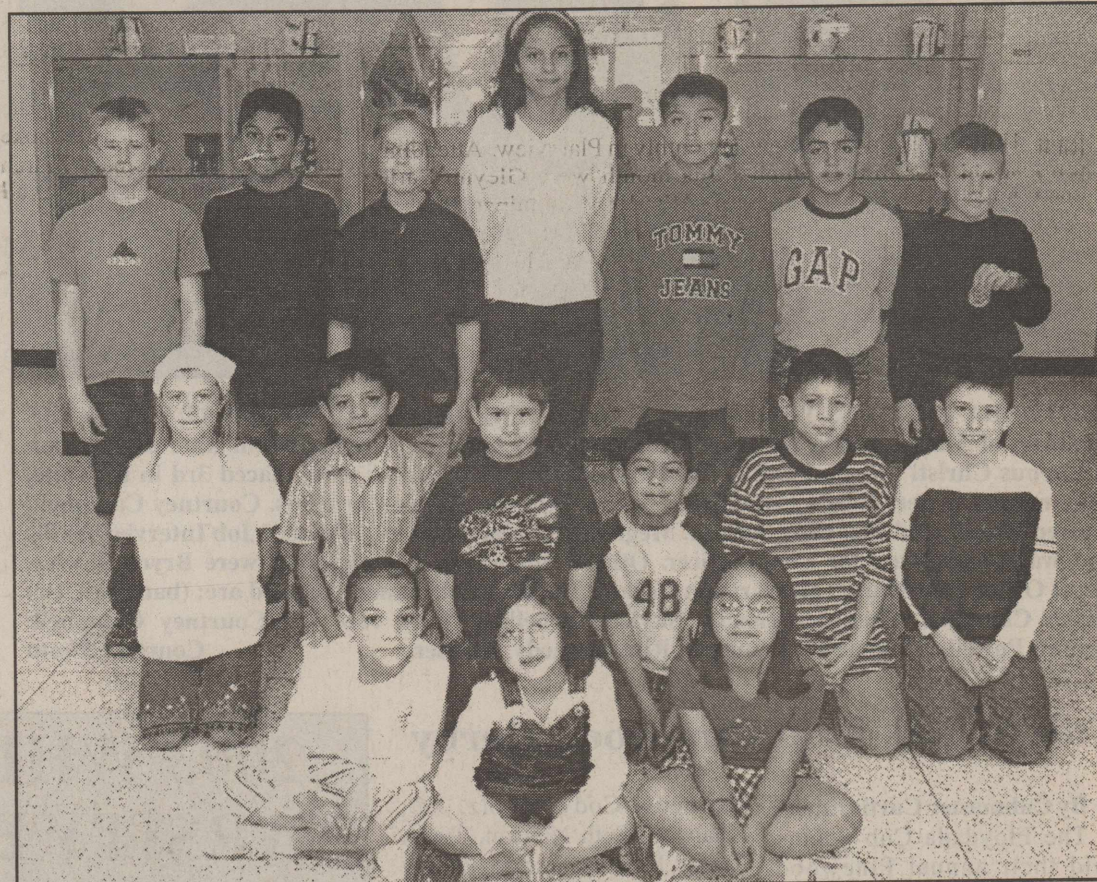
McQuhae named to A&M Honor Roll

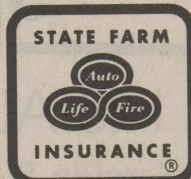

Ferguson to compete

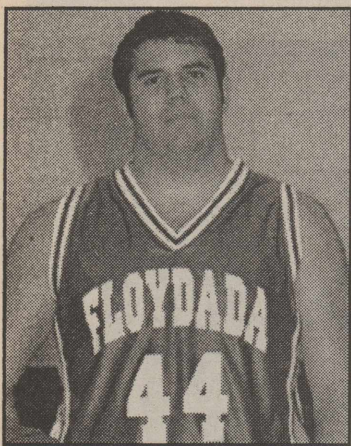
Brittney Ferguson will be traveling to Florida and Guatemala over the next few months.

She will also travel to Guatemala during Spring Break. This will be her third mission trip with the First United Methodist Youth Group of Slaton.

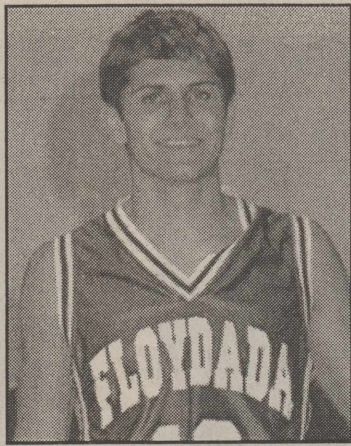

NCC voices Farm Bill concerns

The chairman and the president of The National Cotton Council, with headquarters in Memphis, Tennessee, both spoke to several area farmers and ginners Monday afternoon at the Floydada Coop Gin office.

Newly elected NCC Chairman Bobby Green, who also is the President and CEO of Servico Gin and a farmer in Courtland, Alabama, told those present, "We gin from 40,000 to 60,000 bales of cotton each year depending on the yields. We only had an average crop last year because of the rains that came at harvest time. Our yields were average, but our quality was sorry. 50 percent of our cotton was damaged. Our growers just did not do too well last year."

"We appreciate those who do what they do by supporting the efforts of The National Cotton Council. We are here today to tell you, we have some major challenges before us," Green said.

"Our biggest challenge, I think, now and an on going one, is being brought on by a Mr. Grassley (a senator from Iowa). Mr. Grassley really wants to dismantle the farm program and bring down the cotton growers,

the rice growers and the peanut growers.

"Mr. Grassley wants fixed payments with limitations for the peanut and cotton farmers. He wants to limit payments at \$17,500 and a recourse loan limited at \$65,000. The farmer would be forced to take it out (the stored cotton) at the .52 cents (per pound price) and then be forced to sell it at whatever the going price is on the market," Green added.

Green said, "We must hold on to our farm program. We cannot afford to lose it or have it changed. We have lost a great friend to the farmer in Washington by the resignation of Mr. Larry Combest. He cannot be replaced. We must find more friends (to the farmers) in Washington."

The President and CEO of the NCC, Mark Lange, traveling with Green, said, "The Disaster Program is an interesting one. We need the "emergency money." We don't want disasters, but we need the disaster money to offset our losses."

"Mr. Grassley and the Commodity Programs have stolen money from the Farm Program and the Disaster Package," said Lange.

Lange told the farmers about proposal changes being presented by Senator Grassley and others, such as, limitation on crop recycling, price fixing and disaster collection on only one crop, cotton or milo, but not both.

Lange said, "These will be the rules in possibly another 30 to 45 days. The problem is the USDA is holding payments and cotton seed assistance from the farmer until all farmers have turned in their losses."

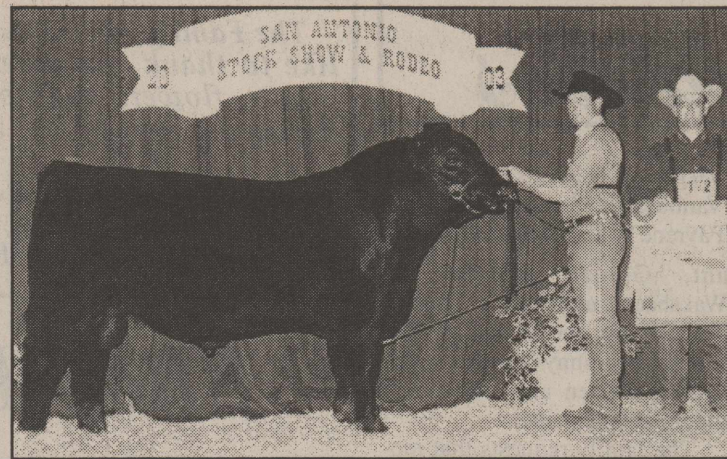
"We need your help, money and new contacts. If Grassley gets his amendment on the floor (in Washington), it will be hard to get the votes against it. We are working right now with friends on "the hill" to stop the Grassley bill from ever reaching the floor."

"Senator Nicols from Oklahoma does not like us, agriculture, nor cotton. We have a freshman senator on the committee, but he cannot fight the chairman. Senator Sessions is our friend, but we need two more good senators on this committee and help vote against this bill," Lange added.

Lange explained, "Grassley will hang his resolution on a bill that a Republican will not vote against. We must walk the halls, talk to our friends and convince them to vote this resolution down."

"You need to contact your representatives in Washington. Grassley wants the agriculture business to go back to the "family farm." We need to pull together to fight this," Lange concluded.

Floydada Coop Manager Layton Stovall told the Hesperian-Beacon, "It is urgent that the farmers contact their local congressman and senator now! If this resolution passes, it will devastate our farming economy."

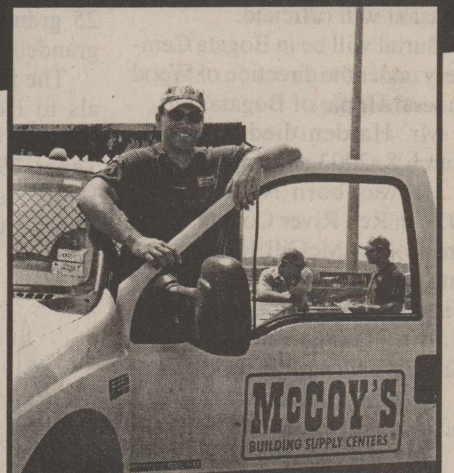

In 1981, Dr. Fuqua joined Texas A&M University's International Programs Division for a special project in Port au Prince, Haiti, working in conjunction with a research team from Texas A&M University and the United States Agency for International Development (AID) and the Haitian Ministry of Agriculture. He worked with their organizations to strengthen Haiti's capacity to conduct research in traditional Haitian crops and to develop a capacity to deliver the positive results of agricultural research to the Haitian peasants. He lived and worked in Haiti until 1986, returning to Texas and retirement.

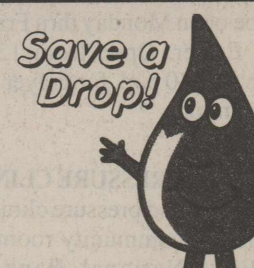

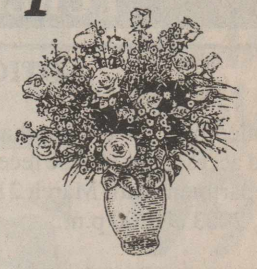
