



South Plains Hobby Club News

The South Plains Hobby Club traveled to Post on March 12, 2003, courtesy of Virginia Taylor, who took the group in her "Doodlevan," for the club's first all day outing of the year. The purpose of the trip was to tour the OS Museum and to have lunch at the Main Street Craft Mall Tea Room, both of which are located in downtown Post, a community founded in 1907 by CW Post, inventor of farm implements and creator of breakfast foods, such as Grape-Nuts and Post Toasties. The group included Virginia Taylor, Ann Hartman, Betty Deavenport, Barbara Cawley, Donnie Bowman, Carolyn Marble, Peggy Roberts, Sandra Lass and Sandra's friend Ruth Ann Labadie, from Chatham, Ontario, Canada.

Since the group arrived in Post before lunch, the members decided to first investigate a number of gift and antique shops on Main Street. Later, the group gathered at the Tea Room and were seated at a large table surrounded by wall decorations denoting the area as "The Hen's Nest" and advising patrons to not count their chickens before they hatched. Consistent with the chicken theme, the group ordered chicken salads or chicken fried steak. During lunch, Peggy Roberts, President of the Hobby

Club, reported that several members were unable to go to Post, but hoped to attend the next meeting. Peggy said that she had received a note from Bessie Bradford, now residing in Canon City, Colorado, and passed around a brochure with a picture of the apartment complex in which Bessie lives and an address for those who wished to write to her

Following lunch, the group proceeded to the OS Ranch Museum. Marie T. Neff, Museum Director, gave the group a guided tour of the museum which is located in the upstairs section of what once was the headquarters of CW Post's Double U Company. A nonprofit enterprise, the museum was established in 1991 by Giles C. McCrary, President, to house the items he has collected from all over the world since 1980. During a phone conversation with Mr. McCrary the next day, he told Sandra that the items in his museum were not to be referred to as a collection or collectibles, but as "stuff". (Mr. McCrary said that he had been advised by his "Uncle Sam" to place his "stuff" in a museum setting rather than to keep them at his ranch.) And mighty fine "stuff" it is indeed. Mr. McCrary said that the main room at one end of the hall, which houses most of his "stuff," was once the Post Community Center and community members had "danced a million miles" on its floor.

During the tour, Mrs. Neff told the group that the room had been remodeled to accommodate the windowed display cases. Mrs. Neff said that the displays are changed three times a year on a seasonal basis and that the annual Easter display had just been completed. Appropriate to the Easter season, the displays include metal eggs designed by Peter Faberge for the Czarina of Russia during the late 1800s. Most of the eggs are intricately decorated with rubies, diamonds and emeralds. Many of the eggs are hinged and contain surprises. Faberge was also a jeweler and often placed jeweled brooches inside of the hinged eggs, much to the Czarina's delight. There is a Limoges egg box, Noritake porcelain eggs and an egg from Mexico that had been carved out of wood by Indian men, coated with beeswax and covered by tiny colorful beads which had been hand placed one at a time by Indian women. There is a large display of the Last Supper with porcelain figurines as well as a large all white porcelain figure of Mary holding Jesus in her lap. In the center of the room is a huge cloth bodied rabbit, fashionably dresses, with an exquisitely

designed porcelain face, as well as porcelain hands and feet. Mrs. Neff introduced him as "Sir Wigglesworth, guardian of the Easter eggs" as well as watch rab-

bit over the other displays. There are handwoven items from South American and Southeast Asian countries. There is a large wooden replica of Lord Nelson's ship, the HMS Victory, hand carved by Robert E. Stewart, which has a hand finished interior below decks, which you cannot see, and is as dedicated to each tiny detail topside, which you can see. There is a large hand carved ivory Chinese city inside a windowed hand carved rosewood cabinet with carved dragons along the top that was made in the mid 19th century. There are lacquered and hinged papiermache boxes with paintings on the top and sides depicting Russian fairy tales, and illustrating the themes of some of Aleksander Pushkin's poems. There are also drawers in cabinets with American Indian jewelry and small items from other countries as well. Mrs. Neff said that the museum is open Monday through Saturday, 10:00 a.m. to 12:00 noon, and 1:00 to 5:00 p.m.

Cotton Market Weekly

Traders ignored an unexpectedly high export sales report from USDA on Thursday, and cotton futures ended the day with a mixed but mostly weaker close after hitting one-week lows amid continued liquidation. Surprisingly, the commencement of hostilities in Iraq on Wednesday evening appeared to have little impact on the market.

In the near term, the war is not likely to have an impact on cotton prices, observers say. However, analysts agree that if the war with Iraq continues for more than a few days it could disrupt business and have a greater effect on prices. One cotton market observer said he did not think the

week average. Once again, China was the primary buyer for the week with purchases totaling 119,100 bales. Pakistan and Hong Kong rounded out the week's list of top three buyers of U.S. cotton with acquisitions of 41,600 and 39,600 bales, respectively

A service provided by Plains Cotton Cooperative Association

"Although we've had a larger amount of export sales recorded in a two-week period a number of time this is the first time we've had over 300,000 bales twice in a row since the first two weeks in November 1990," a cotton market observer explained.

Export shipments for the week established a marketing year high at 265,700 bales. The figure was 5 percent above the previous week and 27 percent higher than the four-week average. Major destinations included Turkey, China and Mexico.

changed hands. The average price received by producers selling their cotton online ranged from 47.71 to 51.24 cents per pound compared to the previous week's range of 48.14 to 49.21 cents per pound.

Meanwhile, the cotton market's focus now is shifting to plantings for the new season. There is anticipation of an abundance of new plantings because of the current higher prices, but the market is waiting for USDA's planting intentions report set for release on March 31. Traders have noted, though, that there is a long way to go between the crop being planted and harvested.

In fact, some adverse weather ready has been experienced as significant rain fell in South and

market had discounted the fact that shipments could be delayed if the war continues for any length of time.

"I'm sure we'll go back to trading fundamentals, and if things get messy in Iraq, cotton prices will fall," the analyst said.

External events such as war can "overwhelm" cotton fundamentals, according to traders. Foreign buyers are likely to be distracted by war and are discouraged from aggressive buying due to the rally in the U.S. dollar, they reason. Looking ahead, traders say that cotton prices have moved sharply higher following wars that have involved the United States, but much of this effect likely was due to currency changes.

"The U.S. dollar strengthens during wars as the world's investors seek safety, but after war it tends to weaken partially because wars-usually increase U.S. debt and partially because foreigners repatriate currency to invest in their local markets," an industry observer said.

In other news, net export sales of U.S. cotton for the week ended March 13 totaled 358,300 bales, a 6 percent slip from the prior week's marketing year high but still 25 percent above the four

A variety of homestead exemptions could lower your property taxes!

A homestead exemption lowers the property taxes on your home by lowering its taxable value. If your home is valued at \$50,000 and you receive a \$15,000 homestead exemption, your home will be taxed as if it were worth \$35,000.

Protect your rights! "Render" your taxable property by April 15th.

A "rendition" is a report to the appraisal district that lists all the taxable property you owned or controlled on January 1st of this year. The rendition form is available at your local appraisal district office... or you may draft a similar form.

Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income-such as the inventory and equipment used by a business.

Are there any advantages to you?

The advantages of filing a rendition are:

- You give your opinion of your property's value. If the appraisal district believes the value is higher, it must notify you in writing of the higher value and explain how you can protest that value to the appraisal review board.
- You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.
- You can also file a "report of decreased value" to notify F the appraisal district of significant depreciation of the value of your property in 2002. The district will look at your property before assigning a value in 2003.

What's the deadline?

The last day for filing 2003 renditions is April 15. Call your appraisal district for the last date the rendition may be postmarked, if mailing. You can get an extra 15 days if you ask for it in writing by the April 15 deadline.

Una exención de residencia reduce sus impuestos de propiedad. Por ejemplo, si su residencia tiene un valor de \$50,000 y Ud. recibe una exención de \$15,000, sus impuestos se calcularán como si el valor de su residencia fuera de \$35,000.

¿Quién califica para una exención?

¿Que ventajas me da?

Who qualifies for an exemption?

Anyone who owned a home on January 1 (and used it as a pri-mary residence on that date) is entitled to a \$15,000 homestead exemption to lower school taxes this year...and it doesn't matter if your home is a house, condominium or mobile home. (Counties, cities and special taxing districts may also offer homestead exemptions.)

Are other exemptions available?

If you're disabled-or if you're 65 years old or older-you are entitled to an additional \$10,000 school tax exemption on your home. And if you qualify for the over-65 exemption, you're also entitled to a permanent, locked-in "ceiling" on the school property taxes on your home. (The ceiling does not apply to county or city property taxes, and those entities may offer other exemptions.) The over-65 homeowner's exemptions and school tax ceiling transfers to the surviving spouse, if the spouse is 55 years of age or older at the time of death and lives in and owns the home. Over-65 homeowners (or their surviving spouses 55 years of age or older) also may transfer the percentage of school tax paid, based on their former home's over-65 school tax ceiling, to a new home.

Do I have to apply each year?

No. If you had a homestead exemption on your home in 2002, you won't need to reapply for 2003 unless your chief appraiser requires it. However, if you haven't received an exemption on your present home-or if you've moved to a new home-you'll need to file for an exemption for 2003. If you are 65 this year, you may file for the over-65 exemption up to one year after the date you turned 65. And if you became disabled during 2002, you need to file for the disabled person's exemption.

When and where should I file?

Cualquier dueño de una residencia principal el día 1º de enero tiene derecho a una exención de residencia de \$15,000 este año para rebajar sus impuestos escolares... y no importa si la residencia es casa, condominio o casa móvil. (Los condados, municipios y distritos especiales de impuestos tambien pueden ofrecer exenciones de residencia.)

;Hay otras exenciones?

Si Ud. es incapacitado—o si tiene 65 años o más—tiene derecho a una exención adicional de \$10,000 en sus impuestos escolares de propiedad. Y si Ud. califica para la exención para los que ya cumplieron 65 años, tambien tiene derecho a un "cielo máximo" permanente en sus impuestos escolares de residencia. (El cielo máximo no tiene que ver con impuestos de propiedad de los condados o municipios, y esas entidades pueden ofrecer otras exenciones.) La exención para los que ya cumplieron 65 años y el cielo máximo se pueden transferir al esposo/esposa sobreviviente si el o ella tiene 55 ó más años de edad y es dueño/dueña de la casa en donde vive. También el dueño de una casa nueva que tiene más de 65 años puede trasladar un porcentaje de cielo máximo de los impuestos escolares que le tocaron en su domicilio anterior.

¿Debo solicitarla cada año?

No. Si Ud. recibió una exención de residencia en el 2002, no hay necesidad de solicitarla de nuevo en el 2003-al menos que se lo pida su jefe de valoraciones. Sin embargo, si no ha recibido una exención en su residencia actual-o si ha cambiado de domicilio tendrá que solicitar una exención para el 2003. Si Ud. cumpliera los 65 años durante este año, tiene hasta un año de esa fecha para solicitar una nueva exención. "Productivity appraisal" may lower the property taxes on your farm, ranch or timber land!

Texas law allows farmers, ranchers and timber growers to pay property taxes based upon the "production value" of their land rather than on market value. This "productivity appraisal" means qualified land is taxed based on its ability to produce crops, livestock or timber—not on its value on the real estate market. And it can mean substantial property tax savings.

When is the application deadline?

If your land has never had a productivity appraisal or you are a new owner, you must apply to your local appraisal district by April 30 to take advantage of this benefit on your 2003 property taxes. You may get up to 60 extra days if you have a good reason and ask for it by April 30. If you miss this deadline, you may still be able to apply, but you will pay a penalty. Check with your appraisal district office.

Do you need to reapply annually?

If your land already receives agricultural or timber productivity appraisal, you normally don't need to reapply unless the chief appraiser requires you to do so. If a new application is required, the appraisal district will notify you by mail.

Y esto le puede ahorrar en sus impuestos de propiedad.

¿Cual es la Fecha límite?

Si su terreno nunca ha tenido una valoración productiva, o si Ud. es nuevo dueño, debe solicitarla a su distrito de valoraciones antes del día 30 de abril, para recibir el beneficio en sus impuestos de propiedad del 2003. Puede recibir hasta 60 días más si tiene una buena razón y si solicita el tiempo adicional antes del 30 de abril. Si se pasa de esta fecha, es posible que todavía la pueda obtener, pero pagará una multa. Pregunte en la oficina de su distrito de valoraciones.

¿Debo solicitarla cada año?

Por lo general, si su propiedad ya recibe una valoración productiva agrícola o maderera, no hay necesidad de pedir una nueva cada año—al menos que se lo pida su jefe de valoraciones. Si una solicitud nueva se requiere, el distrito de valoraciones le mandará un aviso por correo.






