Successful Gala raises money for Unity Center

Over 250 Floyd County friends and neighbors gathered Saturday night, March 29th, at the Unity Center in Muncy and enjoyed a fine meal, good entertainment and a fast moving auction

The Filet Mignon meals with all the trimmings, including potatoes, salads and deserts, were provided by Caprock Cattle Feeders of Lockney and Lowe's Supermarket. The entertainment for the night was the patriotic and spiritual songs of the "Singing Women of West Texas."

Highlights of the evening were the presentations of the big screen TV and the \$1000 cash prize. Nathan Johnson of South Plains was the final "survivor," out of ten finalists, to win the \$1000 cash prize donated by the First National Bank of Floydada. The others were "voted off" by the process of elimination in a numbers game.

The name of Melvin Bradley of Lockney was drawn from the hopper of several hundred raffle tickets to win the big screen TV given away by the Floyd County Friends Board.

Floyd County Friends Board President Martin Stoerner told the Hesperian-Beacon, "All of us who utilize the Unity Center owe a big 'Thank You' to all those individuals and businesses who attended and supported the Gala. Because of their generous support, the Unity Center is available to everyone at a very affordable cost.'

said, "This year's Gala was an exceptional one for fund raising. The total numbers are not in yet, but it looks like we raised about \$15,000. We need around \$18,000 extra each year for the upkeep of the center and for new equipment.'

Long added, "We appreciated all the volunteers involved in making the Gala possible. It took about 60 workers, including the 4-H kids, to serve the meals and put up the decorations.'

Auctioneer Tim Assister and Emcee Long kept the program moving right along from the giveaways to the auction of many donated items by local and area businesses. There were "Fun Bags" donated by Caprock Motor Parts of Floydada and another 83 businesses who were 'auction donors.

One of the larger items in the auction was a donated basketball signed by the Lady Bulldogs Girls 4A State Championship Team from Plainview. The basketball, which previously had raised \$1,010 for the Unity Center, was given to "UPS Man," Curtis Thompson, and his family. His daughter, Tojjina, was recognized as the Most Valuable Player in the 2003 Girls 4A State Basketball Tournament in Austin.

Both Lockney and Floydada high school teams donated signed basketballs and footballs for the auction, along with framed pictures of the 2002-2003 teams, including tennis teams.

dance shows the Floyd County Friends Unity Center, which cost \$631,000 to construct is now debt free. There is \$29,121.28 cash in the General Fund and \$22,442.93 in the Endowment Fund.

The 2003 Operating Budget for the Unity Center is \$28,063. The center generates \$10,000, from rental fees for activities. The number of days the Unity Center has been used has been 101 days in 2000, 210 days in 2001, and 163 days in 2002.

Some of the larger events at the Center have been Lighthouse Electric Annual Meeting, State Gymnastics Meet, and Regional UIL Powerlifting Meet.

School districts and Caprock Hospital have contested races--others cancelled

Although the cities of Floydada and Lockney have cancelled their elections, because of no contested races, both school district will have elections.

Caprock Hospital District also has contested races, however Lockney General Hospital has cancelled their elections.

In Floydada ISD, Trustee Dr. William Dean, Pct. #2, has drawn an opponent--Jerry Don Battey, Jr.

Pct. #1 Trustee, Kerry Pratt, is unopposed so that precinct's election will be cancelled.

In Lockney ISD, Pct. #1

Trustee Jesse Garza will face opponent Richard Zavala.

In Pct. #2 incumbent Trustee Jim Bob Martin chose not to run again. Jeff Don Terrell has signed up for Martin's position. Terrell faces no opponent.

Caprock Hospital District has three At-Large positions coming up for reelection. Incumbents Tom Farris, Denice Payne, and Kyle Smith have signed up to run again. Challengers will be Mark Whittle and Craig DuBois.

Lockney General Hospital's incumbent board members: Dub Hallmark and Nell Glasscock face no opposition.

The term was up for Lockney Hospital Board Member Bill Sherman. Terry Jones signed up for that position and faced no opposition, so the election for the Lockney Hospital was cancelled.

In the City of Floydada, Mayor Bob Gilliland, Council members Ruben Barrientoz, of District 2, and Sheldon Sue, of District 3, faced no opposition.

In Lockney, incumbent Council Members Michael DeLeon, of District #5, Ginger Mathis, District #4, and Lockney Mayor Roger Stapp, were unopposed.



I received another interesting quote on email last week that was attributed to Colin Powell.

I forwarded it to several people and got a response back by Tim Mitchell, of Lockney. Tim is in the Air Force and wanted to make sure I quoted Powell accurately. He sent me to a page that had Powell's full speech.

It wasn't near as short as what was sent out on the email, but since I wanted it remembered accurately I thought I would reprint some of what Powell actually said.

At a conference in England, Powell was asked a very lengthy question by the former Archbishop of Canterbury George Carey. In a nutshell Carey asked if America was relying too much on hard power and not enough on building trust that comes from "soft values"

Powell said, "The United States believes strongly in what you call soft power, the value of democracy, the value of the free economic system, the value of making sure that each citizen is free and free to pursue their own God-given ambitions and to use the talents that they were given by God. And that is what we say to the rest of the world. That is why we participated in establish-

ing a community of democracy within the Western hemisphere. It's why we participate in all of these great international organizations.

"There is nothing in American experience or in American political life or in our culture that suggests we want to use hard power. But what we have found over the decades is that unless you do have hard power--and here I think you're referring to military power--then sometimes you are faced with situations that you can't deal with.

"I mean, it was not soft power that freed Europe. It was hard power. And what followed immediately after hard power? Did the United States ask for dominion over a single nation in Europe? No. Soft power came in the Marshall Plan. Soft power came with American GIs who put their weapons down once the war was over and helped all those nations rebuild. We did the same thing in Japan.

"So our record of living our values and letting our values be an inspiration to others I think is clear. And I don't think I have anything to be ashamed of or apologize for with respect to what America has done for the world." (Applause)

'We have gone forth from our shores repeatedly over the last hundred years and we've done this as recently as the last year in Afghanistan and put wonderful young men and women at risk, many of whom have lost their lives, and we have asked for nothing except enough ground to bury them in, and otherwise we have returned home to live our own lives in peace. But there comes a time when soft power or talking with evil will not work where, unfortunately, hard power is the only thing that works." ******

Dear Editor,

I find myself compelled to write on behalf of some families who have been affected by Travis Hayes' plea bargain.

As I am sure by now, everyone knows that the Special Prosecutor Joseph Kline (who was appointed by Judge Randy Hollums) agreed to one count of Injury to a Child, in exchange for dismissing 7 separate cases of Indecency with a Child and 2 counts of Aggravated Sexual Assault (involving 4 different girls). Travis Hayes then received a sentence of 10 years in prison with a possibility of "60 day Shock Probation"

I am not sure if everyone understands the 60 day Shock Probation program. This states that the convicted felon must serve 60 days incarcerated in a state facility. His time can be served in the county if the prison system does not have any room for him. Before the end of the 60 days, Travis' attorney, Daniel W. Hurley, will submit a request to our local and elected judge, Randy Hollums. Judge Hollums will then request Travis' records from the facility in which he is incarcerated, review it and then make his decision to either grant or deny the request.

If Judge Hollums grants the request, Travis will be out of jail and will be on probation for the next 10 years.

make a couple of points clear. (1) The four girls which stated that Travis had molested them were the age of 7 and younger. (2) When District Attorney Becky McPherson stated that she would be appointing a special prosecutor to the children's cases, their families wanted to get their own attorneys. They were told that since the State of Texas was prosecuting Travis, individual attorneys would not be necessary. (3) Special Prosecutor Joseph Kline did not consult with any of the family members before he agreed to the plea. (4) Once the plea was agreed to by both attorneys and Judge Hollums, Travis' criminal case was closed. (5) The children were never given the opportunity to tell their stories. (6) The family members are unable to overturn the plea, and are outraged by this injustice.

It is my understanding that some of the young girls' family members have spoken with Judge Hollums. It is my further understanding that Judge Hollums told them there are several upstanding church members standing behind Travis. To these people I say, 'Let Travis and his wife, babysit your daughters and your granddaughters.

Judge Hollums also stated if Travis has no misconducts on file, "I will let him out".





Thornberry's bill became the basis for the homeland security realignment plan that was passed by Congress and signed into law by the President last year. During consideration of the plan last summer and fall, Thornberry played a key role in brokering a bipartisan coalition that helped solidify both Republican and Democratic support for the bill.

"Mac Thornberry is one of the foremost experts on homeland security in Congress," Speaker Hastert stated. "His knowledge and experience dealing with this issue, going back to his introduction of a bill in March 2001 to establish a Homeland Security Department, will be very important as we work with the Bush Administration to get the new Department up and running. He will be a real asset to the Select Committee, and I am glad he is a member of our team.

Thornberry has some experience in dealing with government reorganization issues. In the late 1990s, he led the effort to reorganize the Department of Energy nuclear weapons complex. He was an architect of the 1999 law to establish the National Nuclear Security Administration, and was subsequently appointed Chairman of a Congressional panel that oversaw how that reorganization was implemented.



Livestock could be terrorist target

The U.S. Department of Homeland Security has elevated the terrorism threat level to OR-ANGE, which indicates a high risk of attack to U.S. interests both domestically and overseas.


As a result of the increased security level, foreign animal disease (FAD) surveillance should be increased nationwide. We encourage each of you, whether you are involved in disease diagnosis, animal movement, or livestock production and marketing, to be particularly aware of any indication that could signal the occurrence of a highly contagious disease or any other unusual or unexplained adverse animal health event. No potential FAD cases should be disregarded. Potential hoaxes should be treated as suspect incursions of a disease until proven otherwise. Specific attention should be directed at livestock and poultry concentration points.

Be particularly alert to these five signs:

1. Sudden, unexplained death loss in the herd or flock 2. Severe illness affecting a high percentage of the animals. 3. Blistering around an animal's mouth, nose, teats or hooves. 4. Unusual ticks or maggots. 5. Staggering, falling or central nervous system disorders.

If you see something unusual, contact your local law enforcement authorities immediately and notify the Texas Animal Health Commission at 1-800-550-8242. (Or, if you reside outside Texas, please contact your state veterinarian's office.)

Lockney High School Aca-demic program has once again walked away with the district title, making this a duplicate performance of last year's win.



Regional boll weevil vote set for April 21

Cotton farmers and landowners with cotton production are eligible to vote in an April 21 referendum that will determine whether to continue a boll weevil eradication program in the 22 counties of the Northern Rolling Plains Boll Weevil Eradication Zone

Based on Farm Service Agency records, the Texas Department of Agriculture has mailed 2,028 ballots. Eligible voters in the Northern Rolling Plains Boll Weevil Eradication Zone should receive an official ballot by mail after March 28. A postage-paid return envelope will be included. Completed ballots must be postmarked on or before April 21 to be counted. Producers who planted cotton in 2002 but do not receive a ballot should contact TDA at (512) 463-7593.

In addition to deciding if an eradication program should continue in the zone, voters will elect a board member from the Northern Rolling Plains Zone to serve on the statewide board of directors for the Texas Boll Weevil

Eradication Foundation Inc. TDA received one nomination for this position before the March 22 filing deadline.

The name of John Inman of Childress County will appear on the ballot as a board nominee. Inman is a cotton producer who has farmed in Childress County since 1980.

Growers in the Northern Rolling Plains Zone initially approved a boll weevil eradication program in April 1999 and a maximum assessment of \$15 per planted row acre for irrigated cotton and \$10 per planted row acre for dryland cotton to fund it. The referendum will not affect the current assessment rates.

The Northern Rolling Plains Boll Weevil Eradication Zone consists of approximately 350,000 acres in 22 counties: Childress, Clay, Collingsworth, Cottle, Donley, Foard, Gray, Hall, Hardeman, Kent, King, Motley, Wheeler, Wichita, Wilbarger, and portions of Archer, Armstrong, Briscoe. Cotton Market Weekly A service provided by Plains Cotton Cooperative Association

Futures contracts on the New York Cotton Exchange closed lower Thursday as speculative and fund selling won the battle against trade buying and broke through a key trend line support toward the close. Even the release of much better than expected U.S. export sales and shipments could not give the market enough upward momentum needed to finish the day on the upside.

Expectations were for a lower sales figure in USDA's weekly export report, but the actual figure surprised some traders. Market participants had thought last week's soft demand was due to a slowdown in export sales and, therefore, were not anticipating such a high sales figure.

For the week ended March 20, net export sales of U.S. cotton totaled 276,200 bales; however, it was 22 percent less than the prior week and 15 percent lower than the four-week average. For the third consecutive week, China was the primary buyer of U.S. cotton at 148,400 bales. Total sales to China now stand at 1.6 million bales, less than half of which has been shipped. For the same period, total US export shipments of 260,500 bales equaled the previous week and were 19 percent higher than the four-week average. Primary destinations included Mexico, China and Turkey. In other news, the National Cotton Council reported U.S. textile mills used cotton on a seasonally adjusted annualized rate of 7.29 million bales in February. This was in line with expectations and slightly changed from the 7.38 million recorded for January which had been upwardly revised from 7.35 million bales. Market attention now is turning toward USDA's 2003 prospective plantings report for cotton which is expected to show an increase in acreage from the previous season. The data, based on surveys of farmers conducted through the mail or via telephone between late February and mid-March, is scheduled to be released Monday, March 31 An average of analysts' estimates pegged this spring's cotton planting intentions at 14.42 million acres compared to 13.96 million acres estimated for the previous season. The higher price of cotton versus competing crops, subsidies granted by the Farm Bill and favorable weather conditions in cotton growing areas all point to an increase in acreage. Record world demand for cotton and lower yields and quality in the past season due to adverse weather conditions also

have conspired to raise prices, a fact that will not be ignored by cotton producers, one analyst said.

"Although cotton futures prices are not currently at a level that will benefit farmers-they have to reach the mid 70.00-cent level to do so -it is the Farm Bill and the subsidies that it offers that should encourage plantings and will ensure adequate acreage," the analyst said.

Texas, the nation's largest cotton growing state, is expected to see the bulk of the increase in acres planted to cotton in the upcoming season. One reason for this, analysts say, is that the southern part of the state has been so wet that corn and grain sorghum have not been planted in a timely fashion and, therefore, some acres should spill over to cotton. Also, West Texas had a good crop last year which should encourage growers this season. Additionally, the boll weevil eradication program in Texas has been making progress in recent years which will be another factor contributing to the growth of cotton acres in the state. Although some U.S. cotton, planting begins in March, the majority occurs in April and May. Therefore, market participants reiterated that USDA 's survey is based on intentions and the actual amount of cotton planted will be subject to change. On the spot cotton scene, trading activity slowed dramatically. Online sales by Texas, Oklahoma and Kansas cotton producers for the week ended March 27 totaled 786 bales, a decrease from the previous week when 11,223 bales changed hands. The average price received by producers selling their cotton online ranged from 40.00 to 48.50 cents per pound compared to the previous week's range of 47.71 to 51.24 cents per pound.

To date, the farthest west that Columbia debris has been located and recovered in Texas is in Lamb County, near Littlefield.

Any piece of shuttle material could prove to be an essential piece for investigators trying to understand what happened on February 1, 2003.






