HAZMAT team called to clear titanium spill

Faulty barrels blamed for leak south of Lockney

Floyd County firefighters managed a potentially dangerous situation on Monday after a chemical spill was reported south of Lockney.

The chemicals—granulated titanium packed in water—leaked from barrels as they sat on the back of a tractor-trailer rig parked at the home of Danny Thomas.

The Lockney Volunteer Fire Department was notified at 8:30 a.m., and firefighters were standing by until a hazardous material containment contractor arrived.

Ecological Environmental Services of Amarillo arrived at 2:30 p.m. and declared the chemicals stable and blamed the leak on faulty remanufactured barrels.

"They were confident that it was stable," Lockney Fire Chief Preston Belt said. "They determined that the barrels can be un-

loaded safely without harm to person or property."

Eighty-eight barrels of industrial titanium shavings were being shipped by Thomas Trucking of Lockney. The driver of the truck parked at Thomas' house overnight.

The shipment originated in Santa Fe Springs, California, and the chemicals were en route to Washington, Missouri where they were to be recycled.

"Basically what we had were barrels of titanium shavings packed in water," Belt said. "It is eating through the bottom of the barrels and corroding the trailer."

The hazardous material team repacked the leaking barrels into large plastic chemical containers for the rest of their journey.

"Everything that came off was neutral to basic," Belt said. "There wasn't anything acidic out there."

Schaffer Grinding Company of Montebello, California owned the shipment. According to an industrial directory, the company specializes in precision rotary and surface abrasive belt grinding and milling.

Firemen and equipment from the Floydada Volunteer Fire Department were also called in, and a Floydada EMS crew was standing by. A Hale County Emergency Management representative was also called. The crews were dismissed after initial tests by the hazardous material team determined that the chemicals were stable.

The truck had been stopped the previous day at the Arizona, New Mexico state line because of leaking barrels. Two barrels were repacked then. Schaffer Grinding is responsible for the costs associated with the containment and clean-up.

FISD joins reading cooperative

FISD Board voted unanimously, June 10, to join the Plains Reading Consortium--an association of the Texas First Reading Initiative Co-op consisting of Lorenzo, Motley County, Valley, Crosbyton and Ralls school districts.

According to FISD Superintendent Jerry Vaughn, \$64 million dollars of federal money is coming to the states as grant money to be used by those school districts that are eligible for Reading help in Kindergarten through Third Grades.

School districts become eligible for the grant money because

of low reading scores on TAAS and TAKS tests.

"These grants will be competitive," Vaughn said, "and our first step is giving them notice that we intend to apply for this grant."

"We (these six school superintendents met this week) and Crosbyton ISD will be the central agent for this consortium. We will hire a Program Director, an Outside Evaluator, a required Reading Coach for each of the six school districts, and the six superintendents will make up the board," added Vaughn.

The Reading Coaches will work with the teachers, coordinate

with the Program Director and make sure some of the reading techniques and strategies will be implemented in the classrooms. There will be administrative costs and the Outside Evaluator will audit according to Vaughn.

"The minimum grant dollar amount for FISD for this project will be \$170,000. If certain schools do not apply, and we already know some who are not going to apply, then that extra money will be divided between those schools who do apply."

"This will be a six year program only and I recommend we apply for this cooperative program," Vaughn concluded.

Towery finally views records related to '50s land scandal

Austin--Almost 50 years after his reporting rocked the state and won a Pulitzer Prize, a retired South Texas journalist Thursday gained access to documents no one wanted him to have.

Kenneth Towery, a World War II veteran and former prisoner of war in Japan, was a relatively new managing editor of the *Cuero Record* in 1954.

He got curious when he heard that two Anglo businessmen were socializing with black men at the local country club after hours.

The two, he found, were paying the club's black caretaker \$10 for every veteran he could talk into applying to buy land under a state program run by the governor, attorney general and Texas land commissioner--the Veterans Land Board.

The scandal eventually sent Land Commissioner Bascom Giles to prison. It involved elected officials and businessmen who preyed on black, Hispanic and illiterate veterans -- espe-

cially in Bexar, DeWitt, Lavaca, Victoria, Dimmitt, Uvalde and Zavala counties -- and it left a scar on the agency.

Jerry Patterson, the current Texas land commissioner, was researching the agency's oft-tarnished history, and invited Towery, 80, to view the agency's records.

Historians presented Towery with legal-sized folders, a scrapbook of newspaper clippings, and a stack of plastic-sheathed papers.

Then they listened to his stories.

A cataract in his right eye prevents Towery from reading quickly, but Patterson gave him an open invitation to return, encouraging him to snoop around for new aspects of the much-publicized scandal.

"I'm sure there's something here that I didn't know about," Towery said.

A stipulation allowing "block sales" to two or more veterans enabled promoters to get around limits placed on the size of the loans, and they used cash, gifts or outright fraud to get veterans

to sign up, according to the Handbook of Texas.

The scandal ran deep, and speculation abounded that Attorney General John Ben Shepperd and Gov. Allan Shivers were involved. Both helped investigate it and neither was indicted, but 20 others were charged and three were convicted of conspiracy to commit theft, including Giles.

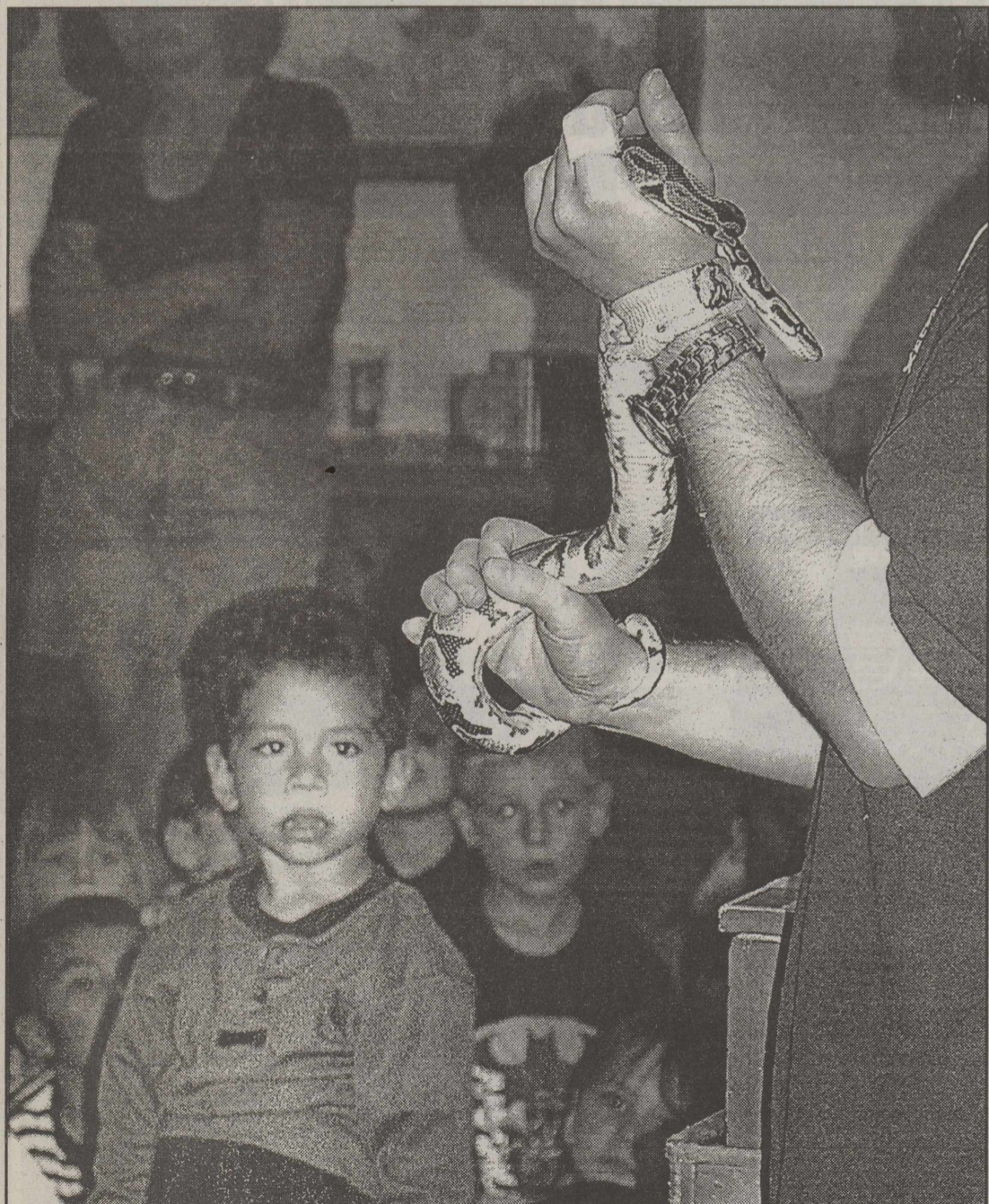
Giles became the first Texas elected official to serve time for a crime committed in office. He served less than two years.

Health problems prevented Towery from going to New York to accept his Pulitzer in person, but he got a check for \$1,000--more than three times his monthly salary. It lifted him into a big-time career, including a stint at the *American Statesman* and 14 years as press secretary to U.S. Sen. John Tower.

Towery said his work still resonates.

"It caused a lot of laws to be changed for the better," he said.

Brown runner-up for state honors

Brown was praised for his work he does in the community and his dedication to making improvements within the Fire Department. He was credited with helping the department stay financially solvent, and with working to keep the department and its members in up-to-date equipment and training.

Brown has been a member of the Floydada Fire Department for 15 years, and City Manager for 15 years.

Another effort, we are told, will be made to jump-start the tattered "road map to peace" put forth recently by President George W. Bush, et. al., and suddenly placed in jeopardy by renewed fighting between Jews and Arabs. (Bush was only one of four entities that came up with the plan, but it bears his name.)

In the meantime, our President has suggested, somewhat rhetorically, that outside money stop flowing into the region for the purpose of underwriting the warring sides.

That is good advice, extremely good advice. In fact, it is so good, we suggest even the President himself take it to heart. We have poured billions upon billions of taxpayer dollars into one side in that struggle, for the sole purpose of assuring a favorable opinion of our side by Israel's friends and allies in this country when election time rolls around.

We suggested years ago that if we truly wanted peace in the region, all we had to do was cut

off the funding. It was good advice then and it is good advice now. But it is advice that will not be taken. When Bush and the leaders of Israel, Jordan and Palestine were meeting in Aqaba, all making the right noise, a huge rally was taking place in Israel by people opposed to any peace between Israel and its neighbors. Perhaps one reason no mention was made of the rally in the American press was that, according to the Israeli press, "a number of United States senators and Congressmen" were in attendance.

Now the chickens are coming home to roost. Political issues have a tendency to do that too, just like chickens. There was the President, belatedly trying to get the two sides to start working together, and members of the Congress urging just the opposite. (The Israeli newspaper we read (Ha'aretz) did not name the Congressmen or the Senators, nor did it mention which political party they were in, but it did much better than the American press,

which didn't even mention the fact that the rally occurred.)

Quite frankly, we didn't have much faith that the road map would lead to any real peace. Too many people on both sides of the equation have too much at stake in continued warfare. The real zealots among the Palestinians would be lost if they did not have the state of Israel in their midst, and the state of Israel would be about \$130 billion poorer if it did not have the American Congress worrying about its future. And who knows how much money has been dumped into American political campaigns because of the Middle East squabbling.

When the Palestinians surprised everyone by accepting the idea that they needed some one other than Arafat to interface with Sharon, and when Sharon said he

would accept the "road map" providing it was shaped to Israel's pleasure, we figured problems were ahead.

George the Younger has shown a great deal of intestinal fortitude in practically every occasion where he feels the interests of the United States and the interests of Israel are identical, but he has shown no interest in standing up to Sharon in those cases where Sharon might take offense. In that respect, young George is much smarter than the elder George. The elder George seemed to think he was President of the United States, and that Israel ought to realize that fact. Young George takes a much more political view of the Middle East. Many of us don't like it, but his view may end up being the right one.

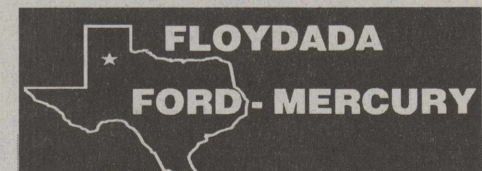

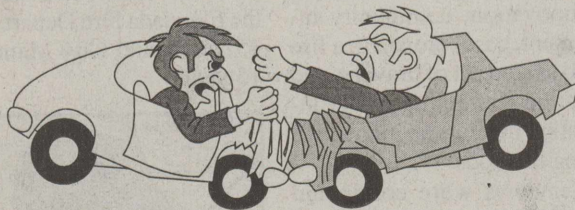

Superintendent says revenue up for FISD

The FISD Board met Tuesday, June 10, and discussed the 2003-2004 budget and this past year's TAKS scores.

Superintendent Jerry Vaughn told the board, "Last year's budget was \$7,402,055 and we are working below our budget right now. I feel pretty good about that. Next year's budget will probably be higher than this year's."

Vaughn explained, "We should receive a \$110 per student increase next school year, or \$180,620 total, from State WADDA revenues. Also, our Tier 2 State funds should increase by \$231,711. Our local tax increase for 2003-2004 should be \$140,000. These are the numbers

we are working on. They will give us a \$411,000 total increase in revenues for next year's budget, if everything stays the same with the tax rate and the state money. Our plans are to increase the local school budget for 2003-2004 by \$320,500."

Concerning FISD TAKS tests taken at the end of this school year, Vaughn said, "Our Third Grade Reading total combined score was at 88 percent. We took the test the first time in February. Those who failed it the first time had to take it the second time. We still have five who have the opportunity to take it again on July 8th.

"Third Grade Reading students are the only ones who get second and third chances at these tests. All

the others only get one chance. We moved from 79 percent in February to 88 percent in May. The state standard is 90 percent.

"Next year an 89 percent will become a 75 percent. The test does not change, but what it takes to pass will change. More questions must be answered correctly in order to pass the test. This year we gained in some tests and we went backwards on some tests due to the difficulty of the test," Vaughn concluded.

In other matters, the board passed a motion by Board Member Mark McCormick to give a five percent raise to all the auxiliary personnel (bus drivers, custodians, cafeteria workers and maintenance workers). The motion was seconded by Board Member Bill Dean. Board Members voting for the motion were McCormick, Dean, Jill Warren and Mitch Probasco. Board Member Kerry Pratt voted against the motion.

FISD Business Manager Sharon Rainwater gave a tax report update to the board. According to Rainwater, over 94 percent of this year's \$2,115,416.99 tax roll had been collected to date.

The board passed an endorsement vote for Cindy Purdy of Muleshoe to be elected to the TASB Board representing this region. Board Members Probasco, McCormick, Warren and Dean voted for the endorsement, while Pratt abstained.

Resignations accepted by the board were: April Heard, Pat Lacewell (retiring), Judy Ballou, Robert Lockwood (retiring), Sharon Lockwood (retiring), and Reba Moore.

Employment of personnel approved by the board were: Pauline Cooper, Angela Oaks (FHS), Bryon Carpenter (FHS, FJHS), Judy Dunlap (Andrews Elementary), April Heard (CCLC), and Kim Jenschke (Andrews Elementary).

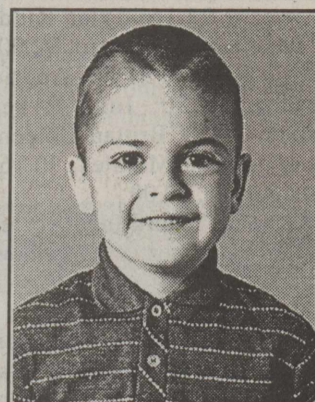

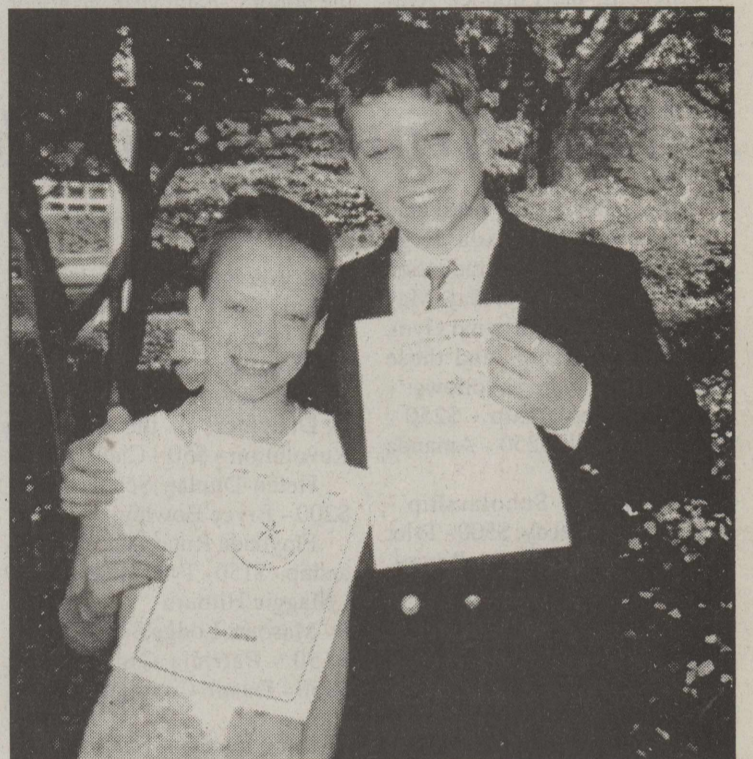
Gilliland graduates

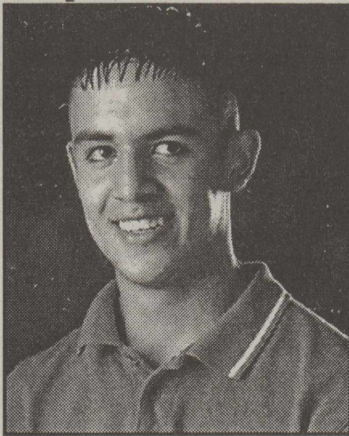

Former Plainview Bulldog Nathan Young was named the recipient of the Bob Jones Outstanding Offensive Lineman award.

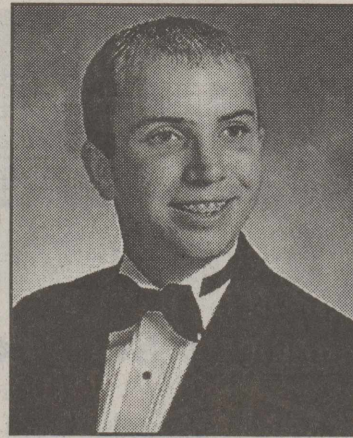

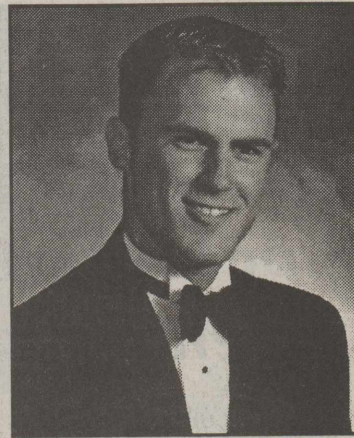

Forest Service loans truck to Lockney F.D.

The Lockney Volunteer Fire Department has received a 2 1/2 ton 6X6 grass fighting truck from the Texas Forest Service. The equipment is considered a "loan" to the city.

The state agency has the authority to acquire excess military equipment and assign the equipment to rural fire departments.

"This equipment is made available through the Federal Excess Personal Property (FEPP) program," said Mahlon Hammetter, a fire prevention spe-

cialist with the Texas Forest Service.

"The federal government maintains title to this property and therefore the equipment is considered on loan to the receiving fire department," said Hammetter.

Only equipment that can be used for fire suppression activities is available through the FEPP program. TFS will license FEPP vehicles for participating fire departments.

To acquire FEPP equipment the fire department has to make a formal application for the equipment. The application is evaluated by the TFS for eligibility and priority.

If approved, the fire department must sign a formal cooperative agreement with the Texas Forest Service and place TFS door decals (furnished by TFS) on the vehicle.

The equipment must be returned to TFS when it is of no further use to the fire department.

Mother nature pounds crops

LUBBOCK - Five hundred thousand to 725,000 acres was the Friday the 13th "best guess" estimate of damaged cotton resulting from violent weather that has wracked West Texas since May 31.

Those estimates were offered by agronomist, entomologists, crop consultants, agribusiness representatives, and others at a Plains Cotton Growers, Inc., roundtable meeting. Economists with Texas Cooperative Extension estimate the raw potential economic value of those lost acres between \$130 million and \$188.5 million.

Texas farmers plant about five million cotton acres each year, stretching from the Rio Grande Valley near Brownsville to the Texas-New Mexico border in the west, and as far north as some counties near Amarillo. The 20-county area surrounding Lubbock is often known as "the world's largest cotton patch," because farmers there typically plant about 3.2 million acres of upland cotton each year. Approximately ten percent of that acreage, roughly 320,000 acres, never makes it to harvest due to weather, insects, disease, or other causes.

"The 2003 crop has taken a big hit in West Texas from a combination of rain, hail, and wind since May 30-31. I have lost count of the number of storms," said Randy Boman, Texas Cooperative Extension cotton agronomist based at Lubbock. "I'm guessing we have about 500,000 acres damaged in the 20 counties surrounding Lubbock. But I feel like that number is low."

Boman noted that producers in Floyd, Crosby, Hale, Swisher, Parmer, Castro, Bailey, Cochran,

Lamb, Lubbock, Terry, and Yoakum counties were hardest hit, to date. The toll of damage on other crops, such as corn or wheat, and equipment (center pivot sprinkler, barns, etc.) is not known at this time.

Farmers on the South Plains began planting their cotton in early May. Roller coaster daily temperatures greeted their efforts this year. The high temperature reached 103 degrees in Lubbock on May 18, but topped out at only 60 degrees on May 20. Large temperature swings hamper heat loving crops such as cotton, which must accumulate thousands of daily heat units to make appreciable yields.

"We are a little behind in heat unit accumulation because of cooler temperatures that have delayed planting and stunted growth of emerging cotton seedlings," Boman noted. "The only silver lining I see in the clouds so far is our soil moisture. The three to eight inches of rain we have received will help the surviving crop, and any crop that we replant."

Cotton producers should evaluate their damaged fields closely and carefully before making any replant decisions, Boman said. There is a host of information on evaluating damaged crops, making replant decisions, and choosing catch crops to replace failed cotton on the Internet at: <http://lubbock.tamu.edu>.

With a new farm bill program under way, producers should check with their county USDA Farm Service Agency (FSA) of-

rice to ensure their replanting decisions will not affect their program participation or program benefits.

"I'm concerned that our recent weather losses could reduce our regional yield potential by as much as one million bales," said Roger Haldenby, vice president-operations for Plains Cotton Growers.

"The damage to date has cut the heart out of some of our most productive areas," Boman added.

To gauge the raw potential product value of lost cotton, Extension economists typically multiply the number of acres lost or failed by its potential yield per acre, and then multiply that number by the existing federal cotton loan rate. Using this year's numbers, that formula would look like this: Scenario A: 500,000 acres X 500 lbs./acre (one bale) X .52 cents/lb. (loan rate) = \$130 million Scenario B: 725,000 acres X 500 lbs./acre X 52 cents/lb. = \$188.5 million

These scenarios do not reflect any crop insurance payments or federal disaster aid payments affected growers might receive, nor do they reflect the "ripple" effect these dollars might have in the regional or state economy. If an economic multiplier of 2.5 is applied, the total projected economic impact could range from \$325 million to \$471 million.

Economic multipliers are often used to account for the ripple effect of currency spending as it passes through a regional or state economy.

FSA announces crop disaster sign-up

Texas producers can expect to receive financial assistance for crop losses through the Crop Disaster Program (CDP), launched by the U.S. Department of Agriculture on Friday, June 6, 2003. CDP is available to producers with qualifying crop losses for the 2001 or 2002 crop years.

We [Farm Service Agency] recognize the hardships caused by the bad weather and drought and believe this program will allow farmers and ranchers to regain some of their lost income.

Crop disaster payments for 2001 and 2002 production and

quality losses will be calculated similar to the 2000 CDP. Eligible producers with greater than 35 percent loss will receive payment at 50 percent of the established price if the crop was covered by crop insurance or the noninsured crop disaster assistance program (NAP) or if coverage was not available. Payments will be based on 45 percent of the established price for crops that could have been insured or covered by NAP, but were not.

CDP payments will be limited to \$80,000 per producer and/or entity, but funding for the program is unlimited. Although no sign-up deadline has been an-

nounced, we are striving to implement this program in a timely fashion in order to effectively benefit the producer.

I encourage producers to begin organizing relevant crop loss documentation and contact the Floyd County FSA Office to schedule an appointment to discuss program eligibility and the application process.

certified by July 15th. Another factor comes to play because of the need to certify failed acreage and also to certify subsequent crops. If a producer has already certified his crop and has lost it due to the weather we have had in Floyd County, the producer needs to call in and make an appointment to fail these acres. He also has to certify his subsequent crop.

The Livestock Compensation Program (LCP-II) sign-up ends July 3, 2003. Please call the office if you want to sign-up into this program.

The FSA county office staff is overloaded at this time, just

like our farmers, but they'll continue to get the job done. Please have a little patience when dealing with the staff in the office. This is a very stressful time for everyone.

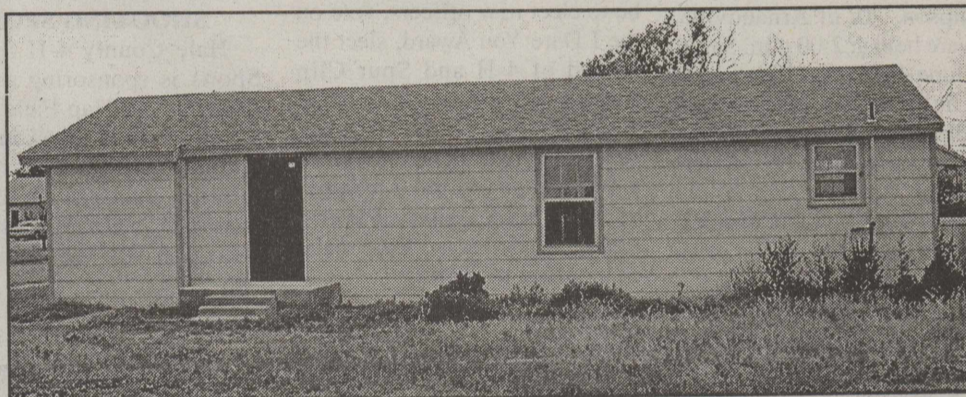

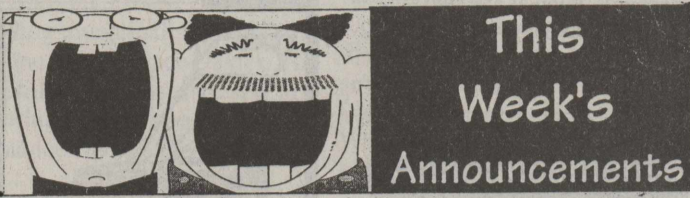
Mr. Thompson died Wednesday June 11, 2003, at his residence in Arnaudville.
