



# Burglars caught nside Kirk & Sons

A burglar alarm sounding off at Kirk & Sons, in Floydada, led to the arrest of 2 men and put a stop to a string of week-end burglaries of downtown businesses.

"We have no idea exactly how many businesses were burglarized," said Police Chief Darrell Gooch. "We are still taking reports and processing paper

What is known at this time, according to Gooch, is that Azteca, Producers, Bibi's Dream Cuts, and a building attached to Payne Pharmacy were burglarized late Friday night and early Saturday morning.

The men hit again late Sunday, and early Monday with burglaries of Caprock Motor Kirk and Sons. Parts and Don Hardy Fuel Efficient Irrigation.

"After they burglarized Don Hardy's they took the stolen items home and returned again to burglarize Kirk & Sons," said Gooch. "They broke in the back door and were inside when the alarm went off at 1:30 a.m. Acity officer was across the street at the county jail when the alarm sounded. He ran around the back of Kirk and Sons and secured the back door. Good citizens, who had been visiting with the officer (and were standing across the street), shined their flashlights through the front windows of

"The lights in front and the officer in back made the burglars think there were cops all over the

"When back-up arrived, police captured the burglars."

Arrested inside Kirk and Sons were: Rocky Terrell, 25, of Floydada, and Jimmy Holland, 19, of Floydada.

"A third suspect, a 21 year old man, has been identified and is cooperating with police," said Gooch. "He has not been arrested at this time."

### New congressional districts will bring new faces to Floyd County

Six months of fighting over congressional redistricting ended Sunday, when the Senate passed a redistricting plan in their 3rd special legislative session. The new map moves Floyd County from Congressional District #13 to District #19.

The bill now goes to Gov. Rick Perry to sign into law. Democrats have pledged to take their fight to court.

Texas voters have elected Republicans to all 27 of the statewide offices, but Democrats still hold a majority in the state's 32member congressional delegation. Republicans say that's because boundaries for congressional districts have been drawn to benefit Democrats.

The new map, approved in the Senate by a 17-14 vote, will likely give the Republicans the majority in the Texas Congressional delegation that is now ruled 17-15 by Democrats.

The new plan could give Republicans 21 or 22 seats in Conpart of District 19. Incumbents with Potter, Randall, and Wichita Randy Neugebauer, R-Lubbock, and Charlie Stenholm, D-Abilene, will now have to face each other in the general election to decide who will represent the new district.

District #19 is made up of 27 counties with a Democrat/Republican split of 39.9/60.1. (This number is based on voting in the 2002 race for lieutenant gover-

Other counties in District #19 will be: Lubbock, Hockley, Cochran, Hale, Lamb, Bailey, Castro, Parmer, Deaf Smith, Yoakum, Terry Lynn, Garza, Kent, Gaines, Borden, Howard, Fisher, part of Nolan, Taylor, Callahan, Shackleford, Callahan, Eastland, Stephens, Young, and

part of Archer. Redistricting affects only Floyd County's congressional seat. The County will lose the representation by the current representative, Congressman Mac Thornberry. Thornberry's District





### Whirlwinds blow by Friona 38-14

The Floydada Whirlwinds opened District 5-2A action last Friday with an impressive 38-14 victory over Friona.

Rebounding from a non-district loss to Crosbyton a week earlier, the Whirlwinds improved to 4-1 overall and set up a crucial battle this week at Abernathy. The Antelopes upset district favorite Lockney 25-19 in triple overtime last week and improved to 4-2 for the year. The 'Lopes have already won more games at this point of the season than they did in their entire 2002 campaign. Abernathy was winless in district play a year ago.

Friona dropped to 2-4 for the season and will host the surprising Olton Mustangs tomorrow night. Olton, lightly regarded by most pre-season pollsters, opened district play by blasting winless Hale Center 33-0 and is atop the district standings with a 5-1 overall record.

The Whirlwinds wasted little time getting on the board by scoring in the game's first 34 seconds. Following a Friona penalty to open the game, Luke Miller took the first snap from scrimmage, timed an option pitch perfectly to Gerald Henderson, who scampered 54 yards downfield into the visitors' end zone. Henderson hooked the point-after kick attempt, but the Whirlwinds were up 6-0 before a lot of spectators were settled in their seats.

Friona quickly responded with a scoring march of its own. Quarterback Brock Field's 20yard pass to Steffan Busch, along with a couple of nifty runs, spearheaded the 10-play, 57-yard drive which ended with a 6-yard touchdown by Ruben Alvarado. Antonio Monreal's conversion kick gave the Chieftains their first, and only, lead of the game.

The recently announced results of Sign-up 26 of the Conservation Reserve Program left many Texas applicants with an uneasy feeling and a ton of ques-

For officials at Plains Cotton Growers, Inc. one of the most visible and surprising statistics of all was that less than 25 percent of the applications submitted from Texas were eventually ap-

For the other 75-plus percent, which included a significant number of applications on current CRP contract acreage, the obvious question is: "What can be done to keep currently enrolled CRP acreage in the program and maintain the conservation benefits that they provide?"

What it really comes down to, however, is how can applicants improve their offer's Environmental Benefits Index (EBI) score and improve their chances of being accepted or, more importantly, reaccepted.

For several years EBI scores have been the basis for ranking and determining which applications will or will not be accepted.

It is understood that as years go by and conservation priorities change that different weight is placed on various portions of the

What Sign-up 26 brought to light was the fact that existing CRP contracts fail to receive any additional EBI credit when reapplying, even though the acreage was deemed worthy of conservation in the past.

The following EBI factors were used to assess and rank offers during Sign-up 26: Wildlife Habitat benefits; Water Quality benefits; On-farm benefits; Enduring benefits; Air Quality benefits; and Cost.

Subcategories identified specific conservation practices and the credit (score) received for

The average EBI score for accepted applications during the most recent sign-up was 269, although counties at or near the CRP cropland limitation could have had a higher EBI cut-off

Nationwide contracts were offered on some 4.0 million acres. Approximately 1.6 million of those acres were currently enrolled in the CRP. Only 700,000 acres of currently enrolled CRP acres were accepted and will remain in the program.

A strong argument can be' made that much of this acreage needs to remain in the CRP instead of being reintroduced to crop production.

Land in the CRP program was placed there for a reason and should have every opportunity to remain actively enrolled in order to extend the benefits the CRP provides.

It is also important that the procedures governing future CRP sign-ups give additional credit to existing CRP acreage and the conservation benefits that have already been accrued.

One idea that could keep thousands of acres of highly erodible land in the CRP would be to grant additional credit within the EBI framework for currently enrolled

It seems only fair that landowners who are participating in the program, at some point, be given extra credit for the conservation practices and benefits they have already realized through the

program. Another option to bridge the time it takes to implement such a revision would be contract extensions that allow landowners an opportunity to reapply for the program during the next sign-up

period. PCG officials say that efforts to seek these changes and investigate other areas where improvements in the CRP sign-up process can be made will be continued.

Nationwide the CRP has been an overwhelming success and has allowed millions of acres of highly erodible land to be retired from crop production.

One thing that must be remembered is that, even though the CRP remains a dynamic program that reflects the changing conservation priorities of the nation, the priorities that brought acreage into the program in the first place should not be ignored.

Doing so would quickly erase many of the positive benefits that are being realized through the program on a daily basis.



Cleta Davis of the Floydada EMS was so kind and reassuring as she gave me the emergency room number and the time my daughter would arrive at the hospital. My husband and 1 were seven hours away in Tyler, but we were able to know exactly how our daughter was doing as we frantically packed and drove to Lubbock. We called the emergency room every hour for updates. Mrs. Davis has called several times to see how our daughter is recovering and Mrs. Workman even visited her in the hospital.

We are happy Lindsay will make a full recovery and we can't thank these two ladies enough for the comfort and reassurance they gave us during a terrifying time. We would also like to thank Floydada Sheriff Royce Gilmore for taking us to the wreck site on a Saturday morning to recover a cellphone and for his help in recovering Lindsay's business papers and items thrown from the car. We appreciate so much all the emergency personnel from Floydada, the Department of Public Safety trooper and others who helped and whose names we do not know.




