A house located at 706 E Thornton in Floydada was heavily damaged by fire Thursday, August 12. The northeast front bedroom was gutted by the fire and the rest of the house was damaged by smoke and water, according to resident Karen

According to Fire Chief Carroll Sims, the call came in about 2:40 P.M. and 15 firemen responded. There were 11 firemen from Floydada and four from Lockney.

Karen told the Hesperian-Beacon, "My mother, Carrie Davis, my 13 year old son and I lived in the house. There was a lot of damage from smoke and water to the rest of the house. My mother did have insurance."

for proposed tax rate

The FISD Board met in Special Session Monday, August 9, and discussed the proposed 2004-2005 budget and the proposed tax rate increase. The Public Hearing was set for Tuesday, August 24, at 7:00 P.M. at the FISD Central Office.

According to Superintendent Jerry Vaughn, the new proposed budget has not yet been finalized. However, the board has proposed an increase in the 2004-2005 tax rate from the present tax rate of \$1.4434. The tax rate has been proposed to be raised to \$1.7196 per \$100 property valuation.

FISD Public Notices published in the Hesperian-Beacon states, the \$0.2762 tax rate increase is necessary in order to pay the Interest & Sinking Fund expenses on the upcoming \$14.5 million dollar Bond Election to be held on September 11, 2004, if it passes public approval.

In relation to this tax rate increase and the upcoming Bond FISD Board met in regular session Tuesday, August 10, and unanimously approved a resolution making a covenant with the voters of the FISD District.

The resolution states, "should the proposition for the issuance of the Bonds receive a favorable vote, the District will make application to receive State assistance in the payment of debt service on the Bonds."

The resolution expresses the intentions of the FISD Board to issue up to \$5,850,000.00 in principal amount of the Bonds, if approved by the voters on September 11, to begin the construction of school improvements. However, the Board will only issue the remaining \$8,650,00.00 in Bonds, if the District receives State Assistance Program (EDA) revenues for that portion of the

Superintendent Vaughn said, "We can't proceed in this (bond) project without this EDA funding. It will be over. We cannot tackle this project without their Election on September 11, the funding. This a legal and bind-Continued On Page 2

Entering Boy Scout Troop 259 when he was 6 years old, as a Tiger Cub, Mike has stayed in the Scouting program and

worked his way to the top. Thursday, August 12, at the age of 18 years old, Mike was presented with his Eagle pin at a Court of Honor ceremony in the San Jose Catholic Church in

To earn the rank of Eagle, a Boy Scout must earn 21 merit badges. The merit badges cover areas of study in camping, wilderness survival, life saving, community service, government, conservation, communications, etc. They also must hike, hike,

"I've hiked more miles than I can count," laughed Mike.

Off the top of his head, Mike remembers three 50-mile hikes, two 80 mile hikes at Philmont, two hikes up the 13,161 foot Wheeler Peak, two hikes up the 8.749 foot Guadalupe Peak, 68 miles on the Pecos Packer, and numerous Caprock Canyon out-

Mike was also required to plan, organize, document, and work at a "Eagle Project" for the community. Mike took on a daunting task of building a wheelchair ramp for the Lockney Library. It turned into a much larger project than anyone ex-

The project ended up taking 446 man hours. As is done in all Eagle projects, other Scouts in the troop pitched in to help Mike on his project.

While in Boy Scouts, Mike served as Assistant Senior Patrol Leader for 2 years and Senior Patrol Leader for 2 years. He has also been Troop Guide (guiding young new Scouts into the troop).

"I believe I have achieved something that most people will not achieve outside of earning a degree or military honors," said Mike. "The Eagle Scout honor serves as an example and is re-

spected by many. Mike graduated from Lockney High School this fall and will be attending Wayland Baptist University. He will major in Pre-

Thinking that social security can do it all - Social Security never was meant to be your only source of retirement income. It always was meant to be part of a three-legged financial stool," along with private pensions and savings or investments. Throughout the season most cotton discussions have been shaped by the fact that 2004 was shaping up to be a record year for cotton around the globe.

Thursday's August Crop Production report from the National Agricultural Statistics Service did nothing to dispel that senti-

Projecting a strong U.S. Upland cotton crop of 19.48 million bales, the NASS report was perhaps a little above the general range of expectations for the first measure of the 2004 crop. On the other hand the reaction by the market and among industry observers, certainly showed that the number is not out of the realm of possibility.

Texas numbers released by the Texas Agricultural Statistics Service illustrate clearly the excellent shape the crop was in during the late July survey period. Overall Texas is forecast to produce a record 6.3 million Upland cotton bales from 5.5 million harvested acres and set a new yield record of 550 pounds per harvested acre.

Closer to home, the estimated production for the High Plains region was set at a record 3.89 million bales for crop reporting districts 1-N and 1-S. Projected yields for 1-N and 1-S were 742 and 498 pounds respectively.

To some these numbers seem a little high when considering the wide range of maturity that comprises the 2004 crop. With cotton ranging from the very early to the very late, the calendar and the September/October temperature pattern become the primary factors driving what may or may not happen.

There is no getting around the fact that a fair number of acres south of Lubbock are nonirrigated and were planted late in June. These acres have generally received the moisture they need. How they turn out is essentially a factor of the calendar and their receiving normal weather the rest of the season.

Cotton acreage north of Lubbock is in essentially the same position, but has a much smaller margin of error. The calendar there is an even bigger factor,

due to the fact this area tends to add heat units at a slower pace in September and October.

In order to capture the tremendous yield potential that exists in this area another warm, open Fall is the must have in-

As is so often the case, whether or not the High Plains crop breaks records or hearts in 2004 will depend on the weather pattern that dominates over the next 6-8 weeks.

Warm temperatures and clear, sunny days are the key to

breaking records in 2004. Anything less could begin to slowly shave 2004 crop potential one shed boll at a time. This is especially true in northern areas that historically accumulate heat units at a slower rate from mid-August through the end of October.

To illustrate this point, from August 11 through October 31 Lubbock will historically accumulate around 828 heat units. In order to reach the Long Term Average (LTA) heat unit accumulation Lubbock only needs to accumulate 810 Heat units through October 31.

This would seem to indicate that growers in Lubbock that planted on or before May 15 are 1-3 days ahead of schedule in terms of heat unit accumulations compared to the LTA.

A different situation exists north of Lubbock where growers are in a slightly more precarious position.

Looking at the LTA, crops in this region are either running slightly-ahead of schedule for acreage planted May 1 or slightly behind if they were planted by May 15. Amarillo area growers should normally expect to receive only about 680 more heat units through October 31. That number has certainly not been the norm the past few seasons, especially in the Amarillo area.

Most everyone agrees that the crop projected by Texas Agricultural Statistics Service is probably in the field today. What they also need to acknowledge is that regardless of everything that has gone into getting the crop to this point, the final outcome could still leave many shaking their heads and wondering - "What if?"

The following tables illustrate where the 2004 crop stands in terms of total heat unit accumulations (DD-60s) versus the long-term average and the 2002-2003 seasons.

Vesicular Stomatitis drifting northward Worst may be over for Texas

that the Vesicular Stomatitis (VS) outbreak in Texas appears to be winding down as of mid-August, but more than 150 infected animals have been detected in Texas, New Mexico and Colorado and more cases may be seen before the outbreak is over. VS is a viral disease that appears every few years. Infected livestock, such as horses, cattle, goats, deer, swine or other susceptible animals, develop blisters, ulcers, or sloughing of the skin in and around the mouth, teats or hooves.

"This year Texas has two diseases that occur only sporadically "anthrax and VS," commented Dr. Bob Hillman, Texas, state veterinarian and head of the Texas Animal Health Commission (TAHC), the state's livestock and poultry health regulatory agency.

"Anthrax and VS are not related. Anthrax is a bacterial disease which is fatal to animals that become infected. However, outbreaks are usually localized. This year, we've had several confirmed cases of anthrax in Uvalde and Val Verde counties. Animals ingest the deadly bacteria when they graze where anthrax spores have become vegetative," Dr. Hillman explained. "VS is thought to be transmitted by sand flies and black flies, and while the viral infection causes lesions and temporarily debilitates an animal, it rarely causes death."

Dr. Hillman said eight premises in Texas currently are under VS quarantine, but no new

Animal health officials say late July. VS-infected livestock and their herd mates are quarantined until at least 30 days after the last lesions are healed, a process that usually takes about two weeks. Restricted sites currently include a ranch in Dimmit County with equine animals; four in Starr County, two of which include cattle; an equine premises in Yoakum County; and two

equine premises in Kerr County. "We've released the quarantines on four premises since the outbreak began," noted Dr. Bob Hillman, Texas, state veterinarian and head of the TAHC. "The first released was in Reeves County, where the nation's initial VS case was confirmed in mid-May in a horse. Quarantines since have been lifted on one premises each in Val Verde, Starr and

Uvalde counties. "When a VS outbreak occurs, it is not unusual for the disease to drift northward, as if it were being moved by a light breeze," commented Dr. John Romero, assistant state veterinarian for the New Mexico Livestock Board. "Right now, New Mexico has 80 VS-infected equine animals and one llama confined with their herd mates on 51 premises in 11 counties. No new cases have been confirmed recently in the southern part of the state."

New Mexico counties with quarantines include: Bernalillo, Eddy, Grant, Mora, Rio Aribba, San Miguel, Sandoval, Santa Fe,

Socorro, Taos and Valencia. In Colorado, 52 premises with cattle and/or equine animals antine. Counties involved include Adams, Alamosa, Boulder, Douglas, El Paso, Fremont, Huerfano, Larimer, Las Animas, Otero, Park, Pueblo, and Weld.

"The number of cases will slow when weather cools, sometime in early October." noted Dr. Keith Roehr, assistant state veterinarian with the Colorado Department of Agriculture's Division of Animal Industry. Dr. Roehr explained that the VS outbreak will not end until sometime in early November, when consistent freezes will kill the flies

thought to transmit the disease. "Livestock owners in Texas, New Mexico and Colorado call the state of destination prior to shipping animals, to ensure that animals meet all entry requirements," Dr. Hillman urged. "Some states have imposed permitting, testing or quarantine restrictions to protect against the spread of VS. Call before you haul to avoid complications

Livestock owners should report potential cases of VS to their respective state veterinarians, office, so tests may be run to correctly diagnose the illness, and to rule out an accidental or intentional introduction of footand-mouth disease (FMD), a highly dangerous foreign animal disease that can affect cattle, sheep and other cloven-hooved
