FISD votes to close CCLC

The FISD Board met Thursday, March 10, and voted to close and cease operations of the CCLC (Caprock Counties Learning Co-op) alternative school campus at the end of this 2004-2005 school year.

Board Member Bill Dean made the motion to close the CCLC facility and Board President Mitch Probasco seconded it. Board Members Dean, Probasco, Kerry Pratt and Rachael Castillo voted in favor of the motion, while Board Member Mark McCormick abstained from voting, due to his late arrival at the meeting and not hearing the discussion of the issue. Board members Bart Greer and Amado Morales were not present for the meeting.

Superintendent Jerry Vaughn recommended to the board to close the CCLC facility. Vaughn said, "We need a definitive action now, in order to close a campus by the end of this school year. Also, Ralls ISD is pulling out at the end of this school year and FISD will be the only school left. We have budgeted only \$108,000 this year for our part in CCLC. It will cost us \$233,000 more this coming year, or \$352,000 total, to keep it in operation for another year."

Vaughn also recommended moving the DAEP (disciplined students) part of CCLC to the High School campus. "We already have the computer programs in place to serve these students. That will save us over \$30,000 to start with. We will have to keep them physically separated from the rest of the student body, even at lunch time. The High School campus is the best and most logical place to move DAEP. The majority of our DAEP placements are high school and junior high students."

CCLC Principal Brenda Parker told the board, "Sixty percent of our DAEP placements are 9th graders. We had 47 DAEP placements in the 2003-2004

school year and there are 42 DAEP placements in this 2004-2005 school year."

Board Member Dean recommended that Superintendent Vaughn investigate further the moving of DAEP to the High School campus and report back to the board at next month's board meeting.

According to Vaughn, the PAC disciplinary and educational facility will remain as is and FISD will continue supplying teachers for those students at that facility. PAC is operated by the 110th District Court of Floyd County.

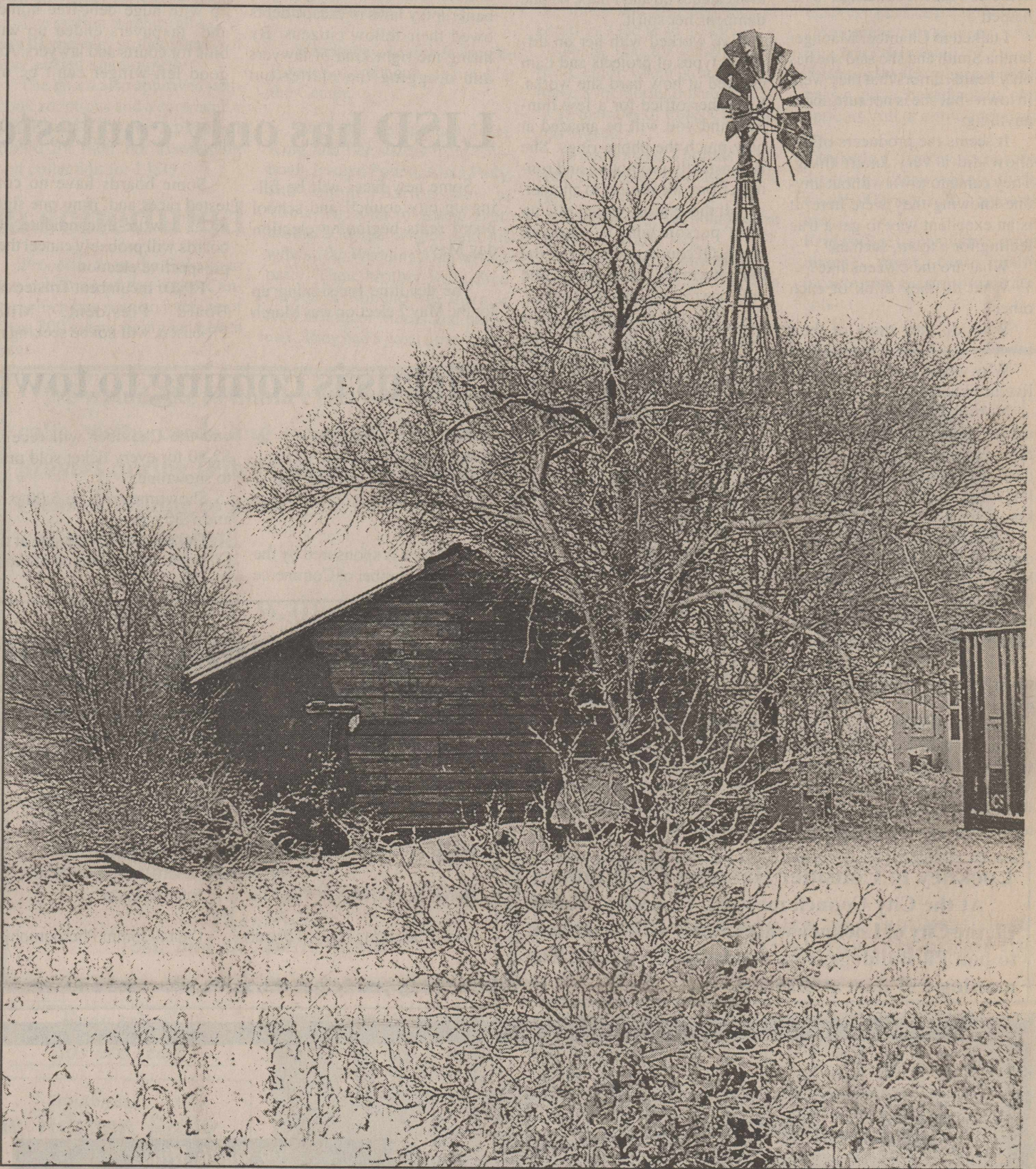
In other matters, the board approved the 2005-2006 school calendar year, which would begin classes on August 17, 2005 and end classes on May 24, 2006. However, Superintendent Vaughn reminded the board that the state legislature is now passing mandatory legislation to force all Texas schools to start classes on September 6, 2005 and end classes on June 7, 2006. "If this passes, then we will have to readopt our next school year's alternate calendar in our April board meeting," said Vaughn.

A \$20,000 budget amendment to the 2004-2005 budget was approved by the board. The \$20,000 was moved from Instruction and Maintenance and placed into Administration.

FISD Business Manager Sharon Rainwater presented the board a written Tax Statement and Cash Flow Statement. The Tax Statement showed \$1,947,924.37 in taxes collected, which is 93.68 percent of the Current Tax Roll of \$2,088,173.01.

The Cash Flow Statement showed FISD Average Monthly Expenses at \$580,000.00, with a Current Cash Balance of \$5,783,233.33.

The board approved the resignations of Erica Reagan, CCLC; Linda Harbin, R.C. Andrews Elementary; Michelle Cox, FHS; and Janna Williams, FJHS.

Garcia's killers apprehended by police

The family of Patricia Garcia, formerly of Lockney, can have some peace now with the knowledge that Patricia's killers are now behind bars.

Patricia's sister, Brenda Poole, of Lockney, was notified by police early in the morning of March 10, that two teenage suspects had been arrested. A third suspect, a 13 year old boy, was arrested at Dunbar Junior High

School, later in the day.

Charged with capital murder were Victoria Hood Harris, 18, and Raymon Carl Jackson, 19.

Besides killing Garcia the suspects also confessed to four robberies and two burglaries.

According to police reports the boy (who was 12 at the time of the robbery and murder) and Jackson entered the 7-Eleven Convenience Store, at 19th Street

and Iola Avenue, in Lubbock, where Garcia worked, sometime between 2:50 a.m and 3:52 a.m.

Harris waited outside behind the wheel of her grandmother's blazer.

Jackson pulled a stolen single-barrel shotgun and shot Garcia, a single mother of four and grandmother of five, in the throat. The 12 year old accomplice was carrying a handgun.

According to police reports and a story in the Avalanche Journal, after killing Garcia the teenagers then drove to an E-Z Mart at 50th Street and Chicago Avenue, stealing cash, candy, and cigarettes.

An informant, bothered by Jackson's lack of remorse, told police that he had heard Jackson bragging about the killing.

Handicap fails to stop desire to vote

Carol Eldridge, confined to a wheelchair at Lockney Health and Rehab, voted for the first time last year thanks to the efforts of her friend, Debbie Montandon, and voter's guides supplied by Free Market Foundation.

The tenacity of Eldridge to express her right and privilege to vote was recorded in a recent mass mailing to all Free Market Foundation supporters.

Free Market Foundation President Kelly Shackelford was told of Eldridge's determination through a letter by Debbie Montandon of Lockney.

Montandon wrote to Shackelford after the election and enclosed a picture of Carol in her wheelchair holding a picture of President Bush.

Montandon told Shackelford that Carol was 37 and confined to a wheelchair because of cerebral palsy.

"She has asked me for the past several years some of the deepest questions concerning politics," said Montandon. "She is especially concerned with regards to the White House and voting issues. Her mind is brilliant but her body limits her."

According to Montandon,

Carol had been praying for the President to maintain his office.

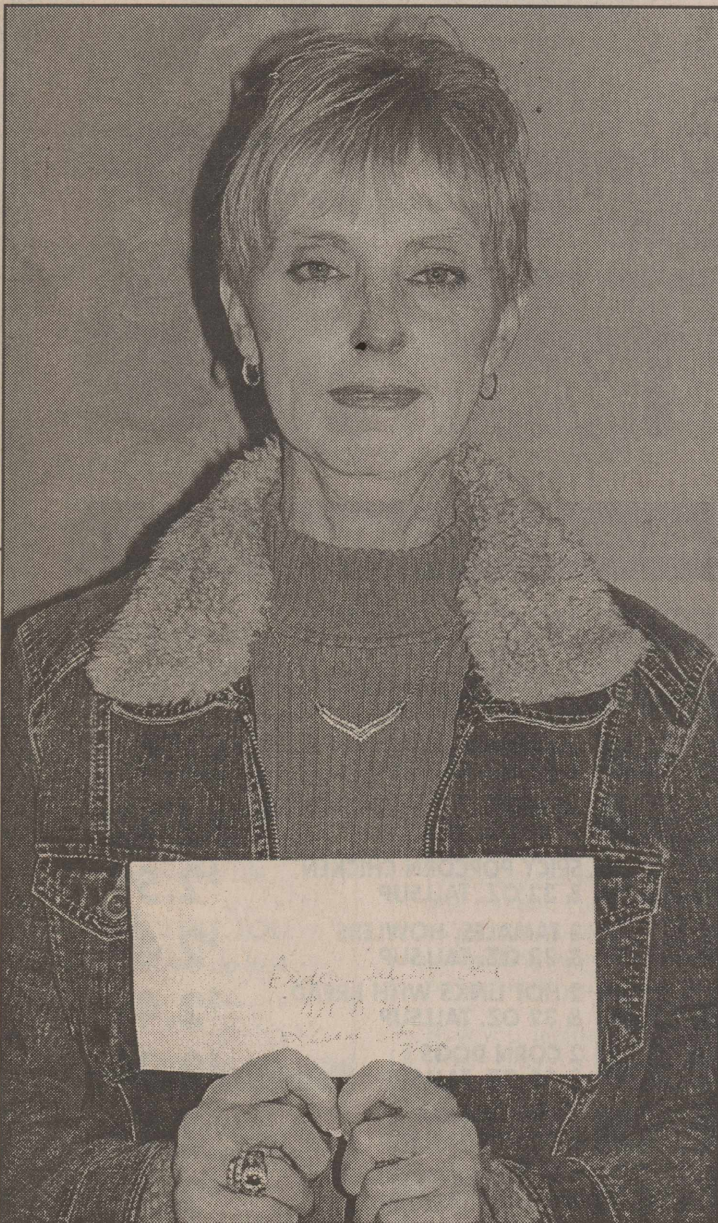
For 6 months Carol had been without a wheelchair and was worried she would not be able to vote. A fund raiser supplied her with a new wheelchair and mobility to get out of the Rehab Center.

Montandon feels the voter's guide helped Carol make informed decisions about the election.

"With the help of your voter's guide Carol was able to vote," said Montandon. "She is so grateful for your help in getting her

information she could not otherwise obtain. People at the voting booth were moved to see her out Election Day. The man that observed her voting was touched by her dedication."

Carol is the daughter of Clela Eldridge, of Petersburg.

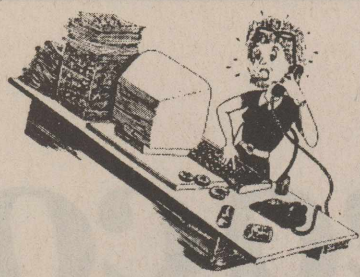

We see by the papers where our U.S. Senators have approved a bill that is supposed to make it a little harder for some folks to walk away from debts they have incurred while trying to live like rich people. Even a lot of Democrats joined most Republicans in voting for the measure.

For years now, Americans have been treated to the spectacle of a few deadbeats hiding behind bankruptcy laws to escape debts owed their fellow citizens. By hiring the right kind of lawyers and dragging the matter out

through the years, many of them have ended up free and clear. About the only ones who got stiffed in the deal were those folks who honestly extended credit. Trial lawyers ended up, naturally, with good bank accounts; left-wing pundits like Al Franken and Molly Ivens ended up with something else to beat George Bush about the head and shoulders with; deadbeats ended up with huge debt-free homes, and taxpayers ended up with bills for courts and lawyers. Any good left-winger can't be un-

happy with a situation like that.

So now it looks like some changes may be instituted in the whole process. We seriously doubt that trial lawyers will suffer greatly in whatever changes might take place. The very prospect that some sort of change will be possible, however, is enough to set off alarm bells throughout the ranks of deadbeats and their lawyers. But after many years of dragging their feet, enough senators joined forces to push the bill through. Now it will be up to the House of Representatives, where

prospects for passage look promising.

We are by no means suggesting that bankruptcy laws are not needed and useful. They are. Or, at least they are to our way of thinking. But no one can deny that on more than one occasion, the bankruptcy laws have been used as a dodge by a few deadbeats to avoid paying legitimate debts. The recently passed measure will not result in a perfect world by any means, but it should improve the situation immensely.

The deadline for signing up for the May 7 election was March 7.

Some boards have no contested races and, if no one signs up as a write-in candidate, the boards will probably cancel their prospective election.

FISD: Incumbent Trustee and Board President, Mitch Probasco, will not be seeking re-

election. Lyle Miller has signed up to run for Probasco's spot. Miller will be uncontested in this at-large race.

In Pct. 3, incumbent Rachel Castillo will run again and faces no opposition.

LISD: Two contested races have developed here. Incumbent Trustee Mike Ford, of Pct. 5, is being challenged by Boyd Jackson.

Incumbent Trustee and Board President John Quebe is being challenged by Dan Smith.

City of Floydada: There are no contested races on the City of Floydada Council. Incumbents Bobby Gilliland, mayor; Pct. 2

Councilman Ruben Barrientoz; and Pct. 3 Councilman Sheldon Sue face no opponents. Monte Williams is also unopposed to fill the unexpired term of Councilman Eric Cornelius.

City of Lockney: There are no contested races on the Lockney City Council. Mayor Roger Stapp is uncontested; incumbent Councilman Dist. 5 Michael DeLeon is unopposed.

Ginger Mathis, who is currently the Councilwoman for District 4, has chosen not to run again. No one signed up for the seat and the council will have to appoint a council person after the May 7 election--or before if Mathis resigns before May 7.

LISD hires a new curriculum director

Lockney School Board Trustees voted unanimously in their March 10th meeting to hire Phil Cotham as Superintendent with a 2 year contract. The motion to hire was made by Trustee Aaron Wilson and seconded by Mike Ford.

The board also voted to hire a curriculum director. This will be a new position in LISD.

At last month's board meeting the board discussed this position with principals and Superintendent Raymond Lusk.

"This (the curriculum director) has been on priority list for 12 years," Lusk had told the board. I think we need more expertise--someone dedicated to this because of changes in state tests and TAKS tests."

The principals were also in favor of a curriculum director, saying the director takes a large load off of the principals and teachers.

"Teachers don't have the time to look at all the curriculums that are best for their subjects," said Cotham.

According to Lusk the position will be a position of authority and the district will be looking at a salary of \$50,000 - \$60,000.

"We've built up our fund balance for something like this," said Lusk.

The motion to hire the curriculum director was made by Jessie Garza and seconded by Robbie Long. Voting in favor of the motion were John Quebe, Lonny

Hooten, Garza, and Long. Voting against was Mike Ford, Aaron Wilson, and Jeff Don Terrell.

The motion to rehire all Junior High and High School professional staff, coaching staff, and professional staff was made by Robbie Long and seconded by Lonny Hooten. All trustees, except Mike Ford, voted in favor of the motion.

Ford voted against the rehire because of his opposition to rehiring Coach Lisa Schumacher.

The motion to rehire all Lockney Elementary professional staff was carried unanimously.

The board also approved textbook adoptions and a contract for the Floyd County Appraisal Board for their tax assessment and collection for LISD.

T.C.E. Tips on lawncare

From time to time we, Floyd County Cooperative Extension, will provide helpful information to homeowners regarding tips on proper lawn and tree management.

The following information is provided by Roger Havlak, Turf and Water Management specialist with the Texas Cooperative Extension.

Spring is in the air! Warmer temperatures means that the soil will soon warm to a level that our warm season turfgrasses (i.e. St. Augustinegrass, bermudagrass, buffalograss, zoysiagrass, centipedegrass, and seashore paspalum) will begin to grow. This also means that one needs

to plan their nutrient management program for the year. Taking a soil sample is a good first step in this process. It will provide useful information pertaining to the level of nutrients in your soil and can assist you in developing your yearlong environmentally sensitive approach to nutrient management.

In the spring, it is recommended to apply your first fertilizer application after your lawn has begun to grow. You may want to wait until after you have mowed your lawn 2 to 3 times. Applying fertilizer too early can cause undue stress to your turf if

a late freeze occurs. Also, apply fertilizer in measured amounts to your lawn. This means you need to know the surface area (square feet) of your site and how much of a nutrient your particular turfgrass requires in a given application and in a given year. Remember, not all turfgrasses require the same level of fertility (i.e. nitrogen) in a year-long program.

Farm Bureau to host DOT seminar

In an effort to help area farmers and ranchers deal with changing DOT regulations and Risk Management, Floyd County Farm Bureau will host a two-fold seminar March 24th at the Unity Center, from 8:00 a.m. to 11:30 a.m.

There is no charge for the seminar and refreshments will be served.

"Many farmers believe that farm tags exempt them from many TxDOT regulations," said Farm Bureau Manager David True. "They don't see past the first page that says, 'You are exempt except in the following cases'. The 'except' part is what we will be covering.

"We want to expose farmers to these laws so they don't have

to pay fines.

Farmers may not be complying with current regulations if they:

- *Operate a pick-up and trailer with a combined weight in excess of 11,000 pounds.

- *Operate a truck hauling farm products.

- *Operate a semi-tractor/trailer.

Sign-up period for 2005 Conservation Programs

The USDA-Natural Resources Conservation Service (NRCS) in Texas announced that farmers and ranchers wishing to be considered for 2005 funding in the Environmental Quality Incentives Program (EQIP) should sign up by the close of business Friday, March 18, 2005.

Landowners interested in the Wildlife Habitats Incentive Program (WHIP), Grassland Reserve Program (GRP) and the Wetland Reserve Program (WRP) have until April 8, 2005, to sign applications.

The 2002 Farm Bill authorized the EQIP, WHIP, WRP, and GRP as tools to implement voluntary conservation.

Each program offers financial and technical help to assist eligible participants install or implement structural and/or management practices on eligible land or preserve land through conservation easements.

"The \$83 million allocated for these programs will help farmers and ranchers improve the natural resources on private working lands in Texas," said Dr. Larry D. Butler, USDA-NRCS Texas State Conservationist. "They will be used to solve locally identi-

fied resource problems in each county and will also fund special statewide concerns recommended by the Texas State Technical Committee such as water quantity, water and air quality, wildlife habitat, and treatment of invasive species.

EQIP and WHIP offer cost share and incentives payments to producers applying approved conservation measures and GRP and WRP provide for the purchase of a conservation easement."

Immediately following the end of the sign-up period, applications will be ranked and those selected for funding will be approved. A conservation planner will develop a contract and conservation plan for each contract that is approved.

Producers who have been awarded contracts can then begin implementing the approved conservation practices this year. Local NRCS field offices have complete details for their county and this information can be found at www.tx.nrcs.usda.gov.

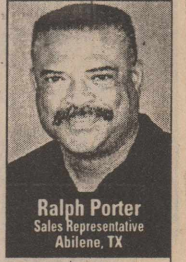

NOTIFICATION OF TOTAL COLIFORM VIOLATION

The City of Floydada water system collected three (3) water samples during the month of February 2005 that contained Coliform bacteria. The City of Floydada water system is required to submit a minimum of four (4) water samples each month for bacteriological analysis.

The Texas Commission on Environmental Quality (TCEQ) sets drinking water standards in Texas and has determined that the presence of total coliform is a possible health concern. Total coliform are common in the environment and are generally not harmful themselves. However, the presence of these bacteria in drinking water, generally is a result of a problem with water treatment or the pipes which distributes the water and indicates that the water may be contaminated with organisms that can cause disease. Disease symptoms may include diarrhea, cramps, nausea and possibly jaundice and associated headaches and fatigue. These symptoms, however are not just associated with disease causing organisms in drinking water, but may also be caused by a number of factors other than you drinking water. The TCEQ has set an enforceable drinking water standard for total coliform to reduce the risk of these adverse health effects. Under this standard, no more than 5.0% of the samples collected during the month can contain bacteria, except that systems collecting fewer than 40 samples/month that have one total coliform-positive sample per month are not violating the standard. Drinking water which meets this standard is usually not associated with a health risk from disease causing bacteria and should be considered safe.

odist Church's preparation for celebrating the joy of Easter Sunday on March 27.

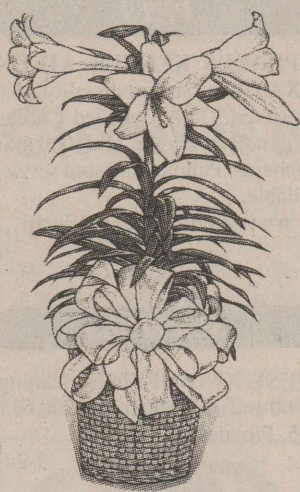
The church will observe Good Friday with a Tenebrae Service of readings and candles on March 25 at 7:00 p.m. The public is also invited to share in this special observance.
