Chamber names Roger Stapp Citizen of the Year

Lockney Mayor Roger Stapp was presented with the Citizen of the Year award at the Lockney Chamber of Commerce Banquet Saturday, April 2.

Last year's recipient of the award, Bobby Hall, presented the trophy to Stapp.

Stapp, a resident of Lockney for 52 years, has been married to his wife, Belinda, for 32 years. They have 4 children: Shanna Hallmark, Andy Stapp, Jeremy Stapp, and Tyrel Stapp.

Roger has owned Stapp Body Shop since 1984. He is also partnered with Andy Stapp in Raceway Fuel and Ricky Griffith in Davis Lumber.

Praising Stapp for his work in the community, Hall said, "He is a good businessman, active in church, and very active with the children in the community. He is most responsible for the success of Lockney's baseball program. He is a public servant-- a caring individual with a tough exterior and a heart of gold."

in building the plant. He also played a significant role in finishing up the pipeline from Aiken to Lockney.

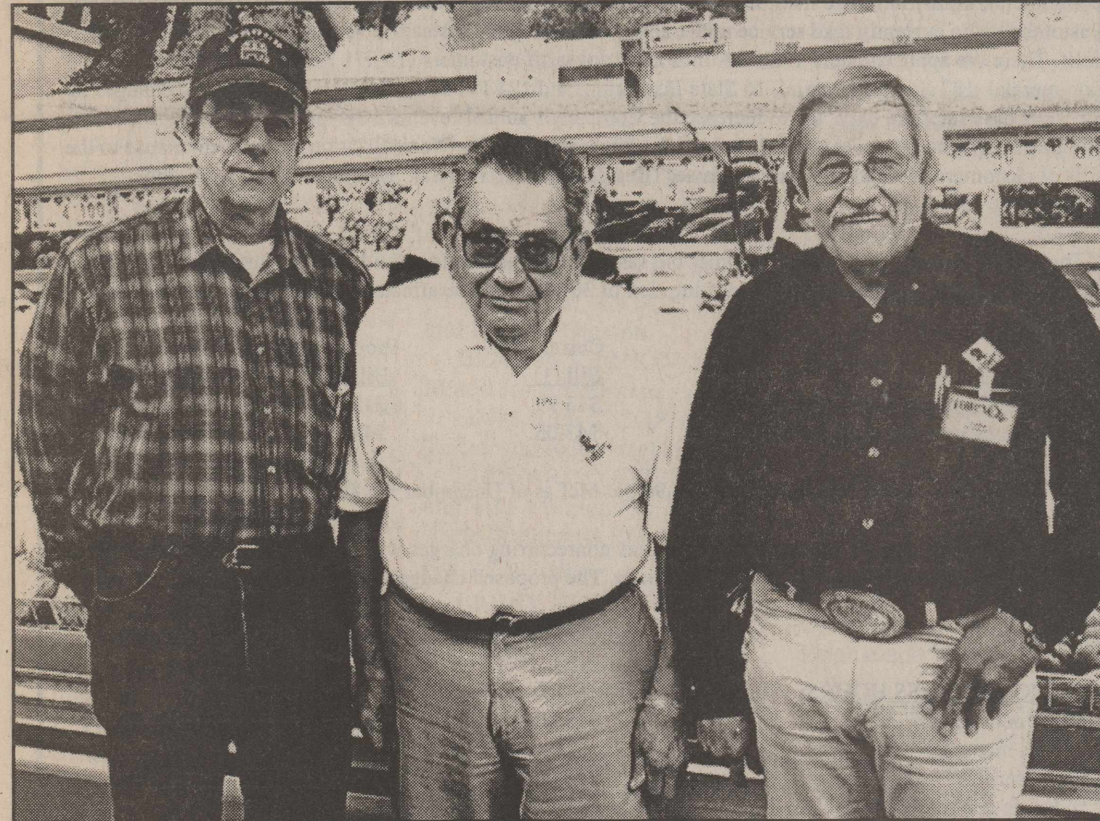
The Lockney High School Honor Society served the brisket meal which was catered by Mac Sherman and the Lockney Chamber Directors.

Gala will celebrate 10th year with Dixieland Jazz

The Floyd County Friends 10th Annual Gala will be held this Saturday, April 9th, 6:30 p.m. at the Unity Center in Muncy.

Entertainment this year will be the Don Turner Dixieland Band and the lively group of musicians from South Plains College. The Dixie Land Band has been playing together for years. They play everything from traditional Dixieland to Jazz/big band.

City of Floydada makes changes and updates Zoning Ordinances

The City of Floydada has made several changes in the Zoning Ordinance for the safety, health, morals and general welfare of the local citizens.

City Secretary Karen Lawson spent over 16 months rewriting the old City ordinance in order to eliminate things that did not pertain to a small town such as Floydada. The previous ordi-

nance had been copied from a larger town's ordinance.

Some of the highlights and changes in the new ordinance are (1) use of land and buildings, (2)

Commissioner election still undecided after hearing

Visiting Judge John Forbis chose not to rule on Wednesday, March 30, in the hearing to decide the outcome of the controversial Pct. #1 Commissioner's election. Forbis decided instead to have lawyers representing both sides present him with written arguments and legal opinions to back up their arguments.

After witness testimonies both sides agreed to Forbis' request and the hearing was over shortly before lunch.

Judge Forbis told the attorneys he would be out of town for 10 days and he would rule shortly after he returned.

The Pct. #1 Commissioner Race has been surrounded in controversy since the November 2 election.

The initial election results showed Write-In Candidate Mike Anderson the winner by 20 votes. Incumbent Commissioner Ray Nell Bearden challenged the results after she was told that 33

additional straight party ballots had been found and not counted.

The recount showed 41 more ballots that had not been counted. The recount gave Bearden one extra vote to win.

It is the results of the recount that has been called into question by Anderson and has led to a challenge in district court.

Anderson's complaint rests on

two different ballots--one counted for Bearden and a write-in not counted for Anderson.

The first involved a ballot that came from the Post Office to the Floyd County Clerk's office on November 4 (two days after the election) and was counted in the recount.

The first witness called to the stand by Anderson's attorney, Bonner Smith, was County Clerk Marilyn Holcomb.

Holcomb testified that she was notified at home by the Post Office on the Saturday before the Tuesday election that there was

express mail for Holcomb at the Post Office.

Holcomb stated mail was delivered to her office on the following Monday and even on the Tuesday of the election. Included in the mail was additional ballots.

Holcomb testified that she assumed the ballot that she had been called about on Saturday had been delivered on Monday or Tuesday.

"I had no reason to think it had not been delivered," said Holcomb.

Instead, Holcomb testified, the ballot was delivered to her office by the Postmistress on the Thursday after the election.

That ballot was counted in the recount.

Smith asked Holcomb if the Absentee Ballot Judge had been made aware the ballot had been late in arriving.

"Yes", said Holcomb. "Is it correct to say if that bal-

lot had not been counted then it would have been a tie between Anderson and Bearden?" asked Smith.

"Yes," said Holcomb.

Bearden's attorney, Buck Wood, said, "To sum this up, the election judge made the decision to count the ballot based on the knowledge it had been at the post office before the Tuesday election?"

"Yes," said Holcomb.

Anderson was called to the stand by his attorney after Holcomb's testimony.

Anderson testified at length about the steps he took to advertise his candidacy as a write-in, and his efforts to inform the public about where and how to write-in his name on the ballot.

Anderson testified that he had advertised for 7 weeks in the local newspaper, handed out 1,500 flyers, advertised on the radio and cable T.V., passed out cards, put up yard signs, and gone to every voter's door.

Smith then called Anderson's witnesses at the recount, Hulon Carthel and Bob Alldredge, and a counter, Preston Belt, to the stand.

At issue in this testimony was a write-in vote for Anderson which was allegedly rejected by the ballot judge.

Anderson's name had been written on the Sheriff's line on the ballot instead of the Commissioner's line which was two lines below the Sheriff's space.

Anderson's argument is that it was clear the voter's intent was to vote for him since he was the only declared write-in candidate.

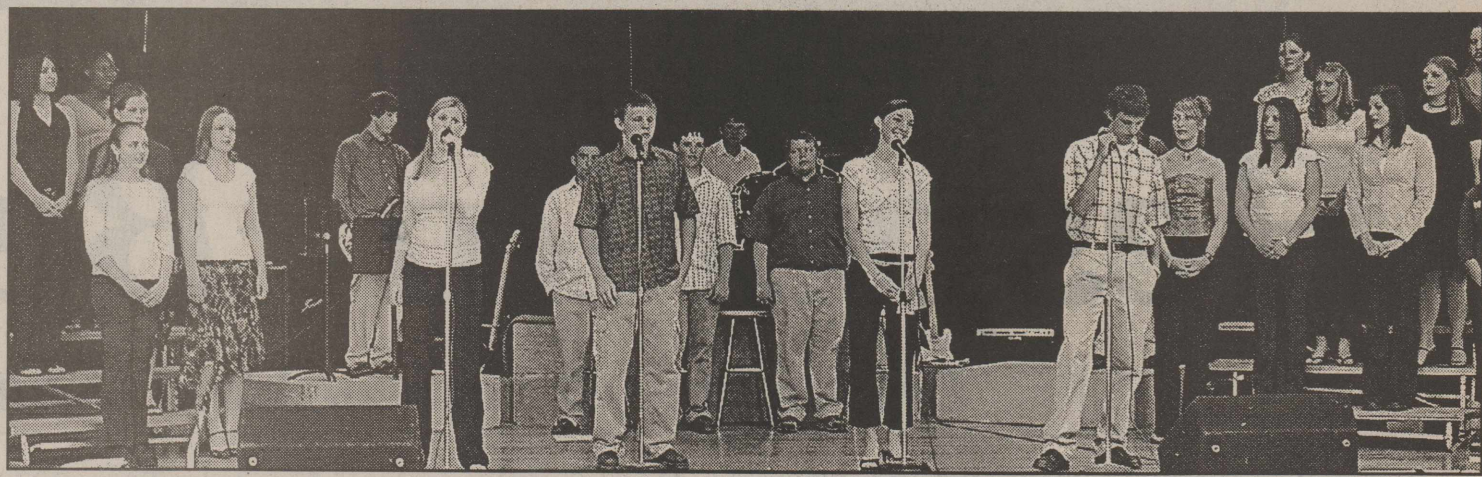
Both Carthel and Alldredge stated they recalled this ballot not being counted.

Belt also testified he recalled the ballot being rejected. Belt said he remembered because of the discussion over the ballot.

Although Attorney Wood objected to all of the testimony concerning this write-in ballot, Judge Forbis allowed the witnesses to testify and said he would rule on the objection after he studied the election law and considered the attorney's written arguments.

After a brief recess Forbis praised the witnesses in the case and said, "It has been an unexpected pleasure to see what appears to be no fraud in this election but instead people who are telling the truth as best they can."

Forbis then adjourned the hearing and Anderson and Bearden will wait on the outcome of the ruling.

NOTICE OF PROPOSED INCREASE IN ENVIRONS GAS RATES

On February 25, 2005, Atmos Energy Corporation ("Atmos" or the "Company") filed a Statement of Intent with the Railroad Commission of Texas (the "Commission") to increase its gas rates in the unincorporated area ("Environs") surrounding the Cities of West Texas Service Area (the "Cities"). This proposed increase in gas rates willing to apply to customers residing inside the city limits of the West Texas Service Area.

In its filing, the Company proposes to change its Environs base rates and service charge tariffs to the same level as those current rates previously approved by the Cities for customers inside the city limits. The service charge rates have been in effect inside the city limits since April 10, 2003 and the base rates have been in effect inside the city limits since May 1, 2004. The Company proposes to change the Environs rates effective April 1, 2005. The Commission may suspend the proposed effective date for up to 150 days.

The proposed changes will affect all classes of Environs tariff customers, including Residential, Commercial, Industrial, State Institution, and Public Authority customers. The Company's Air Conditioning Customers, who currently take service under a separate tariff, will instead be served under the Residential tariff. There are approximately 17,306 Atmos Environs tariff customers (15,071 Residential, 1,916 Commercial, 182 Small Industrial, 16 State Institution, and 121 Public Authority). The proposed changes in Environs base rates are expected to increase the Company's annual revenues by approximately \$440,274. The Company also proposes to implement and apply a new Weather Normalization Adjustment clause to the bill of customers in weather-sensitive classes (Residential, Commercial, State Institution, and Public Authority).

The typical monthly residential customer bill (assuming consumption of 6 Mcf) and the typical monthly commercial customer bill (assuming consumption of 30 Mcf) will be affected as follows by these changes:

Atmos estimates that the proposed changes to its nonrecurring charges will increase its Other Revenues in the Environs by approximately \$30,377 annually. The proposed changes are as follows:

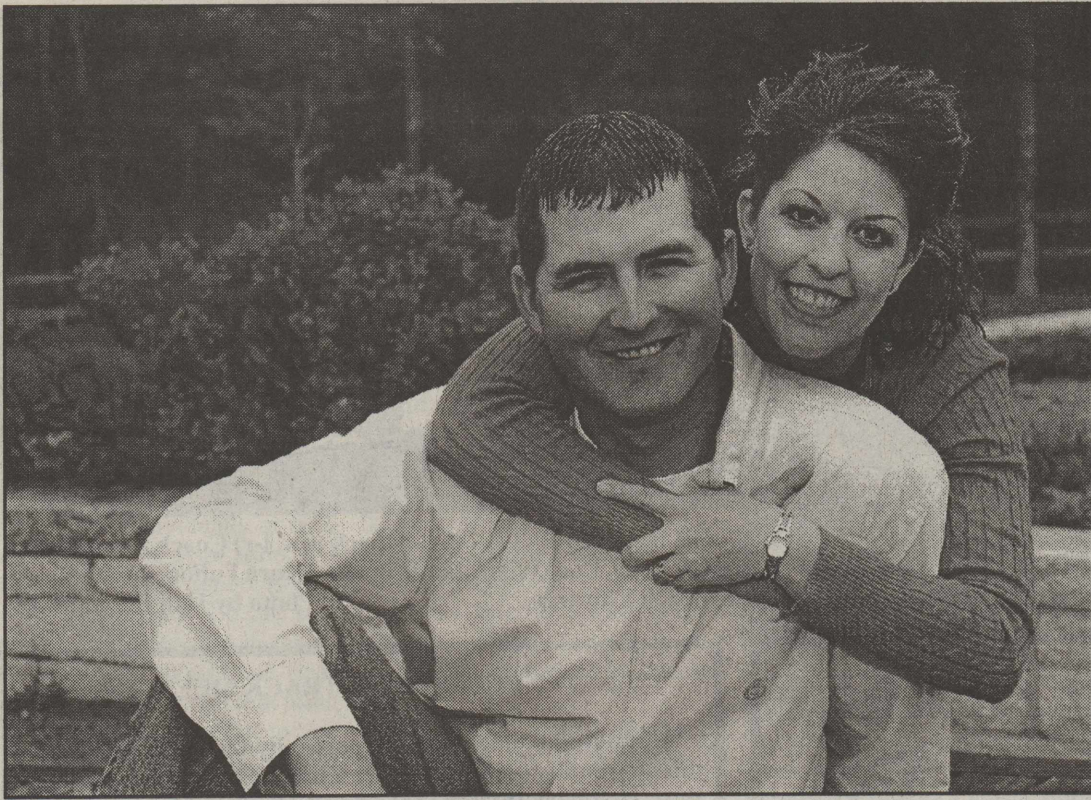

The various changes in base rates and nonrecurring charges proposed by Atmos would increase the Company's total revenues in the Environs by approximately \$470,651 on an annual basis, or 9.7%. The proposed change in revenues is a "major change" under state law. The new Environs rates will not exceed 115% of the average of all rates for similar services in all municipalities served by Atmos Energy within the same county.

City changes ordinance

changes in zoning regulations and districts, (3) swimming pools, (4) fences, and (5) garage sales.

The use of land and buildings in certain districts in the City limits is covered in the new zoning ordinance. This part of the ordinance covers regulations in height, size, demolition and locations of building in different zones throughout the City. This also includes the alteration of buildings and structures in certain zones, and what type of permit is required for these changes or new constructions.

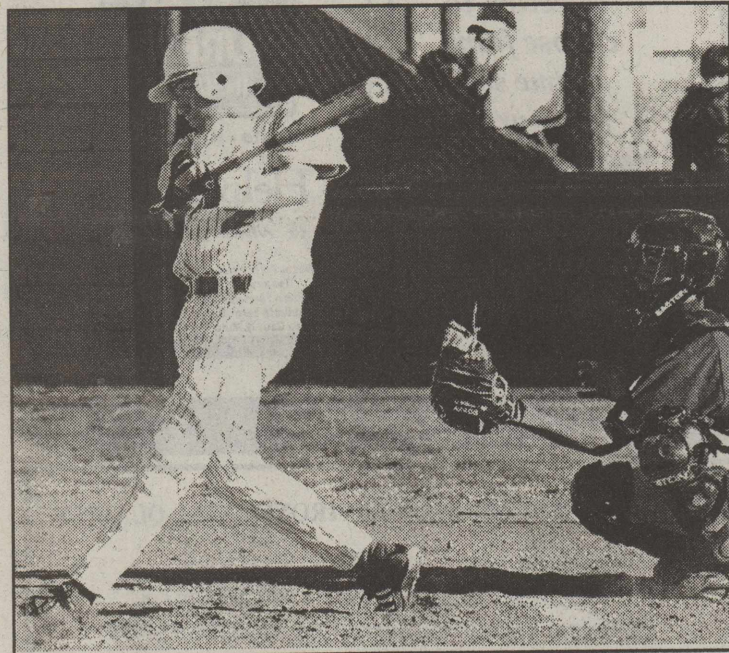
Penalties are in the new ordinance for those in violation of the City ordinance and for injunctive relief to persons affected by the violation of the ordinance.

Single Family Residents make up the R1, R2 and R3 zones. The Commercial District (made up of offices, light, retail and neighborhood services) is labeled the B1 and B2 zones. The Manufacturing and Industrial District is I1 zone, while the Flood Plain District is labeled FP.

Swimming pool construction in the City limits is regulated by the new ordinance covering "a potential attractive nuisance and to promote safety and enjoyment", while regulating the location and improvement of swimming pools, whether private, public or commercial. The pool's location, lighting and P.A. systems are all regulated by the ordinance.

The new ordinance prohibits metal fences in the front yard in any district and "no fence or hedge shall exceed three feet in height in any district." No fence shall exceed eight feet in height and must be constructed of "customary urban fencing materials."

Garage Sales are limited to "no more than four for the same location in any twelve month period and the duration of the garage sale shall not exceed three consecutive days."

FSA still working kinks out of 2003/2004 Crop Disaster Program sign-up process.

Technical difficulties, incompatible files formats and missing data continue to frustrate Farm Service Agency officials as they prepare to assist growers with the 2003/2004 Crop Disaster Program (CDEP) sign-up process.

While many county FSA offices have scheduled CDP appointments beginning April 4, a problem with data provided by the USDA Risk Management Agency could cause an additional delay for FSA offices that are otherwise ready to begin taking applications electronically. Having an accurate data set from RMA records saves a tremendous amount of time and makes the process almost effortless. Missing or inaccurate data can delay the application process and puts additional strain on growers and county FSA personnel.

Until the problems with the initial RMA data set are fully corrected, however, it appears that growers with early CDP appointments should consider gathering the necessary documentation to complete the sign-up process manually. Otherwise, rescheduling their appointment for another time could be the best option. It is also recommended that growers contact their local FSA office to determine what their situation may be in this regard.

In an effort to assist producers and FSA staff who will be impacted by the current delay, Plains Cotton Growers, with the help of Texas Cooperative Extension Risk Management Specialist Jay Yates of Lubbock, has updated their 2003/2004 Disaster calculators with the county average yields and prices that will be used by FSA to calculate CDP benefits. County average yields for upland cotton, corn, sorghum, wheat and peanuts have been prepared by the Farm Service Agency and included in the PCG spreadsheets for every county in Texas. There are three versions of the PCG Disaster Calculators available for growers to estimate 2003/2004 CDP benefits.

The PCG Single Farm calculator is designed to estimate DCP benefits from cotton losses on a single farm or unit. The PCG Multi-Farm calculator will estimate benefits from cotton losses on multiple farms or units and aggregate the results. The third and last version is the PCG Multi-farm/Multi-crop calculator. This calculator will allow losses from cotton, corn, sorghum, wheat and peanuts to be put in by crop insurance unit and then estimate total CDP benefits across several units.

Due to the wide variety of business structures out there, none of the PCG calculators at-

tempt to quantify the effects of the \$80,000 payment limitation that is included in the 2003/2004 CDP rules.

Using the PCG calculators will also help growers gather the information used by FSA during the DCP sign-up process. Growers who use the PCG calculators before going to the FSA office to complete a CDP application should have all the information necessary to prove actual production levels and document crop insurance yields, payments and premium amounts.

To use the PCG calculators a grower should first determine the loss year in which they will apply for benefits. Growers can then input what crop was produced, the county where the crop was grown, whether the unit was irrigated or dryland, verify if the crop was insured or not and if it was carried to harvest.

In addition to the information outlined above, growers will also need to have the following information to estimate CDP benefits: Actual Production History (APH) yield used to determine the insurance guarantee for each qualifying unit; harvested production or amount of cotton counted against the insurance guarantee in the year of loss; planted acres for each qualifying unit; share of production (percent); gross insurance indemnity for each qualifying unit; and, the crop insurance premium paid on each qualifying unit.

In addition to production losses, producers are also eligible for DCP benefits on cotton quality losses. County FSA offices are in the process of receiving software that will determine eligibility and compute Quality Loss Program (QLP) benefits on a bale-by-bale basis. The program will use bale quality data provided by various marketing pools and associations across the U.S., easing the documentation requirement for both producers and county FSA personnel.

While few QLP applications are expected on the 2003 crop, some producers may have to look closely to determine if their 2003 production losses will provide greater disaster benefits than might be available on the 2004 crop because of low quality. Cotton bales qualify for a QLP payment when their CCC loan value is 20 percent below the 5-year average loan value for cotton classed at the applicable USDA Cotton Classing facility.

Quality Loss Program eligibility thresholds are established based on the USDA-AMS Cotton Division Classing office that provided the official classification results for the producer. For purposes of the 2003/2004 QLP, the average loan rates given in the chart below will be used to determine QLP eligibility for cotton classed at USDA Classing facilities.

Texas Cotton Association Annual Meeting set for April 27-29, 2005

The Texas Cotton Association's 94th Annual Convention has been scheduled for April 27-29 at the OMNI Austin Hotel Downtown. All cotton industry representatives are invited to attend.

Featured at this year's TCA Convention will be The Honorable Charles Stenholm who will be addressing "The Politics of Cotton" during the Convention's general session, Friday, April 29.

Also on tap will be a special Open Session on Thursday, morning April 28 featuring National Cotton Council General Counsel and Trade Policy Consultant Bill Gillon of Memphis, Tennessee. Gillon will report on the FY2006 Budget process, the WTO Doha Round agricultural negotiations, the Central American Free Trade Agreement and discuss the recent WTO Appellate Body ruling on the Brazil Cotton case.

New York cotton futures offered a muted reaction to the 2005-06 planting intentions report released Thursday.

The National Agricultural Statistics Service's (NASS) annual survey of growers' planting intentions for 2005-06 fell short of pre-report forecasts as the agency replaced anticipated cotton acreage just one percent higher than last year's acreage.

NASS pegged U.S. cotton acreage at 13.8 million acres compared with the 13.6 million acres planted in 2004-05. Growers in six of the 17 principal cotton growing states reported intentions to reduce the area planted to cotton, while the balance registered a modest increase.

A 90,000-acre reduction in Georgia fully offset gains in other parts of the Southeast, bringing the region to 2.9 million acres, a 36,000 acre decrease in the area planted to cotton last year. The Memphis Territory was the only contiguous growing area to record an increase in all states. Producers reported intentions to plant 3.8 million acres, versus 3.4 million in 2004. The 400,000 acre rise was mainly due to Mississippi and Louisiana, where plantings are expected to rise by 140,000 and 120,000 acres, respectively.

The Southwest expects to reduce the area planted to cotton

by a net of 145,000 acres, bringing total planted acreage to 6.0 million acres. Texas growers reported plans to plant just 5.7 million acres to cotton, compared with 5.8 million last year.

Plantings in the Far West were placed at 780,000 acres, 88,000 below the 2004 figure, with reductions in California and Arizona. The reduction in upland cotton acreage in California is due in part to an increase in acreage expected to be planted to pima cotton.

According to analysts, the application of three-year abandonment and yield averages to the NASS figure of 13.8 million acres suggests a 2005-06 crop of approximately 19.6 million bales, compared with the current USDA projection of 23.0 million bales of production in 2004-05.

In other news, USDA reported net export sales of U.S. cotton totaled 155,700 bales in the week ended March 24. The figure was three percent less than the previous week and two percent lower than the four-week average. Major buyers included China, Taiwan and Hong Kong.

U.S. cotton shipments for the week reached another marketing year high at 377,400 bales, eight percent more than the previous week and an 18 percent increase from the four-week average. Primary destinations were Canada,

China, Turkey and Mexico.

In the spot cotton market, online sales by producers in Texas, Oklahoma and Kansas increased considerably as 57,279 bales traded in the week ended March 31. The previous week's online sales totaled 14,921 bales. Average prices received by producers in the most recent week ranged from 37.87 to 42.35 cents per pound compared to 35.82 to 43.33 cents per pound the previous week.



The family will greet friends at the funeral home from 1:00 p.m. until 3:00 p.m. Thursday, April 7, 2005.

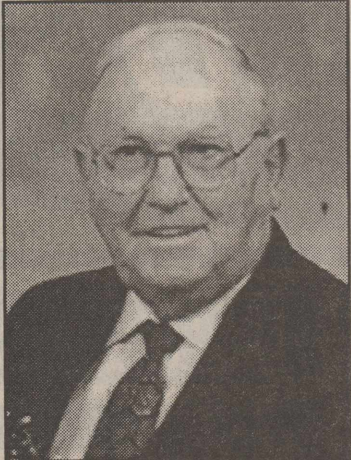
Mr. Allen died Sunday, April 3, 2005 in Houston.
