The familiar faces of owners Leroy Burns, Robert O. "Shorty" Turner, and Ricky Burns will step back to be replaced by new owners Brenda Kinast, Ted Noel, and Jimmy Dewbre.

Kinast, of Abernathy, has quit her 23 year job at PlainsCapital Bank in Lubbock and will be taking over the day to day operations of City Auto. This is where I grew up."


"We've been doing business together for 20 years," said Noel about his relationship with

# City Auto founders retire

Forty-six years ago, in December of 1959, City Auto came into being with a vision by Leroy Burns. Now, after selling approximately 13,500 vehicles the business will pass into new

City Auto was originally a parts and repair shop located at the northwest corner of Wall and Missouri Streets.

Leroy acquired a partner, his father-in-law, Virgil D. Turner, in late 1960. In August of 1961, City Auto became the Pontiac dealer in Floydada, and in September of that year the Rambler franchise was added.

In 1962, Robert O. (Shorty) Turner bought a part of the business and moved back to Floydada from Pampa to manage the of-

In 1963, the Buick franchise was added. Rambler was dropped in 1967 and GMC light and medium duty trucks were added later. Lyndell Roberts was a partner from 1963 to 1966 and worked as a salesman. In 1965 the business was incorporated, Roberts sold his shares to the three other partners (Leroy, Shorty, and Virgil), and the business moved to its present location; 201 E. Missouri.

In February 1969, Virgil Turner sold his third of the business to Leroy's son, Richard H.

The family business had been a big community supporter since

the beginning, and sometimes that support has created some difficulties in day to day operations.

"We have always supported our local EMS and Fire Department with our sacrifice of personnel," said Ricky Burns. "We are a small dealership and we have 2 employees (the parts manager and a technician) who are members of the Fire Department. When there is a fire they both leave. It can be hard on business operations at times.

"We have two women who are part of EMS. When there is an ambulance call we lose our secretary."

Through the years City Auto has won numerous awards for excellence in sales and service, including: the Pontiac Service Excellence Award, the GMC Customer Satisfaction Excellence Award, and the Buick Seal of Excellence for Customer Satisfaction for being the number two dealer nationwide in competition with dealers of all sizes.

"We've been in the top 5 rating for Customer Service Index for almost 20 years," said Ricky

Customer Service has gone hand in hand with car sales for many years at City Auto. City Auto stickers can be found on automobiles all over the United States.

One of the reasons City Auto has become so well known is the popular sales pitch of "selling all new cars \$100 over invoice".

"We've done that since day one," said Leroy. "A lot of people didn't think we would be able to continue doing that."

"There are people who have told us that other car dealerships would tell them, 'don't buy from City Auto because they won't be there next year'," said Ricky.

"The secret has been that we keep our expenses low. We own everything and we work for the 'hold back' at the end of the year. Every dealer gets the hold back of 3% of every vehicle sold.

"Other 'dealerships have higher overhead expenses which makes it hard to sell so low," said

Ricky says he will be around the dealership for a few months to help in the transfer but his future plans are still unknown at this time.

Leroy may still be a familiar face at City Auto, but plans on spending his time on his ranch listening to the coyotes and enjoying his cattle and the peace and quiet.

"I'm 83," said Leroy, "I don't really need a job anymore."

Shorty says he will still be in town and available to help the new owners anytime they need it, but he says it is probably time

"Somebody asked me the other day why I was going to retire," said Shorty. "I told them it was time because in 30 years I would be 103."



A free series of 6 Nutrition and Self Care classes for managing Type 2 Diabetes will be offered to Floyd County residents beginning August 22.





ample, sales tax is not due if a customer buys six shirts each priced at \$99.99 But full tax is due on a shirt sold for \$100; the first \$99.99 cannot be exempted.

Clothing and footwear used primarily for athletic activities or for protective wear are not eligible for the exemption. Customers buying golf cleats or football pads, for instance, must pay sales tax. Athletic wear that is also used for participation in other nonathletic activities can qualify for tax exemption. For example, tennis shoes, baseball caps, and jogging suits are worn during everyday activities and thus may be purchased tax free during the

Also excluded from the sales tax holiday are accessories such as jewelry and watches; items that are carried rather than work, including handbags, briefcases and wallets; clothing rentals, sisters, made the trip to such as formal wear and costumes; and repairs and alter-

#### CHD Board tables transfer of hospital building

Board met Tuesday, July 19, and "tabled indefinitely" the transferring of the hospital building to FISD, according to Board Member Tom Farris.

"We discussed the issue with FISD Superintendent Jerry Vaughn and it just doesn't seem feasible at the this time," Farris told the Hesperian-Beacon.

In a related matter, the FISD Board met Tuesday, July 12, and also "tabled" the possibility to take possession of, and renovate, the Caprock Hospital Building

In other matters, the CHD Board approved the purchase of a lap top computer for Floydada EMS. EMS reported 64 runs in the month of June.

The board adjusted the pay scale for extra hours and extra shifts turned in by EMS paramedics," said Farris.

\$103.95 of Indigent Health Care claims were approved to be paid by the board.

The board agreed to the City's buy-back of two lots purchased by Jane Garza, with Garza paying the re-filing fees of \$141, according to Farris.

The board approved a PNS Cogdell Clinic report that showed the clinic making a net profit of \$22,255.46 for June, and \$115,767.76 for the year-to-date.

Farris said, "We discussed the proposed tax rate and the proposed budget for the 2005-2006 year. The tax rate and the new budget will both be approved at our next board meeting scheduled for Tuesday, August 23rd, 7:00 a.m. The date change is because some of our board members will be out of town that week.'

bers per square yard that may be Trapping of bollworm moths continues to be sporadic overall, but numbers remain higher south of Highway 82 in Crosby County. Beet armyworm moth activity from traps has increased on the East Plains in Crosby County but is relatively low for the rest of

the area.

Cucurbit Crops: Squash bugs continue to be a presence in certain Program cucurbit fields with late egg masses hatching this week. Several fields have required multiple insecticide applications with others remaining completely void of squash bug problems for the entire season. Continued scouting is necessary as the Cucurbit Yellow Vine Decline, that has been shown to be transmitted by this pest, may completely kill infested plants in as little as seven days.

Powdery mildew in cucurbits has not been evidenced yet, but with the advent of this week's rainfall, increased plant tissue surface area in enclosed canopies, and previous irrigation activity, most growers should be applying, or at least planning to apply, a preventative fungicide treatment. Once conditions become suitable for disease proliferation and symptoms become evident, this disease will generally spread

over the entire crop in a short period of time. The July 15th issue of the CERio Blanco Update, has some suggested fungicides and resource links to help in managing this pest.

# New immunization law effective September 1

A new law effective Sept. 1 requires that children attending child-care centers and enrolled in early childhood programs be vaccinated against invasive pneumococcal and hepatitis A diseases, according to the Texas Department of State Health Services (DSHS).

Pneumococcal disease is caused by a bacteria that often leads to middle ear infections, pneumonia, blood stream infections, sinus infections and meningitis. The vaccine is required for all children age 2 months through 59 months attending child-care facilities and pre-kindergarten programs.

Hepatitis A is a liver disease that is spread from person to person, often by putting objects in the mouth that have been contaminated with the stool of a person with hepatitis A. Children in child-care centers and pre-kindergarten programs who are 2 years old or older will need two doses of hepatitis A vaccine given six to 18 months apart.

To attend child-care facilities and pre-kindergarten programs, a child also must by immunized against diphtheria, tetanus, pertussis (whooping cough), polio, measles, mumps, rubella, hepatitis B, varicella (chicken pox) and *Haemophilus influenzae* type b (Hib) at the appropriate age. If children do not have at least the first dose of the required vaccines by Sept. 1, they may be excluded from child-care facilities and prekindergarten programs.

New this year for school children are expanded requirements for hepatitis B and varicella immunizations. Students in kindergarten through 11th grade must have received hepatitis B vaccine. Those in kindergarten through fifth and seventh through 11 grades must have received the varicella vaccine before the start of school.

"Parents should be sure their children are in compliance with all school-enrollment vaccination requirements prior to the start of school," said Monica Gamez of the DSHS Immunization Branch. State rules require that school students be vaccinated against nine illnesses: diphtheria, tetanus, pertussis, polio, measles, mumps, rubella, hepatitis B and varicella.

In addition, hepatitis A vaccine is required for students in kindergarten through third grade who attend school in a county with a high incidence rate.

These counties are Bexar, Brewster, Brooks, Cameron, Crockett, Culberson, Dimmit, Duval, Edwards, El Paso, Frio, Gonzales, Grayson, Hidalgo, Hudspeth, Jeff Davis, Jim Hogg, Kenedy, Kinney, La Salle, Maverick, McMullen, Moore, Nueces, Pecos, Potter, Presidio, Randall, Real, Reeves, Starr, Sutton, Terrell, Terry, Uvalde, Val Verde, Webb, Willacy, Zapata, and Zavala.

Routine vaccination recommendations call for most of the vaccine doses required for school attendance to be given by age 2 with boosters between ages 4 and 6. Catch-up schedules are available for students who did not receive the vaccines when younger.

Military dependents, homeless students and certain students transferring from other Texas schools will be granted temporary enrollment regardless of vaccination status. Some students are exempt from vaccination requirements for medical reasons or for reasons of conscience.

Specific vaccination requirements for school attendance are available from schools, physicians' offices and local public health departments. The information also is available online at <a href="https://www.ImmunizeTexas.com">www.ImmunizeTexas.com</a> or by calling DSHS toll free at 1-800-252-9152.

Vaccination requirements apply to students in all public and private primary and secondary schools, those in registered child-care facilities and students enrolled in pre-kindergarten programs in Texas.


