### **Cancer Coalition Survivor Dinner is November 11th**

The Parmer County Cancer Coalition is hosting its annual Survivor Dinner at 6 p.m. on Thursday, November 11th at the 6th Street Church of Christ in Friona.

All cancer survivors, caregivers, and their families are cordially invited to attend the dinner which is held to honor those whose lives have been affected by cancer. Please join us!!!

This year marks the 11th year of operation for the coalition. Board Chairman Greg Lewellen said, "Since 2010, the organization has given out 201 grants totaling \$102,100 to cancer survivors in Parmer County. We average about 20 grants a year and we annually contribute a percentage of our money raised to the American Cancer Society."

Lewellen continued, "Our Board has allocated 15% of the yearly revenue to be given to the ACS this year. They have also approved raising the grant amount from \$500 to \$1,000 this year." An application form to receive a

#### **Smithee honored by TPA**


Texas Rep. John Smithee, R-Amarillo, has been named a "Champion of Transparency" by the Texas Press Association for his many years of legislative work on open government issues.



# Rural Texas Satellite Phone Rates Spike **Amid Telecom Dispute With State**

Texans in remote areas of the state are facing a choice between a massive increase in the cost of their satellite phone services or losing service entirely. At its root is the State of Texas' alleged breaking of its statutory financial obligation to rural telecommunications providers.

The Texas Universal Service Fund (TUSF) is a pot of money collected from charges on telephone calls then remitted to service providers operating in rural areas of the state. It's designed to defray the cost of providing service. Texas law requires every resident to have access to a phone connection and without the TUSF, the providers fulfilling that mandate could not break even on their operations.

Sparsely populated areas do not provide enough of a customer base to pay for the necessary infrastructure on their own. In June 2020, the Public Utility Commission (PUC), which directs the TUSF, declined to increase the fee from \$0.50 per month to \$0.95 to compensate for a change in the types of calls applicable to the fee — drastically reducing the amount of money coming in. The PUC did so during the pandemic when financial forecasts were bleak and worsening by the day.

This led to a lawsuit by over 50 telecom providers against the State of Texas for withholding \$60 million in legally owed remittanc-

Dial Tone Services (DTS), a satellite telecommunications provider used by Texans in the most remote areas of the state, sent a letter to its customers on September 30 warning of a 140 percent price increase coming in December — from \$24.95 per line per month to \$59.95.

The price change, DTS said, was necessary to prevent its bankruptcy.

"This January, the State of Texas support funding for providing your DTS phone service was reduced by 70 percent," DTS's letter reads.

"Imagine if your income suddenly went down 70 percent. Our company has been losing money all year and are being forced to move you to a higher rate service package in order to continue to

provide service."

DTS then said it will allow a set number of customers to remain at the current price, awarded based on "special circumstances." DRS services 3,000 customers across Texas and a third of those are emergency service operators.

The company then received letters, obtained by The Texan, from customers appealing for the price hike reprieve. One came from a non-profit ambulance company that operates in Brewster County, the largest county in Texas within which Big Bend National Park sits. "In emergency situations, we rely on our satellite phones to keep us in contact with our medics, patients, and the local hospital 80 miles away in Alpine, TX," the letter reads.

"We currently have 6 sat phones and at \$59.95 each would be a significant blow to our already tight budget."

One respondent wrote in on behalf of his grandparents, who at age 80 and 81 years old live 50 miles from the nearest town. The pair live off a set retirement fund and rely on the satellite phones for ranch work.

Another Brewster County resident and a disabled Vietnam veteran said that while hiking on his ranch near the Mexican border, "I from time to time come in contact with people illegally entering the country, who I report to the Border Patrol."

A rancher in northwest Val Verde County told a similar story, saying he recently came across an illegal immigrant "in distress."

"He had been abandoned by the larger group with whom he was traveling...[and] was assaulted and left behind," the respondent said. Border Patrol officials were contacted by satellite phone, and they were able to "prevent a difficult situation from becoming worse."

"With our government turning a blind eye, the deep canyons on our property are being used by drug mules from Mexico," a Terrell County resident says in his letter to DTS. "The only way to reach authorities in case of an altercation, weapons fire, etc — is by sat phone."

Governor Greg Abbott vetoed

legislation during the 2021 regular session aimed at fixing the solvency problem by stating explicitly in law that the TUSF fee should be applied to Voice over Internet Protocol (VoIP), too. Abbott vetoed the bill because "It would have imposed a new fee on millions of Texans."

VoIP calls are already eligible for the fee but the enforcement by the PUC therein is lacking.

The Texas Telephone Association (TTA), the group that filed the lawsuit on behalf of the rural providers, says this problem has been years in the making, the consequences of which are now really beginning to sprout.

"This inaction has manifested into real world consequences," TTA Executive Director Mark Seale told The Texan, "first, rural phone providers had to stop investing in new network infrastructure. Then, some had to consider deregulating parts of their rural territories, meaning not all their customers will be guaranteed service any longer. Now, the first rural provider has had to massively increase its customer rates."

"The PUC must fix the crisis it created — and they can by simply meeting and adjusting the funding formula. Rural Texans need connectively to live, work, and go to school," Seale concluded.

The telecom providers' lawsuit against the PUC is in front of the 3rd Court of Appeals and is set for oral arguments in December. A group of 29 rural state legislators filed an amicus letter with the court voicing their support for the TTA's case.

In the original petition, the companies pegged the amount owed to them at \$60 million during 2020. The amount owed so far this year is \$90 million. Without delivery of TUSF remittances, the providers expect to lose \$11 million per month.

The current PUC board is entirely different from those who oversaw the agency in June of last year — each was removed and replaced by Governor Abbott after the fallout from February's blackouts.

Neither the PUC nor the governor's office responded to requests for comment.





#### Cappuccino

November 8 was National Cappuccino Day and you probably missed it, but I won't tell if you celebrate a few days later with these delicious recipes.

#### Cappuccino

This recipe is to be used if you have a coffee machine equipped to make cappuccino.

#### **Ingredients**

For the Espresso 2 tablespoons finely ground dark roast coffee 4 ounces water For the Foamed Milk 4 ounces milk

#### Steps to Make It

Gather the ingredients. Place the water into the boiler of your espresso machine. Place the 2 tablespoons (2 shots) of ground coffee into the portafilter. Tamp (press) the coffee down using a tamper. Do this 2 to 3 times to make sure the grounds are packed tightly. Place the portafilter into your espresso machine's group head and lock it in place by turning it to the right. Place a demitasse cup or the glass carafe that came with your espresso machine under the group head and pull the shot for 23 to 30 seconds, or until 2 ounces of espresso is yielded. Typically, there is a lever, switch, or button to start this process. Once

the shot is pulled, foam the milk. Place the milk into either a glass measuring cup or a small metal pitcher. Insert the steam wand into the container with the milk, just under the surface of the milk. Engage the steam wand on your espresso machine. (You may need to read your espresso machine's manual for this, as each espresso maker is a little different.) Make sure to keep the tip of the wand toward the side of the container. This will create a vortex with the milk. Move the container higher, lower, closer, then further so that the steam wand can incorporate the air into the milk, making the foam. The bubbles should get smaller and smaller as you do this. Once the milk has foamed to double its size, turn the steam wand off. Top the espresso with foamed milk right after foaming. When initially poured, cappuccino is only espresso and foam, but the liquid milk quickly settles out of the foam to create the (roughly) equal parts foam, steamed milk, and espresso for which cappuccino is known.

#### **Ingredients**

8 ounces low fat cream cheese softened

2 cups powdered sugar

1 tablespoon cocoa powder 1/4 teaspoon cinnamon

1/4 cup milk

1 teaspoon instant espresso granules or instant coffee granules

8 ounces whipped topping

#### **Instructions**

Cream the cream cheese and powdered sugar in a large mixing bowl with an electric mixer until smooth. Add in the cocoa powder and cinnamon; mix on low until combined. Pour in the milk and espresso/coffee granules; continue to beat/mix until thoroughly combined. Slowly fold in the whipped topping. Spoon mixture into dip bowls. Refrigerate for at least one hour, or until ready to serve. Serve with cookies, optional.

## Gas prices unchanged

By Gas Buddy

Texas gas prices were unchanged in the past week, averaging \$3.05 per gallon, according to GasBuddy's daily survey of 13,114 stations in Texas. Gas prices in Texas are 15.7 cents per gallon higher than a month ago and stands \$1.29 per gallon higher than a year ago.

According to GasBuddy price reports, the cheapest station in Texas is priced at \$2.53 while the most expensive is \$3.68 per gallon. The national average price of gasoline has risen 1.8 cents in the last week, averaging \$3.41 per gallon. The national average is up 15.1 cents per gallon from a month ago and stands \$1.31 per gallon higher than a year ago.

Last week saw oil prices briefly fall back under \$80 for the first time in weeks. While it wasn't enough to provide much relief last week, we should see small declines this week in a majority of the country, thanks to the corresponding drop in wholesale gasoline prices," said Patrick De Haan, head of petroleum analysis for GasBuddy.

De Haan stated, "At OPEC's monthly meeting last week, the cartel held firm to the small increases they agreed to in July, raising November production by 400,000 barrels per day. With President Biden still mulling over options to help push gas prices down, we could continue to see some volatility in oil prices. I don't immediately see a large decline or surge coming in the run up to Thanksgiving, but U.S. gasoline demand does remain strong. Levels are currently rivaling September demand, so we know high prices aren't significantly curbing consumption."





# Young appointed to Texas Supreme Court

Evan Young, a former clerk to the late Supreme Court Justice Antonin Scalia, has been appointed to the Texas Supreme Court by Gov. Greg Abbott. He will replace Justice Eva Guzman, who resigned in June to run for Texas attorney general.

"Evan Young is a proven legal scholar and public servant, making him an ideal pick for the Supreme Court of Texas," Abbott said. "Evan's extensive background in private practice and public service will be a fantastic addition to the bench, and I am confident that he will faithfully defend the Constitution and uphold the rule of law for the people of Texas."

Young is a partner at the Baker Botts law firm in Austin and previously served as counsel to the U.S. attorney general, where he spent a year on detail to the U.S. embassy in Baghdad, Iraq. He earned his law degree from Yale.

## State lost 616,600 jobs during pandemic

The annual cash report from the state comptroller outlines the economic damage caused by the COVID-19 pandemic. From August 2019 to August 2020, the state's economy lost 616,600 non-farm jobs, largely from the economic aftershocks of the pandemic and a drop in energy prices. However, sales tax collections, a major part of the state's revenue, increased two-tenths of a percent in 2020 because of increases in retail

spending that offset declines in oil and gas-related sectors.

Sales tax collections comprise nearly 60% of the state's total revenues, according to the comptroller's office.

## Workplace injuries, illnesses decline in Texas

The incidence rate of nonfatal work-place injuries and illnesses reported in Texas for 2020 dropped to its lowest rate in a decade, at 2.0 per 100 full time workers. That compares favorably to the national rate of 2.7 incidence rates per 100 workers.

The report was compiled by the Texas Department of Insurance. In 2020, a total of 178,600 cases of workplace injury or illness were reported by Texas employers. The highest incident rates were reported in the health-care sector, followed by agriculture and other outdoor-related occupations.

# Preventing wildfires during hunting season

Dry weather and increasing drought conditions have prompted Texas A&M Forest Service officials to urge Texans to be mindful of activities that may cause a wildfire during the major hunting seasons now underway

"Drought or freeze-cured grasses provide a very receptive medium for an accidental wildfire ignition and dead grass will readily ignite under a wide range of weather conditions," said Brad Smith of the forest service. "An additional fac-

tor that will contribute to the difficulty of extinguishing a fire burning in dead grass this year is that there is a lot of grass on the landscape due to above-normal rainfall observed over much of the state during this year's growing season."

Nine out of 10 wildfires are caused by humans. The TFS reports that nearly two-thirds of wildfires that occur during hunting season are caused by debris burning and equipment use, such as parking in dry grass and dragging trailer chains.

#### SNAP benefits again extended

Once again, the U.S. Department of Agriculture is allowing the state to extend the maximum allowable amount of emergency food benefits in November. The Supplemental Nutrition Assistance Program is providing more than \$310 million to the state, allowing all SNAP households to receive a minimum of \$95 in emergency allotments in addition to their regular amount.

SNAP is administered in Texas by the Texas Health and Human Services Commission. Texans in need of such benefits, including SNAP and Medicaid, can apply at YourTexas Benefits.com.

## Community colleges receive state grants

The Texas Higher Education Coordinating Board recently awarded \$26 million in grants to 46 community colleges across Texas to support students affected by COVID-19. The grants, a result of a bill passed during the legislative session, can be used to create or expand workforce training programs in occupational areas with high demand.

"The COVID-19 pandemic clearly demonstrated how quickly specific jobs

and necessary skills can change. We need to get our Texas students and displaced workers onto a fast track to lasting careers that equip them for greater economic mobility," said Harrison Keller, higher education commissioner.

More than 80% of the state's qualified two-year institutions received funding.

## State gets 1.3 million pediatric doses of vaccine

The state is receiving more than 1.3 million doses of Pfizer's pediatric vaccine this week, which is being shipped to more than 900 providers across the state. The doses, which come in a different formulation than the vaccine approved for adults, are intended for children between the ages of 5 and 11. The federal Food and Drug Administration recently approved the emergency use of the pediatric vaccine.

New cases of COVID-19 continue to drop statewide, with 22,023 reported by the Coronavirus Resource Center at Johns Hopkins University in the past week. New deaths stood at 775, also a marked decrease.

The number of lab-confirmed COV-ID-19 hospitalizations dropped to 2,949, down by more than half from a month ago, according to the Texas Department of State Health Services. Meanwhile, 15.54 million Texans are fully vaccinated, which is 53.3% of the state's population. In addition, 1.76 million Texans have received an additional dose of the vaccine.

#### **Council purchases communication equipment**

The Friona City Council met in regular session on Tuesday, November 8, 2021 at 6:30 p.m. in the City Council Chambers at 619 Main in Friona, Texas. The meeting began with roll call, an invocation, and the Pledge of Allegiance. Alderman Bruce Fleming conducted the meeting.

There were no public comments. The Minutes of the October 12, 2021 regular meeting were approved. The accounts payable for October 2021 and the financial statement for October 2021 were approved.

Chief Isidro Jimenez presented a report regarding budget, expenses, personnel, and upcoming events at the Friona Police Department. He informed the council that the department is currently looking to hire two new officers in order to be fully staffed. Lieutenant Je-

sus San Miguel is taking a position with the Hereford ISD. He began his law enforcement career with the FPD in 2009. During the past thirteen years, he worked three years in the Parmer County Sheriff's Office before returning to the FPD. The Lieutenant will still work for FPD on a part-time basis.


In a related matter,

the Council approved the purchase, not to exceed \$35,000, of a repeater system from Omega Electronics. The electronic device will be attached to the City's tower just north of the Community Center. The repeater system will allow patrol officers and dispatchers to communicate more clearly no matter where the officers are located in town. Currently, there is so much interference in and around Friona that officers find it almost impossible to talk

to each other in certain parts of town.

In other matters, the Council discussed Year 2022 sealcoat projects, future housing projects, and the upcoming election deadlines and propositions. The terms of Mayor Ricky White, Alderman Greg Lewellen, and Alderman Brent Loflin will expire. The election is scheduled for May 2, 2022. Also, there is the possibility of a joint election with the school district and hospital district.





# Burn Ban is back

The Parmer County Commissioners Court met in regular session on Monday, November 8, 2021 at 10:00 a.m. in the County Courtroom of the Parmer County Courthouse in Farwell, Texas. The meeting began with prayer and the Pledge of Allegiance to the American Flag and Texas Flag.

There were no public comments. Minutes from the October 26th meeting were read and approved. Commissioners approved the payment of the accounts payables as presented by County Treasurer Sharon May. The Treasurer's Payroll Report was also approved.

Commissioners proved the adoption of a new districting plan for County Commissioner precinct boundary lines in compliance with with applicable federal and state laws.

Due to increasing drought conditions and the meager outlook for precipitation in the near future, Commissioners approved the installment of a Burn Ban for 90 days beginning Monday, November 8th.

Commissioners reviewed and approved the Special Amendment Election results as provided by Parmer County Clerk Susie Spring.

In other business, video and sound system upgrades for the District Courtroom in the amount of \$7000 were approved. A bond for the new Tax Assessor-Collector Deputy Yesenia Anaya was approved. Rocio Carrasco from Bovina and Brenna Burch from Lazbuddie was approved for the Parmer County Appraisal District for 2022-23. A water line under County Road 21 200 ft. south of Highway 86 was approved.

Sheriff Randy Geries reported that he was currently housing 43 inmates in the Parmer County Law Enforcement Center. Of that total, 21 are from Deaf Smith County. Parmer County will be reimbursed for housing those inmates.

The next Commissioners Court meeting is scheduled for Monday, November 22nd. The Courthouse will close at noon on Wednesday, November 24th for the Thanksgiving holiday and will reopen on Monday, November 29th.

All meetings are open to the public. The Commissioner's Court reserves the right to go into Executive Session at any time. The agenda may be found on the Parmer County website. #### **Veterans Day Is for All of Us**

"I didn't want to miss that war." -- 17-year-old Clifton McCleskey

Bessie's youngest son said these words to his mother and his sister Eula at the laundromat in Rotan in June 1944. He had just graduated from Dowell High School in Fisher County but still needed to have his mother's signature on the enlistment papers since he was not yet eighteen. They drove to Roby where my grandmother signed her name and gave a reluctant blessing. Her other son Preston was already in the South Pacific, serving in the U.S. Navy. Clifton was going to follow.

Throughout our country's history, many

young men and women have entered a branch of the military to serve. The reason for their decision varies. The draft may have been in place. Some may have felt the strong pull of a family legacy of military service. Others could be seeking a sense of belonging to a cause, stability, discipline, and a chance to see more of the world. Of course, we cannot underestimate that, for most, love of country manifests itself in enlistment.

November 11 marks our country's official recognition of that service. In just a few years, no World War II veterans will be alive. The voungest of our Vietnam Veterans are now in their mid to late six-

ties. The twenty-plus years of the War on Terror will add large numbers of veterans as they exit their service.

Some veterans have served without combat experience. Their work is none the less important. All hands-on deck may refer to the servicemember monitoring for cyber-attacks to the mechanics who refuel bombers at any of our various domestic bases. To be a veteran means a person served in the role assigned to them, took orders without question, and often did so under intense scrutiny and pressure.

Serving in the military is by no means the only way to show patriotism. To judge others for not choosing this path is not wise--numerous factors influence such a weighty decision. And as with any profession, there are unfortunate instances of those who have not served in the best interests of their country. Benedict Arnold comes to mind.

May the rest of us serve our country in ways that make our future veterans' job easier: being informed citizens who do what we can to preserve, protect, and defend our Constitution with decency.

#### Outdoor burning: What to know before you light the match

If you plan to light an outdoor fire this fall, remember to check first with your city and county about burn bans and local fire rules. Check the Texas burn ban map to see county burn ban information maintained by the Texas A&M Forest Service.

Statewide, Texas limits outdoor burning to: (1) Campfires, bonfires, fire pits, and cooking fires, and (2) Household trash fires on your home propertyonly if you lack trash pickup.

Most wildfires start from carelessness. Control your fire by putting trash, grass, leaves and branch trimmings in a burn barrel or similar container. Top it with a screen or metal grid.

Also, keep water, a shovel and a rake handy in case your fire starts to spread. Finally, stay by your fire until it's out.

Certain items should never

be put in a fire-such as aerosol cans or anything that could explode; electrical insulation; building/construction materials including treated lumber; and plastics and asphalt-based materials.

#### State Sales Tax Revenue Totaled \$3.4 Billion in October

**Texas** Comptroller Glenn Hegar announced this week that state sales tax revenue totaled \$3.41 billion in October, 25.2 percent more than in October 2020. The majority of October sales tax revenue is based on sales made in September and remitted to the agency in October.

Year-over-year increases for most tax revenues continue to be affected by base effects: Year-ago revenue collections to which this year's collections are compared were suppressed by the pandemic. Compared to October 2019, sales tax collections were up 20.9 percent.

"October state sales tax collections again strongly surpassed pre-pandemic levels, reaching a new monthly high," Hegar said. "Tax receipts from most major economic sectors were up by double-digit percentages from a year ago, indicating continued brisk spending by both businesses and consumers.

"Collections from the oil- and gas-mining sector more than doubled from a year ago, while exploration and drilling activity remains at a pace little more than half that of the pre-pandemic months. Strong construction, manufacturing and wholesale trade sector receipts persist despite ongoing supply chain issues.

"Receipts from the retail trade sector showed some signs of a shift in consumer spending patterns back toward pre-pandemic norms. As Texans increasingly venture away from home for entertainment, shopping and resumption of office work, remittances from sporting goods stores declined from last year's record levels, while those from ticket sales for live entertainment

venues rose. "Receipts from genmerchandisers eral continued well above pre-pandemic levels, with receipts from mall-based department stores surging from year-ago levels, while receipts from big box and discount retailers remained at last year's elevated levels without further growth. Among more specialized retailers, the fastest growth in receipts was again with electronics and appliance stores, as has been the case in recent months, while receipts from clothing and accessory stores continued to grow robustly as well. Receipts from online general merchandisers continued to grow moderately from

last year's elevated lev-

Total sales tax revenue for the three months ending in October 2021 was up 21.9 percent compared to the same period a year ago and 28.6 percent compared to 2019. Sales tax is the largest source of state funding for the state budget, accounting for 59 percent of all tax collections.

Texas collected the following revenue from other major taxes, most of which were up sharply from a year ago due to base effects: (1) motor vehicle sales and rental taxes — \$543 million; up 19 percent from October 2020, and up 12 percent from October 2019; (2) motor fuel taxes — \$322 million, up 12 percent from October 2020, and up 3 percent from October 2019; (3) oil production tax — \$410 million, up 105 percent from October 2020, and up 18 percent from October 2019; (4) natural gas production tax — \$258 million, up 356 percent from October 2020, and up 206 percent from October 2019; (5) hotel occupancy tax — \$54 million, up 63 percent from October 2020, and up 9 percent from October 2019; and (6) alcoholic beverage taxes — \$130 million, up 47 percent from October 2020, and up 11 percent from Oc-

tober 2019.


