

Arrington supports National Dairy Month

Not many farmers dream of becoming a political leader in order to help their friends, family, and home state. Jodey Arrington lives that exact dream. On the House floor, U.S. Representative Arrington (TX-19) debates bills that help energy and agriculture. June is National Dairy Month and Representative Arrington wants to affirm his support for dairy farmers. He has fought for all farmers and has helped build a fair and strong environment for them across West Texas and across the state of Texas.

I had the opportunity to interview Representative Arrington, and I was amazed by his strong relationship with the dairy industry. Arrington grew up in production agriculture, cotton farming, and said that "like most kids from Plainview, I was a farmhand during the summer." While he grew up in the cotton industry, he understands agriculproduction ture as a whole and has learned about the dairy industry extensively during his time in office. His relationship with the dairy industry has been strengthened over the years with dairy farmers inviting him to tour their facilities. During the tours, Arrington learned about the fascinating technologies the dairies used such as robotic arms and rotary parlors. Through his experiences, Representative Arrington learned how unique the dairy is and said that, "we have some of the most efficient operators [dairy farmers] in the world." In addition to that relationship, strong dairies have an important role to play in Arrington's congressional district. The Congressman said that dairies represent millions of dollars in total economic impact to his district and more dairies want to move to Texas because of a better regulatory environment and more pro-business laws. He said that because of those factors and cheaper land, "you're seeing a





migration of dairy farmers from other parts of the country to West Texas." Arrington said because of new dairy farms West Texas has been able to benefit economically from new revenue streams and new jobs.


While talking about Rep. Arrington's relationship with dairy and the role it plays, I had to ask about his legislative agenda regarding the dairy industry and agriculture. He started describing the difference between the various agricultural commodities and how they needed different legislation to be successful. He said that, "you don't assume that the challenges facing each commodity are the same. The costs of production and markets are different. What I've learned, you've got to stay connected to the people who have the boots on the ground." He said the best way to legislate the needs of dairy farmers is to take the time to "sit down and listen to them." These meetings have influenced his policy decisions to reflect the needs of West Texas dairy farmers so that he can best assist them.

through specific legislation such as the United States Mexico Canada Agreement (USMCA), a free trade agreement between the United States, Mexico, and Canada that was a revamp of the North American Free Trade Agreement. At the signing of the bill Arrington replied, "This historic trade agreement is a major win for our farmers, ranchers, and energy producers who feed, fuel, and clothe the world."

Rep. Arrington wants to recalibrate new needs in the upcoming farm bill. Expenses such as feed, fertilizer, and fuel have increased dramatically the past few years and the new farm bill needs to reflect those changes. With volatile markets, unfair trade disputes, and uncertainty created by global crises, Arrington believes it is necessary to create a safety net that provides stability to the United States agricultural economy. However, he also stated that the best thing the United States could do is support "free markets, fair trade, and robust competition. That's how you reward the best operators and ensure the best value to the American people."





In the 1950s The Fair Park Coliseum in Lubbock, Texas was the place to go for major venues for live musical entertainment. When the Louisiana Hayride was in town, we would make every attempt to go. The venue was mostly country western entertainers on the bill. But on April 11, 1956, two entertainers were on the billboard, Faron Young and Elvis Presley. I was fifteen and keenly aware of who Elvis Presley was thanks to my sister Mary Ann two years older than me. She and her best friend Barbara Ann were gaga over Elvis. My daddy didn't have a chance except to let us attend the April 11th show.

The coliseum was full, packed to the ceiling. Our seating was midway in the center down on the floor level. It was time for the show to begin and we waited. Nothing! Later a man announced Faron Young was a bit delayed and a local group came on stage



to fill in, Buddy Holly and the Crickets. One member of Buddy's group playing guitar was a friend of ours Sonny Curtis from Meadow, Texas. Sonny and my sister Mary Ann were in the same grade. Sonny's brother,

Pete Curtis married my third-grade teacher Glenda Winston. Glenda was my piano teacher. Sonny went on to be a great songwriter, played with the Everly Brothers and Paul McCartney.

Back to the show.



Faron Young came on stage and sang a few songs. With the usual country twang, the audience gave the usual applause. All was quiet on the western front as he walked off stage. I don't know how to describe what happened next. The man making the introduction barely got the word out "Elvis" when the place erupted with this shrill scream in unison. The girls, including my sister and her friend, were all standing and screaming. Some girls hanging over the rails on the upper level shaking their heads and screaming. Elvis's first song was "Blue Suede Shoes" and when he started shaking the scream level blew the top off.

After the show, the girls rushed to the stage to get his autograph. Luck was on Mary Ann and Barbara Ann's side. They got an audience with Elvis and got a picture autographed and then Elvis autographed their hands. "Elvis" on one hand and "Presley" on the other hand. At home that night I watched in disbelief and amazement as they fell on the bed looking at their hands both swearing never to wash them again. That was in 1956 and now in 2022, a movie is coming out about Elvis. If you would like to experience what I did that







Uniting Parents announces free conference





Gas prices down for second week

Average gasoline prices in Texas fell 12.0 cents in the last week, averaging \$4.52 per gallon, according to GasBuddy's survey of 13,114 stations in Texas. Prices in Texas are 29.1 cents higher than a month ago and stand \$1.73 per gallon higher than a year ago. The price of diesel has risen 2.6 cents nationally in the past week and stands at \$5.80 per gallon.

According to GasBuddy price reports, the cheapest station in Texas was priced at \$3.99 while the most expensive was \$5.68.

INGREDIENTS

INSTRUCTIONS

To make the hot dog bar an easy process, make a list of all the toppings you'd like to have out. You can chop, cut and grate all of them the night before, place them in separate bowls or jars, then cover and store them in the fridge until it's go-time! For cookouts, I like to estimate about 1.5 hot dogs per person. For toppings, they will differ depending on what's popular in your family. I'd say as long as you have 1 cup of most toppings (for instance, you don't need an entire cup of bacon! But you do need a cup of cheese and tomatoes), you're good. Use your judgement! Don't be afraid to get crazy - baked beans and mac and cheese actually taste amazing on hot dogs. Make it a carb party. To make the grilled corn salad I mention above: stir together about 1 1/2 cups corn kernels with 2 tablespoons chopped cilantro, a pinch of salt and pepper, a 1/4 teaspoon chili powder, juice from 1/2 lime and 2 to 3 tablespoons crumbled cotija cheese. This can be made the night before, but is probably best 2 to 3 hours before. To make the jalapeno apple slaw I mention above: toss together 2 cups shredded green cabbage with 1 grated apple, 1 thinly sliced jalapeno pepper, a pinch of salt and pepper, a drizzle of olive oil and juice from $\frac{1}{2}$ lime. This can be made the night before. Gets even more flavor in the fridge!

The national average price of gasoline fell 8.8 cents last week, averaging \$4.88 per gallon. The national average is up 28.3 cents from a month ago and stands \$1.79 per gallon higher than a year ago.

"With Independence Day a week away, gas prices have continued to fall for the second straight week as the price of oil has faltered, ushering in the drop we're seeing. The good news is we could also see a third straight week of decline," said Patrick De Haan, head of petroleum analysis at Gas-Buddy.

De Haan cautioned, "While prices will be at their highest July 4th level ever, they'll have fallen close to 20 cents since our peak in early June. Motorists should be wary that while the decline could continue for the week ahead, any sudden jolts to supply could quickly cause a turnaround, and risk remains that when the peak of hurricane season arrives, we could see a super spike at the pump."

A Brick or a Sponge?

Are you more like a sponge or a brick when it comes to the Word of God? Obviously, a brick is hard and nonabsorbent, but a sponge is soft and absorbent. When it comes to listening to and obeying the Lord, we should be more like a sponge than a brick, in that we absorb his Word and then squeeze it out as we lovingly obey Christ. This is easier said than done, because the pressure of the world, our flesh, unconfessed sin, and unholy habits can so quickly harden our hearts to the Lord.

God's love was manifest in Christ's death and resurrection, but it continues to sanctify and shape you more into the image of Christ after you are saved. God's delight in you flows from his perfect delight in Christ, in whose image you are being conformed into as you grow as a Christian. You grow as a Christian as you live in loving obedience to the Lord, soaking up his truth and living it out, which brings us back to the original question of whether you are more like a sponge or a brick when it comes to God's Word.



I don't even know Cooper, but I am so proud of him I can hardly stand it!!! And, I am proud of his parents for rearing such an honest young man! I hope he always maintains his honesty and integrity.

By the way, he apologized to his header after that first run, but he said he had to do the right thing. After their good second run, they did talk about it for a long time. He told Garrett he really didn't want to hear what he was thinking, and LOL, he probably didn't!

Highway 60 project at a standstill

Parmer County Commissioners Court met in regular session on Monday June 27, 2022 at 10:00 a.m. in the County Courtroom of the Parmer County Courthouse in Farwell, Texas. The meeting began with prayer and the Pledge of Allegiance to the American Flag and Texas Flag.

Minutes from the June 13th meeting were read and approved. Commissioners approved the payment of the accounts payables as presented by County Treasurer Sharon May. The Treasurer's

Payroll Report was also approved.

Parmer County Sheriff Eric Geske reported that the Parmer County Law Enforcement Center was currently housing 36 inmates. Of those, 20 are paying customers from Deaf Smith County. Sheriff Geske also reported that he has billed out \$136,350 so far this year for the housing of out-of-county inmates. The PCLEC will probably continue to house outof-county inmates for the foreseeable future. Parmer County Judge Trey Ellis reported that the Highway 60 project from Farwell back to Bovina Cattle Company is apparently at a standstill due to a shortage of workers. Judge Ellis said that he trying to determine what options the County has in trying to get the overdue project finished.






