Representative, County Judge, and Justice of the Peace in Prec. 1.

In the race for Representative, the incumbent Ed J. Cloud of Rule polled 3,381 votes in the four-county district while his opponent in the run-off, Donnell Dickson of Seymour received 2,348 votes. Third candidate, Leroy Ressell of Knox County polled 1,568 votes.

Run-off in the race for County Judge will be between Jim Alvis, who received 823 votes, and Hallie Chapman, who got 795 votes to edge out John Brock who was third with 794 votes. In fourth place was John Crawford with 445, followed by John Ivy with 297.



A short time ago thousands of young people graduated from schools and colleges throughout the Nation. And something said by William Park, nationally known businessman, should stay in the minds of all of them:

We must recognize that formal education is not an end in itself. It is rather a period of preparation for the duties of life and the opportunities of a career.

"There is really no time in life where we can say, 'My education is complete'. As we work, we learn; as we learn, we progress; as we advance, we increase in knowledge. So for all of us, whether we are recent graduates from high school or starting retirement, we look forward to new experiences and every day is commencement day.

### Why Not Seek Econom Instead Of Looking for New Taxes? 14-

(The Houston Chronicle)

The Texas Tax Journal, a monthly magazine published in Austin since 1923, laments the fact that in the current campaigning for legislative posts in Texas, so much is heard about what should be taxed to meet the state's deficit and so little is heard about economizing.

The thought is a pertinent one in this election year. I need not be limited to state government. It applies equally well to the federal government and to local governments. The trend throughout the United States is for the government to be the paternalistic uncle of the people, rather than the servant of the people.

Government has no money of its own. It has only what it takes from the people in taxes. It is the people who are paying for government's seeming generosity. But in the process of being generous, the government squanders many millions of dollars.

Texans, like other Americans, want progress and are willing to pay for it. They want the essential services of govern. ment and they are willing to pay their share of the costs of government's fulfilling its traditional responsibilities to the people. such as medical care for the indigent at the county level.

Government today is going far beyond its traditional obligations. It is constantly launching unnecessary programs under the guise of essential services. As a result, the cost of government has gone up astronomically. The tax-and-spend advocates try to delude the working man by telling him that the rich are paying the taxes and the working people are benefiting from it. Government figures show that the millionaires pay only about 15 percent of the income taxes collected. The other 85 percent comes County



But what about your Mom and Dad? The odds are they haven't even thought about getting the vaccine for themselves. At least 30 million adults between 20 and 40 years haven't had a single shot yet. So-here's where you can help. Tonight at danner, or anytime you get a chance, ask your parents if they've started the anti-polio shots.

Maybe they'll say that polio is a kid's disease. Well, you tell them it isn't so. Last year, for example, one out of every five persons who went to the hospital with polio was over 20.

You can also tell them that polio hits hardest at aduits Of all patients using iron lungs and other respiratory aids last year, 61 percent, or three out of five, were over 20 when they got the disease. A lot of these patients were parents. They had children they loved, children to take care of. But you can't do nuch about that from an iron lung, can you?



were 50c lower and some bids were \$1 off as packers displayed faint urgency. Their lack of interest was credited to expectations of lower priced beef from their cornbelt plants, as well as from good supplies of fat cattle shipped direct to their plants.

Medium to good butchers sold from \$22 to \$22.75. Sows cashed at \$18 to \$21 and pigs drew \$21 to \$22. Stags cashed at \$12 to \$15 and boars sold from




