**Dear Patrons:** 

The condition of school finance in Texas seems to be in constant turmoil. That fact is apparent that alleviating the problem will require a great influx of money from sources not yet available to the school finance system. The problems in Austin have caused burdens to shift from state funding to local property owners to carry the majority of the load for funding your school in Sherman County. This issue is the major part of the school funding legislation to be tackled in the next session. It is an issue that, in my opinion, must not only establish equal financial responsibility to all Texans for funding their educational system, but at the same time provide local districts the freedom to operate their own schools as they see fit. This is a difficult task, but a vital effort for the future of our state. Stratford ISD continues to maintain a firm financial condition as we begin a new year. The district continues to update programs as well as the physical plant, all to provide the best education for our students. As we build the budget for the ensuing year, plans are being made to place funds in position to alleviate the district's debt. Current plans include the designation of funds to pay the debt off in 2008 when the bonds become available to be called. That plan, barring any need for the funds due to unforeseen disasters, pays the bond off seven years early and saves the patrons of Stratford ISD about \$270,000 in interest. The budget and proposed tax rate reflect these plans. Your Board of Trustees and administration are very aware of the challenges in the local economy and will continue to guard your trust, and your schools will continue to reflect the values and educational ethics you expect. Please be aware of the school finance issue as it heats up again in Austin.



Please keep these people in your prayers (and send a check to the Red Cross if you are so inclined) These trailer parks had been well ignored until pretty Tuesday (17th). The girl with me today was up there doing search and rescue. The greatest thing that happened today was finding a Sr. citizen in trailer and he was very sick. We took him to the hospital...well actually to the tents they have set up because the hospital is so damaged. It is like a MASH unit, soldiers and all. Asked him about his insurance..he's paying \$3000 a year for a supplement...told him I would call him in a couple of weeks and take care of that. After all, Punta Gorda is my territory at work. I will never be able to describe w hat I saw and felt today. All I do know is that we are all so blessed!!

#### Veneman Proposes Reforms to FSA County Committee Elections, USDA Seeks Public Comment on Guidelines to **Increase Minority Participation**

Agricultrue Secretary Ann M. Veneman has proposed new guidelines to ensure that Farm Service Agency (FSA) County Committees fairly represent agricultural producers, especially minorities women.

guidelines **These** better define the County Committee election process, Veneman. "The proposed reforms will help encourage participation by minority and under-represented producers on County Committees.

The 2002 Farm Bill gave the Secretary of Agriculture authority to issue uniform governing guidelines County Committee election process. The proposed guidelines were prepared with advice from community groups and leaders, as well by an interworking convened by the Secretary. Adopting the definition set forth in 7 U.S.C.-2003, the 2002 ethnic, or gender prejudice -Hallie Burnett because of their identity as members of the group, without regard to their individual

qualities. 7 U.S.C.-2003 (e) (1)

states that SCA producers have

generally been defined to

Washington, Aug. 18, 2004- include: African-Americans: Asian-Pacific Americans; Americans: Subcontinent Asian-Americans; and women. By statute, USDA must solicit nominations for County Committee positions from organizations representing the interests of SDA groups.

> The public has 30 days to comment on the proposed guidelines published in the Aug. 17 Federal Register. The guidelines will not become final

> until USDA has received and considered public comments.

> Among the provisions, the Secretary may nominate to a slate regardless of whether any nominations have been filed. Currently, one or more SCA producers may be appointed to be an advisor to a County Committee; however, these advisors have no voting authority. A nomination by the Secretary may include the current advisor.

> After evaluating whether the proposed reforms in these guidelines result in an increase in minority and under-served producers on County Committees, the Secretary may exercise her authority to appoint SCA producers to County Committees. Before exercising this authority, USDA will seek



### **AgriPartner Report**

Week of August 16, 2004 for Dallam, Sherman, Hartley and Moore Counties

Corn borer moth activity has decreased. Insecticide applications to refuges and non-Bt fields likely have been accomplished by this point unless corn was late-planted.

Spider mites have increased but remain below economic threshold level in most fields. Once corn reaches dent stage, spider mites are no longer considered to have an economic impact.

Corn earworm can be found in most cornfields. As these larvae complete development in corn and emerge as moths, they will seek alternate hosts such as cotton, soybeans and sorghum in which to lay eggs initiating another generation in these crops.

Check soybeans for podworms. Corn earworms leaving cornfields as moths will be attracted to soybeans with developing pods in which to lay eggs. The economic threshold for podworms in soybeans is an average of 3 per foot of row.

Keep a close watch on sorghum for headworms. Corn earworms moths that cycle out of corn will be attracted to sorghum that is in the bloom and milk stages to lay eggs. Economic threshold for headworms in sorghum is an average of 1 to 2 per head.

A light bollworm egg lay has been observed in area cotton. Keep checking fields for developing worms. Bollworm economic threshold in cotton is considered to be approximately 5,000 bollworms per

Cotton aphids can be found in area cotton. Current infestation levels are well below the economic threshold of 50 aphids per leaf. Keep monitoring this pest particularly in fields that receive an insecticide application to control other cotton pests.



# USDA Creates Voluntary Register to Reach Minority Producers

Washington, August 20, 2004-Agriculture Secretary Ann M. Veneman announced today that minority farmers and ranchers may now join a new voluntary register to receive information from USDA.

"The new Minority Farm Register is an outreach tool to undeserved farmers ranchers who are not currently enrolled in USDA loan, farm or conservation programs, "said Veneman during video taped remarks to the 37th Annual Meeting of the Federation of Southern Cooperatives Land Assistance Fund being held in Epes, AL. "The Register will create a shared outreach list that will help USDA, communitybased organizations and minority-serving educational institutions to communicate with minority farmers and ranchers.'

ranchers."

By joining the Register, minority producers may receive outreach materials, newsletters and program announcements from USDA agencies. They may also receive information and assistance from other USDA-approved outreach partners, such as community-based organizations, faith-based organizations, and minority-serving educational institutions. USDA will carefully control

access to the Register.

People wishing to join the register must sign and date an application that provides their name and address. Providing phone numbers, e-mail address, race, ethnicity, gender and farm or ranch location will be voluntary, although the additional information increases the producer's opportunities for receiving appropriate
