


First Bank Transaction in new Building

James G. "Jim" Cloyd

Canadian-James G. "Jim" Cloyd, 78, died Tuesday, December 21, 2004.

Rosary services were said at 6:30 p.m. Thursday, December 23, 2004 at Hughs Funeral Home Memorial Chapel, Mass was at 11 a.m. Friday December 24, 2004 in Sacred Heart Catholic Church with the Rev. John C. Barragan officiating. Burial was in Edith Ford Memorial Cemetery

Cloyd was November 18, 1926 in Hereford to the late Mr. E.R. Cloyd and Mrs. Bessie Hargrave Cloyd. Jim's family had been in the cattle business and connected to the Panhandle for well over a century. He started cowboying as a young boy. Jim graduated from Canadian High School in 1944. He was also a 1957 graduate of Texas Tech University, where he received a bachelor's degree in animal husbandry. While at Texas Tech, he was the first masked rider, known as the Red Raider, after Texas Tech joined the Southwest Conference.

Jim was a veteran of the Navy aboard the USS Providence during World War II> Jim worked for the 6666's, Matadors, U Lazy S, Mill Irons, and Brainard Triangles, Ranches of Texas and also worked for the Kern County Land and Cattle Company and the Diamond A's in Wasco, California. As a young man, Jim enjoyed rodeoing and also worked for the Santa Fe Railroad on two different occasions.

After the war, Jim returned to Canadian and worked with his father at Cloyd's Custom Slaughtering. He married Lynda Cagle on Nov. 19, 1965, in Pampa. That same year, Jim followed in his father's

footsteps by becoming the sheriff and tax assessor/collector of Hemphill County, where he served proudly until 1972. November 1976, after f our years in the penned cattle Hereford, Jim industry in worked, for the Texas and Southwestern Cattle Raisers Association in Stratford, where he retired after more than 20

He was commissioned as a Special Texas Ranger by the Texas Department of Public Safety and as an Oklahoma Ranger by the Oklahoma State Bureau of Investigations, serving as a certified peace officer in both states. Upon retiring, in 1997, Jim was a member of the Sheriff's Association of Texas, the Veterans of Foreign War, the American Legion and was a board member for the River Valley Museum in Canadian.

Jim was happiest when he was astride a good horse working cattle or just being out for an afternoon ride enjoying God's creation. His word was his bond and was always there for family and friends. Jim was a devoted father husband, grandfather. While his physical presence will be missed by all who truly knew him, the wonderful memories he helped create and values he instilled will always be cherished.

He was preceded in death by a brother, David Cloyd and a sister, Elizabeth Ann Cloyd. Survivors include his wife; two sons, Richard Cloyd and wife, Melissa, of San Angelo and

Unanimous Jury finds that First State Bank **Took Money from Customers' Accounts** without Authorization

On December 8, 2004, a unanimous Moore County jury found that the First State Bank of Stratford, Dalhart, and Dumas took money from the checking accounts of Bacc Farms, Ltd., and Rockin' Lazy S Cattle Co., Inc., without authorization. The unanimous jury awarded Bacc Farms \$175,014 and awarded Rockin' Lazy S \$279,355. Bacc Farms and Rockin' Lazy S will ask visiting judge H. Bryan Poff, Jr. to enter a judgment this week based on the jury's unanimous verdict.

Blake Stringer, a Dumas farmer, had borrowed money from First State Bank. Mr. Stringer was the general partner of Bacc Farms, Ltd, and the president of Rockin' Lazy S Cattle Co., inc. Bacc Farms and Rockin' Lazy S were not borrowers of First State Bank and owed the bank no money. Starting on May 20, 2003, without authorization, First State Bank took money from Bacc Farms's account and from Rockin' Lazy S's account to Stringer's Blake reduce personal debt and to pay itself back. The unanimous Moore County jury found that First State Bank took \$145,014.25 from Bacc Farm's'account without authorization and took \$169,655.\$5 from Rockin' Lazy authorization.

During the trial, George Odom, president of First State Bank, Chris Johnson, vice president of First State Bank, and Gail Johnson both testified that Blake Stringer authorized the

debits in question. Mr.Stringer testified that he had not authorized the debits in question. After seven long days of trail, the unanimous Moore County jury agreed with Mr.

Dumas CPA Tom Brandon testified about Bacc Farms's and Rockin' Lazy S's economic damages, and Pat McElroy, a banking expert, testified about First State Bank's policies and practices. First State Bank claimed that Blake Stringer told Chris Johnson and Gail Johnson to debit Bacc Farms's account and Rockin' Lazy S's account. Mr. McElroy testified that the bank's position was not believable because among other things none of the debit slips were signed or initialed by Mr.

James Wood, attorney for Bacc Farms and Rockin' Lazy S said: "We are happy about the jury's verdict. The jury worked hard, they listened carefully and closely to the evidence, and they rendered a fair and just verdict." Mr. Wood said: "The jury's verdict sends a clear message to First State Bank that you can't take money from your customer's accounts without proper authorization." Mr. Wood added: "The verdict vindicated Blake Stringer. The bank attacked Blake personally and even called him a liar. But the jury rejected the bank's attacks on Blake's character."







The survey also found that it's a dog-gone good life for pups these days. Among dog lovers surveyed, many spoil their dogs as they would a child. From showering their dog with gifts, to surprising them with unexpected treats (72 percent), people frequently pamper their pooches. Many even give their dogs presents during the holidays (50 percent), proving dogs really are another member of the family.

What's in a Name?

Ask 1,500 people what they named their dog(s), and you'll get 1,181 different answers. While Max, Buddy and Bear were the most common names uncovered in the survey, it seems dog names are as individual as the pups themselves. There were, however, some interesting similarities, as "people" names were more common than the traditional Fido, Rufus or Spot. In fact, of those surveyed, nearly half (47 percent) gave their dogs a human name, with the most common being Max, Jack, Molly and Daisy.

A Happy Dog is a Healthy Dog Nearly all dog lovers who participated in the survey believe their dogs are happy (99 percent) and most also report taking steps to keep them that way. The most common things people do to keep their dogs in good health include a daily romp around the block (55 percent) and keeping up with regular visits to the vet (41 percent). In fact, 49 percent incorporate their dog into their daily exercise regime, offering them both a good workout.

When asked what dinner time was like in their house, over half of dog owners surveyed say their pooches dart to the dish when their favorite fare is served (54 percent). Others add their dogs can be finicky if they don't provide the preferred food and that some will even stage a hunger strike if they don't like what's served. DO YOU WANT TO BE SAVED?

Only one time, in the entire Bible, is the question asked. "What must I do to be saved?" (Acts 16:30).In the next verse (Acts 16:31) the question is answered, "Believe on the Lord Jesus Christ, and thou shalt be saved, and thy house."

Remember:

Hell's Hot Life's Short Death's Sure Eternity's Long

and, "There Ain't No Exits In Hell." NO MAN KNOWS, HOW SOON IT IS TOO LATE

Thou shalt not take the Name of the Lord thy God in vain; for the Lord will not hold him guiltless that taketh His Name in vain." Exodus 20:7

Any way that you use God's Name, the Lord's Name, Jesus' Name, other than in a Holy manner, is taking His Name in vain.

"For God so loved the world, that He gave His only begotten Son, that whosoever believeth in Him should not perish, but have everlasting

Acts 2:21 and Romans 10:13 indicate that, "whosoever shall call upon the name of the Lord shall be saved." In the next verse, Romans 10:14 it says, "How then shall they call on him in whom they have not believed?" Believing precedes calling upon The name of the Lord. Jesus Himself said in John 14:6 "I am the way, the truth, and the life: no man cometh unto the Father, but by me." God reaffirms this truth in I Timothy 2:5 saying "For there is one God, and one mediator between God and men, the man Christ Jesus." When someone says "repeat this prayer after me to be saved" it is making people feel like they have to "do" something to be saved, other than believing. If someone is asked to say a prayer to be saved, the person who says the prayer is still on his way to hell, after repeating the prayer, if he hasn't believed in his heart. Nowhere in the Bible is it found that a person has to pray a prayer to be saved. God does not hear a prayer unless you go to God in the name of Jesus Christ, The Only Mediator between God and man. Jesus Christ is not your Mediator unless he is your Lord; and Savior. So according to God, the steps are, first, you believe in Jesus Christ as your Lord and Savior. By believing as Acts 16:31 indicates, you are saved! Acts 16:30,31 is the only time in the Bible where the question is asked, "what must I do to be saved?" God answering through Paul said, "Believe on the Lord Jesus Christ, and thou shalt be saved." By being saved, Jesus Christ is your Lord, Savior, and Mediator between God and yourself. I believe that when a person "prays" to God, without being saved, his prayer goes no higher than the ceiling, and God probably says, "Who do you think you are, to think that you can come to Me, without coming to Me in the only possible way that I have set out in My Word? For you come to Me, through My Only Begotten Son, Jesus Christ, the One and Only Mediator between you and Me." You don't just pull Jesus Christ out of the air, and say today I want You to get me to God, be my gobetween for God! It doesn't work that way. Jesus Christ is either your Lord and Savior, making Him your Mediator, or, if Jesus Christ is not your Lord and Savior, He is not your Mediator. I believe it is very important to stress that you are saved by believing only. John 3:16, probably the most quoted verse in the Bible, says that, "whosoever believeth in him should not perish, but have everlasting life." Again, this passage clearly prescribes believing, not repeating a prayer. In John 3:4, Nicodemus asks Jesus, "How can a man he born when he is old? Can he enter the second time into his mother's womb, and be born?" He was asking this in regard to Jesus' statement in John 3:3, that a man needs to be born again. Jesus' answer in John 3:5 and following is "Except a man be born of water and of the Spirit, he cannot enter into the kingdom of God." Nowhere does Jesus say, pray to be saved, it is always believe.

Years ago, I heard Dr. Donald Grey Bamhouse say "I'm deeply offended when I hear a prayer that does not end with the idea that God must be approached only through the Name and the Being of the Lord Jesus Christ." Ephesians 1:13 says"In whom (Christ) ye also trusted, after that ye heard the word of truth, the gospel of your salvation: in whom also after that ye believed, ye were sealed with that Holy Spirit of promise." Romans 10:9 tells us "That if thou shalt confess with thy mouth the Lord Jesus, and shalt believe in thine heart that God hath raised him from the dead, thou shalt be saved. 10 For with the heart man believeth (first) unto righteousness; and with the mouth confession (next) is made unto salvation." How many people have gone to hell or are going to hell by putting their trust in the ungodly "pray the sinners prayer" or "repeat this prayer after me", instead of believing John 3:36: "He that believeth on the Son hath everlasting life: and he that believeth not the Son shall not see life; but the wrath of God abideth on him."

Luke 23:39-43 tells us "And one of the malefactors which were hanged railed on him, saying, If thou be Christ, save thyself and us. 40 But the other answering rebuked him, saying, Dost not thou fear God, seeing thou art in the same condemnation? "And we indeed justly; for we receive the due reward of our deeds: but this man hath done nothing amiss. 42 And he said unto Jesus, Lord, remember me when thou comest into thy kingdom. 43 And Jesus said unto him, Verily I say unto thee, Today shalt thou be with me in paradise." In these verses in Luke, we see that a man was saved by believing only. The malefactor did not, and was not instructed by Jesus, to pray, to receive salvation. He said unto Jesus, "Lord, remember me when thou comest into thy kingdom. 43 And Jesus said unto him, Verily I say unto thee, today shalt thou be with me in paradise." You don't fool Jesus. Jesus knew that this man believed in Him; that this man believed that this Jesus that he was talking with was the Lord, The Messiah, the Only Begotten Son of God, the Savior, and in believing, the man was saved. Now if you think that you have to pray first, repeat first, or anything first, before believing, why did Jesus tell him "today thou shalt be with Me in paradise?" OR if there is a need to do for anything to go along with believing, why didn't Jesus tell him what that was? Jesus doesn't make mistakes! God's Word is true. You don't (really you can't), add to or take away from God's Word, and it be true. Just leave His Word alone, and do what God said, believe. Psalm 119:89" "For ever, O LORD, thy word is settled in heaven." Revelations 22:18,19" 18 For I testify unto every man that heareth the words of the prophecy of this book, If any man shall add unto these things, God shall add unto him the plagues that are written in this book: 19 And if any man shall take away from the words of the book of this prophecy, God shall take away his part out of the book of life, and out of the holy city, and from the things which are written in this book." Take your Bible and check the references that we contained herein-nothing added to and nothing taken away; and when you hear "the plan of salvation" from anyone, get your Bible out and see if it is God speaking or "someone's" idea. I can't see 'ten steps" to salvation, I can see only one step: believe. The malefactor on the cross had but one step, and he took it. You, I, we all have "one step," believe. Please take it, and believe in the Lord Jesus Christ for your salvation.
