"I've gotten a tremendous response from businesses in Snyder. The chamber (of commerce) has bent over backwards for us. I haven't been anywhere or talked to anyone who has not been cooperative," said Scott.

One of his efforts is directed toward getting students employed. "Some employers only need someone two or three hours a day, but that's okay. We have students who can work two or three hours a day," said Scott. "I'm always encouraging employers to call me. Some places only need help for a few days or weeks, for inventory or during the Christmas holidays. We have students who can work."

A requirement for the programis the student must be pursuing a vocational certificate or degree.

We're trying to provide an avenue for them," he said.

Typical needs include child care, transportation, uniforms for nursing students and cosmetology supplies

"Two uniforms and a lab coat can cost over \$100. That can be the difference for some people," Scott pointed out. "In the past, some have literally dropped out of the course because they couldn't afford that extra expense. We try to see that no one drops out -- or fails to come to WTC - because they couldn't afford those things. We may have someone who gets a grant to cover tuition and books, but it might not cover things like lab coats and mannequins for cosmetology, for instance. That may be the difference between finishing or beginning their education."





Comatose woman latest victim in four months

BEAUMONT, Texas (AP) -The daughter of an elderly woman severely injured during a robbery and assault says she hopes the man who attacked her mother will be brought to justice.

"I pray night and day that police will be able to get the necessary evidence," said Bobbie Quilleon. "The victim's plight is forgotten except by those loved ones who are forced to deal with shattered lives.

Myrtle Conner, 73, lies comatose in a Beaumont hospital, the most seriously injured of 11 elderly women attacked here between June and October.

Police believe the same man is responsible for assaulting the women, whose average age is 80. One of the women was attacked twice. Beaumont detectives said three of the victims were beaten so savagely, they will endure lifelong ailments.

Ms. Conner is kept arve by a feeding tube. Her gray hair is growing back slightly after being shaved for brain surgery. Her skin is pale, her mouth is sunken and she has suffered a bout with pneumonia and two violent seizures.

DEAR READER: No wonder you're confused - so am I. Let me give you a broad answer.

Polyps are small growths in the lining of the colon. They take five or six years to grow big enough to be seen. Most are benign. However, certain types of polyp are believed to be premalignant. As a general rule, polyps should be removed (an easy procedure through the endoscope) and examined under the microscope. If there is a chance of pre-malignancy, the whole colon should be examined (by colonoscopy) and any other polyps removed.

The colonoscopy should be repeated every five or six years.




