Enjoin Collector

Ask Restraining Order Stopping Remittances on State Highway Funds

A petition to District Judge R. C. of Floyd County is being heard in Plainview today asking a temporary order from the district court judge restraining the tax collector of Floyd County, J. A. Grigsby, from paying over to the State Highway Depart-"weight" taxes on automobiles in proposition. Floyd County, under the new Highway Law, passed by the last legislature.

Decision to ask for this restraining order was reached by the commissioners in special session last Thursday. It was intended that the petition to the district judge should have been presented the latter part of last week. Delays, however, prevented this and the petition was finally completed last night for presenting to the judge. The injunction asks that the tax collector of this county be restrained from paying over to the state highway dedepartment funds collected from car owners in this county as "weight" tax "until cases invoiving the constitutionality of the Highway Law can be determined in the courts." Cabbage is one of the most common leafy vegetables and can be secured easily and at small cost now. If cooked in the following manner it is good for both grown-ups and chil-

Take off the outside leaves of a cabbage. Cut the cabbage into small pieces, discarding the tough stalk. Cook in an uncovered kettle full of boiling salted water 20 or 30 minutes, or just until it is tender; drain and serve with butter, salt and pepper.

Following are other recipes for cooking cabbage which will be liked: Cabbage with ham. 1 cabbage, 1-4 pound cooked ham, water.

Separate and wash the cabbage leaves. Place in boiling water, adding the cooked ham. Allow all to boil until cabbage is tender. Drain water from the leaves, arrange cabbage on serving dish, and garnish with the ham. Bacon may be substituted for

Creamed Cabbage-1 cabbage, 1-2 pound butter, 1-2 c. Water, 2 egg yolks, 1-4 c, vinegar, 1 c. cream.

Separate the cabbage leaves, wash and cut them in thin pieces, and cook in boiling salted water. Prepare a custard of the yolks of eggs, water, vinegar, and butter., Cook the mixture in a double boiler and as it thickens add cream. When custard is thick, pour it over the cabbage in a serving dish. Serve hot.

Sauces which are good to serve with cabbage, making it palatable to even those who have an aversion to cabbage are; cream sauce, tomato sauce, cheese sauce, and peanut butter sauce. These all may be made by a cream sauce recipe. Served on crackers or toast with one of the above sauces, cabbage becomes a real delicacy.

FIRST M. E. QUARTERLY CONFERENCE, 1923-24

Rev. L. N. Lipscomb of Plainview held the first quarterly conference for the Floydada Methodist Church here in the First National Bank on Monday afternoon. He came as a representative of the presiding elder, Rev. G. S. Hardy, who is quite seriously ill in a hospital in St. Jo, Mo. Rev. Lipscomb brought a hopeful report as to the present condition of the presiding elder.

Reports showed that during the two and one half months of this conference year the sum of \$918.90 had been expended on current expenses, \$348.15 for repairs and furnishings for church and parsonage; and \$157.-00 for charity.

There was a net increase in membership during the quarter of eleven, which brings the present membership of the Methodist Church; here up to 481.

The pastor, Rev. J. L. Henson, has during the quarter preached four funerals, performed four marriage ceremonies, preached thirty-six sermons, ten of which have been in the country, has made approximately two hundred pastoral visits, secured sixtyeight subscriptions to church papers and sold eighteen books on Bible study and church work.

He has, in the way of work at the parsonage, during the last two and one half months, built four bookcases, and two clothes closets; dug a cess pool and helped to wall it, secured an oil heater for the bath room and had a nice new sink installed in the kitchen. He did this work himself except walling the cess pool and doing the plumbing, and he helped to do that.

Other ministers who attended the quarterly conference Monday were Rev. J. P. Patterson of Lockney, Rev. Marvin Brotherton, pastor, Floydada Circuit and Rev. H. E. Smith, superannuate member of the North Texas Conference but residing in Floydada.

Roy Baker was elected steward to take the place of his brother, Pitzer Baker who recently moved to Weinert, Texas, to take charge of the new Baker-Campbell store at that place.

MANURE OFTEN DOUBLES WHEAT YIELD, SAYS BAINER

"When wheat is worth \$1.00 per bushel, good, well-rotted manure is worth more than \$2.00 per ton as a top dressing to wheat," says H. M. Bainer of the Southwestern Wheat Improvement Association. He states that this valuation is based on results from several of the leading experiment stations in the wheat belt. This means that the farmer who hauls out only a few loads of manure a day is making big wages.

Mr. Bainer continues by saying, "Wheat farmers are losing millions of dollars annually because they place too little valuation on manure and let

too much of it go to waste. At the Oklahoma station, he says, "Ten tons of barnyard manure per acre applied as a top dressing to wheat once every four years, for a 24-year period, where the land was in wheat continuously, produced 9 bushels more wheat per acre per year than the same kind of land by the side of it which was not manured. This is equal to an increase of 36 bushels per acre in each fouryear period and a return of more than \$3.50 for each ton of manure applied.

"The Kansas station produced from 9 to 11 bushels more wheat per acre, for several years, on land that had been manured, than on similar land that had not been manured. At this station, land that was in wheat continuously, and was manured and cropped for 10 years, produced an average of 18.4 bushels per acre per year; during the same period similar land by the side of it was not manured produced an average yield of only 6.9 bushels per acre.

"The effect of manure on land will continue for several years. The subsoil of manured land always contains more moisture than unmanured land. The nitrogen added by the manure not only increases the yield of wheat but also improves its quality, insuring a higher protein content and a better price."
