



Senate Joint Resolution No. 1

Proposing an amendment to Section Article 6 of the Constitution of the State of Texas by providing that only native born or naturalized citizens of the United States shall be qualified electors in this State, and permitting either the husband or the wife to pay the poll tax of the other and receive the receipt therefor, and permitting the Legislature to authorize absentee voting.

Be it resolved by the Legislature of the State of Texas:

SECTION 1. That Section 2 of Article 6 of the Constitution of the State of Texas be so amended as hereafter to read as follows:

Sec. 2. Every person subject to none of the foregoing disqualifications, who shall have attained the age of twenty-one years and who shall be a citizen of the United States and who shall have resided in this State one year next preceding an election and the last six months within the district or county in which such person offers to vote, shall be deemed a qualified elector; provided, that electors living in any unorganized county may vote at any election precinct in the county to which such county is attached judicial purposes; and provided fur-ther, that any voter who is subject to pay a poll tax under the laws of the State of Texas shall have paid said tax before offering to vote at any election in this state and hold a re next preceding such election. Or if said voter shall have lost or misplaced said tax receipt, he or she. as the case may be, shall be entitled to vote uponmaking affidavit before any officer authorized to administer oaths that such ta xreceipt has been lost. Such affidavit shall be made in writing and left with the judge of the election. The husband may pay the poll tax of his wife and receive the receipt therefor. In like manner the wife may pay the poll tax of her husband and receive the receipt therefor. The Legislature may authorize absentee voting. And this provision of the Constitution shall be self-enacting without the necessity of fur-






