Final arguments were scheduled to begin this afternoon in the 132nd District Court trial of Ray mond Medrano Jr., 42, who is charged with the attempted capital murder and aggravated robbery of a Snyder man on Sept. 9.

Armstrong put eight witnesses on the stand after testimony got underway Monday afternoon. The 7woman, 5-man jury was selected shortly before noon Monday.

James Clark, defense attorney, rested his case without calling any witnesses.

Medrano was indicted on Oct. 2 for the alledged stabbing and robbery of Gilberto Jimenez.

# **Failor-made antibodies said** to reverse lethal skin cancer

WASHINGTON (AP) - Tailormade antibodies can dramaticaly reverse spreading melanoma. the deadliest form of skin cancer, when injected directly into the tumors, researchers say.
The work, though still in its

preliminary stages, suggests that it may be possible to stop the disease by harnessing the body's growths on victims' skin. own built-in defenses.

### **Beef exports** may improve


COLLEGE STATION, Texas (AP) — American cattle producers must take advantage of global trends if they are to sell more beef to the swelling world population, the head of the Commodity Futures Trading Commission said.

Ewen Wilson, executive director of the trading commission, said rapid population growth could result in more beef eaters around the world. But farmers will have to find ways to overcome the fact that many of those in new markets have extremely low incomes, Wilson said Mon-

"With 90 million new mouths to feed every year for the next decade, that is like adding about 3½ new Canadas to the world every year," Wilson said.

He predicted that the U.S. cattle industry could grow as much as 2 percent a year to supply meat for the increasing popula-

Sweeping political and economic changes in Europe, international trade talks and economic growth in the Pacific Rim bode well for beef producers, said Wilson, a former U.S. assistant agriculture secretary for economics who recently took over as executive director of the Commodity **Futures Trading Commission.** 



Antibodies are among the cells. body's principal weapons for fighting off a variety of foreign invaders, including cancer. In this case, scientists crafted human antibodies in the test tube that were specifically targeted against the cancer. Then they injected them into cancerous

"The lesions dry up and regress," said Dr. Donald Morton, director of the John Wayne Surgical Oncology Clinic at the University of California, Los

In initial studies, Morton and colleagues gave the injections to 28 people whose melanoma came back after initial surgery. In 18 of them, the shots caused partial or complete disappearance of the growths.

The doctors injected three different kinds of antibodies. Each recognizes a different chemical structure that is unique to cancer ticularly hard to study.

The antibodies latch onto these chemical structures, marking the cancer cells for destruction by other patrolling white blood cells. To the researchers' sur-prise, they found that the cancer patients began making more of these antibodies on their own.

"We are actually stimulating immunity with this treatment," said Morton. "We don't know why, but it is happening."

Morton presented his findings Monday at the annual meeting of the American Society of Clinical Oncology.

"I was quite impressed by the response rate," commented Dr. Carol Westbook of the University of Chicago. "It appears to be a promising treatment that warrants further investigation."


Foster said authorities contacted the Lawrences by mail.

"And we were very specific about what we wanted, in the letter and telephone calls that followed," Foster said.

An undercover officer met with Doug Lawrence May 22, 1989. Both Lawrences were arrested later that day and spent nearly a year in the Morris County Jail before charges against were dropped May 15.

The couple is from Elsmere, Ky., near the Ohio border. Lawrence, who spent 20 years in the Army, insists he came to Texas looking for work as a mechanic. He says they responded to an advertisement in "Soldier of Fortune" magazine and were contacted by a fictitious Addison company called North American Racing Association.

Lawrence said, "I thought maybe I could put my military experience (as a mechanic) to use. After retiring from the Army, I still wanted to connect myself with some type of military action, but still stay in my field as a mechanic."

DEAR ABBY: In a recent column on spanking children, you indicated that your readers' response to spanking was 10-to-1 in favor. You may be interested in the results of a 1990 survey done by the National Committee for Prevention of Child Abuse, which measures attitudes and actions about child abuse and its prevention. Of the parents in the survey who have children under the age of 18, 49 percent said that they never spank their children. And 26 percent

said that they "hardly ever" spank or hit their children. In addition, 72 percent said they believe that physical punishment of a child can lead to ills crucial injury. Overall, as an organization dedicated to the prevention of child abuse, we were encouraged by these





How easy it is to make light of the problems that occur at the bridge table! What seems so easy when one is carefully looking at all four hands can be very difficult when the hands held by partner and declarer are concealed. That does not excuse the mistake made by West in today's deal, but please view it with a little compassion.

With a double stopper in hearts, South first bid one no-trump after East's overcall. When East persisted with two hearts, South then bid two spades, obviously showing a four-card suit and maximum values for the previous one no-trump bid. North raised

to three and South bid four, certain from North's raise that North held a singleton heart. That set the stage for West's defensive disaster.

When the heart jack was led, East won the king and returned a low diamond. He hoped that West would hold the diamond king, and maybe the jack as well. No such luck. South won the jack of diamonds and played a low spade. West followed low; the jack was played from dummy and East took the ace. That did it for the defense. When a subsequent spade was played toward the Q-9-2, West could win the king, but no more tricks were there for East-

The contract fails if West grabs the spade king when the suit is first led. A second heart is played, ruffed in dummy. Later, when East wins the spade ace, he plays the ace of hearts. Dummy must ruff again, and West eventu-ally takes the setting trick with the 10

Chambers said there are two issues. TEA is dealing with the question of determining if there has been a violation on no-pass, no play.

Based on the TEA ruling, the UIL will determine what penalty, if any, would be given the Snyder schools.

# U.S. will pay fees for trial

will foot Manuel Noriega's legal bills until \$20 million of his frozen assets are confiscated or released, under a deal that averts disclosure of secret U.S. payments to the fallen dictator.

Before the deal was reached Monday, Noriega's lawyers had threatened to quit the drug trafficking case because they hadn't been paid. Prosecutors froze the former Panamanian leader's assets, contending they were illegally obtained.

In agreeing to cover Noriega's legal fees, the government headed off a confrontation over \$11 million in U.S. intelligence agency payments he claims to have

received over several decades. Noriega's lawyers had been trying to force the government to produce secret records of those payments to show Noriega had other than drugs. But on Monday, the defense agreed to drop the subpoenas when the deal involving Noriega's legal fees is formally approved.

The U.S. government "wanted to avoid litigation that would get into matters having to do, certainly, with classified information, with payments by our government and other governments to Noriega," defense attorney Jon May said.

U.S. Attorney Dexter Lehtinen told U.S. District Judge William Hoeveler that the government agreed to cover the legal bills "to assure Mr. Noriega receives a fair trial."

The long and complex nature of the case made it possible for the prosecution to invoke a federal law allowing the unusual arrangement, he said.

Noriega, who was in court in his general's uniform, agreed to sign affidavits declaring he was indigent and promising to repay the government if his assets are

"It can't be said that the American taxpayer is paying for this, because all the funding for the general's legal fees will come out of the seized assets," said chief defense attorney Frank Rubino.

Defense attorney Steven Kollin has estimated Noriega would need \$5 million to properly defend himself. The defense contends prosecutors have spent \$12 million so far and are prepared to spend \$25 million more to convict

DALLAS (AP) - Greyhound Lines Inc., seeking to replace cash spent on fighting a bus drivers' strike and avert bankruptcy, is asking junk bond holders to turn in their notes at a steep discount.

The company also said it will change its pay scale for drivers and withdraw proposed bonus and pension schemes to save

"The ability to restructure the balance sheet in some way is very important to avoid bankruptcy," said Michael Doyle, the company's chief financial officer.

"The cost of the strike has been pretty expensive," Doyle said, and cash is "very tight." Nevertheless, he said the only nationwide bus company is able to meet its payroll and buy fuel.

Greyhound issued a variety of junk bonds to refinance debt taken on in a leveraged buyout three years ago.

The bonds include \$150 million due in 1995 that pay interest of 13 percent and \$75 million of 12.5 percent bonds due in 1997. The two issues represented more than half of the company's total debt of \$359 million at the end of 1989.

The company is technically in default on the first issue after missing a recent interest payment, and noteholders could force the company into bankrupt-

As a result, Greyhound said it was making a cash tender offer to redeem the 13 percent notes at 54 percent of their face value and the 12.5 percent notes at 27.5 per-

"The offers are being made in connection with an overall financial restructuring plan being developed by the company in an effort to avoid bankruptcy reorganization," Greyhound

Doyle said both offers are higher than prices currently quoted for the bonds in secondary

The offer is conditional on its cceptance by a majority of noteholders, plus their agreement of a change in some terms on the notes, especially those that restrict Greyhound's indebtedness and call for certain levels of net worth.





DEAR DR. GOTT: I've been diagnosed with lupus lesions on my head. Will the lesions ever go away, and will my brain eventually be affected?

**DEAR READER: Lupus erythema**tosus, a disease of unknown cause, is characterized by inflammation of the body's supportive (connective) tissues. The affliction appears in two forms: systemic LE (which affects skin, joints, lungs, heart and kidneys) and discoid LE (which affects only the skin). Some patients with discoid LE eventually develop systemic LE. From your brief description, I sus-

pect that you have the typical rash of discoid LE: round, scaly patches on the nose, scalp and ears. Although these skin lesions may spread to the upper body, progressing to infected areas and atrophy (portions of skin that wither and dry up), you are un-likely to experience inflammation of internal organs - unless, as I mentioned, you are one of the unusual patients whose discoid LE turns into systemic LE.

Because the skin changes of both forms of lupus are indistinguishable, even by biopsy, your doctor should obtain a blood test called anti-DNA antibodies.

Lupus is believed to be an autoimmune disease; that is, the body some-

how misperceives normal tissue as abnormal and tries to destroy it. DNA is a basic-constituent of all tissues. Therefore, the presence of anti-DNA antibodies in the blood indicates systemic LE.

Because patients with discoid LE are reacting only to normal skin cells, they do not have anti-DNA antibodies in their blood. Thus, this blood test effectively discriminates between patients with the two forms of lupus.

If you have discoid LE, your brain will not be affected, as is the case with some systemic LE patients who develop headache, seizures and personality changes

However, the skin lesions will probably not disappear without treatment. This consists of cortisone cream, injections of cortisone directly into the LE patches and the use of sunscreens (because sunlight can worsen discoid LE). In resistant cases, hydroxychloroquine pills may be necessary.
