Plane crashes

MINERAL WELLS, Texas (AP) - The Federal Aviation Administration is investigating the fatal crash of a single-passenger airplane that went down in western Parker County.

The pilot, Martin L. Decker, 42, of Yuba City, Calif., was killed in the

crash Sunday. **Investigators said Decker** was on a confidential experimental flight when his plane went down just after 8 a.m. Sunday. The wreckage was found in a rural area about one mile north of the Mineral Wells Airport.

End dispute

DALLAS (AP) American Airlines and its flight attendants have agreed to settle lawsuits stemming from the carrier's decision to place foreign attendants on its Latin American routes, according to a top union of-

Under a compromise, the company will hire about 200 foreign nationals as flight attendants on Latin American routes acquired from Eastern Airlines.

In turn, American has agreed to use more domestic attendants on flights departing from its in Central and South America.

PLO stand

BAGHDAD, Iraq (AP) — The PLO today issued what appeared to be a condemnation of an abortive guerrilla raid against Israel last month, after the United States threatened to cut off dialogue with the PLO over the incident.

"The PLO position remains unchanged. We are against any military action that targets civilians, whatever form it may take," said the statement by an unidentified PLO spokesman in Baghdad and distributed by the PLO's official news agency WAFA.

The State Executive Committee of the University Interscholastic League will discuss allegations against Snyder High School one-act play Director Jerry Worsham during a 10 a.m. Tuesday meeting at Red Lion Inn in Austin.

A central issue in Tuesday's hearing is a two-page letter written by Worsham to math teacher Jamie Hall, asking that a cast member be allowed to take makeup work after the fifth sixweeks grading period. The makeup work resulted in the student's grade being changed from 69 to 70.

The Texas Education Agency ruled last month that the student should have been declared ineligible and that Snyder's one-act play entry in the state meet had violated the no-pass, no play rule.

with a racially insensitive name. out of competition to protest rules that animals in horse shows must be entered by their full registered

Linda Rose held the horse in rented stall No. 767, but refused to enter him in competition.

She is angry that the American Miniature Horse Association, based in Fort Worth, has refused to allow her to change her horse's racially insensitive name. She had planned to post a sign at a show over the weekend and petition other horse owners for support.

But Bob Branch, show chairman of the "Biggest Little Horse Show in Texas," sought and got an agreement from Ms. Rose not to create a controversy with the 5-year-old horse, registered by a previous owner as Nigger Boy's Little Flash.

Branch said he would not have allowed Ms. Rose to enter a second horse in the show "unless she assured me in advance that she would not pass out literature."

Ms. Rose, who lives in Atascosa, near San Antonio, is in miniature horse, Saginaw.

Texas spill compared with recent disaster in Alaska

by The Associated Press

The supertanker burning in the Gulf of Mexico carried more than three times the oil spilled by the Exxon Valdez off Alaska last year. But authorities said that if the Mega Borg sank, it might not cause as big a catastrophe.

Two key differences: The Mega Borg's cargo was light crude, which disperses much more rapidly than the heavy crude carried by the Exxon Valdez; and fire is consuming the Mega Borg's oil.

The Exxon Valdez spilled nearly 11 million gallons of oil about one-fifth of the 987-foot ship's cargo - when it ran aground on Bligh Reef in Prince William Sound, 25 miles from the port of Valdez, on March 24, 1989.

It was the nation's worst oil spill. More than 1,100 miles of Alaska shoreline were soiled. Thousands of birds, mammals and other wildlife were killed.

The Mega Borg was carrying 38 million gallons of light crude when it was wracked by explosions and fire on Saturday about 57 miles southeast of Galveston, Texas. At first, little oil spilled, but five powerful explosions Sunday sent blazing crude pouring into the Gulf.

The Mega Borg was listing and apparently in greater danger of sinking than the Exxon Valdez was. The fire, however, appeared

to be consuming much of its oil. "It causes some air pollution,

but that dissipates," said Coast Guard Chief Petty Officer Todd Nelson. "What would be worse would be for it to sit on the surface and drift toward shore.'

Even if that happened, the light crude would disperse much more rapidly than heavy crude, Coast Guard Capt. Tom Greene said.

A spill about one mile long north of the vessel and one about 20 miles long to the south were visible Sunday evening. Officials estimated the slicks contained 7,000 gallons of oil.

Currents and winds were expected to push the oil toward a 150-to 200-mile stretch of Texas coast between Freeport and Corpus Christi. But Greene said inshore currents could keep the spill from washing ashore.

If it reached shore, nowever, the spill could jeopardize a wildlife refuge, salt marshes, oyster reefs and other crucial habitat, environmentalists said.

Tears over spilt milk (the missed grand slam) should never cause a bridge player to be careless in the play of the actual contract. The only threat to the small slam would be a holding of four spades to the jack, and that holding can be guarded against. Best after ruffing the opening club

lead would be to simply play a low spade from dummy and let it ride. Although West would win the jack, nothing he could then do would prevent declarer from playing the remaining high spades and making the contract. Even after playing to the ace of spades, declarer can make the safety play of a second spade to dummy, inserting the 10. If East wins the jack. the remaining tricks are secure, barring a truly remarkable circumstance such as East playing a heart from an original holding of five and having West ruff with the remaining spade.

When East actually shows out, South will cash dummy's king of spades and come to his hand with the heart king to pull the last trump. That will be an overtrick well earned by declarer's caution.

World Cup openers marred by violence

ROME (AP) — It was an ugly performance by the United States, nearly as ugly as the clashes between fans and police in two Italian

The soccer has been superb, for the most part, with West Germany putting on the best display Sunday. The Germans, one of the favorites for the World Cup, routed Yugoslavia 4-1.

The Americans, probably the biggest longshot in the tournament,

made their first World Cup game in 40 years a forgettable one with a 5-1 loss to Czechoslovakia. It could have been worse.

The worst performances of the day, however, were made by the English-speaking fans in Cagliari, on the island of Sardinia, and the German fans who confronted police in Milan.

Late Sunday night, on the eve of the England-Ireland game, English-speaking fans were confronted by police in Cagliari after a woman was hit on the head by a thrown bottle. Riot police wielding batons waded into the crowd, and at least three young men were taken away in police cars.

Fans of both teams packed bars, ordering beers before a midnight ban on the sale of alcoholic beverages took effect. On Friday, street violence led to the arrest of 14 English fans

In Milan, at least seven people were injured and 20 were taken into

custody, police said.

Groups of fans, apparently drunk despite a ban on alcohol sales, smashed windows of shops and cars along the street. Hundreds of riot police rushed to the area after reports of confrontations between West Germans and Yugoslavs.

Police then clashed with the rowdies near Milan's well-known Duomo cathedral square.

Meanwhile, Verona police reported that 13 West German supporters were arrested. Charges of violence and vandalism also were filed against 55 others following several disturbances early Sunday morning along Lake Garda.

The violence away from the stadiums has taken some of the gloss off what was a spectacular opening weekend. From Cameroon's startling victory over defending champion Argentina in the opener Friday night to Romania's upset of the Soviet Union on Saturday; from West Germany's powerful play and the excitement of Brazil's 2-1 win over Sweden, it was a sensational first three days of soccer. Except, of course, for the Americans.

"Everyone said we would lose, and we did lose," U.S. captain Michael Windischmann said. "We've got to come out in these next two games and show that we could play.

"Even though we lost, it's still a great feeling to play in the World Cup. I'm dissapointed in the results. I think we could have done bet-

Czechoslovak coach Jozef Venglos also thought the Americans would put up a better fight.

"We expected a little bit more from the U.S. team," Venglos said. "At the beginning, the U.S. team played us even, but then we started to play to our potential."

And they peppered the net. Goalkeeper Tony Meola, betrayed by his defense, made some outstanding saves. But he also was caught out of position too often.

Tomas Skuhravy scored twice and Michal Bilek, Ivan Hasek and Milan Luhovy once each for Czechoslovakia, whose players dedicated the victory to President Vaclav Havel and his Civic Forum

"We decided yesterday that if we won, it would be in the name of President Havel and the Civic Forum," Kubik said. "But today's win is only our first step in this tournament.'

West Germany took a major step against a good Yugoslav team. The Germans got two goals from captain Lothar Matthaeus on long, hard shots with each foot, and one apiece from strikers Rudi Voeller and Juergen Klinsmann.

Brazil's classy striker, Careca, accounted for both goals on short tip-ins. But Sweden came back and made it uncomfortable as Thomas Brolin scored with 11 minutes remaining.







Court rejects argument

WASHINGTON (AP) - A Texas school teacher who was not rehired after he gave his students an unapproved reading list lost a Supreme Court appeal today.

The court, without comment, rejected arguments that the teacher's free-speech rights were violated.

Timothy Kirkland taught history for two years at Taft High School in San Antonio. He accused school officials of censorship after they refused to rehire him

Kirkland gave his students a list of 47 books to supplement their reading for his class, substituting his own selections for the school's list of 90 books without the approval of his superiors.

School officials said Kirkland was let go because he was a poor teacher, and cited distributing the non-approved list as one example. The officials said Kirkland's list consisted almost entirely of novels that were available in the school library and were assigned in other classes.

The school's list of 90 books included some fiction but primarily was comprised of non-fiction.

A federal jury awarded Kirkland \$50,000, deciding his rights were violated. A judge tacked on nearly \$17,000 in legal fees and ordered Kirkland reinstated.

But the 5th U.S. Circuit Court of Appeals last December overturnthe awards reinstatement.

"Under the court's holding, every citizen is subject to being seized and questioned by any officer who is prepared to testify that the warrantless stop was based on an anonymous tip predicting whatever conduct the officer just observed," Stevens

damage it's already received," Coast Guard Chief Petty Officer Todd Nelson said. "We want to be prepared for a large oil spill if it could occur."

The Mega Borg carried more than three times as much oil as was spilled by the Exxon Valdez off Alaska in March 1989 in the nation's worst oil spill.

But authorities noted that the oil spilled in Alaska was heavy crude, which doesn't dissipate nearly as rapidly as the light crude aboard the Mega Borg, and that much of the oil spilling off Texas was being consumed by

Thousands of feet of oil-spill

containment booms were brought in. Four Coast Guard cutters were in place around the tanker while two salvage-team ships sprayed water on its deck in an attempt to keep the ship cool.

Foam couldn't be used earlier because the nearest available equipment to spray it was in Louisiana, said Coast Guard Chief Petty Officer Sam Wilson.

A slick about one mile long north of the Mega Borg and one about 20 miles long to the south were visible. The spills were estimated to contain 10,000 to 100,000 gallons, said Petty Officer Mark Sedwick. He said a plane dropped oil dispersant late Sun-

DEAR DR. GOTT: Several months ago, you published a remedy for toe-nail fungus — LaPacho tea. For years, I've treated my infection with Epsom salt soaks and peroxide. with your condition than I am. You may be reacting to one or more dicines; for example, Lanoxin (digoxin) often causes nauses and Tenormin (atenolol) frequently produces shortness of breath. Ordinarily, Lanoxin is a good drug for treating atrial fibrillation — a rapid and irregular pulse - because it slows the heart rate. Perhaps, in your case, this drug alone would be suitable, especially if the dose were altered to suit your needs.

With respect to the use of other drugs, either alone or in combination, I'll defer to your physician. Suffice it to say, there are other drugs available for fibrillation. If your doctor is unable to discover an appropriate treatment for you, I recommend a consultation with a cardiologist.

DEAR DR. GOTT: Six months ago, I broke up with my girlfriend of two years. One month later, she informed me that she tested positive for venereal warts. On her advice, I saw my doctor whose response was "no symptoms, no worry." (No test either.) How can I ensure that I am not contagious? What symptoms would I have if I am?

DEAR READER: Venereal warts are sexually transmitted warts that appear on the skin of the genitals. Although, in some cases, the virus can remain dormant for weeks, there is no test for the presence of the wart-virus thing keeping Hood County before warts actually appear - and no one knows why some sexual partners seem to be resistant or immune to venereal warts. Once they have appeared, however, the warts can be tested for the presence of the venere-

Your doctor is correct: Don't worry until (or unless) you develop the telltale warts. Since you have been symptom-free for six months, I think the chance of you developing venereal warts is very remote.

Just one-third of respondents expected pollution to decrease in the next 10 years, while 44 percent said it would increase. The rest expected little change.

Toxic waste disposal remained the greatest priority, with 65 percent saying it required 'urgent government action no matter what the cost." The related matter of drinking water pollution got the next highest priority.


