Year's cotton crop 'way above average'

Preliminary reports indicate that farmers are enjoying the best cotton crop this year in a decade or more.

Cotton ginning is in full swing, Agent Marvin Ensor said that the according to local ginners. Some office is predicting some 59,000 11,134 bales have been ginned by acres harvested this year with a county average of 470 pounds per lint yield.

Ensor said that this year's crop is "way above average" and the best in the last eight to 10 years.

Prime weather conditions are cited for the bumper crop, especially the rains the area received in mid-summer, according to Ensor.

"I'm hearing reports of farmers getting one-half to 134 bales to the acre, dry land cot-

He said that the last few days have seen excellent weather for stripping and noted that the recent freezes have helped kill some of the green cotton left.

Three county gins and an area gin report they are ginning around the clock and, if favorable weather conditions hold out, expect to continue full-scale operations through the holidays and into the new year.

Farmers Co-Op leads the county in gin operations with 6,200 bales ginned and some 5,000 bales in the fields waiting to be ginned.

Paymaster has processed some 2,834 with over 600 waiting to be ginned.

Ira Gin reports a sharp increase in ginning activity and 1,050 bales ginned.

Inadale Gin reports 8,400 bales ginned. The gin services farmers in Scurry, Mitchell, Fisher and Nolan Counties.



Scientist also say it is impossible to accurately predict an earthquake, but a fellow in New Mexico claims to have more confidence in his theory than in the country's top seismic experts.

The New Mexico scientist is predicting that a major earthquake will hit the Midwest in early December. In fact, Monday, Dec. 3 is the day he says will include strong tidal forces that will produce a greater-than normal chance that the New Madrid area will have a quake in the magnitude of 7.0 — about as big as the one that struck the California Bay area last year.

The New Madrid fault has about 150 small earthquakes each year. The fault is about 120 miles long and runs from Illinois to Arkansas. In the early 1800s, it is said to have experienced some of the worst quakes ever on this continent.

The prediction is being taken seriously, as some schools and businesses are considering closing their doors in early December.

Some seismic experts have dismissed the prédiction as absurb. Nevertheless, people have flocked to earthquake survival seminars. Persons selling earthquake insurance have experienced

In spite of assurances from experts to downplay the predictions, there'll be some littery nerves in the Midwest for the next few days.

Although Tax Reform first made headlines in 1986, it has not, like many other headlines of nearly five years ago, faded into obscurity. Confusion about the changes wrought by tax reform remains, particularly in regard to Individual Retirement Accounts (IRAs).

Two things about IRAs remain the same. Anyone under age 70 1/2 with earned income can contribute to an IRA. And, all contributions can earn tax-deferred income. Beyond that, eligibility and benefits vary according to several factors.

Following are some ground rules that can help you decide if an IRA is still beneficial to you. If you are a single working taxpayer not covered by a company-sponsored retirement plan you can deduct annual IRA contributions up to \$2,000. If you are married and neither spouse is covered by a company-sponsored retirement plan, you may be able to deduct up to \$4,000 annually for you and your spouse.

If, on the other hand, either spouse participates in an employer-qualified retirement plan, the amount of your contribution that's deductible depends on your adjusted gross so income (AGI). For couples with an AGI up to \$40,000, a full deduction is available. Between \$41,000 and \$50,000, the deducton above are not eligible for a deduction; however, they may still contribute to an IRA.

Single people who participate in an employer-sponsored retirement plan can still claim the full IRA deduction if their AGI is below \$25,000. Between \$25,000 and \$35,000, the deduction is phased out, and for those with an AGI above \$35,000, there's no deduction.


Even if you do not qualify for a full or partial tax deduction, an IRA contribution can still make sense. Remember, IRAs continue to offer long-term, tax-sheltered compounding of both capital gains and dividends.

Over a 20-year period, for example, an individual in the 28 percent tax bracket making an annual \$2,000 IRA contribution that earns only 8 percent, would wind up with \$23,000 more in his account than an individual making the same investments without the benefit of tax sheltering.





Devastated by her brother's death, Mrs. Key, her family and her parents have been working through the grief process and recovering with the help of Compassionate Friends, an organization which offers support to parents who have lost a child.

It is still difficult for Mrs. Key to talk about her brother's death, but she feels she must because, as she recently told the Snyder Daily News, "If just one person is helped it's worth it."

She said the hardest part was receiving the news of her brother's death in a 6:30 a.m. call from her mother. "I hope to be able to prevent someone else from getting a call like that."

Not wanting to believe her mother, Mrs. Key said as she drove from Kerrville where she then lived to Boerne she kept saying, "This is a mistake. They have the wrong person."

But 60 miles later, she had to accept the bitter truth that her younger brother was dead, along with his dream of becoming a

basketball coach. Besides dealing with her own grief and shock. Mrs. Key was freshman at Shriner College in also very concerned about Kerrville. He and his sister were Cassandra because she was ex-

Cassandra was told that her uncle had been badly hurt in an accident and that rather than let him suffer anymore, Jesus had taken him to heaven. Mrs. Key said her daughter accepted that explanation from the beginning and even today when Jerald's name is mentioned she says he is with Jesus.

Jerald had been in San Antonio and after accepting a ride back to Kerrville with two other students whom he had not met previously, he went to sleep on the backseat of the car.

Mrs. Key's brother had not been drinking, but the driver had. Jerald, who was not wearing a seat belt, was thrown clear of the vehicle and landed on a creekbed some 40 feet below.

Neither the driver nor the other passenger were seriously hurt, but Mrs. Key's brother was pronounced dead at the scene.

Investigators took her brother's blood alcohol concentration level which tested normal, but the driver's BAC was not tested until some four hours later. Since it then tested .09, Mrs. Key said the grand jury did not indict the driver. In Texas. .10 is considered above the legal limit.

During the aftermath following her brother's death, Mrs. Key said the family was exposed to a legal system which seemed "to deny rights of the victim and family members while protecting the drunk driver."

Not knowing anything about the legal process following such an accident, she explained that very often they did not know what-was going on or what happened during the grand jury hearing. Since they could not legally attend the meeting, she said they do not know what evidence was presented at the

she is willing to work toward making that happen.



> If MADD approves their charter, Mrs. Torres said the MADD headquarters in Texas will send them a Chapter Binder which will provide them a more detailed history of the organization which was founded in 1980 by a mother, Candy Lightner, whose 15-year-old daughter was killed by a drunk driver.

> MADD will also provide detailed explanations of specific areas which they might want to work on after committees are established. MADD, which now enjoys 97 percent name recognition, has a variety of services available tothe public.

> For the most part, each MADD chapter can choose what it wants to concentrate on but one requirement is to establish a Level I Victim Service Number. This means that MADD representatives will be available to assist family members as they come to grips not only with the tragedy of a family member being hurt or killed in an alcohol-related accident, but also with the trauma of dealing with the legal system in the months that follow. Since the average person has no idea what to expect, Mrs. Key said one of MADD's goals is to have someone "walk them through the system," and to keep them informed about the law, due projury system.

> In addition, the local MADD chapter will also stage several fund raisers each year and all proceeds will stay in Scurry County. Besides purchasing suppaying expenses for a MADD representative to attend quarterly State Coordinating Committee meetings. These meetings are a way for MADD chapters to stay in touch with what is happening in the state.

DEAR DR. GOTT: I have Crohn's disease and have had an ileostomy. water I can, and I feel the six quarts a day I consume has prevented me from getting kidney disease. What do you think?

By Peter H. Gott, M.D.

DEAR READER: Crohn's disease, a chronic inflammation of the bowel, causes persistent diarrhea, fever, abdominal pain and weight loss that are sometimes impossible to control with medicines; surgery may be necessary to remove portions of infected intestine.

Under these circumstances, fecal material has to be collected in a bag worn on the abdomen. Such an ileostomy is a nuisance, but it prevents the serious consequences, including intestinal blockage, of Crohn's dis

Patients must maintain a high fluid intake after this surgery to prevent constipation, so your doctor was correct in urging you to drink plenty of fluids. However, adequate fluid in-take will not necessarily prevent kidbey disease. Really, this is a separate ue. Six quarts a day seems, to me, to be more than you or anybody else needs. However, you should heed your doctor's advice about this issue.

DEAR DR. GOTT: I have been advised by an oncologist to take beta-carotese for my chronic lymphatic

boukemia. Do you agree?
DEAR READER: Recent studies have shown that beta-carotene, a precursor of vitamin A in many vegetables, may exert an anti-cancer effect. Natural sources of carotene include carrots, squash, pumpkin, apricots, peaches and leafy green vegetables. The role of this compound in preventing or treating cancer is still unclear; therefore, most experts recommend a well-balanced diet (including carotene-containing vegetables) but stop short of urging patients to take syn-

thetic carotene supplements.

If your doctor has advised you to consume more beta-carotene, do so; it won't harm you, providing you follow his instructions. Excess carotene can lead to sunlight sensitivity and other signs of toxicity. The Recommended Daily Allowance is 5,000 International Units. As a general rule, chronic lymphatic leukemia is best treated with chemotherapy, such as chlorambucil.

DEAR DR. GOTT: I'm 73 and have been impotent for two years. Is there medication I can purchase over-thecounter for my problem, or should I see a doctor?

DEAR READER: There are many causes for impotence, ranging from ological factors and poor circulation to side effects from prescrippreferably a urologist, for diagnosis and treatment. Appropriate therapy depends on the cause, and no over-thecounter remedy is available for treating impotence, which is a symptom,

DEAR DR. GOTT: What are the differences between a cold, influenza and pneumonia, and what are the treatments for each?

DEAR READER: Because this important topic is so complicated, I've chosen to answer in three installments, of which this is the first.

The common cold, medically known as coryza, is a self-limited virus infection of the upper respiratory

More than 100 types of rhinovirus have been identified as causes of coryza; any one (or combination) produces symptoms. In addition, the common cold can be caused by many other kinds of virus, including syncy-tial, adeno-, echo- and Coxsackie viruses. Thus, the common cold is a dis-

tinct ailment, caused by a multitude of potential microbes, all of which are different. This is probably why having a cold does not grant immunity from soon as we recover from one type of virus infection, other viruses are waiting in the wings to cause another

round of symptoms.
Scientists do not know what makes us susceptible to colds. For example, chilling the body will not by itself lead to coryza. However, fatigue, stress and other factors certainly play a

To a large extent, whether or not you catch a cold depends on the amount of exposure. Since the viruses are spread by direct contact (hand-tomouth and water droplets, such as sneezing), you can pretty well count on catching cold from someone in your family or from a person who

sneezes in your face. Unfortunately, patients can infect others for a day or so before symptoms appear, so it's virtually impossible to avoid person-to-person spread in a close environment, such as home or office, even though you may take pains to avoid contact with an infect-

After a short incubation period of one to three days, the illness begins as a "chemical" taste in the mouth or a scratchy throat, progressing to sore throat, runny nose and eyes, malaise and fever. These and other symptoms usually reach a peak in about three days, and then diminish. On occasion, fever may be quite high (102 F) and the sinus congestion extreme. A dry cough, which may last seven to 10

days, can be especially bothersome. The old aphorism "If you treat a cold, it will last a week; if you don't, it will last seven days" is true. The old saying "Feed a fever, starve a cold" is false. Vaccines and antibiotics are completely useless against the virus-es, nor does vitamin C make a whit of difference in this ubiquitous ailment.

Therapy merely relieves symp-toms, while the infection runs its course. Decongestants, nose sprays, cough medicine, aspirin (in adults) or acetaminophen (in children), rest and fluids are traditional and, to my knowledge, no one has improved on them. People get over colds once their immune systems identify the virus and produce anti-virus antibodies.

Coryza rarely leads to complications, although some patients (notably smokers) may develop sinus infection or bronchitis. These bacterial illnesses are treated with antibiotics.

People who exercise regularly should discontinue strenuous activity while they have colds. Some cold viruses affect the heart, leading to in-flammation (myocarditis), which is worsened by exertion. Therefore, when your body tells you to take it easy, do so.

Patients with colds owe their neighbors consideration by careful attention to coughing and sneezing, use of disposable tissues (because handker-chiefs can be highly infectious), meticulous avoidance of intimate contact (such as kissing and sharing food/eating utensils), and care of secretions (because nasal discharge and

saliva will spread the virus). To avoid catching cold, healthy people should frequently wash their (because finger-to-mouth spread is common), obtain additional rest, maintain a high fluid intake, reduce or eliminate the use of tobacco, and - for those most fortunate take a long and languishing vacation in the Bahamas during the winter months, at the height of the coryza season, when the rest of us are plodding along simply trying to stay out of the viruses' way.


