Of the 2000 tax receipts which are to be issued this year by the tax collector's department, only 763 receipts had been issued up to last Tuesday, with approximately 1200 more to follow by the first of February, provided the tax payers save the penalty for non-payment by that date. This means that an average of about 75 receipts will be issued per day, besides the work on the books, and as the last few days will see more payments, probably as high as 150 or 200
