

## \$1,000 above base for teacher salary finalized by board

A commitment to pay Snyder teachers a minimum of \$1,000 above state base pay was approved Tuesday by the school board on a split 4-3 vote.

The three voting against the measure indicated during discussion that they favored a higher pay range of \$1,500 above the minimum level required by state law.

The board had three options before them, levels of \$500, \$1,000 and \$1,500. The decision for \$1,000

DEAR DR. GOTT: Some months ago I had a prostate gland operation and in the process, the surgeon removed both testicles. Is there any possibility of having an erection?

DEAR READER: Ordinarily, orchiectomy (removal of the testicles) is an operation reserved for men with prostatic cancer. Many such cancers are hormone-dependent, meaning that they grow more quickly in the presence of the male hormone testosterone. Because the testicles are the prime source of testosterone production, they may have to be removed if prostatic cancer is to be controlled. Ask your doctor why you required this operation in conjunction with your prostatic surgery.

Since normal sexual functioning, including erection, depends on testosterone, I predict that you will develop impotence. This may not occur immediately, but it is a virtual certainty. You will also lose sexual interest because it, too, is dependent on testosterone. I wish your surgeon had given you this information before the operation.


In the event that your orchiectomy was not performed because of prostatic cancer, your doctor can advise you about whether hormone replacement (or other treatments for impotence) is appropriate for you.

DEAR DR COTT This seems hard to believe, but my 7-year-old has a problem with body odor. He has dry skin and atopic eczema which is made worse because of all the showers he takes. He's too young to use deodorant. What should he do?

DEAR READER: Unpleasant body odor in a youngster is very unusual because this condition is usually dependent on skin oils that are secreted after puberty.

Perhaps your son's problem is related to his eczema, a troublesome skin affliction often caused by aller-

DEAR DR. GOTT: I'm female, 69, and had a cracked vertebra which went undiagnosed for two months. Now my upper back is curved and I'm experiencing pain again. My doctor just tells me to wear a brace.

DEAR READER: Even if your cracked vertebra had been diagnosed promptly. I doubt it would have made any difference in the long run. Doctors cannot cast or splint a fractured backbone the way they can immobilize a broken leg or arm.

Given your age, I suspect that you are particularly susceptible to spinal fractures because of osteoporosis, post-menopausal bone softening from abnormal loss of calcium. If you have this condition, fractures can occur spontaneously, without apparent injury. Therefore, your spinal curvature could be due to additional fractures that are taking place without your knowledge. In this case, a brace may help relieve your pain. You also might

## **Corporate raider's** company leads new Fortune 500 members

DALLAS (AP) - The nation's are Houston-based Shell Oil Co., clearly reflected among the billion, and Tenneco Inc. at 24, Texas members of the latest Fortune 500 list of industrial companies, with several newcomers and shifts on the popular ranking directly related to corporate shakeups. For example Valhi Inc., the main holding company of billionaire Harold C. Simmons, last year bought control of NL Industries Inc., another Texas company. As a result of the deal, Valhi led nine Texas newcomers to the list, debuting at No. 118 with 1988 sales of \$2.25 billion, while NL Industries, which had been No. 253 in 1987, disappeared. Overall, Texas membership among the elite listing released Tuesday increased from 28 to 34 as only three companies fell out of the rankings. 

## Protecting computers from hackers crucial to business, experts say

## **Texas teachers slip further** in national salary rankings

teachers, complaining they have been ignored and are slipping behind teachers in other states, say they deserve a pay raise and a minimal state health insurance program.

A national survey released Tuesday showed that Texas fell to 31st in average teacher salary, the state's lowest ranking since 1980-81

Failing to respond to this decline "would be tantamount to a wholesale retreat from the race for educational excellence," said Charles N. Beard Jr., president of the Texas State Teachers Association.

But Beard said he hasn't had much luck in convincing state leaders.

"It seems that when we talk with them (legislators) individually they will all agree that the teachers are very deserving of a pay increase in this state.

"But yet when we mention that word called taxes, they all kind of want to turn away from it a little bit," Beard said.

A spokesman for Gov. Bill Clements said he would support a teacher pay raise if funds are available. Clements has said he will veto any tax increase.

"The primary consideration is would like to see all public employees receive a raise," said Reggie Bashur, Clements' press Later, state Treasurer Ann secretary.

## Cut your own taxes and save Moving provides valuable deduction

#### By George W. Smith, CPA

(10th of 14 parts)

If you moved to a new location during 1988 as a result of a transfer by your employer, found a new job in another community or are self-employed and moved for business-related reasons, you may have a valuable moving-expense deduction. There are two important qualifiers: distance and time

Your final moving-expense deducion is listed on line 19, Schedule A, Form 1040. Make sure your completed Form 3903 is attached to your

To meet the first requirement, the distance between the new job and the former residence must be at least 35 miles greater than the distance from the old job to the prior residence.

The time requirement varies according to your employment status. An employee must be employed full time for at least 39 weeks during the first 12 months immediately following the move. The self-employed individual must work for at least 78 weeks in the two years immediately following the move, with at least 39 of those weeks occurring within the first 12 months.

Moving expenses are deductible if the time test has not been met by the date your 1988 return is due, and, as an employee, if you expect to meet the time test by the end of 1989; or, for the self-employed, by the end of 1990. If, for some reason, the time test is not met by the appropriate deadline, the amount of the moving expense deduction must be reported as income for the year in which the test was not

met. Under extenuating circumstances, the time test can be waived. These

circumstances are: · Loss of job, if not due to willful misconduct;

 If you moved again in a transfer that was for your employer's benefit. · Disability or death; Note, however, that there would be

If the distance and time requirements are met, file Form 3903, Moving Expenses, to report your various expenses. The following is a list of ex-penses that qualify for a moving deduction

. The cost of moving household goods for all members of the family. In addition to the actual hauling charge, this could include charges for packing and crating, in-transit insurance and storage.

· Travel expenses for the worker and members of the family from the old location to the new one. This inludes meals, lodging and the cost of transportation. Meal expenses are limited to 80 percent of actual costs. If you travel by plane, train or bus, the actual fare can be claimed. If you travel by car, your transportation expenses can be claimed in one of two ways. Either total all out-of-pocket expenses for gasoline, oil, repairs, parking and tolls, or claim 9 cents a mile for each mile driven. If you use the mileage method, you may also deduct the actual cost for parking and tolls.

· Premove house-hunting trips made after obtaining the new job but before moving from the old residence to the new place of employment. Such costs include transportation, meals and lodging for all members of the family. It is not required that everyone travel together, or at the same time, and there is no limit on the number of house-hunting trips taken. The cost of house-hunting may be deducted even though no new residence is purchased.

• Temporary guarters. This is solely for meals and lodging for any period of 30 consecutive days after obtaining employment. Non-reimbursed meal expenses are limited to 80 percent of actual costs.

· Costs incurred in selling your old residence and buying a new one. Typical home-sale costs include the real estate broker's commission, closing costs, attorney fees and points charged on a mortgage if they are not deductible as interest. Any loss incurred in the sale of the home is not deductible.

The home-owning taxpayer has an option in determining how the selling expenses on the home are allocated The selling expenses can be used to reduce the gain, if any, on the sale of the first residence. Or purchase expenses can be added to the purchase price to increase the cost basis of the newly purchased home. Although the same dollars cannot be used twice, the taxpayer can apportion the figures and use them to his greatest advantage.

While there are no dollar limitations for the cost of moving your household goods and traveling from the old homestead is the cost must be fair and reasonable according to Internal Revenue Service rules.

The maximum deduction for premove house-hunting expenses, temporary quarters and qualified real-estate expenses is a total of \$3,000, of which not more than \$1,500 is allowed for the combined expenses of househunting trips and temporary living expenses

The purpose of this deduction is to eliminate your paying tax on money that was used for a business-related move. If the moving allowance is included in your W-2 Form, report it along with other wages and take a deduction for the total moving expenses on Form 3903. If the moving allowance is not covered on your W-2, you will receive from your employer Form 4782, Employee Moving Expense Information. This report will provide you with the required breakdown of your reimbursements.




