#### **Find artifacts**

AUSTIN (AP) — Digging for a large sewer line has unearthed evidence of what experts say could be an enormously important archeological find, including one of the first Indian settlements in the region.

The digging in Austin's Zilker Park has uncovered stone tools and other materials, possibly 7,000 to 8,000 years old. Experts believe the site could hold a treasure of artifacts dating back at least 10,000 years.

#### **Jobless rate**

DALLAS (AP) — Texas' unemployment rate fell to its lowest level in almost 412 years during March, despite the absence of any real growth in the job market, federal labor officials reported today.

Last month's decline to 6.0 percent matched the rate for November 1984 and reflected U.S. Bureau of Labor Statistics estimates that almost 7.8 million Texans are working.

"What we're seeing is people coming off the unemployment rolls and moving into jobs with no real growth in the labor force," said BLS analyst Nic Santangelo. "That, in



# Compensation is due Adams, attorney says

DALLAS (AP) — In the wake of a shakeup in the Dallas County District Attorney's office, the attorney for Randall Dale Adams said his client deserves some payback for being wrongly imprisoned for more than 12 years.

Randy Schaffer said Thursday he would like to see Adams compensated in some way, "whether it's the state of Texas, the city of Dallas... he was wrongfully incarcerated.

Schaffer, the Houston attorney who represented Adams during appeals of his 1977 capital murder conviction of a Dallas police officer, said this week's actions by the district attorney's office further stain the city's reputation for injustice.

"First Tom Landry and now Winfield Scott. Is no icon safe in Dallas?" said Schaffer

Scott, 48, who insulted a colleague and two judges during a last-minute battle to keep Adams behind bars, was fired by District Attorney John Vance Wednesday. Two other assistant prosecutors who worked on Adams' case resigned earlier in the week.

Vance told the Dallas Times Herald that Scott "just did not handle (the Adams case) the way I had told him to handle it ... He was convinced he was doing right and I was convinced he was doing wrong.

Scott and Vance did not return phone calls from The Associated casualty of the Adams case. Press

'Apparently, the powers that be just perceived that they could no longer keep him in the office. But I think he was just following orders," Schaffer said. "I guarantee you if he won the recusal hearing (to oust state district Judge Larry Baraka from the case), he wouldn't have

Adams, whose conviction for the 1976 slaying of a Dallas police officer was overturned last month, was freed after spending 121/2 years in prison, coming within three days of execution at one point

His case was resurrected with evidence uncovered in the Errol Morris documentary "The Thin Blue Line," which strongly suggested that Dallas officer Robert Wood was not slain by Adams, but by witness David Harris.

The Texas Court of Criminal Appeals ruled the prosecutor in 1977, Doug Mulder, suppressed evidence in the case while at least two witnesses lied on the stand

Schaffer said the lasting effects of Adams' wrongful in-carceration will be felt by the rest of the state.

"I talked to a colleague of mine in Dallas who was picking a jury for a murder case this week,' Schaffer said. "I understand during jury selection, 17 prospective jurors were slashed because they said they couldn't be fair to the state. One juror raised his hand and asked if Winfield Scott had anything to do with the case. I think that says a lot.'

> king? If you bear in mind that a defender with A-Q-J-9-8 would lead the queen against three no-trump, that should help you decide to win the trick with your king. That way, should East come on lead, he might not realize that a shift to hearts is the winning defensive play.

Having won the king of spades, declarer leads a diamond. West plays the queen. Is there a choice here? It does no harm for declarer to duck in dummy. On the actual layout of the cards. East may as well overtake partner's queen with the king, but if you give the opponents a chance to make a mistake they sometimes will. Furthermore, if declarer plays ace and another diamond, forcing East to win the king, West will have the opportunity to make a discard. If he throws a spade, East would have to be blind not to realize that a heart shift is mandatory. Suppose all your good efforts are for naught. East does overtake his partner's diamond queen and makes the right decision to switch to hearts. That's not the end of the deal, since East cannot lead a low heart. (South would simply play low and the king would be protected.) Instead, he must play the heart queen. Now declarer's king of hearts is swallowed up and the contract is defeated. ## **Dozens killed in Namibia** skirmishes; meeting called

WINDHOEK, Namibia (AP) -The commission overseeing Namibia's transition to independence has scheduled an emergency meeting as South African-backed security forces battled anew with black nationalist guerrillas. Dozens were reported killed.

There is a crisis in Namibia." said a State Department official in Washington who is monitoring the Namibia situation. "We've got a real problem.'

Chief Inspector Kierie du Rand, a South African who heads the Namibia territorial force, said 42 guerrillas were killed in clashes Thursday.

The fighting began Saturday when a cease-fire was to take effect to coincide with the beginning of Namibia's transition to independence under a U.N.sponsored plan.

Angola's state news agency quoted SWAPO defense spokesman Peter Muehihange as saying only 38 guerrillas had been killed and that nine were missing. He said 20 security force members were killed.

Foreign Minister Pik Botha of South Africa said his government remained committed to the independence plan. Pretoria has ruled the territory for 74 years.


Union officials said they hoped the deal could end the month-old walkout at the nation's seventhlargest airline and get Eastern flying a full schedule.

But some daunting hurdles remain for the deal, announced by Ueberroth and Lorenzo, chairman of Eastern's parent Texas Air Corp.

Eastern's major creditors and the U.S. Bankruptcy Court must approve it. In addition, the deal requires Eastern to reach new work agreements with its three unions by midnight Tuesday Ueberroth's group is seeking about \$210 million in pay cuts and work-rule concessions from the unions, sources close to the situation said. Lorenzo had sought \$125 million in concessions. "Under this agreement Eastern can be back flying in very short order," Lorenzo said at the news conference. "Eastern is prepared to be back flying within 24 hours ... after agreement is reached with the unions." The Miami-based carrier has been virtually grounded since March 4 by the machinists' strike that was supported by pilots and flight attendants and drove Eastern to file for bankruptcy protection and reorganization on March 9. 'To sum it up, it's a mammoth challenge," said Ueberroth, who organized the 1984 Summer Olympics in Los Angeles. "I'm convinced that there is a spirit amongst the people in the company that I can help bring together to help this airline.' Although Texas Air has endorsed the Ueberroth plan, others still might submit competing proposals to the bankruptcy court. Nevertheless, the Ueberroth deal was greeted with cheers by union members, who have vilified Lorenzo as a union buster. At a crowded union hall in Miami, members chanted "Hey, hey! Ho, ho! Lorenzo's got to go' and sang "Take Me Out To The Ballgame" as they heard of the sale. Union leaders were more cautious. "We're reviewing the documents and we'll be making a decision very shortly," said Charles Bryan, head of the machinists' local at Eastern, who was in Washington for the talks with Ueberroth. In New York, Lorenzo told reporters that under the proposed purchase Texas Air would get about \$200 million cash, would be forgiven \$185 million that it owes to Eastern and would get \$79 million worth of Eastern assets. A union analysis, on the other hand, reckons the value of Texas Air debt owed to Eastern at \$288.6 million. The debt includes loans to Texas Air and Eastern's sister carrier, Continental Airlines, to buy gates at airports in Newark, N.J., Houston and Cleveland, and for aircraft purchases.

## Cut your own taxes and save New law makes IRAs less appealing

It almost goes without saying that Social Security benefits alone will not always provide a comfortable source of income for retirement. Company pensions and personal savings are sometimes needed to supplement Social Security benefits.

In recent years, one of the best ways to save for retirement was through individual retirement accounts, because contributions to IRAs could be deducted from taxable income, thereby saving current income tax. Also, earnings from IRAs were not subject to current tax. Although IRAs will continue to be an important source of retirement savings for some, dramatic changes in the tax rules have minimized their use for others.

The Tax Reform Act of 1986 changed the rules for IRAs. An individual who is not an "active participant" in a qualified retirement plan may continue to make deductible IRA contributions as allowed in the past. This means that up to \$2,000 may be contributed to an IRA. If you have earnings of less than \$2,000, you may contribute up to 100 percent of earnings. You may not make an IRA contribution based on investment income; you must have earnings from employment or net earnings from self-employment. However, you may treat alimony as earnings.

If you are an active participant in a qualified retirement plan, you may claim a full IRA deduction only if your adjusted gross income is \$25,000 or less for singles; \$40,000 or less on a joint return. A partial IRA deduction is allowed for singles with adjusted income between \$25.000 and \$35,000 and for married filing jointly with adjusted gross income between \$40,000 and \$50,000. No IRA deduc- ed to either spouse. However, in figur-

tion is allowed for an active participant who is single with adjusted gross income exceeding \$35,000 or for married individuals filing jointly with adjusted gross income exceeding \$50,000.

Taxpayers who are allowed a partial deduction may figure the maximum amount allowed by using a formula that can be found with the instructions to their tax return.

Active participants whose adjusted gross incomes preclude deductible contributions are permitted to make non-deductible contributions. Form 8606, Non-deductible IRA Contributions, IRA Basis and Non-taxable IRA Distributions, must be filled out and filed with your tax return. Earnings on non-deductible contributions may accumulate free from current taxation.

Total contributions to an IRA for one individual may not exceed \$2,000 (or 100 percent of compensation if less than \$2,000) in a year. A spousal IRA may not exceed \$2,250 for both SDOUSES.

If earnings are less than \$2,000, the deduction may not exceed earnings. If the maximum contribution arrived at is not a multiple of \$10, then it is rounded up to the next highest \$10. If the result of the formula is more than zero but less than \$200, the deduction limit is automatically \$200. An IRA deduction goes on Form 1040A, lines 12a-c, or Form 1040, lines 25a-b.

An IRA for you and your spouse: If ou work but your spouse doesn't, contributions may be made for you and your spouse. The maximum contribution is \$2,250. A working spouse with low earnings may elect to be treated as having no compensation, thereby becoming eligible to receive a spousal IRA contribution. The spousal IRA contribution may be divided between spouses in any manner they wish as long as no more than \$2,000 is allocat-

ing the maximum deduction contribution, the adjusted gross-income limits must be taken into account.

Non-deductible contributions: A decision on whether to make non-deductible contributions depends on several factors, such as the availability of cash and the opportunity to earn tax-deferred income outside the IRA. Most importantly, the decision is

influenced by the tax treatment of IRA distributions. If only deductible contributions have been made all along, then all distributions from the IRA are treated as ordinary income. If both deductible and non-deductible contributions are made, a distribution will be treated as partly out of deductible contributions and account earnings and partly out of non-deductible contributions. Only the portion of the distribution that relates to non-deductible contributions is tax

This makes sense, since it is a return of previously taxed dollars. But what it really means is that if you put in non-deductible contributions, you may not earmark those dollars when you make withdrawals. Thus, your after-tax dollars are tied up. If you anticipate a need for those dollars in the future, you may want to consider other tax-free or tax-deferred investments, such as tax-exempt bonds or certain life insurance products.

PORT-AU-PRINCE, Haiti (AP) — Loyalist troops killed four rebel soldiers with cannon fire, witnesses said, and the U.S. ambassador offered Washington's support for the embattled government of Haitian leader Lt. Gen. Prosper Avril.

# DR. GOTT PETER GOTT, M.D.

#### By Peter H. Gott, M.D.

DEAR DR. GOTT: My 40th birthday is coming up. Is there anything different I should be doing from now on to maintain my health? What tests should I get for "baseline" information, and what schedule of tests should I have regularly now?

DEAR READER: The answer to your questions could best be provided by your personal physician, who knows the state of your general health and can suggest an appropriate program for health maintenance.

In general, a person approaching 40 should have the following: a complete history and physical examination (including a Pap test for women), a complete blood count (to detect anemia and abnormal white blood cells), a chemical screening battery (including cholesterol) and a test for hidden blood in the stool. Some doctors would add a cardiogram, a chest X-ray, mammogram and a flexible sigmoidoscopy to investigate the lower intestine

I think it's wise to address other issues as part of the health maintenance program: Patients should stop smoking, maintain an ideal body weight, be fastidious in selecting sexual partners, reduce dietary fat, engage in regular exercise, attempt to cut down on stress, limit alcohol consumption, avoid mind-altering drugs and be alert to subtle body changes that could indicate potential trouble.

If you have no current health problem and are taking good care of yourself, you do not - in my opinion need another exam until you are 50. (If you are a woman, you should have an annual Pap test and learn breast self-examination.)

Finally you will want to make sure that you have adequate health insurance.

DEAR DR. GOTT: One doctor told me I have Parkinson's disease, another said it was a tremor. What concerns me is that my grandson, 12, has the same problem with shaking hands. Isn't he too young for this?

DEAR READER: Your grandson is too young for Parkinson's disease, a progressive neurological disorder, usually beginning after age 40, marked by slow movements, muscular rigidity and resting tremor.

Perhaps you and your grandson have benign hereditary tremor. This is an annoying but harmless tremor that affects the hands, head and voice; it runs in families and tends to worsen with stress and age. Mild tranquilizers will often reduce the severity of this common affliction.

Perhaps you and your grandson should be examined by a neurologist who can establish the cause of your difficulties.

DEAR DR. GOTT: About a year ago my tongue started burning. I've tried vitamins, herbal teas, antibiotics and it's still going on. What else can I do? DEAR READER: Glossitis, or tongue inflammation, can cause burning and has many causes, including irritation and infection. Badly fitting dentures or the chronic use of astringent mouth washes can irritate the tongue; many types of bacteria and yeasts are associated with glossitis.

Also, vitamin deficiencies (especially B-12 deficiency) can cause the condition. One variant of the disease, Moeller's glossitis, is a chronic tongue inflammation seen primarily in middle-aged women. Its cause is unknown.
