Sherman County Director resigns from North Plains GCD Board

County board representative, Wesley Spurlock. Spurlock submitted his resignation citing other obligations that are interfering with his ability to devote the time necessary to do the job. Spurlock serves as the finance chairman of the National Corn Growers Association Board. He is a liaison to the National Cattlemen's Beef Association and also an elected board member of the Texas Corn Producers Association and is serving as treasurer. He has served on the Texas State Technical Committee in cooperation with Farm Service Agency. Spurlock has represented Sherman County on the North Plains GCD Board for ten years. Wesley's father. Neal Spurlock represented the county on the board from 1982 until Wesley took over the seat in 2003. Spurlock recommend Justin Crownover of Stratford to complete the remainder of his term. The board voted to accept the recommendation pending Crownover's acceptance of the appointment.

The General Manager presented a draft proposed amendments to the District's rules for discussion by the board. Over the next months the board will review amendment options to the District's rules to achieve the District's desired future conditions for the Ogallala and Dockum aquifers. The board will propose rules for public comment later in 2013.

In other business, the board voted unanimously to reject the application of a well owner for an exception to Rule 2.1 (Classification, Spacing, Density, and Production Provisions) Paragraph A2 (Property Line Spacing Easement). The owner had declared the well abandoned and plugged with the District in 1975. Since the well is registered as abandoned the District requires the well to be permitted as a new well. However, the owner has been unable to secure the required property line easements necessary to legally permit the well under current District rules.

Another application for an exception to Rule 2.1 (Classification, Spacing, Density, and Production Provisions) was also not approved because the applicant drilled the well as permitted by the District and there was no need for the exception. The owner can continue to use the well as the owner had originally intended. The exception to Paragraph A (Well Spacing) was filed by a well owner on the grounds that the well spacing issue only affected the owner's property and would not conflict with any other well or property line spacing rules.

The board received several reports including a legislative report on relevant bills filed during the ^{83rd} Texas Legislature, a report from Texas AgriLife Research regarding activities at the District's research field, and a report regarding the District's 200-12 demonstration program and High Plains Initiative. The board also discussed the need for additional personnel to enhance the District's Conservation Projects and Programs, and directed the General Manager to solicit applications the fill that need

Texas Wheat Board to Hold Biennial Election

AMARILLO, Texas - The Texas Wheat Producers Board (TWPB) is holding its biennial election to elect five board members to fill expiring positions. The election, to be held by mail, officially begins March 23, 2013 and will conclude April 9, 2013

Terms expiring in 2013 include Cagle Kendrick of District I, Tommy Womack of District II, Fred Dwyer of District III, Ken Davis of District IV, and Jack Norman also of District IV.

Any person who is engaged in commercial wheat production in Texas is eligible to vote for the district in which they reside. This includes owners of farms and their tenants and share croppers if they are subject to paying the assessment that is collected on wheat within the following counties:

District I: Dallam, Sherman, Ochiltree, Lipscomb, Hansford, Roberts, Moore, Hartley, Hutchinson and Gray. District II: Carson, Potter, Oldham, Deaf Smith, Randall, Armstrong, Briscoe, Swisher, Castro, Parmer, Hale and

District III: Childress, Hardeman, Foard, Knox, Throckmorton, Haskell, Archer, Baylor, Wilbarger, Wichita, Young and Clay.

District IV: All other counties in Texas.

Ballots are available from the Texas AgriLife Extension Service and Farm Service Agency offices in each Texas county, local elevators or by mail from the TWPB office between March 23, 2013 and April 9, 2013. Ballots must be mailed to the TWPB, 5405 West 1-40, Amarillo, Texas 79106, and will not be valid with a postmark date later than April 9, 2013.

Collin Bowers of Spearman, David Cleavinger of Wildorado, Glen Gibson of Lometa, Ron Kuehler of Groom, Scott McGarraugh of Perryton, Gary Murphy of Dawson, Ben Scholz of Wylie and Freddie Streit of

Board members are responsible for the allocation of funds from a state-wide wheat producer assessment of two cents per bushel.
