## Hit & Run Accident

Last Thursday night, around 10:30pm, Sheriff Powell was returning from a meeting in Perryton when he noticed a vehicle sitting in a field on the south side of Highway 15, just west of County Road 24. Sheriff Powell stopped and immediately noticed the small SUV had severe damage to the back-end and there was an elderly gentleman sitting in the drivers' seat. Stratford EMS, Stratford Fire Department, and Texas DPS responded to the Sheriff's call for assistance. Apparently, the driver, who resides in Boise City, was traveling nome on Hwy 15, when another vehicle came north on CR 24, crossed 15, and collided with the SUV. Deputies and Fire Department Personnel canvased the area, but found only tire marks from the second vehicle. The driver refused transport and was released to a friend. ## Tax Deferral Available for **Elderly Homeowners**

Texans aged 65 or older can postpone paying delinquent and current taxes on their homes. They can take advantage of a tax option called "over-65 deferral" by signing an affidavit at the Sherman County Appraisal District office.

If the affidavit is on file, an older homeowner cannot lose a homestead because of delinquent taxes. Once a homeowner files an over-65 tax deferral affidavit with the appraisal district, no taxing unit can start or continue a lawsuit for delinquent taxes as long as that person owns and lives in that home. The tax deferral only postpones paying delinquent taxes on the home; it does not cancel them. Penalties and interest will continue to accrue on the deferred property.

This deferral applies only to homesteaded property. It does not include other real property or personal property taxes.

# Multi-use exemption applies to some taxpayers

Texas Property Tax Code Sec. 11.254, provides for an individual to exempt one passenger car or light truck from personal property taxes if the vehicle is used for both business and personal purposes.

11.254. Motor Vehicle Used for Production of Income and for Personal Activities

- (a) Except as provided by Subsection (c), an individual is entitled to an exemption from taxation of one motor vehicle owned by the individual that is used in the course of the individual's occupation or profession and is also used for personal activities of the owner that do not involve the production of income.
- (b) In this section, "motor vehicle" means a passenger car or light truck as those terms are defined by Section 502.001, Transportation Code.
- (C) A person who has been granted or applied for an exemption under this section may not apply for another exemption under this section until after the application or exemption has been denied.
- (d) This section does not apply to a motor vehicle used to transport passengers for hire.

To qualify for the exemption individuals need to fill out an application form available from the appraisal office at 402 N. Third Street in Stratford. The exemption form must be filed prior to April 30. Annual Renewal of this exemption is no longer required (Sec.1 1.43c). However the exemption is for a specific vehicle, so if you change vehicles or replace the tag you must file a new exemption form.

Income producing vehicles are and continue to be taxable. The law allows the local taxing jurisdictions to choose to tax personal vehicles. The legislature did not exclude the multi-use exemption in jurisdictions that tax vehicles for personal use.

# Remember to "Render!" Taxable property renditions are due April 15.

#### Does this apply to you?

If you own tangible personal property that is used to produce income, such as the equipment or inventory owned by a business, it does.

#### What is a rendition?

A rendition is a report to your county appraisal district that lists all of the taxable property that you owned or controlled on Jan. 1 of this year. This often applies to furniture, fixtures, equipment or inventory owned by a business.

#### What are the advantages of filing?

- You give your opinion of your property's value.
- You record your correct mailing address so your tax bills will go to the right address.
- If your property's value depreciated, you can file a report of decreased value.

#### What is the deadline?

- The last day for filing 2013 renditions is April 15.
- An automatic extension is available if requested in writing by the April 15 deadline.
- The chief appraiser may grant an additional 15 days after the deadline for an owner who shows good cause in writing.

#### REMEMBER!!

Filing is your responsibility. If you render late, don't render or file an incomplete or false rendition, you may face a 10 to 50 percent penalty.





#### Sherman County FSA Announces 45th General Sign-Up for the Conservation Reserve Program

(Stratford, TX), Feb. 28, 2013 -- Sherman County Farm Service Agency (FSA) Executive Director Rebecca Lowe announced today that FSA will conduct a four-week Conservation Reserve Program (CRP) general sign-up beginning May 20 and ending on June 14.

"It continues to be our goal to ensure that we use CRP to address our most critical resource issues" said Lowe. "In 2012, Texas experienced the worst drought in 60 years. CRP protected environmentally sensitive lands from washing or blowing away. It gave ranchers extra grazing land when they needed it. I expect there will be strong competition to enroll or re-enroll acres into CRP, so I urge Sherman County producers to maximize their environmental benefits and make sure their offers are cost-effective."


In addition to erosion control, CRP provides significant water quality benefits including reduced nutrients and sediment loadings and adverse consequences associated with floods as well as expanded and enhanced wildlife habitat.

Currently, about 27 million acres are enrolled in CRP nationwide; more than 3 million of these acres are enrolled in Texas. CRP is a voluntary program available to agricultural producers to help them safeguard environmentally sensitive land. Producers enrolled in CRP plant long-term, resource-conserving covers to improve the quality of water, control soil erosion and enhance wildlife habitat. Contracts on an estimated 3.3 million acres of CRP nationwide are set to expire on Sept. 30, 2013, and more than 362,000 of those expiring acres are in Texas. Producers with expiring contracts or producers with environmentally sensitive land are encouraged to evaluate their options under CRP.

Sherman County currently has 87,680.2 acres enrolled in CRP and 10,954.6 of those acres are set to expire on Sept. 30, 2013.

Producers that are accepted in the sign-up can receive cost-share assistance for planting covers and receive an annual rental payment for the length of the contract (10-15 years). Producers also are encouraged to look into CRP's other enrollment opportunities offered on a continuous, non-competitive, sign-up basis. Continuous sign-ups often provide additional financial assistance. Those sign-up dates will be announced later.
