### **Sherman County Appraisal District Board of Directors Holds meeting**

The Sherman County Appraisal District Board of Directors met on Friday. January 18. 2013 in the appraisal district board room. Board members present were Roger Wells. Dana Buckles, Tim Hudson, Brad McBryde, Tom Moore, Mel Yates, Valerie McAlister, and Chief Appraiser Teresa Edmond. Mike Grotegut was not present.

The meeting was called to order at 7:05 a.m. by Roger Wells. Moore moved that Wells serve as chairman and Buckles as secretary of the board for 2013. Hudson seconded the motion, and the motion passed. The minutes of the December 7 meeting were presented. Yates moved that the minutes be approved, and Moore seconded the motion. The motion passed.

The December financial report and bills were presented and reviewed. Hudson moved that the report be approved and the bills be paid. Buckles seconded the motion and the motion passed.

The budget funds remaining in the Legal Expense account for 2012 were discussed. Edmond requested that the board consider retaining some of these funds since there are three pending lawsuits. After discussion, Hudson moved that the \$1850 balance in the 2012 Legal Expense budget be retained for the Legal Fund Balance. Yates seconded the motion, and the motion passed.

Preliminary Line Item Adjustments for the 2012 budget were presented and discussed. The Contingency Allowance is adequate for these adjustments. Yates moved that these adjustments be approved as presented. Buckles seconded the motion, and the motion passed

Appraisal Review Board members for 2013 need to be appointed. Board members suggested people for Edmond to contact about serving on the ARB. Moore moved that the first two people that agree to serve on the ARB be appointed. Hudson seconded the motion, and the motion passed. By law, the appraisal district board appoints the ARB officers. The board agreed to appoint the same ARB officers as last year. These officers are: Craig Cartrite, Chairman; Cindy Miller, Vice Chairman; and Jo Hinds, Secretary.

The following meeting dates for 2013 were selected: March 15, May 17, September 6, and December 20 at 7:00 am.

Chief Appraiser Edmond reported that second statements for 2012 taxes and delinquent tax statements were recently mailed. Renditions for 2013 have also been mailed. The role of the Agricultural Advisory Committee was discussed, and board members suggested Do you need help with computers? names for the 2013 Ag Advisory Committee members. There being no further business. Do you want to upgrade your job Hudson moved that the meeting adjourn. Buckles seconded the motion and the meeting



### Develop Landscape to Conserve Water

#### By Brad Easterling

With hot, dry weather looming ahead, homeowners and others involved in landscape development should focus on water conservation.

Water conservation can be practiced in all areas of landscape development and maintenance, including plant selection, irrigation practices and equipment, and soil preparations. These practices can be aesthetic as well as practical.

Homeowners can lower their landscape water usage in several ways:

--Using native and adapted plants. Native plants often thrive on existing growth conditions and reduce the need for extra irrigation. Many plants have been introduced that show adaptability to soil, rainfall and temperature conditions.

-- Taking advantage of innovations in irrigation practices and equipment. The landscape irrigation business is experiencing a revolution, with new timing devices, low pressure systems, drip irrigation and other highly specialized water devices focusing on more efficient water usage. Irrigation systems and small ponds and fountains also can effectively use water as an aesthetic addition to a landscape.

--Using mulches for insulation. By providing an insulating layer between the sun and soil, mulches prevent rapid drying and lower soil temperature in hot weather, which keeps the top soil from crusting or hardening. Low-cost materials such as hay, grass clippings, bark and pine needles are excellent for mulching and can add appeal with texture and color.

--Properly preparing the soil. When soil has been loosened and improved with plenty of organic material, such as peat.

#### TEXMATI PECAN RICE STUFFING 3 cups cooked Texmati White or Brown rice 1/4 cup margarine 3/4 cup chopped onion 3/4 cup chopped celery 1/2 cup chopped pecans, toasted 1/4 cup chopped parsley 1/2 teaspoon salt (or to taste) 1/4 teaspoon pepper 1 teaspoon poultry seasoning (or to taste)

In large skillet, sauté onions and celery in margarine until tender. Stir in remaining ingredients. mixing well. Spoon into casserole: cover tightly and bake at 375 degrees for 15-20 minutes.

#### CRANBERRY PECAN RICE PILAF

2 tablespoons butter or margarine 1 cup uncooked Texmati White Rice

1 3/4 cups chicken broth
1 cup grated Parmesan cheese
1/2 cup dried cranberries
1/2 cup chopped pecans, toasted
1/4 cup sliced green onions
Salt and ground black pepper, to

taste

Melt butter in 2-quart saucepan over medium heat. Add rice; cook and stir 2 to 3 minutes. Add broth and heat to boiling; stir once or twice. Reduce heat; cover and simmer 20 minutes or until liquid is absorbed. Remove from heat. Stir in cheese, cranberries, pecans and onions. Season to taste with salt and pepper.


### Hope Fest Banquet Thursday, April 18th

pine bark or compost, it will hold significantly more moisture and release it over a longer period of time. However, organic materials break down over time and need to be supplemented. A compost pile can be a good source of these materials, allowing the homeowner to recycle leaves, grass clippings and other waste to improve the soil.



### Remember to "Render!" Taxable property renditions are due April 15.

#### Does this apply to you?

If you own tangible personal property that is used to produce income, such as the equipment or inventory owned by a business, it does.

#### What is a rendition?

A rendition is a report to your county appraisal district that lists all of the taxable property that you owned or controlled on Jan. 1 of this year. This often applies to furniture, fixtures, equipment or inventory owned by a business.

#### What are the advantages of filing?

- You give your opinion of your property's value.
- You record your correct mailing address so your tax bills will go to the right address.
- If your property's value depreciated, you can file a report of decreased value.

#### What is the deadline?

• The last day for filing 2013 renditions is April 15.

- An automatic extension is available if requested in writing by the April 15 deadline.
- The chief appraiser may grant an additional 15 days after the deadline for an owner who shows good cause in writing.

#### **REMEMBER!!**

Filing is your responsibility. If you render late, don't render or file an incomplete or false rendition, you may face a 10 to 50 percent penalty.

### Great Plains Ag Credit Declares \$4.78 Million Patronage

AMARILLO. Texas - Great Plains Ag Credit. an agricultural lending cooperative, recently declared a \$4.78 million patronage to its customers. The amount is a combination of cash and equity allocation. Customers received checks in late March. Patronage payments are based on the amount of business a borrower does with the co-op and lower the borrowers' effective interest rate. As a cooperative, Great Plains Ag Credit is owned by its borrower stockholders. When the co-op performs well, it shares its earnings with the stockholders.



According to Congressional procedure, it was introduced twice more in 1993 and 1994. and then became permanent. without the need for yearly introduction.

Week" Telecommunications and "International Public Safety Week." Telecommunicator's The Congressional resolution also stated there were more than "500,000 telecommunications specialists." although other estimates put the number of dispatchers at just over 200,000. The Congressional figure may include support personnel and perhaps even those in the commercial sector public of safety communications.





### Help Us Help You: Your Guide to Calling 9-1-1 Emergency Services



#### 9-1-1 NEEDS TO KNOW WHERE TO GO

- When calling 9-1-1 one of the first things you'll be asked to provide is the location of the emergency you're reporting.
- The call taker may not automatically know your location or may ask you to confirm it
- Make sure you provide as much detail on your location as possible, such as landmarks, cross streets and mileposts.

#### KNOW YOUR CELL WELL

- The current 9-1-1 system is designed for voice communications only.
- Texting 9-1-1 is not an option in most locales; you must dial 9-1-1 and speak with a call/taker
- Pull over when driving, if possible. This reduces the chance of a dropped call.
- Lock your keypad when you're not using your phone, so 9-1-1 isn't dialed by mistake. For the same reason, don't put 9-1.1 on speed dial
- Do not give old phones to children as toys. A wireless phone with no active service can still call 9-1-1
- If you accidentally call 9-1-1 stay on the line and tell the call taker that you do not have an emergency
- Calling 9-1-1 from a cell phone is always free and it is never necessary to dial an area code.

#### 9-1-1 IS FOR EMERGENCY USE ONLY

- Call 9-1-1 for emergencies only. It is appropriate to call 9-1-1 when you need to save a life. Istop a crime or report a fire.
- 9-1-1 is the right number to call in an emergency

when a prompt response is needed.

 If you are not sure you have an emergency to report, call 9-1-1 and let the call taker decide.

### KNOW HOW TO USE 9-1-1 WITH THE PHONE YOU OWN

- Before you need help in an emergency, be sure to understand how the type of phone you use affects your call to 9-1-1. It is important to know the capabilities of the device you are using (landline, cellular VoIP)
- Cell phones may not automatically tell 9-1-1 where you are so be prepared to provide detailed information about your location.

#### REMAIN CALM, BE PREPARED

- Try to stay calm give information and follow all instructions.
- Protessional call-takers are trained to get information from you. Listen carefully and answer as concisely as possible.
- Remember that even if the dispatcher is still asking questions or giving instructions, help is on the way.

#### HELP 9-1-1 HELP YOU

- The more you know what to expect when you call 9-1-1, the faster 9-1-1 can get you the help you need
- You can save a life! Follow all instructions the ' 9-1'1 call taker gives you, and don't hang up until the call taker does. If you get cut off call back and explain that you were cut off.


