

Notice Of Tax Revenue Increase

The Sherman County Commissioners' Court conducted public hearings on August 31, 2012 and September 5, 2012 on a proposal to increase the total tax revenues of Sherman County from properties on the tax roll in the preceding year by 3.99981 percent.

The total tax revenue raised last year at last year's tax rate of 0.45631 for each \$100 of taxable value was \$3,145,574.

The total tax revenue proposed to be raised this year at the proposed tax rate of 0.43916 for each \$100 of taxable value, excluding tax revenue to be raised from new property added to the tax roll this year, is \$3,268,033.

FREE Pronghorn Youth Hunt

How would you like the rare opportunity to hunt a pronghorn buck, for free? If you are 13 to 17 years of age and have never hunted pronghorn before, here is your chance:

One lucky teenager will get the chance to go on a Moore county ranch and hunt a pronghorn buck. This event is completely free of charge and the selected teenager will be accompanied by the local Texas Parks and Wildlife Biologist as well as the local Texas Parks and Wildlife Game Warden. There's no hunting experience or equipment needed (only a hunting license).

If the winner is successful in harvesting a pronghorn buck, the winner's family has the option of getting a free European mount (donated by Frank Williams of Trophy Taxidermy of West Texas 4(806) 342-5000) or having the animal mounted at their own expense. The family also has the option of donating the meat or having it processed at their own expense.

"Thanks to the generous donation of a valuable pronghorn permit by a Moore County landowner, we are able to offer this fantastic opportunity" says Texas Parks and Wildlife Biologist Joachim Treptow. "Together with the local Game Warden we will show the winner how to shoot a rifle, talk about Pronghorn habitat and their biology and finally go out and try to harvest one".

"I've always felt that getting kids out and hunting is a great way of connecting the younger generation with nature" says Herschel Neal, the Moore county landowner that donated his permit for this event.


Stratford "Big Blue Band" Prepares for Upcoming Marching Season

Fit pie crust into a 9-inch tart pan with removable bottom and trim the edge OR a 9inch pie pan and flute the edge. Line the crust with a double sheet of foil. Bake in preheated 350°F oven for 10 minutes. Remove foil and cool slightly.

Combine sugar and flour in a medium bowl. Add eggs, ½ cup corn syrup, ½ cup lemon juice and vanilla. Beat until smooth. Pour into partially baked shell. Bake about 30 minutes until filling is golden brown. Cool. Refrigerate at least 2 hours.

Combine remaining 2 tablespoons corn syrup, 1 teaspoon lemon juice and lemon peel. Cover and set aside. Just before serving, arrange sliced berries on top of baked filling and drizzle with lemon mixture. Top each serving with whipped cream and a lemon slice, if desired.

ORDER PROHIBITING OUTDOOR BURNING

WHEREAS, the Sherman County Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning;

IT IS HEREBY ORDERED by the Commissioners' Court of Sherman County, pursuant to Local Government Code §352.081, and other applicable statutes, as follows:

- 1. All outdoor burning is prohibited in the unincorporated area of the county for 90 days from the effective date of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court.
- 2. This Court may terminate the prohibition on outdoor burning prior to the expiration of 90 days if this Court determines that drought conditions no longer exist The County Judge is also hereby designated, pursuant to Local Government Code 352.081(e) to terminate the prohibition on outdoor burning prior to the expiration of 90 days if the Judge determines that drought conditions no longer exist
- 3. This Order does not prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Commission on Environmental Quality for:
- 1. Firefighter training;
- 2. Public utility, natural gas pipeline or mining operations;
- 3. Planting or harvesting of agricultural crops; or
- 4. Burns that are conducted by a prescribed burn manager certified under National Resources Code 153.048, and meet the standards of Natural Resources Code 153.047
- 4. In accordance with local Government Code §352.081(h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.01
