

On Sunday, October 21<sup>st</sup> at 5 p.m. at the First United Methodist Church, Bret Barnard was honored by receiving his Eagle Scout Ceremony. Welcome was given by his father Pat Barnard. Presentation of Colors was presented by Troop 38. Marihoward Engelbrecht played the Star Spangled Banner. Invocation was given by Dr. Jim Smith. A.J. Riffe and Russell Spurlock presented the Scout Law. Andy Riffe told about the 100<sup>th</sup> Year of Eagle Scouts.

### THE HISTORY OF THE EAGLE SCOUT AWARD

This is the 100<sup>th</sup> year of the Eagle Scout Award, Scouting's highest rank. It is surprising that the Eagle rank was not a part of Scouting's earliest years. Robert Baden-Powell (the father of scouting) called for there to be a wolf badge which was a "reward for special distinction". This badge was so special that only one would be awarded each year.

After the Boy Scouts of America was founded in 1910, it was decided that America's National Bird should grace scouting's highest award. The 1911 "Handbook for Boys," the first publicly available edition, introduced the Eagle Scout award, as well as two lesser awards, Life and Star Scout.

At first, Life, Star and Eagle were not ranks, but special awards for earning merit badges. The Eagle Badge was earned when the Scout completed 21 merit badges. Arthur Rose Eldred earned his 21 merit badge in April of 1912. All that remained was a Board of Review. Eldred's review Board may have been the most intimidating in history, consisting of Chief Scout Executive James E. West, Chief Scout Earnest Thompson Seton, National Scout Commissioner Daniel Carter Beard and Wilbert E Longfellow of the U.S. Volunteer Lifesaving Corps. Eldred survived his high powered review and on August 21, 1912, West notified him that he was the Boy Scouts of America first Eagle Scout. He had to wait till Labor Day to receive his Badge because no medal had been created. Eldred's medal is now on display at the National Scouting Museum and has been the model for all the medals presented in the last 100 years. Incidentally, Bret earned his Eagle Award on August 23, 2012, 100 years and 2 days after Arthur Eldred.

Eagle Scout requirements have been strengthened steadily over the years and in 1965 the Eagle Service Project was added. In the words of the 1965 handbook, the Scout had to "Plan, Develop, and Carryout a service project helpful to his church, or synagogue, school, or community approved in advance by his Scoutmaster." The Eagle Scout Leadership service project was born.

The one-millionth Eagle Scout was awarded in 1982. To date, over 2 million boys have been awarded the Eagle Scout Award and approximately 50,000 boys their Eagle each year.

Bret talked about his Scouting Memories, and then Pat presented the Eagle Charge. Chris Riffe presented Bret's Eagle Award. All Eagle Scouts said the Eagle Pledge, Benediction was given by Dr. Jim Smith and Retrieval of Colors was presented by Troop 38. Refreshments were served in the Fellowship hall while folks in attendance congratulated Bret and his parents on his special accomplishment. Congratulations Bret, and thanks for inviting us. Glad to be there to help you celebrate your big moment.

## Annual Veteran's Day Assembly Nov. 12th

On behalf of the Stratford High School Student Council, we invite you to our annual Veterans Day assembly. Daniel Gade, a former U.S. Army Major who was severely wounded in Operation Iraqi Freedom has participated in the Warrior 100K with George W. Bush and worked in the upper levels of the White House. 



## Superintendent Appel selected for Leadership Academy

The Center for Executive Leadership at Lamar University has announced that, Hope Appel Superintendent at Texhoma Independent School District, Texhoma, Texas, is the recipient of a scholarship to attend the Lamar University Superintendent Academy, an advanced leadership training program on Lamar University's Beaumont campus. According to its Executive Director, Dr. Bob Thompson, participation in the Academy is by invitation only. The twenty-two superintendents in the 2012-2013 class were chosen from a list of approximately seventy-five nominees from Texas, Louisiana, and Oklahoma. To be selected is an honor not only to the superintendent, Thompson said, but also to his or her board and district. Without the support of forward-looking boards, no superintendent could have achieved the level of success and recognition necessary to be selected to the Academy.

At the Academy, Appel will review the latest technology for enhancing student learning, participate in advanced leadership training from some of the nation's foremost trainers of company executives, and get training in the Decision Support Center, a high tech laboratory for improving the speed and quality of management decision making. Appel will also have an opportunity for field trips to visit other school districts to review practices that have helped make those districts be successful. And since the Superintendent Academy is a post-graduate program; the superintendents who complete the yearlong program will receive doctoral level credit for their work.

Thompson says the knowledge superintendents glean from work in the Academy is immediately applicable to any district, regardless of size or location. To assist districts in incorporating these management concepts, the Academy will host a three day Visioning session in the spring for Academy superintendents and their boards where they will be led through joint leadership training and planning activities. They will also meet with boards and superintendents from similar sized districts to share ideas for increasing student achievement and developing a vision for the future.

The year-long Academy is designed, Thompson says, to provide the most professional growth opportunities with the least amount of time away from the district. Appel just returned from New York City where she visited schools in Harlem, the Bronx, and in Manhattan. "The school of New York City work hard to be unique instead of similar to each other. Each school we visited was a "C" rated school by New York standards. However, we saw teachers and administrators working hard to do what is best for children." During the visit to New York City, Appel was able to participate in the St. John Fischer Comparative Education Seminar held at Columbia University.

"I am honored by the nomination and selection to participate in the leadership academy. I look forward to helping Texhoma Schools meet the demands of student achievement" says Appel. This is Appel's third year as superintendent at Texhoma, Texas school district.







### KEY STEPS OUTLINED FOR HARVESTING COTTON

By Brad Easterling

While harvesting is the final operation in cotton production, it is also the most important for achieving high lint grades. What works best in one year is not necessarily the best for the next season. There are several factors that affect the performance or lack of performance of harvest-aid chemicals.

Some factors that increase the performance of harvest-aid chemicals include the following:

- Warm, calm, sunny weather
- Soil moisture relatively low but sufficient to maintain cotton plant in active growth condition without moisture stress
- Soil nitrogen levels relatively low
- Leaves active and uniformly expanded on plants
- Little or no secondary growth evident on plants
- Plants with a high percentage of open bolls that have shed some mature leaves

Conversely, some of the factors which negatively affect harvest-aid chemical performance include:

- Applications made under cool (below 60o F), cloudy conditions
- Prolonged periods of wet weather following treatment
- Plants in vegetative growth state with low fruit set
- Plants severely moisture stressed with tough, leathery leaves at time of treatment
- High soil moisture and nitrogen levels which contribute to rank, dense foliage and delayed maturity
- Plants exhibiting secondary growth (regrowth) following a "cutout" period
- Improper calibration of application rates and poor spray coverage

### CROP MATURITY

There are a number of key steps in cotton harvesting that will help produce a high quality crop:

- \*Follow a good harvest-aid program. The acreage treated at any one time should not exceed harvesting capacity. Strive for good coverage with careful sprayer calibration, and do not apply harvest-aid compounds ahead of unsettled weather.
- \*Harvest dry cotton. Seed cotton should be below 12 percent moisture for efficient harvest and safe storage. If seed coats are brittle and lint springs back after a hand squeeze, cotton is dry.
- \*Do not mix damp cotton with dry cotton. Also, the lint portion can lose and gain moisture much more rapidly than cottonseed.
- \*Brush strippers should be set to operate too aggressively. It's better to tag some cotton in the fields to minimize trash content and reduce baky bales.
- \*Premature crop termination has been shown to reduce lint yield, seed quality, micronaire, and fiber strength. Desiccants generally abruptly terminate fiber and plant development.

### Harvest-Aid Chemicals

Harvest aids are basically classed in three categories – desiccants, defoliant, and boll openers. Desiccants (paraquat formulations such as Gramoxone SL 2.0, Firestorm, Parazone and various tank-mixes with other products) dry down the plant by causing the cells to rupture. The old "rule of thumb" is that desiccants are normally applied when approximately 80 percent of the productive bolls are open, or at 2-3 nodes above cracked boll. However if sufficient numbers of bolls are mature, based on the knife test, then these chemicals may be applied to somewhat lower percent open boll fields.


Desiccants (paraquat formulations such as Gramoxone SL 2.0, Firestorm, Parazone and various tank-mixes with other products) dry down the plant by causing the cells to

rupture. The old "rule of thumb" is that desiccants are normally applied when approximately 80 percent of the productive bolls are open, or at 2-3 nodes above cracked boll. However if sufficient numbers of bolls are mature, based on the knife test, then these chemicals may be applied to somewhat lower percent open boll fields.


Ethephon based boll-opener products increase the boll opening rate to allow for more rapid harvesting of the crop. Primary ethephon materials include Prep and other related products such as Boll'd, Boll Buster, Setup, and SuperBoll. A few years ago, some enhanced boll opener-defoliant products were marketed. These include Finish 6 Pro and FirstPick which contain both ethephon and the synergists cyclanilide and urea sulfate, respectively. FirstPick is now being marketed by Nufarm. FirstPick is described as a "water soluble emulsifiable concentrate that has reduced corrosivity and different surfactants" than the older CottonQuik formulation. FirstPick performed similarly to CottonQuik in many trials in the High Plains. These chemicals affect natural plant processes associated with boll opening, but do not increase the rate of boll or fiber maturation. Once inside the plant, ethephon is converted to ethylene, a plant hormone which increases the rate of abscission layer formation. Many times, higher rates of ethephon products result in significant defoliation responses, but generally lower rates are used to obtain effective boll opening. The maximum labeled rate for ethephon products is 2 lb a.i./acre. Defoliant chemicals can be tank mixed with normal use rates of ethephon products to enhance defoliation. The response to ethephon is generally driven by temperatures. Under warmer conditions, reduced rates of ethephon may be used compared to cooler temperature regimes where higher rates are required to obtain similar plant responses. Ethephon product labels generally state that there should be "sufficient mature unopened bolls present to produce desired crop." Mature bolls are defined as "too hard to be dented when squeezed between the thumb and fingers, too hard to be sliced with a sharp knife, and when the seedcoat becomes light brown in color." Applications of boll opening products when bolls lack adequate maturity will likely result in reduced lint yield and micronaire. Results from several High Plains studies indicate that reductions occurred when applications were made at 25 percent open bolls, but not at 50 percent open bolls. Lint yields were reduced at least 10 percent, and micronaire was decreased by about 5 percent. A sequential application of paraquat (or other product with desiccant activity) is generally required to sufficiently condition the crop for stripper harvest.

These steps are generally only to be used for irrigated cotton unless we have had an unusually wet year and you are expecting a bumper dryland crop. Otherwise it is generally not practical or feasible to defoliate dryland cotton. Good harvest practices should still be followed.




# Stratford Elk Football 2012




