#### State law requires private sale vehicle buyers to title in 30 days or face financial penalties

Not transferring a vehicle in 30 days can cost Sherman County residents big money.

A new state law requires those who purchase vehicles in a private sale, whether it's in or out of state, to obtain a new title within 30 calendar days or face financial penalties.

"In some counties people are finding they owe hundreds of dollars in title penalties for failing to title within a month of purchasing their new car or truck," said Valerie McAlister, the tax assessor-collector for Sherman County. "Please don't let this happen to you," McAlister added.

Failure to title within the 30 days results in an automatic \$25 penalty, plus another \$25 for each month the title is late. There are no waivers for these penalties, which means the Sherman County Tax Office and the Texas Department of Motor Vehicles cannot reduce or forgive what you may owe.

The law does grant an additional 30 days to active-duty military personnel, which gives them 60 days to transfer the title before facing late title penalties.

While the penalties may seem harsh, it's important to remember this helps to protect you when you go to sell a vehicle. "When vehicle buyers don't put the title in their name when you sell them a car or truck, anything they may do with that vehicle is going to trace to your name," McAlister explained.

Sellers don't have to rely solely on the buyer to do the right thing.


Whenever you sell a vehicle yourself or even trade one in to a dealer, it is important to file the free Vehicle Transfer Notification on the TxDMV website, <u>www.TxDMV.gov</u>. "Sellers must file the Vehicle Transfer Notification within 30 days to receive the state-guaranteed protection from liability," McAlister said. "This way you cannot be held responsible for anything the buyer does with your old vehicle."

Buyers need to realize that titling the vehicle in their name also offers protection. "When a vehicle is titled in your name it gives you proof of ownership," McAlister said. McAlister offers these tips for people planning to buy or sell a vehicle.

#### **Texas Buyers**

• For your protection, never buy a vehicle in a private sale without receiving the title and a bill of sale.

• Be sure the seller gives you the title. If the title is from Texas, you can go to Title Check at

• The seller must sign, date and enter the odometer reading on the title back.

• Be sure the seller signs, dates and enters the sales price on Form 130-U. If you are purchasing the vehicle out of state, have the seller download the form from the Texas Department of Motor Vehicles website, www.TxDMV.gov.

• Go to your local county tax office within 30 days to title the vehicle in your name.

#### **Texas Sellers**

• Sign, date and enter the odometer reading on the back of the title.

• Fill out your section of the mandatory Form 130-U. The buyer needs this to title the vehicle out of your name.

• Take off the license plates and transfer them for free to the new vehicle you buy. (That plate number ties directly to your name.)

• File the Vehicle Transfer Notification online at <u>www.TxDMV.gov</u> to remove your liability for the vehicle in the event the buyer does not transfer the title. You only have 30 days to file the Vehicle Transfer Notification to receive this state-guaranteed removal of liability.




### **Quilt Show July 28**







### **Celebrating Confederate History**

The Sherman County Historical Commission with Rocky Sprott, Chaplin of the Plemons Shelby Camp 464 Amarillo, Texas, Sons of Confederate Veterans celebrated confederate History Month with the Stratford Community, Saturday, April 21.

Most of the counties west of the 100th longitude in Texas were organized after 1876, more than 10 years after the Civil War, and largely by ex-Confederate soldiers seeking a new start for their families. They were a great pioneer generation which laid the foundations of government, industry and agriculture upon which the prosperity of subsequent generations was built.

Those contributing to the service were: Sherman County Sheriff's Department, Stratford City Maintenance Department, Sherman Co. Historical Commission, The High Plains Brigade of the Texas Division of the Sons of Confederate Veterans and 26th Texas Cavalry Dismounted CSA. Stratford volunteers were John Hussman, Johnny Pulliam, Richard Ragsdale, and Michael Hipp.

The program began with the posting of the colors, an invocation by David Terry, pastor of First Methodist Church and a greeting by Sherman Co Historical Commission chairman, Gaynelle Riffe. The Confederate History and Heritage Month, Texas Senate Resolution No. 526 was read and Rocky Sprott gave a history of the 8 Confederate veterans buried in the Stratford Cemetery as well as acknowledging the 2 Federal veterans. A 21 gun salute was fired for the Confederates and the Sheriff's Dept. fired a 21 gun salute for the Federals.

Hang on - the mad dash to the finish line is here. It has been an unbelievable year. I am so proud of the accomplishments of our students and staff. Graduation is just around the corner.

April is full of competition and testing. As we turn to May, we begin our celebrations with banquets, honor assemblies and graduation. We have a lot to be proud of at Stratford school and none of it is possible without a supportive community.

While our district is financially sound, the board of trustees and the administration has been looking into the future – looking to ensure the quality of services that the district provides will continue. ratification election (TRE). By eliminating the personal property tax and having a successful voter-approved TRE, the district can realize \$375,000 of more revenue while giving overall tax relief to a large majority of taxpayers.

I encourage you to pull out your property tax bills out for 2011. Look at only the Stratford ISD levy and see what an additional 13 cents per \$100 would cost you. Then subtract the amount of personal property tax paid. Most taxpayers will pay less, while the school will replace some funding that the legislature cut. We will dig a little deeper on the how and why we are where we are in upcoming in Bird's Nest – 1 just want to get the conversation started as we look for the best ways to maximize our tax revenues and provide first-class education services at Stratford ISD . When you have questions, please come by a see me – these types of decisions affect all of us.

### "Pigeon Fever" in Horses Update

Contrary to what the name might imply, pigeons have nothing to do with transmission of the equine disease known as "pigeon fever", which is also called Dryland Distemper. "Pigeon Fever" causes abscesses and swelling in the horse's pectoral region (breast muscles) causing a "pigeon-like" appearance, and is caused by the bacteria Corynebacterium pseudotuberculosis. Pigeon fever is most common in dry areas of the Western United States, but cases diagnosed in other parts of the country may be on the increase.

Cases of pigeon fever tend to be seen more in summer and fall but can happen anytime of the year. While the Texas Animal Health Commission (TAHC) regulates a number of equine and livestock diseases, the TAHC has no specific authority to regulate pigeon fever and therefore does not require vets to report cases. However, the TAHC has noted an upswing in calls and questions about this disease. The Texas Veterinary Diagnostic Laboratory obtained over 350 positive cultures for C. pseudotuberculosis in 2011 compared with less than 100 cases each year from 2005-2010. The Veterinary Medical Teaching Hospital at Texas A&M diagnosed more than 4 times as many cases in 2011 compared with 2010. A number of factors could be at play, including the recent severe drought, as well as fly activity.

Horses affected by pigeon fever can show a variety of signs including fever, weight loss, swelling of the breast muscles or ventral abdomen (belly), and other areas of the body. Abscesses caused by the disease are usually external, and so the swelling is visible. Less commonly, the abscesses form inside the horse's body where they are more difficult to detect. Treatment of horses with internal abscesses can be difficult, with major complications possible. Prompt veterinary care greatly increases treatment success and reduces complications in any case of pigeon fever.

It is important to realize the bacteria can live for extended periods of time in dry soil. Research shows that flies carry the disease and are crucial to transmission, so good fly control is a must. Basic sanitation is also critical - affected horses should be isolated, and abscess drainage (pus) should be disposed of properly. The draining material contains large amounts of the bacteria and contaminates the area around the horse, potentially spreading the disease. It is also important to promptly treat any wounds that could become contaminated by flies or dirt.

Because of this infectious disease and many others that can affect your horse, the TAHC encourages you to call your veterinarian at the first sign of any illness or injury.

Additionally, if you organize an equine event, pigeon fever is one of many infectious diseases for which planning is encouraged. The California Department of Agriculture recently released a helpful Biosecurity Toolkit for Equine Events. They include tips to prevent the spread of abscess diseases like pigeon fever and strangles, as well as a wide variety of other infectious diseases.
