

SWCDS in State District I to **Elect TSSWCB Board Member**

(TEMPLE—April 25, 2011) Soil and water conservation districts in State District One will elect a member to the Texas State Soil and Water Conservation Board (TSSWCB) on Tuesday, May 3. The election will be held at 6 p.m. in Room 205 of the Pete & Nelda Laney Activities Center located on the campus of Wayland Baptist University in Plainview. State District One consists of 51 counties within which there are 49 soil and water conservation districts in the Panhandle Plains region of Texas.

The current TSSWCB member for State District One is Aubrey Russell of Panhandle, TX. Russell, who has been a member of the TSSWCB since May, 2003, runs farming and ranching operations in Carson and Roberts Counties.

"Since its beginning, the TSSWCB has been governed by five board members. Each respective board member is elected in a convention type election by delegates from soil and water conservation district directors within the state district that the member resides. However, with the enactment of S.B. 1828 by the 78th Legislature, two Governor Appointees also serve on the TSSWCB to create a seven-member board," said Rex Isom,

"Elections occur annually to comply with the soil conservation laws of Texas. The elections are held in state district conventions and TSSWCB members serve two-year staggered terms. Since this is an odd numbered year, TSSWCB member elections are being held in State Districts One, Three, and Five," added Isom.

SWCDS in State District I to Elect Board Member—page 2

Elected State Board members must be 18 years of age or older, hold title to farmland or ranchland, and be actively engaged in farming or ranching. The gubernatorial appointees must be actively engaged in the business of farming, animal husbandry, or other business related to agriculture and wholly or partly own or leases land used in connection with that business. They; however, may not be a member of the board of directors of a conservation

The TSSWCB is responsible for numerous natural resource conservation efforts, the most prominent of which is serving as the lead state agency for the prevention, management, and abatement of nonpoint source pollution resulting from agricultural and forestry-related

"In short, the services and programs provided by the TSSWCB target rural Texas farmers and ranchers through soil and water conservation districts, but the results of these services benefit all Texans. For example, soil and water conservation districts provide

technical assistance in cooperation with the USDA's Natural Resources Conservation Service (NRCS) to assist agricultural producers implement voluntary conservation plans that best address the capabilities of the land they operate," said Isom.

"In addition to on site soil and water conservation benefits to a farmer or rancher, the public enjoys residual benefits which includes wildlife enhancement as well as the prevention of sediment, pesticides, nutrients, bacteria and other contaminants from impairing Texas waters," added Isom.

The TSSWC B, which was organized in May 1939, has its state headquarters in Temple, Texas. Within the state there are 216 soil and water conservation districts.

CASA 69 is celebrating 25 years serving 700 abused and neglected children by hosting a special evening with speaker Dave Pelzer on Friday, April 29, at the Dumas High School Auditorium in Dumas. Court Appointed Special Advocates, or CASA, is a nonprofit organization that believes a child's right to a safe and permanent home should be acted upon by the court in a sensitive, expedient manner. CASA 69, Inc. provides trained community volunteers to represent the child's best interest in the court and serves children in the 69th Judicial District, which includes Dallam, Hartley, Sherman, and Moore Counties.

CASA was founded in 1976 by a Seattle Superior Court Judge who had become familiar with children "lost" in foster care. He then decided to recruit and train volunteers in the community to be fact finders and step into the courtroom to speak up for the child. In 1985, District Judge Bill Sheehan (69th Judicial District) learned of this program at a seminar for Juvenile Justice. He felt that a CASA program in the 69th Judicial District could help him also make quality decisions regarding the future of children in the court system that were abused and neglected. Because of Judge Sheehan's efforts, CASA 69 was born in 1986, and became the first rural CASA program in the United States. Judge Sheehan was also a founding member of Texas CASA in 1989, serving as its board president for several years

"I was on the Dallam County Child Welfare Board years ago when I first heard about CASA," says Lynn Wells, a volunteer from Stratford. "I knew I wanted to be a part of it though I had no idea of how it would bless me in the process. I've had an opportunity to help children who didn't have anyone who cared and needed that little bit

of stability in their lives."

"I've been with one particular family for 16 ¹/₂ years. They have gone through seven caseworkers in the foster system over the years, but I am the only one who has known them all the way through since they entered the system. I'm the only one who remembers what they like to do, where they like to eat, and where they like to go. That's what CASA is all about," says Lynn emphatically.

In honor of 25 years in this community, CASA would like to invite members of the community to a complimentary evening with Dave Pelzer, a man whose inspirational work has "...encouraged countless organizations and millions of individuals to recommit their efforts and remain steadfast to their personal convictions." Dave suffered extreme abuse at the hands of his mentally disturbed alcoholic mother, and nearly died as a child. Years later, his case was identified as one of the most gruesome and extreme forms of child abuse in California history at that time. Dave was placed in a series of foster homes at age 12, and finally, at age 18, enlisted in the Air Force. There, he was hand-picked to refuel the highly secretive SR-71 Blackbird and the F117 Stealth Fighter, both playing major roles in Operation Just Cause, Desert Shield, and Desert Storm. During this time Dave also made a point to serve in the community, and he was a recipient of the JC Penny Golden Rule Award, making him California Volunteer of the Year.

Dave is the author of several books, perhaps most famously A child Called It, and his books have been on the Best Sellers list for thirteen years combined. Among numerous awards, he has also been recognized for his service and achievements by Presidents Reagan, Bush, Clinton and George W. Bush. He is intent on bettering himself and also helping and encouraging others to overcome challenges and live life to the fullest.

CASA 69 will also display a "traveling memorial" at the event on April 29. The memorial is made up of tri-fold panels that are a tribute to children who have died because of abuse. Guests of the event are invited to bring a memento to place with the memorial which is traveling all across Texas.

Admission is free, but donations will be accepted, CASA 69 Executive Director Ann Bookout is excited about the event, saying, "We want as many people to attend as possible in order to hear Dave's powerful testimony and message about forgiveness. It will be a wonderful evening."

FORAGE MANAGEMENT FOR **COW-CALF PROGRAMS**

A ranch's forage system is the basis of successful cow-calf programs. The more effectively a forage system is managed, the greater the resulting animal

Many cows in Texas need a higher level of body condition at calving and breeding to improve reproductive performance and income.

Both the quantity and the quality of forage available to the cow largely determine her productivity, . her need for supplemental feed and the profitability of her

A typical cow-calf pair requires about six tons of forage a year. Unfertilized land typically will produce one to one and one-half tons of plant dry matter annually with an extra ton of forage generally being produced with each 50 pounds of actual nitrogen fertilizer. Land needed to produce feed for a cow-calf pair largely depends on added fertilization with needed rainfall and to some extent n the mature size of the cattle and the type of forage involved. Of course we generally do not apply much if any fertilizer to native pasture, but much higher production and stocking rates can be achieved by fertilizing improved grasses.

Quantity in pastures is measured by the volume of forage present. The rate of gain on growing cattle or the condition gain or loss on a cow is directly related to stocking rate - - acres of grazing available per cow - - or to the grazing pressure, the amount of forage dry matter available per acre for each 100 pounds of animal weight.

A cow's body condition score of five or more (at least 14 percent body fat) at calving and through breeding is required for good reproductive performance. Overstocking pastures is a common cause of poor body condition and reproductive failure.

A successful forage program will provide quantity and quality properly matched to the requirements of the cattle. Proper stocking, year-round mineral supplementation and timely use of protein supplements offer the greatest potential for economically improving body condition scores and rebreeding performance of beef

Next week I will discuss more on properly stocking pastures, determining body condition scores of cattle, and rebreeding.

From the Bird's Nest-April, 2011 By Jerry Birdsong Superintendent Stratford ISD

The clock is running out for the current school year. By most accounts it has been a successful school year. Our kids have done a great job inside and outside of the classroom. We put a lot of miles on vehicles but our students always give great effort and represent our school and community well.

Congratulations to Mary Allen Elementary and Stratford Junior High for being recognized as Title I, Part A Distinguished Schools for academic performance. The criterion for the recognition includes the number of low socio-economic students, exemplary school ratings and meeting adequate yearly progress. The principals and federal programs director recently attended a luncheon at the service center in Amarillo on behalf of their campuses.

The school finances situation continues to be the major topic. The doom and gloom numbers are still being discussed (and cussed). We are holding tight waiting to see what the actual numbers will be before we take any adverse action 1518189 concerning the district. It will be a busy summer preparing for the next school year. The state house recently passed its version of a two-year state budget and it is not very friendly to public education or any state services. The numbers are not very encouraging. I have seen model runs that would cut from \$690,000 up to \$1.2 million from the Stratford ISD revenue budget. I have shared with Rep. Price's office that these types of cuts would be devastating to our school district and community.

Fortunately, it is not yet a done deal. The senate has its own bill to work on and it is about \$10 billion (yes, billions) different from the house bill. Then there will be conference committees to compromise the two bills before going to the full legislature and then the governor. Also the comptroller will release new revenue numbers the first of May that will affect the budgets. There is still a great deal of work to be done. Wonder if they can get it all done by May 30 or will they require a

The district administration and board regretfully accepted four resignations from long-time employees whom have decided to retire. There are a lot of years of great teaching in our retirees. With the state budget crisis on our minds, the board remains supportive of maintaining small class sizes - protecting the classrooms for students. We will continue to replace grade-level teaching positions in the district.

The replacement process is not always easy. Our first consideration is whether we will replace or absorb. Or is there a more cost-effective way to provide the same services? Unfortunately, with the looming budget problems across the state, cost effectiveness and need became a major part of the decision. If we decide to fill, then we post job openings online and in the district's offices. Our campus principals become the primary agents to recruit new personnel to their campuses. Fortunately over the past few years we have been able to replace good people with other good people.

One of things that are being debated is the 22:1 class size. Our district has been committed to smaller class sizes for our students. We believe it improves the quality of the education that kids receive at Stratford ISD. Our performance on the state assessments has reflected that. I am sure that raising the 22:1 will save money, but quality and effectiveness will suffer. There will be less one-onone time with our kids in larger classes. We will take the financial resources available to us and do the best we can - we have excellent teachers, students and community.

There may come a time that you become involved - the legislators may need to hear from you concerning class sizes, retirement, state assessments, etc. The only message some of them are receiving is how much money the schools are wasting and how bad public schools are. We know that is not true. If you are looking for good news about Texas Public Schools, check out "Friends of Texas Public

Schools" at www.fotps.org. Great source for good news about public education. Our board continues to support the implementation of new technologies into our classroom. Our kids live in a technological world - it is a good thing we have professionals that look for ways to reach them. A large majority of our classrooms are equipped with interactive white boards. The document cameras and remote clickers that are being utilized in our classrooms are amazing.

Our FFA Livestock Judging Team became our first state qualifier this spring. Wright's Aggies will be traveling to College Station in May. No one seems to remember the last time Stratford had a judging team advance to state competition.

Then on the heels of that, SHS qualified another student for the UIL Academic State Meet. That competition will be in Austin during the month of May. Congratulations to the state qualifiers and good luck.

Our track athletes continue to advance toward state meets. We have had several district and area champions in track as well as golf. The regional track meet will be in Levelland the first of May. We can always expect a great effort for our

The Big Blue Band did an exceptional job at the concert/sightreading contest earlier this spring. The band received I in concert and II in sightreading - just one judge away from sweepstakes. The kids sounded great and I appreciate the work and efforts of the band directors.

The junior high bands also performed well in their contests. Both the seventh and eighth bands received I ratings in concert and sight-reading. Congratulations to the students and directors for a job well done.

It is an honor and a privilege for me to serve the community, parents, staff, and students of Stratford ISD. Stratford ISD has done a tremendous job of educating the kids of this community for many years. After completing graduation requirement, our kids have doors opened to them to pursue employment, military option or further their education. This is possible because of the excellent staff, along with the great support of the community. It is my pledge to you to continue this tradition of excellence.



2. The Presiding Judge shall appoint not less than two (2) but no more than five (5) qualified election clerks to serve and assist in conducting the Election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks.

POR CUANTO, el Consejo de administración del Distrito escolar independiente de Texhoma (el "Distrito") celebró una reunión especial el día 23 de febrero de 2011, estando dicha reunión abierta al público, y habiéndose dado aviso público de la hora, lugar y propósito de dicha reunión, según lo exige el Capítulo 551 del Código gubernamental de Texas; y

POR CUANTO, el Distrito considera aconsejable convocar las elecciones especiales (las "Elecciones") que aquí se ordenan, y,

POR CUANTO, en dicha reunión se declaró y determinó oficialmente que (1) es en interés público y del Distrito que la celebración de las elecciones especiales aquí convocadas, debería llevarse a cabo conjuntamente con la Ciudad de Texhoma, (la "Ciudad"); (2) la celebración de las elecciones aquí convocadas cumple los requisitos de elecciones conjuntas a tenor de la sección 271.001 y siguientes del Código electoral de Texas, y (3) es en interés público que el Distrito celebre las elecciones aquí convocadas el día 14 de mayo de 2011, fecha para la celebración de elecciones uniformes establecida en la sección 41.001(a) del Código electoral de Texas, y

AHORA, POR LO TANTO, EL CONSEJO DE ADMINISTRACIÓN DEL DISTRITO ORDENA:

• Las declaraciones contenidas en el preámbulo de esta Orden son fieles y correctas y han sido adoptadas como decisiones sobre cuestión de hecho y disposiciones operativas del presente documento. Se celebrarán elecciones especiales para la emisión de bonos (las "Elecciones") en el Distrito entre las 7:00 de la mañana y las 7:00 de la tarde, el día 14 de mayo de 2011. Dichas elecciones se llevarán a cabo conjuntamente con la Ciudad, de acuerdo con el Capítulo 271 y siguientes del Código electoral de

Texas, y del Acuerdo de elecciones conjuntas entre las Partes (el "Acuerdo de elecciones conjuntas"). Las Elecciones tendrán lugar en los siguientes centros electorales designado y se han nombrado a los siguientes oficiales electorales para celebrar dichas elecciones:

Texhoma Independent School District (Distrito escolar independiente de Texhoma) 4th and Denver Texhoma, TX 73949

Juez presidente: Mary Lou Johnson
Juez suplente: Olamae Rhoden

- Cada Juez presidente nombrará no menos de dos (2) ni más de cinco (5) secretarios electorales cualificados para servir y ayudar en la celebración de las elecciones, siempre que el Juez presidente ejerza sus funciones como tal, el Juez suplente será uno de dichos secretarios.
- La votación adelantada se realizará mediante comparecencia en persona en el Centro principal para la votación adelantada:

Texhoma Independent School District (Distrito escolar independiente de Texhoma) 4th and Denver Texhoma, TX 73949

La votación adelantada en ambos lugares se llevará a cabo durante el periodo requerido o permitido por la ley, desde el 2 de mayo de 2011 hasta el 10 de mayo de 2011, diariamente de 8:00 de la mañana à 12:00 del mediodía y de 1:00 de la tarde a 5:00 de la tarde. - Todos los electores cualificados que residan en el Distrito, tendrán derecho a votar en las elecciones.
