Attention: Important Information for our readers:

BACKGROUND: The Freedom of Information Act (FOIA) was signed into Federal law by congress in 1966, and has been amended several times. In 1996 it was amended to create electronic formats of these records. The State of Texas Legislature signed into STATE LAW the Public Information Act in 1996 which is now called the Open Records Act, making ALL records in control of any department head in any form of Government in the State of Texas (property records) Public Information & subject to being requested by anyone who wants a copy. Court Records do not fall under the Open Records Act because they have been determined to be records of the Judiciary and even they are open records they cannot be released; only the indexes can be which do not contain any personal information only names and these are not digitized.

What does this mean to you? Public Information (mainly oil and gas leases, State and Federal Tax Liens) contains PRIVATE INFORMATION such as your social security numbers and anyone that request copies from my office can get these records with your Social Security number on them. Attorney General Greg Abbott has given an opinion that even if these public records contain private information they are to be released to anyone who requests these records, unless, you request in witting that your social security number be redacted (obliterated so it cannot be read). I now have such a request for copies of all records in my office. I have no choice but to comply with this request since it is the law. When this person made his request I responded I don't have digitized indexes. He replied, "That's ok I have a building in India about the size of 2 city blocks and I have hundreds of Indians that index all day long & they will have all this indexed in a couple of weeks. He puts these copies of our records on the internet and charges a \$4.00 search fee plus \$2.00 per page for copies. If someone wants to pay a membership fee to search these records they pay \$ 500.00 per month and can make 250 copies for free, then the user has to pay \$5.00 per document searched and \$2.50 per page for copies. ANYONE can search these records. I believe that this is an open invitation to Identity Thieves. As you may know you can come to my office and search the records for free and the law requires me to charge you \$1.00 per page, as well as anyone who makes any copies from my records. Under the FOIA or the Open Records Act I have to give these copies to him for free. I am only allowed to charge him \$15.00 per hour to compile and copy this information. This hurts our County, our taxpayers, and our local businesses. I have roughly estimated that he will be obtaining around 313,000 copies for approximately 2-4 thousand dollars. The County & District Clerks Association tried desperately to get this changed in the last Legislative Session but was unsuccessful.

WHAT I NEED FROM EACH OF YOU IS the written request you must sign to redact your social Security numbers from the records, and I need them fast (by March 1st1. I have the forms in my office for you to fill out. I also need you to pass the word and let your friends & family know what the situation is, and help me get forms out to them. You may also request redaction for deceased family members because their identity an also be stolen. If you have any questions you may give me a call, the office number is 366-2371 and my cell number is 922-3592, you can also leave your email address on the answering machine and I can email you the forms you can fill them out and then drop them by the office. I need the original back. I am also going to attempt to put the form On the County's website www.co.sherman.tx.us so you can print it out. Please understand I have no choice, and no one hates this anymore than I do. This law needs to be changed to except the property records or make these people pay just like anyone else.

¼ cup butter

1 large onion, diced 3 carrots, chopped, about 1

½ cup flour 2 cups turkey or chicken broth

2 cups leftover turkey, diced 1 cup frozen peas

6 biscuits, 1 package readyto-bake biscuits

Preheat the oven to 400° F. In a large heavy skillet or saucepan, melt the butter over medium heat. Add the onion and carrots, and cook until soft and golden. Sprinkle in the flour and cook for an additional minute, then whisk in the stock vigorously to avoid any lumps. Whisk in the milk and bring to a simmer, then turn the heat to low and cook until thick but still saucy, stirring often, for 5-10 minutes. Stir in the turkey and peas, then season to taste with salt and pepper.

Arrange six ramekins on a baking sheet. Spoon the filling into the ramekins. Roll out the biscuits to fit the top of the pot pies and cover each ramekin. Bake until the crust is golden and the filling is bubbling, about 20 minutes.









USDA Designates 108 Counties in Texas as Primary Natural Disaster Areas

(COLLEGE STATION, TX) -January 16, 2014-- USDA Texas Farm Service Agency (FSA) Executive Director, Judith A. Canales, announced that 108 counties in Texas were declared a disaster on January 15, 2014, due to drought using the streamlined Secretarial Disaster Designation process. Under this designation, producers in any of the primary or contiguous disaster counties are eligible to apply for low interest emergency loans.

The streamlined disaster designation process issues a drought disaster declaration when a county has experienced a drought intensity value of at least a D2 (severe drought) level for eight consecutive weeks based on the U.S. Drought Monitor during the crop year.

Farmers and ranchers in the following counties in New Mexico are also eligible for disaster assistance because their counties are contiguous: Curry, Lea, Quay, Roosevelt and Union. Farmers and ranchers in the following counties in Oklahoma are also eligible for disaster assistance because their counties are contiguous: Beaver, Beckham, Cimarron, Cotton, Harmon, Jackson, Jefferson, Texas and Tillman.

"The disaster designation is welcome relief to producers because it allows all qualified operators in primary and contiguous counties to apply for a low interest emergency (EM) loan," said Canales.

Emergency loans help producers recover from production and physical losses due to drought, flooding and other natural disasters or quarantine.

Producers have eight months from the date of the declaration to apply for emergency loan assistance. FSA will consider each loan application on its own merits, taking into account the extent of losses, security available and repayment ability. Producers can borrow up to 100 percent of actual production or physical losses, to a maximum

(NAPS)-According to the Internal Revenue Service, more than 101 million income tax refunds were issued in 2013, averaging \$2,651 each. The average was a couple hundred dollars have their refund directly deposited into a bank account.

available on federal returns due April 15, 2014 include:

· Child and Dependent Care Credit-The maximum amount of child and dependent care expenses eligible for the credit is now \$3,000 if you have one child or \$6,000 if you have two or more children. These increased amounts are

·Child Tax Credit-The credit has been made permanent at \$1,000 per child under the age of 17 at the end of 2013. This credit may be claimed in addition to the Child and Dependent Care

Credit.
• Tuition and fees deduction—If you, your spouse or your dependent is enrolled in a postsecondary institution, you may be able to deduct tuition expenses as an adjustment to income, even if you don't itemize deductions. You generally take this deduction if you don't qualify for an education credit or other tax break for the same expenses

• American Opportunity Tax Credit—The maximum amount of this credit for the first four years of postsecondary education costs in a degree or certificate program is \$2,500 per student. Costs may include tuition, fees and course materials (books). If you don't owe any tax, you may also be eligible to receive up to 40 percent of the credit (\$1,000) as a refund.

• Educator expenses deduction—Elementary and secondary educators can deduct up to \$250 in related job expenses as an adjustment to income, even if not itemizing deductions. Unlike most employee expenses, educator expenses are not reduced by 2 percent of your adjusted gross

• Deduction for mortgage insurance premiums—If you pay mortgage insurance premiums, also known as private mort-

gage insurance (PMI), you may be able to deduct premiums as mort-

· Alternative Minimum Tax-The AMT was created to ensure wealthy taxpayers receiving large tax benefits pay some tax. It will now be adjusted for inflation each year so fewer taxpayers are subject to the tax. The exemption amount rises in 2013 to \$51,900 (\$80,800 for married couples filing jointly). For married individuals filing separately, the exemption is \$40,400.

· Adoption credit-You may qualify for a credit equal to up to \$12,970 of your adoption expenses including fees, court costs, atter-ney fees, traveling expense and other expenses directly related to and for the principal purpose of the legal adoption of an eligible child. If your employer provides adoption benefits, you may also be able to exclude up to the same amount from your income. Both a credit and exclusion may be claimed for the same adoption but not for the same expense.

·State and local sales tax deduction—For 2013, you can still deduct state and local sales taxes. You can take this deduction or a deduction for state income

As with most tax benefits, vou must meet certain criteria in order to claim them on your tax return, and even if you are eligible, you may not qualify for the

entire amount. Online and mobile tax preparation programs make it easy to do your own taxes and confidently claim all your deductions and credits. As you answer simple questions, the program completes your tax forms and checks for errors and potential opportunities.






