Amarillo Area Foundation Panhandle Disaster Relief Fund Receives \$10,000 from **Xcel Energy Employees**

On June 11, 2014, David Hudson, Xcel Energy CEO, presented a \$10,000 contribution from Xcel employees to the Amarillo Area Foundation to provide assistance for the Fritch post-fire recovery. AAF will work primarily with the Hutchinson County United Way and is in contact with the Hutchinson County Disaster Relief Committee, appointed by Judge Faye Blank, to coordinate intake applications for special needs.

The AAF Panhandle Disaster Relief Fund provides a way for companies, organizations and individuals to give charitable gifts in support of the intermediate and long-term recovery of the Fritch community. Several ecumenical groups have volunteered for clean-up and to provide labor or materials to rebuild. The Fund could support some of those efforts. The Foundation has waived all fund administration fees for response to these needs and will honor restrictions placed on specific donations for food, rent, transportation, etc.



Henry Harrison August 8, 1940 - June 8, 2014



Texas A&M Leaders AgriLife Extension Service graduates lifetime leaders

Lawyers, farmers, bankers, ranchers and agriculture-related industry representatives banded together for two years with one aim: learn to be leaders. Their intensive study of agriculture worldwide culminated this month when their Texas Agriculture Lifetime Leadership XIII class graduated at a ceremony in College Station.

"The Texas A&M AgriLife Extension Service administers the program known as TALL, which focuses on local, state, national and international issues to help ensure effective understanding and encourage positive action that will advance the agriculture industry," said Dr. Jim Mazurkiewicz, program director.

This class — the 13th since the program started — traveled extensively, including a trip to Brazil to learn about the impact of agriculture worldwide.

"TALL creates leaders in agriculture by exposing participants to all segments of the industry - locally, nationally and internationally. We develop a network with other participants and those who generously host us during visits to realize opportunities where we can positively affect how we, as agriculturalists, will feed and clothe the world," said Kelley Sullivan of Houston.

"The program has truly broadened my perspective on many production, political and social issues impacting agriculture, which will help me be a stronger leader and spokesman for this great industry," said Lindsay Kennedy of Lubbock. "The TALL program is making a lasting impact not only in the lives of its participants, but on Texas and American agriculture as a whole."


Dax Hayes, plans on attending college and obtaining a degree to further his education. Mr. and Mrs. Jay Hays of Dumas are the proud parents of Dax.
