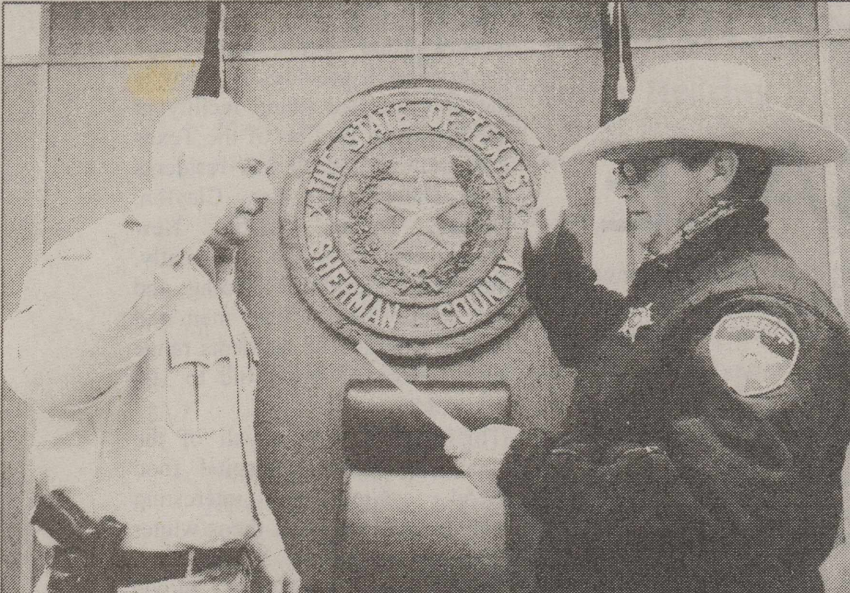

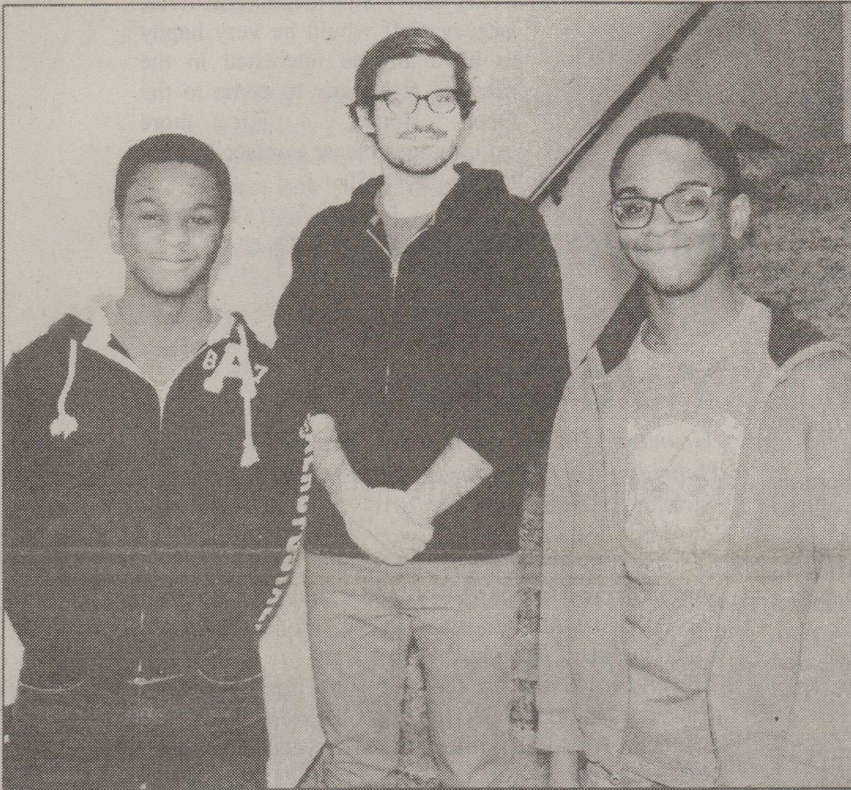

Sherman County Livestock Producers Reminded to Report Forage Losses by Feb. 1

USDA LFP Covers Eligible Grazing Losses Due to Drought and Wildfire Stratford, TX, Jan. 14, 2016 - Sherman County USDA Farm Service Agency (FSA) Executive Director Rebecca Lowe reminds livestock producers who suffered grazing losses that occurred throughout 2015 due to drought or wildfire that they have until Feb. 1, 2016, to report their losses and to enroll in the Livestock Forage Disaster Program (LFP).

LFP provides compensation to eligible livestock producers who suffered grazing losses for covered livestock due to drought on privately-owned or cash-leased land or fire on federally-managed land. Producers in Sherman County are eligible to apply for 2015 LFP benefits on small grain, native pasture, and improved pasture. Livestock producers are encouraged to contact the Sherman County FSA Office with any questions regarding specific forage crops that are eligible.

"Prolonged drought conditions have created a need for livestock disaster assistance programs in Sherman County," said Lowe. "I encourage all affected livestock producers to contact the Sherman County FSA Office to schedule an appointment to enroll in the program before the Feb. 1 deadline."

Livestock producers must complete the LFP application and required supporting documentation no later than Feb. 1, 2016, for losses that occurred throughout 2015. Producers who already have appointments scheduled require no additional action to meet the deadline.

Eligible livestock includes alpacas, beef cattle, buffalo, beefalo, dairy cattle, deer, elk, emus, equine, goats, llamas, poultry, reindeer, sheep or swine that have been or would have been grazing the eligible grazing land or pastureland.

We keep some drip supplies in stock, and will help in the design of your system and order exactly what is needed for you if we do not have it. Delivery is usually within three working days. You can also help your investment with the installation of weed barrier. We have this available also. This is especially important in windbreaks because we do not want the newly planted seedlings to have to fight with weeds and grass for water. The barrier will help prevent the growth of weeds and grass and keep the moisture in the ground.

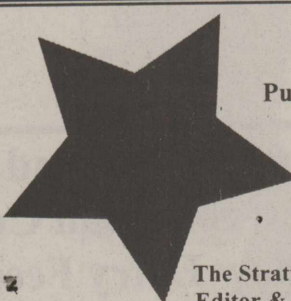

Meyer Places in State Sorghum Yield Contest

Growers Using Pioneer(r) Brand Sorghum Hybrids Win 16 National Titles in 2015

Walk the Appalachian Trail

The residents and staff members of Legacy Assisted Living facility in Dalhart, Texas, have begun a new exercise program for the winter. They plan as teams to "walk" the length of the Appalachian Trail! This nationally recognized trail system is approximately 2,200 miles long, and runs from Mount Katahdin Maine to Springer Mountain in Georgia. The Appalachian Trail is the longest hike-only trail in the world.

Legacy residents will be on the Bear Team. Eleven residents have joined. The staff members will walk for the Moose team. This team has fourteen members. The purpose of this program is to increase activity in everyone's daily life. Options can include: walking, running, biking, using exercise equipment, exercises, laundry, shopping, going to the mail box, and etc. If someone is doing an unusual activity, such as shoveling snow, a conversion calculator will be used to translate their minutes of work into miles for the program.

This program will last through March which will provide a 12 week session. Weekly tallies will be calculated and a tote board will be kept showing everyone's progress. The 'End of the Trail' party will be held April 1. In 2015, the teams participated in the Walk Across Texas program sponsored by the Texas Cooperative Extension Service. The Legacy total was 2,880.33 miles in 14 weeks or approximately 205 miles per week! Future updates will be posted in this publication. GO TEAMS!

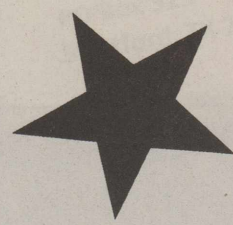

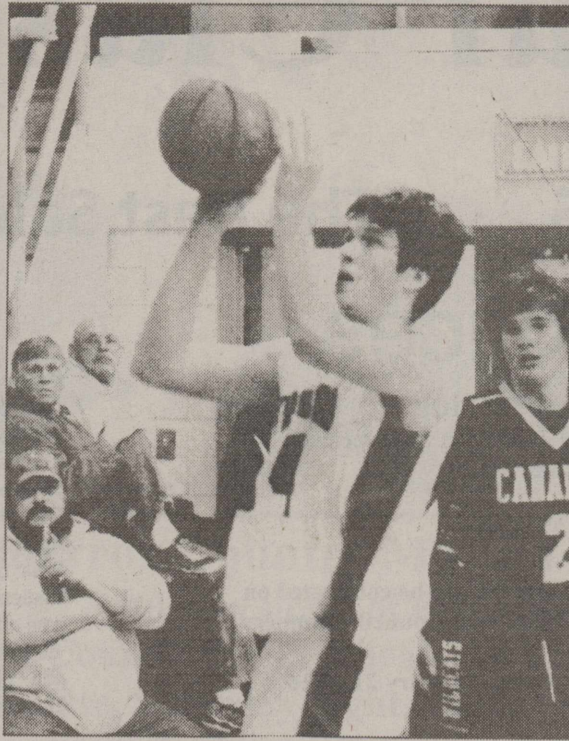

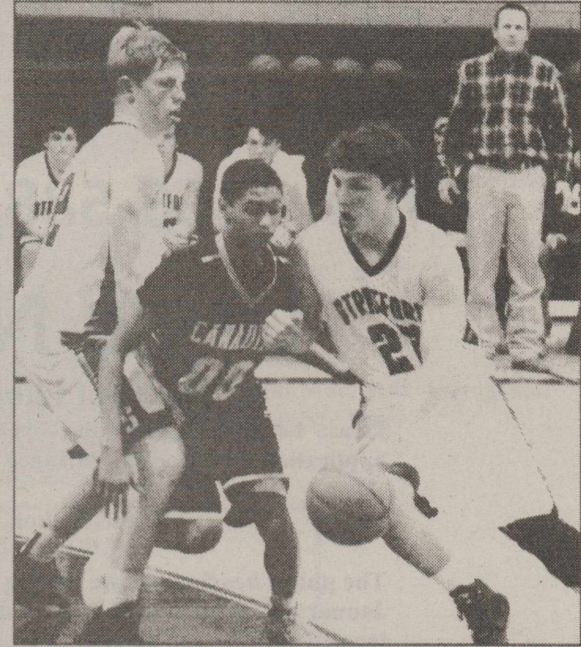

Stratford Elk #14 Jack McBryde sets up the offense in the Elks 48-40 win over Canadian.



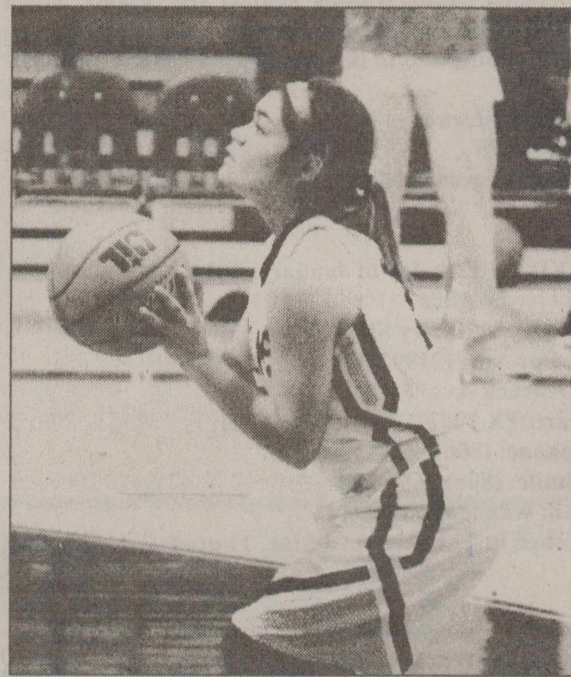
Stratford Elk Russell Spurlock goes up for the shot in the Elks district win over Canadian.



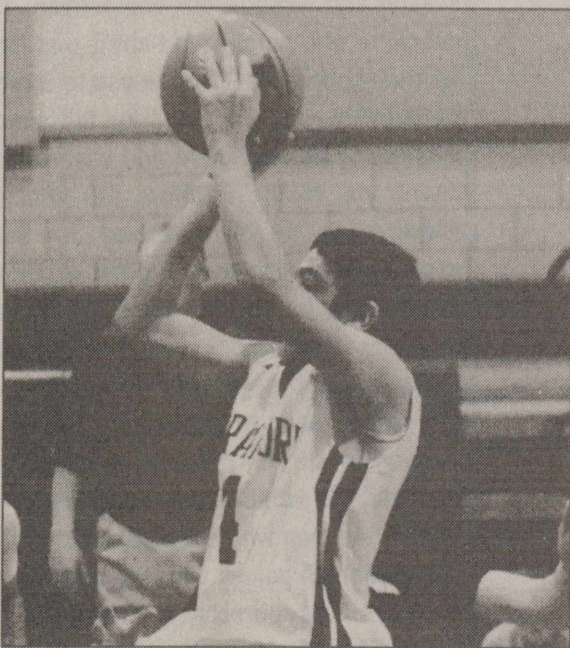

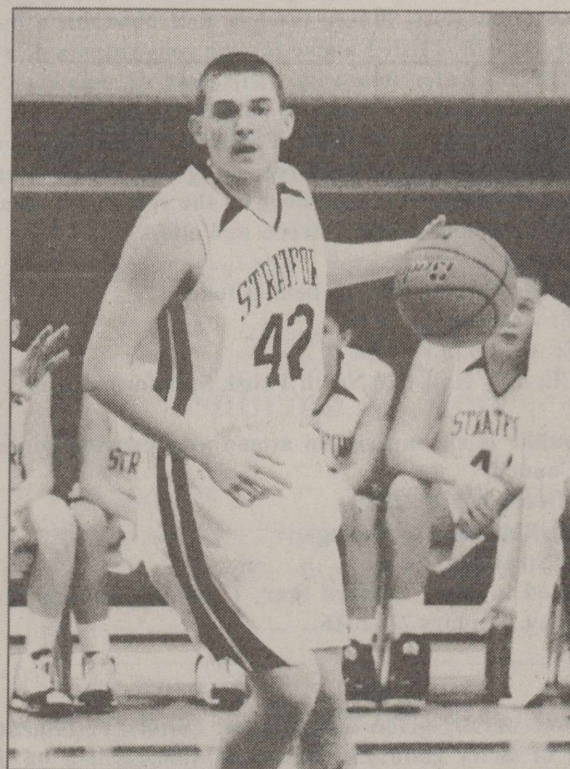
Lady Elk #11 Allie James goes with the shot in the Lady Elks 2 point loss to Canadian on Friday, January 16, 2016.
