According to Andy Riffe of Stratford Grain Company, wheat harvest is going really good so far. He estimates it to about 70 per cent complete. Dryland is anywhere between 19 to 42. He said irrigated quality is really good and the harvest this year is about 30% bigger than last year, but the bad news are prices are lower. We will have more about Harvest in next week's edition.

The City Code Enforcement Officer will be checking properties in the upcoming weeks for compliance with these and other ordinances. Citations for noncompliance may be issued. Please be sure to keep your property, including behind fence lines and up to the alleyways, free of high grass/weeds and other debris in order to avoid a Citation. Attention All Stratford Residents!

As a reminder to all residents, fireworks are prohibited within the city at all times and a fine or penalty for the violation of a rule, ordinance or police regulation that governs fire safety, zoning or public health and sanitation, including the dumping of refuse, may not exceed two thousand dollars (\$2,000.00). The applicable City Ordinances are listed below:

ARTICLE 5.03 FIREWORKS*

Sec. 5.03.001 Penalty

Any person, firm, corporation, or association who shall violate any of the provisions of this article, or suffer or allow the same to be violated, shall upon conviction therefor be subject to a fine in an amount in accordance with the general penalty provided in section 1.01.009 of this code. (1977 Code, sec. 7-14)

Sec. 5.03.002 Use prohibited


No person, firm, corporation, or association shall cast, throw, or fire any squib, rocket, cracker, torpedo, grenade, gun, revolver, pistol, cap, or cartridge, or other combustible fireworks of any kind, in the city. (1977 Code, sec. 7-11)

Sec. 5.03.003 Sale

No person, firm, corporation, or association shall exhibit or have in his possession with intent to sell or offer for sale or to give away within the city any squib, rocket, cracker, torpedo, grenade, gun, revolver, pistol, cap, or cartridge, or any other combustible fireworks of any kind, in the city; provided, however, that this section shall not apply to the sale of any such article or articles by wholesalers to each other or to the sale of any such article or articles at wholesale to merchants doing business entirely without the city, or to the sale by wholesalers for private or public demonstration as provided herein. (1977 Code, sec. 7-12)

Sec. 5.03.004 Exceptions

Nothing in this article shall be construed to apply to the sale, storage, or use of railroad-track torpedoes or other signaling devices used by railroads, nor to the sale, storage, or use of flashlight composition by photographers or dealers in photographic supplies, or prevent any public or private demonstration or display of fireworks of any kind if conducted under proper police supervision after application is made and a permit issued by authority of the governing body of the city for such demonstration. Said permit shall not be granted unless such demonstration or display shall be of such a character, and so located, discharged, or fired, as in the opinion of the chief of the fire department, after proper inspection, shall not be hazardous to property or endanger any person or persons. (1977 Code, sec. 7-13)
