Memorial Highway Dedication for Fallen Stratford DPS Trooper Steve Booth to be Held March 24th, 2016

The Texas Department of Public Safety (DPS) announced today a memorial highway dedication for fallen Stratford DPS Trooper Steve Booth.

On Thursday, March 24 at 2 p.m., a dedication ceremony will take place in Stratford, Texas; at the Sherman County Courthouse. The Trooper Steve Booth Memorial Highway will consist of approximately 15 miles of US-287 that starts at the north city limits of Stratford and ends at the Oklahoma state line.

In June of 1993, Trooper Steve Booth responded to a call of a man waving a gun and driving erratically, approximately two miles north of Stratford on US-287. Trooper Booth located the vehicle and initiated a traffic stop. During the traffic stop, Trooper Booth was shot and killed by the driver. The driver was later located in Stratford and taken into custody. He currently serves a life sentence. Stratford Lion's Club member and close friend of Trooper Booth, Duane Pittman,

initiated the proposal for a highway dedication. Pittman and the Stratford Lion's Club worked with State Senator Kel Seliger and State Representative Four Price to have this part of US-287 dedicated for Trooper Booth.

The public and media are invited to attend the ceremony in honor of Trooper Booth's selfless sacrifice and continued support for family and friends.



XIT RURAL TELEPHONE TO HOST 65" ANNUAL MEMBERSHIP MEETING

XIT Rural Telephone Cooperative, Inc. will be hosting the 65th Annual Membership Meeting of its rural landline telephone membership on Wednesday, March 09, 2016, at the Rita Blanca Coliseum in Dalhart. You must be an XIT rural member to attend the event, and have a home phone number in one of the following exchanges: Middlewater - 343; Texline - 362; Bunkerhill- 377; Coldwater - 384; Kerrick - 727; Stevens - 753; and Lautz - 769. Member registration will begin promptly at 11:00 a.m., and will be followed with a noon luncheon consisting of roast beef and gravy, mashed potatoes, corn, green beans, hot roll and dessert, catered by The Loose Caboose of Dalhart. Members will be treated to a delicious sit-down dinner served by XIT's own management and employees.

After the meal, XIT will introduce the 2016 XIT Rural Telephone Educational Program recipients to the membership. This is the seventeenth year for the XIT Educational Program. The scholarships are awarded to members' children who are graduating seniors from one of the local area high schools.

The business meeting will begin promptly at 1:00 p.m. J.W. McClellan, President of the XIT Board of Directors, will welcome the members to the meeting, and announce the guests who are present. The business meeting will conclude with the election of directors and the drawing of door prizes.

There will be approximately \$4,000 worth of door prizes given away at this year's meeting to members who are present. There will be six grand prizes awarded: 1 - \$500 cash prize; 3 - \$300 cash prizes, and 2 - \$100 cash prizes. There will also be some prizes for the members' children or grandchildren who are 12 years of age or younger. All winners must be present to win.

The purpose of the annual meeting is to elect directors for each district, to review the financial reports for the previous fiscal year, and to conduct any other business that might need to come before the membership.

A quorum must be met in order for the business meeting to convene. Based upon the total number of the Cooperative's members, fifty members or two percent of the members present, whichever is larger, constitutes a quorum.

The XIT board members and officers are: J.W. McClellan, President; Water E. Lasley, Vice President; and Gary Finch, Secretary-Treasurer. Other directors are Marcia French, Nick Olson, Steve Baskin, Gared McBryde, Barry Poling and Larry Kemp.

Members of the Nominating Committee met on Thursday, February 4, 2016 at the Cooperative's headquarters office to place into nomination one or more candidates to be elected for the directors' positions. Nominations included: District 1, Dallam County - J.W. McClellan, Jr.; District II, Hartley County - Nick Olson; and District Ill, Sherman County - Gared McBryde.

Members vote only for nominees from the district in which they reside, or the district in which they have telephone service. No proxy voting is permitted, so all members must be present at the annual meeting to vote. Only one vote per household is allowed per membership, and either the husband or wife are eligible to vote at the annual meeting.

An official letter was mailed to all active members of the Cooperative on February 19th in accordance with the bylaw requirements.



While we try to list as many species that are available for this area, we cannot list them all. If you have any special wants or wishes as far as trees go this year, please call the office at 396-5517 ext. 3 and we will be happy to try and find what you need.

The District can also fill requests for drip irrigation supplies. We keep some drip supplies in stock, and will help in the design of your system and order exactly what is needed for you if we do not have it. Delivery is usually within three working days. You can also help your investment with the installation of weed barrier. We have this available also. This is especially important in windbreaks because we do not want the newly planted seedlings to have to fight with weeds and grass for water. The barrier will help prevent the growth of weeds and grass and keep the moisture in the ground.

If you need a Tree Order Form, want to place an order for trees, irrigation supplies, weed barrier or just have any questions regarding the trees or need help planning for your particular needs, please do not hesitate to contact the District or the NRCS at 396-5517 ext. 3.










Stratford Elk Jack McBryde scores on the jump shot in the Elks 71-52 area win over Vega on Friday, February 26, 2016.






