

## House gutting weapons

WASHINGTON (AP) - The White House is counting on the Senate to rescue President Bush's defense priorities torn asunder in House votes gutting or cutting back virtually every major strategic weapons program.

In two days of votes on a \$295 billion defense authorization bill, the House ignored White House and Pentagon lobbying and turned Bush's defense priorities on their head.

It restored funds for conventional aircraft discarded by the Pentagon while suspending most production of the radar-evading stealth bomber. It cut money for the Star Wars missile defense system, stripped funds intended to make the MX missile a mobile weapon and eliminated all of the \$100 million provided for the Midgetman missile. Rep. Les Aspin, D-Wis., said the House had "shredded" Bush's defense priorities to produce "a Michael Dukakis defense bill.' The Senate, meanwhile, only narrowly turned aside a strong bid to freeze research and development of the Star Wars strategic defense initiative. It tabled the amendment offered by Sen. Bennett Johnston, D-La., 50-47.

AUSTIN (AP) — A selfdescribed tree wizard who came from Pennsylvania to try and help the centuriesold Treaty Oak says the city killed the live oak by trying to rescue it, but city of-ficials scoffed at the claim.

Stephen Redding, 42, of Green Lane, Pa., said the latest attempt to counteract a poison coursing through the tree "was the final nail in the coffin."

"I felt the spirit of the tree leave," said Redding, who stayed near the tree for six days.

City officials Thursday denied Redding's claim, saying the tree is clinging to life and that experts have devised their rescue at-

# **Diplomat admits Soviet connection**

**By The Associated Press** The U.S. diplomat suspected of spying for the Soviet Union told the FBI he worked with the Soviets for "many years" and was paid "a lot of money," The New York Times reported today.

Meanwhile, officials in believe you are now infected." Washington disclosed Thursday that Felix S. Bloch received State Department merit raises of more than \$13,000 while he was the No. 2 officer in the American embassy in Vienna.

The raises are given to diplomats whose work is "well above average," said a U.S. official who spoke on condition of anonymity.

The Times quoted an unnamed official as saying Bloch made the admission during his only interview with the FBI on June 22, the day he was placed on administrative leave from his State Department job. He has not been charged with any crime but remains under heavy FBI surveillance.

Bloch refused to discuss his motives or to give details on any spying activities, the Times said.

Three administration sources familiar with the Bloch case said in Washington Thursday night that they had not been told of such admissions.

But a congressional source told The Associated Press the FBI believes Bloch was recruited by the KGB, the Soviet intelligence service, while he was serving at the U.S. Embassy in East Berlin 14 years ago.

The Times said the FBI had received information that prompted major interest in a recent trip Bloch was making to Europe and planned a surveillance operation. recommended the raises, said The agency notified foreign in- the official.

The FBI interviewed Bloch, who told agents he had worked with the KGB for "many years' and that they "paid me a lot of money," the Times said. The FBI also got permission to search his home but found nothing incriminating, the paper said.

Government sources say Bloch was videotaped in Paris handing a briefcase to a Soviet agent earlier this year. The contents of the briefcase remain unknown.

In Moscow, Foreign Ministry spokesman Gennady I. Gerasimov denied any Soviet connection with Bloch. Gerasimov said Thursday he made inquiries about Bloch's activities. "The name of Bloch was not familiar. We have no connection with him," he said.

Bloch's merit raises included an increase of \$4,500 for fiscal 1983-84, \$4,000 for 1984-85 and \$4,800 for 1985-86, said an official who spoke on condition of anonymity.

But Bloch's raise was the lowest of three merit pay grades in the Senior Foreign Service, with the highest reaching about \$9,000 a year, the official said.

## Grandma Thinks Home-Study Course Is Way Off the Track

DEARABBY: Please help me. My daughter has taken her children out of public school to teach them herself. I called the Board of Education, and I was told it is legal to use a home-study course for children.

Abby, my daughter didn't graduthere's a third ingredient - declarer ate from high school hersen. She was very headstrong and refused to attend classes, so when she was old spades, played king and ace of hearts, enough to quit school, she quit.

#### WORRIED

#### **DEAR WORRIED: Some home**study programs have worked very well; others have not. It depends upon the competence of the teacher. (It's usually the mother.)

In view of the problems your grandchildren have encountered thus far in school, I suggest that they be tested for reading (and learning) disabilities regardless of whether they are taught at home or in a public school.



DEAR DR. GOTT: My ex-daughterin-law's 31/2-year-old son is on a lowcholesterol diet, and she doesn't want us to give him chocolate anymore. She exposes him to cigarette smoke, doesn't take him to the doctor for colds or allergies, yet she's firm on this low-cholesterol business. Is this appropriate for a 3½-year-old?

DEAR READER: For the vast majority of 31/2-year-old children, lowcholesterol diets are not appropriate. Youngsters need fat in their diets, as well as the nutrition present in eggs, dairy products and meat. I can understand the reason for limiting chocolate, but a strict diet for a growing child is inadvisable. I think your grandson should be under the care of a pediatrician - not necessarily for "colds and allergies," as you suggest, but for routine, well-baby checkups and immunizations. The dector can assess your grandson's diet and, if necessary, advise his mother about what modifications are needed.

Ex-daughters-in-law often do not get along with ex-mothers-in-law. Try to be objective, not vindictive, in your criticism. Your son, who must have. some say in the manner his son is raised, is probably the person who can

DEAR DR. GOTT: Why haven't I neard of a method to increase the sine of a man's penis? I know this sounds ridiculous, but if you could put yourself in my shoes, I am sure it would be a serious concern of yours.

DEAR READER: You haven't heard of such a method because none exists.

The size of the penis is governed by poorly understood genetic influences. In rare circumstances, however, hormone deficiencies can result in a small penis; this may be corrected with supplemental hormones. If you are concerned about the size of your organ, I urge you to be examined by a urologist, a specialist in disorders of the male reproductive tract. Incidentally, your concerns are not "ridiculous"; I take them seriously, as I am sure any physician would.

I should add that a urologist may end up reassuring you that the size of your penis is within the normal range. Most men would like to have larger penises but, alas, nature has provided penises of varying size, some of which may seem deficient when compared to others. Rather than fretting about the size of your penis, you may be happier in the long run by accepting your inheritance and doing the best with what you've got.

OCC Senior Deputy Comptroller Frank Maguire closed Brushy Creek National Bank, with the FDIC transferring the bank's deposits and some other liabilities to Union National Bank, Austin for a \$1,000 premium.

A Lubbock native, Harmon currently is president of First Equity Homes, an Austin construction company.

He came to Texas in 1968 as a freshman catcher for first-year coach Gustafson and helped the Longhorns to three straight trips

to the College World Series. Afterward, Harmon played eights years in professional baseball, including stints with the Kansas City Royals and St. Louis Cardinals organizations. Between 1978 and 1983, he was

# **Testing of AIDS drug**

**Researchers hopeful of new weapon** 

tests of a new AIDS drug are so promising that federal scientists are expressing hope it may recovered from the disease. become a powerful new weapon numbers 100,000 cases.

Scientists say they hope to start an expanded second phase of tests this fall and perhaps have the drug available for wide use next year.

Phase I trials, described in a report published today in the journal Science, showed that the drug, called DDI, controlled the growth of the AIDS virus and enabled patients to gain weight, feel better and develop some resistance to infection.

"This is not a cure for AIDS," said Dr. Robert Yarchoan, a National Cancer Institute researcher who helped direct the Phase I trials. "But it appears to control the disease."





### **Priest fasting**

DALLAS (AP) - Until a bishop agrees to his terms for a meeting about sexual misconduct and embezzlement allegations, a Catholic priest is vowing to maintain a hunger strike.

The Rev. Justin Lucio started fasting July 21 to end what he called an "impasse" between him and Bishop Thomas Tschoepe over Lucio's 16-week leave of absence, which the priest claims was forced.

Lucio has maintained that after he stepped down as priest of St. James Catholic Church in Oak Cliff in April, Tschoepe denied him a new assignment because of allegations he is a homosexual, had raped a woman and embezzled church money.


