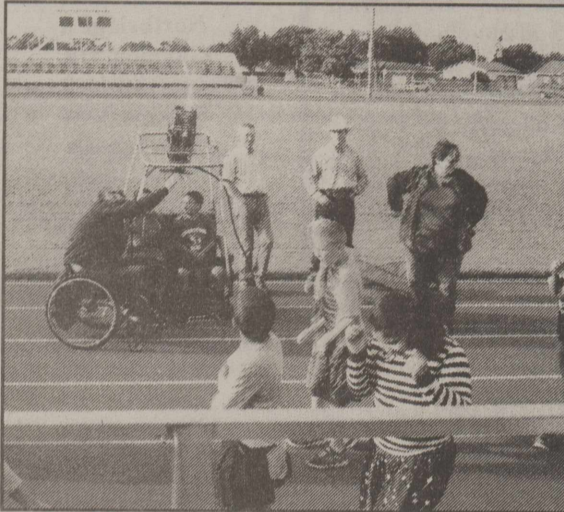


### Hot Air Balloon Pilot shares his Uplifting Story with Stratford ISD

March 6, 1950- September 11, 2016

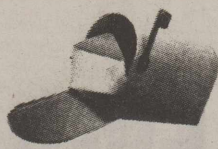

## War Memorial Education Center proposed for Texas Panhandle

Our freedom is not free, and the proposed Texas Panhandle War Memorial Education Center will serve to ensure that the brave servicemen & women of the Texas Panhandle who've made the ultimate sacrifice for our freedom will never be forgotten. On Wednesday, September 7th Mary Nell Lemert, Chairwoman; Ron Boyd, Co-Chair; and Sheri Brosier, Co-Chair of the Campaign Executive Committee for Texas Panhandle War Memorial Education Center visited Happy State Bank to share with the community what the facility will mean for the Texas Panhandle.

The proposed Education Center will be located adjacent to the existing War Memorial at 1-27 and Georgia in Amarillo. The 12,546 square foot facility is unique both in its purpose and functionality. Nothing like this remarkable facility exists in Texas. The purpose of the Education Center is to honor, to educate, and to inform.

The proposed facility is not a museum, but an education center intended to tell the stories of the individuals from the 26 counties in the Texas Panhandle who have died to protect our freedom. This state-of-the-art center will bring 240 years' worth of history on American conflict to the fingertips of visitors through digital archives and video interviews with veterans from the Texas Panhandle. All information is true and accurate, explained Lemert. It will all be factual, even if it's not politically correct. The group explained that the first floor of the Education Center will take visitors on an interactive and chronological journey through each conflict in which the US military has fought. The second floor will honor our local heroes and tell their personal stories in an engaging environment. Visitors will be able to search digital archives by the name of a veteran to find their story. The personalized experience is intended bring the effects of war into focus and provide a lasting understanding of how our communities have been impacted by each US conflict.

Children from all over the Panhandle will be able to visit the Education Center, but the impact of the facility will reach even beyond our 26 counties. Lemert and Boyd explained that approximately 60 tour buses stop in Amarillo to visit the existing War Memorial, and this is expected to increase with the Education Center.

This \$8.5 million project is currently in the fundraising stage. "We are a long way from breaking ground, but we are not going to stop until it's done," Brosier said. The group has traveled to numerous communities in the Panhandle to share their stories, explain what the Education Center will be, and to invite the communities to join in then in their efforts.

## Cave Springs, Ark. PD Chief Under Investigation for falsifying Sheriff Commissions

**EDITORS NOTE:** This article was posted at 11:08 a.m. August 25, 2016 By **Zuzanna Sitek**, updated at 03:30 p.m. August 25, 2016 5 NEWS KFSSM KXNW Sheriff Joe Powell was the former Sheriff of Sherman County before taking a position in Benton County, Arkansas.

**CAVE SPRINGS (KFSSM)** - The Benton County prosecutor requested Wednesday (Aug. 24) that Arkansas State Police take up the investigation into the unauthorized issuance of sheriff commissions to several police officers at the Cave Springs Police Department.

In a letter to Col. Bill Bryant, Director of ASP, prosecutor Nathan Smith writes that Cave Springs Police Chief Joe Powell may have tampered with public records, which is a felony.

Powell was suspended with pay over the weekend after Cave Springs Mayor Travis Lee said he received information Aug. 19 regarding Powell's conduct. -

As is the case across the rest of the state, the Benton County sheriff issues commissions to officers who work for other law enforcement agencies in Benton County so they have county jurisdiction when needed, Smith's letter states. The commissions are issued at the discretion of the sheriff, who in this case is Meyer Gilbert. The sheriff then drafts a document appointing a certain person to be commissioned as a deputy sheriff. The appointee has to sign the document and give his or her oath before a public official.

Following the oath, the documents is filed with the Benton County Circuit Clerk and commission cards are issued by the sheriff's office to authorize the appointed officer to exercise county jurisdiction, according to Smith's letter.

On Aug. 17, Sheriff Gilbert learned several unauthorized appointment forms had been presented at the sheriff's office to obtain deputy sheriff commission cards, the letter states. The appointment forms authorized commissions for Cave Springs officers Nathan Coy, Gary Grews, Jeff Ward and Scott Hammersla, according to the letter.

The officers told sheriff's office staff that Powell had given them the forms, but Gilbert said he had not issued commissions to these officers, the letter states. After examining the documents, the sheriff noticed the forms appeared to be copies of authorized appointment forms he had issued, but another officer's name had been inserted into each document, according to the letter. The appointment forms had been filed with the Benton County Circuit Clerk. In the letter, Smith writes that he requesting assistance from ASP because he does not believe it is wise for the sheriff's office to conduct an investigation that involves several witnesses from the sheriff's office, including the sheriff himself.

Lee told %NEW on Sunday that he is conducting his own internal investigation into the matter.

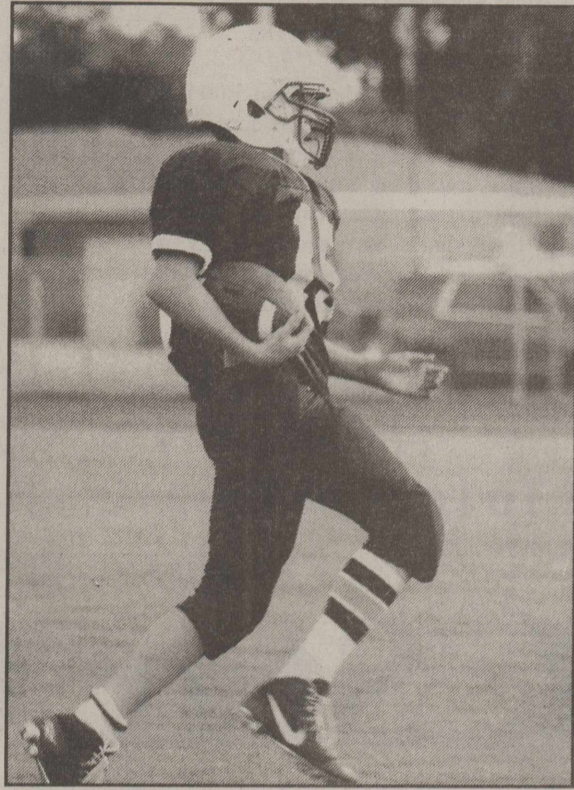

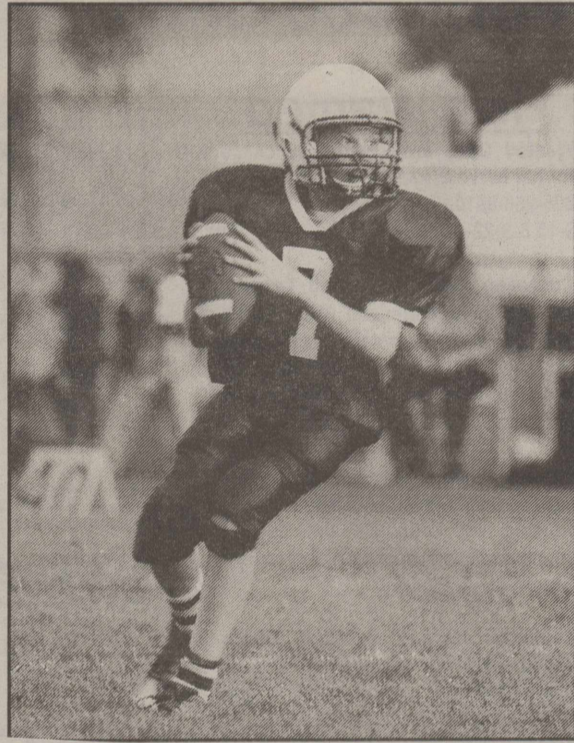

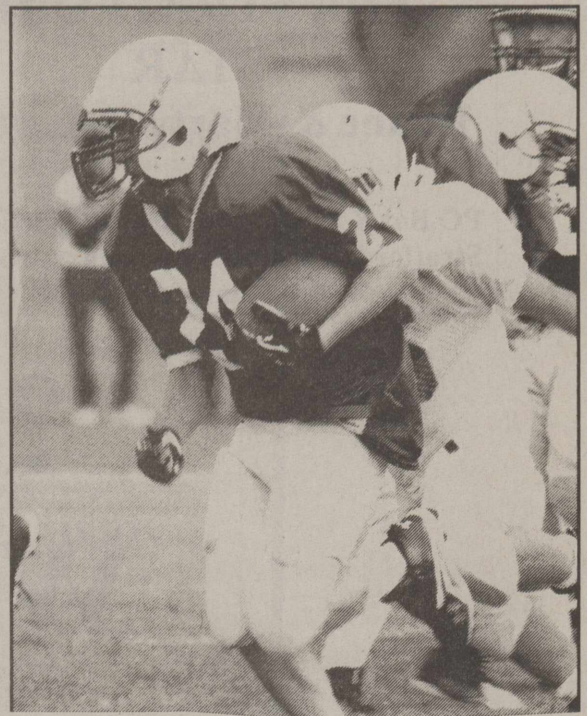

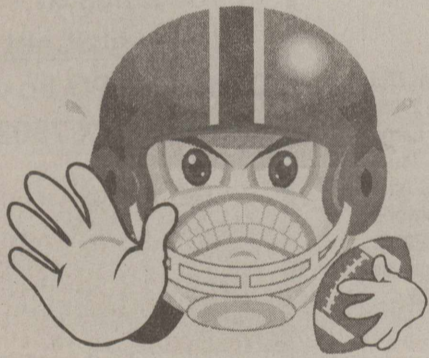
Stewart Skiles scores for the Elks on Thursday, September 8, 2016 against Panhandle.

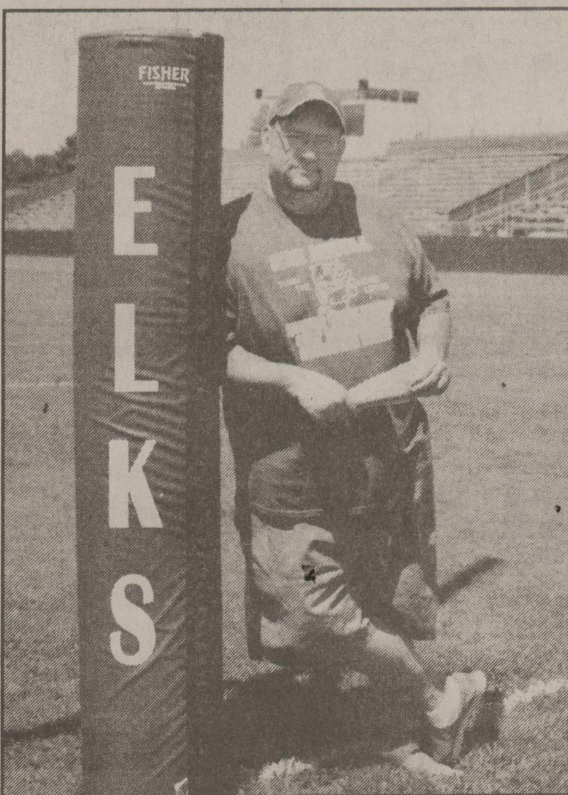
