The Small Town Dreams Benefit Concert will take place at the Boise City Auditorium in Boise City, Oklahoma on Saturday, November 26th. All proceeds for the Concert will benefit the municipal pool repair project. In May 2016, White released an independent EP, a five-song effort titled Long Way that is available through digital retailers.

The Boise City Recreation Foundation (BCRF) is a nonprofit organization founded to manage, maintain, repair and operate the municipal pool and additional recreation facilities in Boise City, Oklahoma on an ongoing basis. BCRF will raise money to repair the current municipal pool and restore it to operational status. The pool's inlet piping is in poor condition and needs replaced.

The estimated cost to renovate the existing facility with enhancements and professional labor is between \$745,000 and \$894,000. It is the plan of the Boise City Recreation Foundation to repair the facility with volunteer labor and donated materials. The initial cost estimate is between \$40,000 and \$65,000. BCRF hopes to accomplish this by securing funds from outside sources; i.e. grants, donations, and fundraising events.

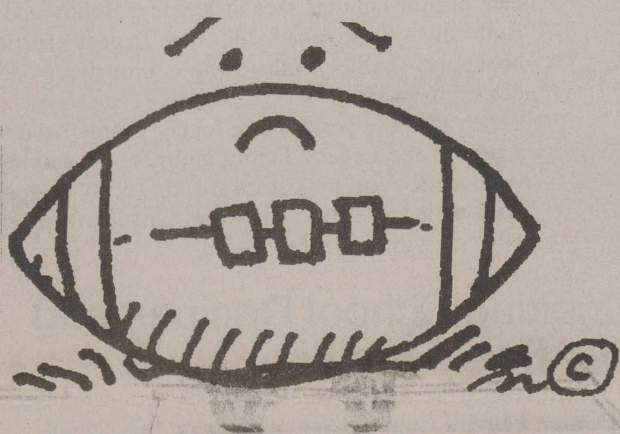
Seniors Fernando Jacquez and Russell Spurlock celebrate after Jacquez scores for the Elks.



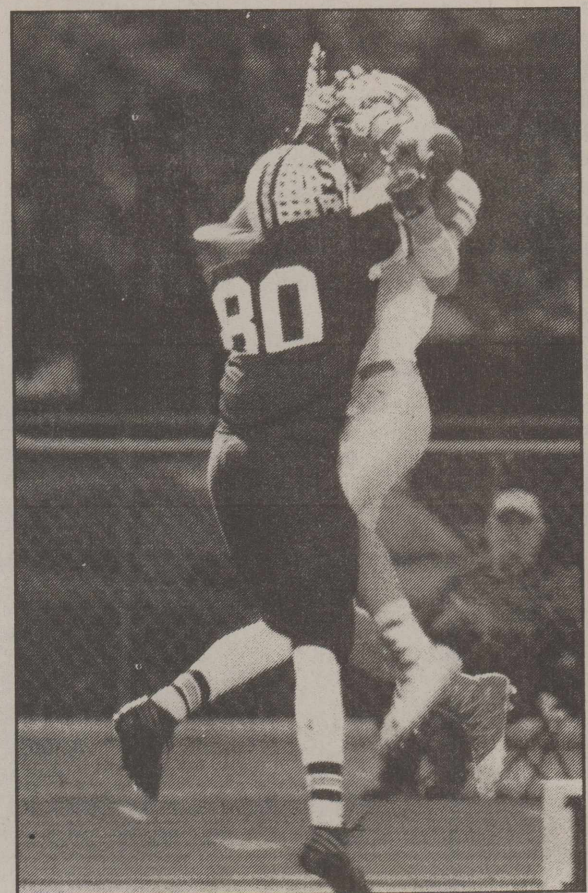
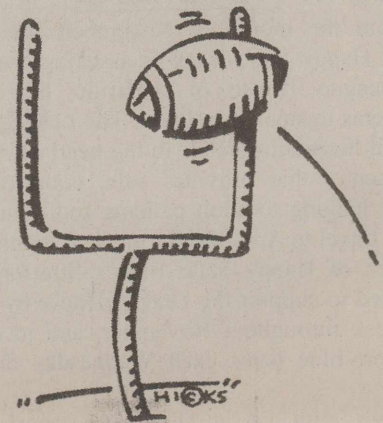
#3 Shay Hess catches the pass to turn and score for the Elks in their 29-22 district win over WT on Friday, October 28th.



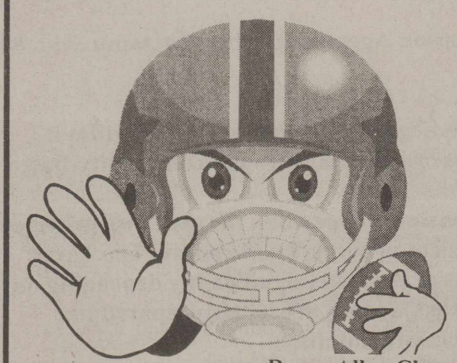
Elk quarterback #5 Kade McBryde steps back to look for receiver downfield.

Stratford Elk Sr. Jaime Jacquez #80 deflects pass intended for WT receiver.



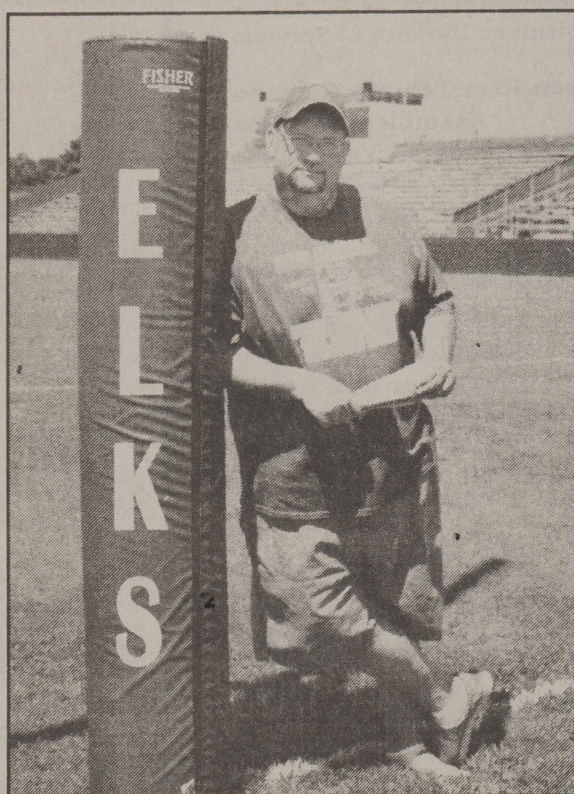

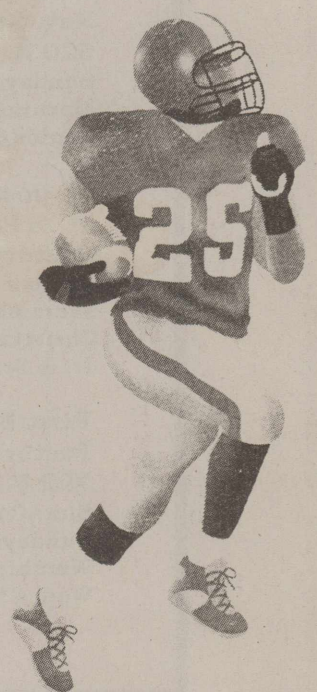


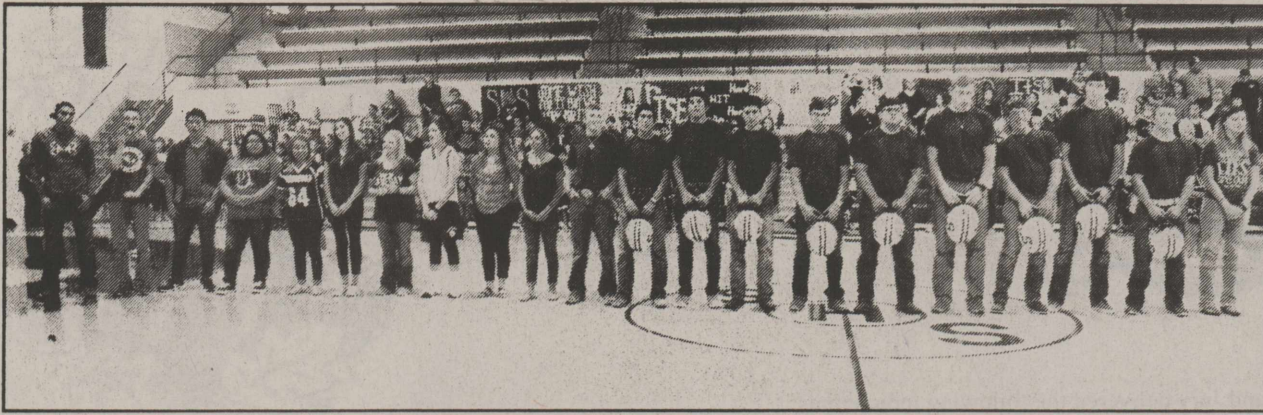
Time Out With Rog!

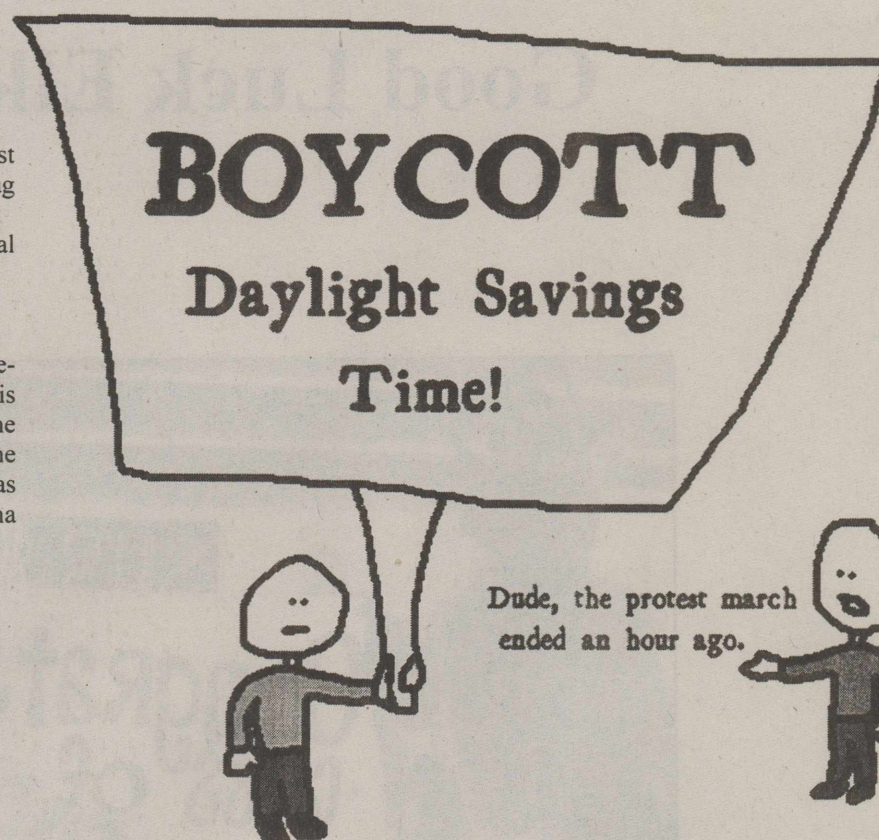
For fiscal year 2015 -2016, and to date, Sherman County Sheriff's Office has received just over \$84,000 in seized funds from 69th District Attorney's Office. Resulting from drug arrests by Sheriff's Deputies, this money will be used for equipment, and vehicle updates. Please remember Sherman County is currently under a burn ban. Due to exceptional growth of forage and dry conditions, the danger is high for catastrophic fires.

Deer Season Update:

Chronic Wasting Disease (CWD) is a fatal deer disease that has been discovered in white-tailed and mule deer in localized portions of Texas. In order to detect and manage this disease, Texas Parks and Wildlife Dept. has established CWD zones within which the intact, unfrozen head of any white-tailed or mule deer harvested by a hunter in this zone must be presented at a TPWD-designated check station within 24 hours of harvest. Areas of Sherman County west of US 187 are in this zone. This zone extends from the Oklahoma Panhandle, west of US 287 south to I-40. Portions of this zone continue further south.
