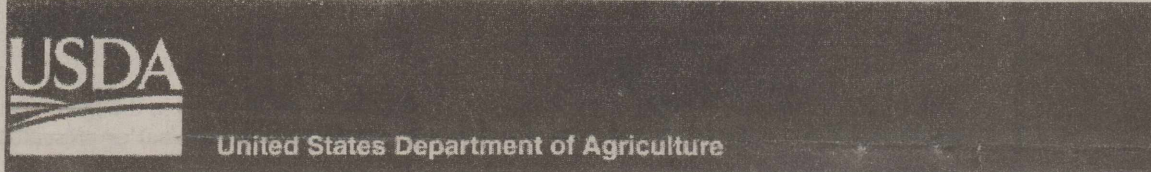


Lutes resigns from City Council

FILING A TIMELY AND ACCURATE ACREAGE REPORT FOR ALL CROPS AND LAND USES, INCLUDING PREVENTED PLANTING OR FAILED ACREAGE, CAN PREVENT THE LOSS OF F-S-A PROGRAM BENEFITS.

PRODUCERS WHO HAVEN'T COMPLETED PLANTING BY THE JULY 17 DEADLINE CAN STILL FILE A TIMELY REPORT UP TO 15 DAYS AFTER PLANTING IS COMPLETE.

The Stratford ISD board of trustees met in regular session on Thursday, June 22, 2017. President Brad McBryde established a quorum of members present and called the meeting to order at 7:00 PM.

Board members present: Brad McBryde, Dan Law, Tres Hess, Walt Berry, Jo Hinds, Bryan Clift and Tim Hudson.

Mr. Seward led the invocation.

Brad McBryde read a thank you note from the Bass family and the Sikora family for flowers sent from the district to them.

Mr. Dominguez gave the superintendent's report. He reported a district enrollment of 572 and a final ADA of 525.04. He went over the district financial statement. He gave the transportation and maintenance reports. He then gave the quarterly investment report.

Mrs. DeAnda gave the elementary report. She went over the preliminary results of the STAAR tests.

Mr. Seward gave the junior high report. He went over the preliminary results of the STAAR tests.

Mr. Hanna gave the HS report. He went over the preliminary EOC results.

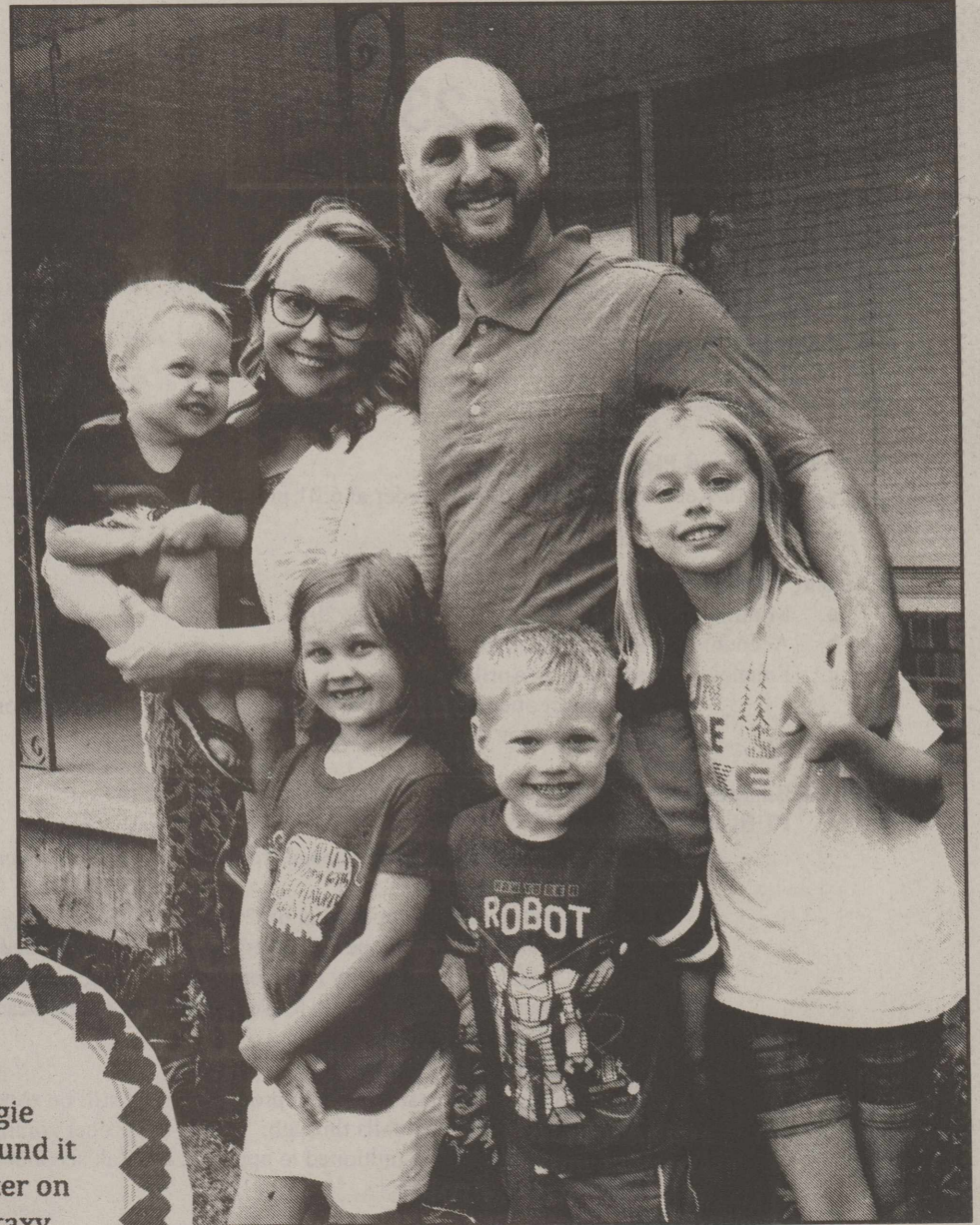

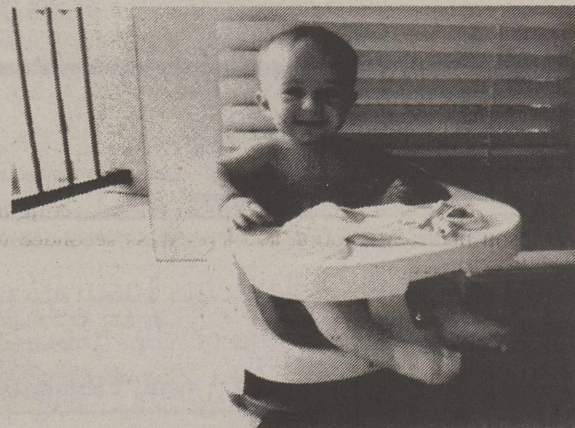

Call to Order and Pledge of Allegiance

- Mayor Reed called the meeting to order at 6:01 pm and led the Pledge of Allegiance.

Consent Agenda Items

- Minutes from regular meeting on April 25, 2017
- Accounts Payable for April 2017
- Financial Statements for April 2017
 - Greg Wright motioned to approve as presented, Ann Johnson seconded, all in favor, motion carried.

Council Business

a. PUBLIC HEARING

- Public hearing for a zoning change from "B" to "C" for property located at S. Maple and S. 2nd
 - Public hearing opened at 6:02 pm. CM Tommy Bogart stated that the property owners have hired an engineer to assist in meeting City requirements. The engineering must be included in the Master Plan. The public hearing closed at 6:06 pm.
- b. Discuss and consider action re: public hearing
 - CM Tommy Bogart stated that the property would still be zoned "C", even if the project falls through. This is the proper zoning for this area. Greg Wright motioned to approve, Joe Zak seconded, all in favor, motion carried.
- c. PUBLIC HEARING
 - Public hearing for a zoning change from "C" to "B" for property located at 1104 N. 5th Street
 - Public hearing opened at 6:10 pm. CM Tommy Bogart stated that these properties owned by the City are currently zoned "commercial". 38 pages of bid specs will be available for viewing for those looking to submit a bid for clean-up/debris removal. The public hearing closed at 6:14 pm.
- d. Discuss and consider action re: public hearing
 - James Lutes motioned to approve, Joe Zak seconded, all in favor, motion carried.

- Discuss and consider action re: **first** reading of **ORDINANCE # 2017-0523**
 - Adopting a backflow/cross-connection control program
 - This ordinance is in response to a TCEQ violation. The City has no choice but to enforce this requirement. Inspections will be conducted by the City and enforcement will be the responsibility of Code Enforcement. Ann Johnson motioned to approve, James Lutes seconded, all in favor, motion carried.
- f. Discuss and consider action re: date and time for **second** reading of **ORDINANCE #2017-0523**

- Ann Johnson motioned to schedule second reading for next regular council meeting, Greg Wright seconded, all in favor, motion carried.

City Manager Report

- CM Tommy Bogart reported that Wayne Smith thanked the City and was appreciative of a job well done in repairing the alley behind the Church so quickly.
- This is no park grant available for this cycle. Kathy Allen has volunteered to work on this grant for the City for future consideration.

Citizen Comment Period

- There were no citizen comments.

- Joe Zak commented re: week control in the streets, repairing potholes is easier when they are smaller, if the street sweeper is being run
- Kyle Sandvig commented re: update on Pearl St. grant for water line repairs. CM Tommy Bogart report the City has not been advised on any funds awarded yet.
- Greg Wright commented re: mosquito control
- James Lutes commented re: he will be moving and will be submitting his Council seat resignation
- Ann Johnson commented re: potholes on South 287 and County Road M, potholes on road going to the cemetery
- Ricky Reed commented re: receiving good comments on alley maintenance, street traffic between N. Chestnut and N. Maple on 9th Street, good job of snow removal during May blizzard, unable to accommodate a multi-purpose storm shelter due to expense, reported that he is on the bond committee
