

PLANNING AHEAD ₩ HELPFUL HINTS FROM EXPERTS

Five Steps To Plan For Dealing With Diminished Capacity And Illness

(NAPS)—Aging can change many things in a person's life, including the ability to manage one's own money. That sobering reality is behind the creation of a new resource, "Planning for Diminished Capacity and Illness," issued by the U.S. Securities and Exchange Commission and the Consumer Financial Protection Bureau (CFPB). These organizations offer this key tip for how to prepare for your financial future: Hope for the best but plan for the worst.

The Problem "Diminished financial capacity" generally refers to a decline in a person's ability to manage assets to serve his or her best interests. When people of any age lose the capability to manage their finances, they may also become more vulnerable to investment fraud and other forms of financial abuse

What You Can Do

These five steps can help you prepare. Step 1: Organize your important financial documents. Store them in a safe, easily accessible location. Give copies to trusted loved ones or let them know where to find them. When it comes to bank and brokerage statements and account information, make a list of your accounts with account numbers. Keep a separate list of online bank and brokerage passwords and PINs, and keep both lists in a safe place. List the locations of your safe-deposit boxes and their keys. Keep your mortgage and credit information, insurance policies, retirement benefits and Social Security information

Step 2: If you work with a financial professional, give that person emergency contact information in case he or she can't reach you or suspects something is wrong. Discuss what you would consider to be an emergency and specify when your financial professional may contact someone on your behalf.

Step 3: Consider creating a durable financial power of attorney. A financial power of attorney gives someone the legal authority to make financial decisions for you if you cannot. That person is called your agent. A financial power of attorney differs from a health care power of attorney, which covers only health care decisions

After signing a durable financial power of attorney, you can still manage



things easier for you later, should you ever become too ill to manage your own finances.

your money and property as long as you have the ability to make decisions. Since you're essentially giving financial decision-making authority to your agent, it's critical he or she be someone you

Step 4: Keep things up to date. If something changes (for example, you open a new account), keep your information as current as possible. Your trusted contact may also change over time. Keep your financial professionals informed of changes regarding who has authority to review your account or whom they should contact in an emergency


Step 5: Speak up if something goes wrong. If you ever think someone is taking advantage of you or that you've been the victim of a fraud, speak up. Sadly sometimes even family members, financial professionals and other people they think they can trust commit financial crimes. If this happens to you or your loved one, you're not alone-and the sooner you let someone know about it, the better chance there is of putting an end to it.

Have A Deliciously Healthy Holiday Season

(NAPS)—A delicious holiday season can be healthy, too. One key: Find small, simple ways to incorporate more nutritious foods, without losing the flavors you love. Blueberries can help.

"Blueberries are a small, tasty package with big health benefits," advised registered dietitian and spokesperson for the U.S. Highbush Blueberry Council Patricia Bannan. "They're sweet, tart and delicious but, at only 80 calories per cup, they make a nutritious addition to a holiday dish or an easy, on-the-go snack. Just rinse and go. Blueberries are also an excellent source of vitamin C, which can give the immune system

Blueberries are low in sodium with virtually no fat. They're a good source of dietary fiber (3.6 grams per serving), which aids digestion, keep you feeling fuller longer, and help you resist some of those tempting seasonal treats.

Blueberries complement different flavors and cuisines and add depth to sweet and savory dishes alike. For a festive twist, add them to favorite holiday recipes such as this:

Blueberry Ginger Jam-Filled Scones Makes 16, 3-inch scones

Blueberry Ginger Jam:

31/2 cups fresh (or frozen) blueberries 1/4 cup maple syrup

3-inch piece fresh ginger (about 2 tablespoons finely grated) 1 tablespoon lemon juice

34 cup toasted pecans, ground into

11/2 cups all-purpose flour

- 1 cup whole-grain spelt flour espoons sugar, plus
- 1 tablespoon for topping
- 4 teaspoons baking powder. 1 teaspoon cinnamon 1 teaspoon kosher salt
- 3/4 cup cold low-fat buttermilk ¼ cup cold unsweetened applesauce
- 1/3 cup cold unsalted butter, cut into ½-inch cubes
- 1 egg, for egg wash

To a medium saucepan, add 2 cups of blueberries and maple syrup and cook over medium-high heat. Grate the ginger into the mixture. Cook for 8 minutes, letting the mixture come to a light boil. Once the fruit has cooked down and the jam has thickened, add the remaining 11/2 cups blueberries and stir in the lemon juice. Remove from

heat and transfer to a bowl. Chill covered in refrigerator until ready to use.

In a large bowl, whisk the ground pecans, flours, sugar, baking powder, cinnamon and salt. Set aside. In a medium bowl, combine the buttermilk and applesauce and whisk until smooth. Set aside. Add the cubed butter to the dry mixture. Using your hands, gently rub the butter into the flour until peasized pieces form. Pour half of the wet mixture over the dry mixture and gently combine, incorporating more of the wet mixture with the second addition. Pat the dough to quickly flatten and then gather it back into a mound and repeat. After two or three repetitions, the dough should be well formed. Form each scone by packing 4 tablespoons of dough, spoonful by spoonful, to form 16 balls. Transfer to two large plates. Dip the back of a 1-tablespoon measuring spoon in flour and press into each ball to form a well for the jam. Scoop ons of the ja each well. Freeze the prepared scones for at least two hours before baking to let the pastries set.

Preheat the oven to 375° F and line two large baking sheets with parchment paper. For the egg wash, beat an egg with a splash of water in a small bowl and set aside. Remove the scones from the freezer and evenly space them over the sheet pans, at least 2 inches apart. Brush the outer rims of the dough with the egg wash and sprinkle with the remaining tablespoon of sugar. Bake from frozen until cooked and lightly browned, about 30 minutes.

Citizen Comment Period




Ann Johnson commented concerning possible winter repairs for Fulton, Pearl and Spruce streets.



Stratiord Elk #11 Iuden Romero scores on the run in the Elks 48-12 Regional win over Post.




Sergio Guerrero #10 for the Elks catches the 2 point conversion pass from McBryde in the Elks Regional win over Post.






