New Organization Formed

The XIT Rural Telephone Cooperative Inc., with operating headquarters in Dalhart, Texas, since 1951, announces the formation of a new organization--the XIT Telecommunication & Technology, Inc. or XT&T.

Nology, Inc. or X1&1.

XT&T is a new whollyowned subsidiary of the XIT
Rural Telephone Cooperative, Inc. formed in January,
1988. Jimmy R. White
serves as General Manager
of both Organizations. The
Board of Directors are also
the same for both organiza-

White stated that the XIT Telecommunication & Technology, Inc. will perform all the unregulated functions of the XIT Rural Telephone Cooperative, Inc. XT&T will sell, lease, and maintain all of the telephone instruments and business telephone systems, as well as provide inside wiring maintenance for the members of the Cooperative. XT&T will also offer telephone equipment and maintenance to anyone needing assistance with telephone equipment or systems, White added.

Being outside of the regulatory constraints allows XT&T many opportunities that the regulated Telephone Cooperative is unable to pursue, Mr. White reported. XT&T is presently involved in some of these endeavors and is negotiating or studying others.

Manager White reported that XT&T has secured a contract to lease facilities to AT&T from Guymon, Oklahoma, to Amarillo, Texas. This is a joint effort with Panhandle Telephone Cooperative, Inc. (PTCI) of Guymon, Oklahoma. PTCI has constructed fiber optic facilities from Guymon, Oklahoma, to the Texas state line on Highway 385, north of Dalhart, Texas. XT&T is near completion of its construction of fiber optic facilities from the Texas state line to the Coldwater Exchange, five miles north of Dalhart, Texas, to Dumas, Texas, and into downtown Amarillo, Texas, at 8th and Tyler. This facility is now in place and the electronic

equipment is presently being installed for this project. Plans are to cut this facility into service starting in January, 1989, and completing in June, 1989. This new fiber optic facility will provide for all of the AT&T long distance service from the Guymon, Oklahoma Toll Center, the Panhandle Telephone Cooperative Toll Center, Hooker, Oklahoma, the XIT Rural Telephone Cooperative Toll Center in Coldwater, Texas and the Dumas, Texas Toll Center. White stated that this fiber optic facility is the latest in technology. This facility will have the ultimate capacity of approximately 30,000 circuits on eight fibers. This could effectively double or triple with the new electronics equipment being developed. The facility is capable of video transmission, as well as voice circuits. The contract with AT&T will provide an approximate \$900,000.00 annual revenue to the XT&T corporation over the next five years, White added. XT&T is presently negotiating with General Telephone Company to lease facilities for the long distance services from the Dalhart, Texas and Stratford Texas Exchanges on the same facility.

XT&T also owns a limited partnership with Southwestern Bell Mobile Systems in the cellular service being offered in Amarillo, Lubbock Abilene, Midland & Odessa, Texas cellular markets. XT&T participates in ALAMO Cellular Corpora-

tion, Inc., along with five other organizations in this limited partnership. XT&T is presently negotiating with the other wireline companies on the cellular service for Texas Rural Service Area (RSA #1). This is Dallam, Hartley, Sherman, Moore, Oldham and Deaf Smith counties of the Texas Panhandle. XT&T would like to operate cell sites in the Dalhart and Dumas areas contained in this RSA. At this point, our chances are looking good to attain this. If we are successful, we will plan to introduce this service as soon as possible after the

licenses are issued by the FCC, which could be within the next 12 to 24 months, Manager White reported.

XT&T is also having a study developed to determine if it would be feasible to start into the competitive distance services. Should this prove feasible, we could be offering long distance services directly to the XIT Rural Telephone Cooperative members and to the Dalhart and Dumas areas. It is too early to determine if, or when, XT&T may be offering these services in the area, White stated.

Other projects being considered are offering facilities to area schools for interactive video television classes. This is presently in operation for schools in Beaver County of the Oklahoma Panhandle with some very impressive success. Staff of XIT Telecommunication and Technology, along with representatives of the National Telephone Cooperative Association Marketing committee, re-

cently toured the schools in Beaver County, Oklahoma, hosted by the Panhandle Telephone Cooperative, Inc. Other possibilities include linking area hospitals with interacitve video and audio television to a major medical center.

Manager White concluded that XT&T is very excited about the new information services of the future and the role that XT&T may play in bringing some of these services to the Northwest Texas Panhandle Area. The management and directors have maintained the XIT Telephone Coopera-Inc. as a very tive, progressive telephone company. Under that same direction, with more freedom regulatory restrictions, XT&T should accomplish some exciting projects in the

High Plains Conference To Examine Needs Of Individual Irrigators

Ways county producers can get maximum benefit from their irrigation systems, including use of the systems to apply herbicides and pesticides, will be explained during the annual High Plains Irrigation Conference January 10 in Amarillo.

"Each year, this is one of the most beneficial programs irrigators in Sherman County can attend," said Jim Allison, Sherman County Extension Agent. "It is planned by area producers who irrigate and staff of the Texas Agricultural Extension Service to address local needs."

The conference will be held at the Texas A&M University Agricultural Research and Extension Center, 6500 Amarillo Boulevard, West, in Amarillo. An exhibit of equipment and irrigation supplies will begin at 8:30 a.m., with presentations starting at 9:25 a.m.

Information about insectigation and herbigation will

be presented by Carl Patrick, extension entomologist, and Brent Bean, Extension agronomist. George Ratledge, assistant manager of Inject-O-Meter Company, Clovis, New Mexico, will discuss chemigation equipment, laws and safety.

Fred Pringle, soil chemist with the Soil Conservation

Service, USDA, Amarillo, will explain how soil propertities affect water intake. Robert Bruno, P & R Surge Systems, Lubbock, will discuss successful surge use.

Effects of pump and power unit efficiency on irrigation costs will be shown by Leon New, Extension irrigation specialist and conference coordinator. Steve Amosson, Extension economist at Amarillo, will discuss the optimal mix of farm program crops where water is limited.

The growers' panel will feature Dale Coleman of Dumas and Glen Hart of Stratford. They will relate their experience and suggestions on management and operation of irrigation management and maintenance of center pivots.

Additional information about the conference is available at the County Extension Office.





CHOOSING THE RIGHT DIET

So you overdied it on the holiday eating and now it's time to hop on the diet bandwagon.

To help you fulfill your New Year's vow to lose weight, the magazines will be filled with diet plans and the commercial weight loss programs will advertise heavily in January. The question is, how to choose.

You may not need a "Special diet" at all, according to Dr. Mary Kinney Sweeten, a registered dietitian and nutrition specialist with the Texas Agricultural Extension Service.

'People with an extra 2 to 5 pounds from overdoing it during the holidays can probably drop the weight just by cutting back on extra calories and getting on an exercise program, such as walking a mile or two each day," she said.

"Following the low-fat recipes from a magazine diet plan may help some people do that. But if you're already 20 to 30 pounds overweight & have added even more over the holidays, it's time for a significant diet," said Sweeten.

Although a post-holiday fad diet may help in the short run,

research indicates that 95 percent of the people who go on them regain the weight within a year, said the specialist. Before choosing a diet book, class or plan in hopes that it

will help you with significant and permanent weight loss, Sweeten suggests asking the following questions: *What's the souce of the diet? Is it a reliable health

*How is the effectiveness of the diet documented? Be wary of testimonies by "successful" clients. Ask for figures on

long-term maintenance as well. *Are sensational claims made for the diet? Does it make sense that you can "lose ten pounds overnight" or "Eat all

you want" and still lose weight? *Is the program supervised by qualified personnel, such as a physician or a registered dietitian?

*Along with calorie reduction, does the diet include instruction in behavior and lifestyle modification to help maintain the weight loss?

*Is this a one-food diet or a liquid diet? In addition to being boring, these diets omit necessary nutrients and can be a danger to your health. *Is the diet nutritionally balanced? It should include foods

from the major food groups of meat, poultry and fish; fruits and vegetables; dairy products; and grains and cereals. *What is the cost of the diet? If you have to buy special foods, devices, supplements or books will it be worth it?

Supt. Ned Burns Speaks To TRTA

Mr. Ned Burns, superintendent of Dalhart ISD, spoke to the local unit of the Dalhart Refired Teachers at the December meeting in the Community Room of the First National Bank.
