Mayor's plan to evict Crossroads fails due to lack of second

Continued friction between the City of Big Spring and the Crossroads Housing Development Corporation featured in Tuesday evening's Big Spring City Council meeting.

During the meeting, acting on an item he requested be added to the agenda, Mayor Shannon Thomason moved to demand that the CHDC do one of: Convert its offices at 201 N.E. Seventh Street into low- to moderate-income housing; return ownership of the location to the City of Big Spring; or sell the building and remit all the funds from the sale to the

Thomason's justification for such a demand is wording in the original Special Warranty Deed dated June 12, 2001, granting the property – along with another property at 907 E. 16th Street – to CHDC (grantee) from the City (grantor). The payment - or "Consideration" - paid by the CHDC to the

city for the property, as listed in the deed, is "Ten and No/100 $\,$ Dollars (\$10.00) and other good and valuable consideration, being Grantee's agreement to develop the property as low to moderate income housing. While the property at 907 E. 16th Street was converted into

such housing, the property at 201 N.E. Seventh Street was converted into the Crossroad's office. CHDC Board Chairman John Scott was the first to broach the subject during the meeting in the time for Public

Comments. "(201 N.E. Seventh Street) was given to Crossroads from Customs and Border Patrol through the City," Scott said.





"Katherine described the dream as vivid as real life. She saw a young man sitting on the side of his bed in the middle of the night, hunched over. There was a permeating feeling of despair. I could see his war demons clustered down into an emotional gutter," Tarpley read. "Katherine continued, it was as if in a movie. She saw him wrapped in a quilt and his whole demeanor changed. There was now a sense of hope and well being... quilts equal healing."

Quilts of Valor Foundation is a national organization founded in 2003 by a "Blue Star" mom, Catherine Roberts. The idea of finding a way to provide comfort for veterans came to her while her son was deployed in Iraq. While he was deployed, she constantly felt 10 seconds away from panic and those feelings turned into quilt making.

"I received my quilt one day in the mail and I was lucky to have my wife and my mother around me when I opened it," Quilts of Valor local presenter Mike Tarpley, said. "Since then I guess you could say I have been honored with many quilts that I have been able to present to our veterans."

Since the founding of the organization, more than 300,000 quilts have been awarded in the United States, Germany, Iraq and Afghanistan. With each quilt the mission to honor service members and veterans is fulfilled - one human-being reaching out and touching another without judgement, reaching out with acceptance and with acknowledgement of service to our nation in very trying circumstances. According to Tarpley, this presentation draws him almost to 100 Quilts of Valor presented in Howard County.

"The Quilts of Valor Foundation recognizes war demons that plague soldiers from all wars. There are thousands of quilters across the United States working to make these quilts to cover our warriors, from all conflicts," Tarpley said. "Each of these quilts is composed of love, tears, and heartfelt appreciation and gratitude from many ladies."

The quilts are made up of three layers: the top with its many colors, shapes and fabrics represent the community and the many individuals we are; the batting - filler - is the center of the quilt, its warmth.

"This second layer represents the hope that this quilt will bring warmth, comfort, peace and healing to the individual who receives it," Tarpley said during the presentation. The backing is the final layer and it represents strength that supports the

other layers. It represents the strength of the recipient, the support of his or her family, communities and nation. Each of the stitches holding the layers together represent love, gratitude and sometimes the tears of the maker. Each quilt represents the three-part message from the givers to the recipient. "We honor you for your service. We honor you for leaving all you hold dear

and to stand in harm's way in a time of crisis, protecting us from the effects of war," Tarpley said. "Next, we know that freedom is not free. The cost of freedom is the dedication of the lives of men and women like you, and this quilt is meant to say thank you for your sacrifice."

He continued, "Finally, this quilt is meant to offer comfort to you and to remind you that although your family and friends cannot be with you at all times, you are forever in our thoughts and hearts."

"The City was given the property with the understanding that they had to give it to us, and it was transferred to us the same day it was transferred to the City by Customs and Border Patrol.'

Scott referred to a letter sent by Customs and Border Patrol to then-Mayor Russ McEwen regarding the property.

"These houses were given to promote affordable housing opportunities," Scott said. "They were not given to be made into housing, although one of the units was made into an affordable housing unit and sold as a Section 8 property by Crossroads.'

During the New Business portion of the meeting, the council considered an item labeled "Discussion and Possible Action regarding property located at 201 N.E. 7th Street that was granted by the City of Big Spring to Crossroads Housing Development Corporation, the Deed recording the transfer, and Resolution 40-01 that authorized the transfer.'

During discussion of the item, Mayor Thomason made a motion: "I move that the Big Spring City Council a) Request that Crossroads Housing Development Corporation honor their agreement and adhere to the 2001-B consideration regarding 201 N.E. Seventh Street and develop the property as low- to moderate-income housing; or b) Either deed the property back to the City of Big Spring or turn over to the City all proceeds from the sale of said property; c) If Crossroads Housing Development fails to honor these requests of the Big Spring City Council, that the Council retain outside counsel to either regain the property or the sale proceeds of the property in question."

The motion failed when no other council member seconded it.

Another loosely related item came up later in the New Business portion of the meeting when the Council heard the first reading of an ordinance requesting an increase of the City's budget amounting to \$30,000 to perform repairs and maintenance on a city-owned building at ABC Park. During discussion on the item, it was revealed that the building is being considered as a home – or possibly a temporary home – for the Big Spring Housing Authority.

During the discussion, Councilman Maury Smith (District 6) asked how the BSHA came to be in the position of needing new offices.

"Because Crossroads evicted them," Thomason replied.

"And why is that?" Smith said.

"They were selling the building," said Thomason.

"They're selling the building. They're going to sell it now? Put it on the narket right now?" asked Smith.

"It's already listed, yes," the Mayor responded.

Following the meeting, Crossroads Chairman John Scott spoke to the press regarding the Mayor's statement.

"The Housing Authority is leaving because the (Housing Authority) commissioners, on advice of the mayor, refused to sign our key agreement," Scott said. "And so we had no choice since they would not honor the terms that we asked, we had to end the lease. We had to evict them, and it took them almost 60 days to get out. They had 30 to get out. They refused to sign the agreement that controlled the use of keys." At the time, members of the Housing Authority commission and Mayor

Thomason insisted that – in what Crossroads considered a violation of their key policy – Housing Authority commissioners be issued keys to the Crossroads office, which the Housing Authority commission used as a meeting place. The Crossroads policy stated that only paid employees – both of Crossroads

and of the Housing Authority – were to be issued keys. Unpaid personnel, including unpaid elected officials, were not. At the start of the meeting, following Scott's Public Comment, local citizen

Jeremy Longoria spoke, decrying what he considered to be "...a lot wrong with

Two Public Hearings were next, starting with the second public hearing regarding the proposed Downtown Tax Increment Reinvestment Zone to be located between First and Sixth streets, and between Gregg and Goliad streets. The plan is for the City Council members to serve as board members for the proposed TIRZ. Big Spring resident Scott Emerson spoke on the proposed TIRZ. Emerson,

who owns the Gold Rush Tobacco Shop at 800 E. Third Street, two blocks east of the proposed zone. Emerson questioned how the borders of the zone were determined. Emerson also asked why no representatives of Howard County or the Big Spring Economic Development Corporation were included on the TIRZ board Shane Bowles responded that the purpose of the TIRZ is to redirect property

tax dollars back into downtown infrastructure, so the city wants to keep the zone focused on the downtown blocks. Mayor Thomason also responded, saying that both Howard County and the

Big Spring EDC have been invited to participate in the TIRZ but have yet to respond.

Jeremy Longoria also spoke during the public hearing.

The second public hearing was on the addition of "Indoor Shooting Range" as an permitted use in Big Spring's Heavy Commercial, Light Industrial and Heavy Industrial zoned areas.

Longoria once again commented on the issue, questioning the advisability of condoning gun use in Big Spring, a city that, in April 2021, passed a resolution declaring itself a "Second Amendment Sanctuary City." Big Spring remains the only city (along with 77 counties) in Texas to pass such a resolution.

Big Spring's T.J. Stewart questioned where Indoor Shooting Ranges would be located. Big Spring's Heavy Commercial districts are mainly along Third and Fourth streets. Industrial districts are located north of Third Street, at the Airpark, along FM 700 in east Big Spring, and in north Big Spring along Interstate 20 and along U.S. Highway 350.

The council approved vouchers for March 10 totaling \$1,351,458.06, and for March 17 totaling \$409,605.53.

The council unanimously awarded a contract for the 2022 Seal Coat Project to Ronald R. Wagner and Co. LP of Kendalia, Texas, in the amount of \$1,335,188.49 for the base bid on the project. The total includes three sections, including

City Streets (\$1,014,273.06), Airpark Streets (\$232,382.92) and Howard College (\$88,532.51). The city will fund the City and Airpark sections, while the Howard College will pay for sealcoating its own streets and parking lots.

Following the item during which contemplated legal action against Crossroads Housing died due to lack of a second on the motion, the council unanimously approved an emergency resolution authorizing the city manager to submit an application to the Body-Worn Camera Grant Program for fiscal year 2022 to secure funding for digital storage and other technology relating to body-worn police cameras. The grant would be fore \$17,357.25, with a 25 percent match by the city totaling \$5,785.75.

The council approved naming Mayor Thomason and Finance Director Sandy Smith as representatives authorized to transmit and withdraw funds from the city's TexPool investment acount. Additionally, Assistant Finance Director Gary Givens and Assistant City Manager John Medina are listed as "limited representatives" with the rights to make inquiries for informational purposes regarding the city's TexPool account, but not to perform transactions. The council voted down 3-4 on first reading an ordinance amending the

budget to fund building repairs at the ABC Park building. Had the ordinance passed, the city's budget would have been increased by \$30,000 to pay for the repairs. According to discussion during the meeting, the building is being considered as a new home for the Big Spring Housing Authority. While Mayor Thomason, Councilman Cody Hughes (District 3) and Councilwoman Gloria McDonald (District 4) voted in favor of the item, the rest of the council voted against it.

The next item on the agenda was the item regarding zoning permitted uses for Indoor Shooting Ranges, discussed earlier during the Public Hearing. The item, which passed 6-1 with Councilman Nick Ornelas (District 1) dissenting, allows indoor shooting ranges as a permitted use in Heavy Commercial, Light Industrial and Heavy Industrial zones.

By a 6-1 vote with District 5 Councilman Troy Tompkins dissenting, the council authorized Mayor Thomason to negotiate and execute a right-of-way license agreement with Gravity Oilfield Services LLC near Perimeter Road, and under the railway near mile marker 515.5 on the Toyah Subdivision. According to Public Works Director Shane Bowles, the company thought

that the affected railway was owned by Union Pacific Railroad, so went ahead and created the tunnel beneath the railway. The track is actually owned by the City of Big Spring. Finally, by acclimation, the council approving Maria Padilla as an alternate

member of the Zoning Board of Adjustment. Padilla was nominated by Councilman Nick Ornelas (District 1).

During the time at the end of the meeting during which Council members offer input on items they feel are important, District 4 Councilwoman Gloria McDonald celebrated the recent passage and signing of the Ports-To-Plains bill, which should extend Interstate 27 through Big Spring along U.S. Hwy. 87.

Deshaun Watson trade done, Browns defend decision to add QB

Deshaun Watson's complicated past didn't dissuade the Cleveland Browns from betting on the quarterback's fu-

He is on Cleveland's roster, and at this point that is the only certainty with the talented yet controversial QB.

Watson's stunning trade to the Browns became official Sunday, capping a whirlwind few days during in which the three-time Pro Bowler — accused by 22 women of sexual harassment or assault — agreed to come to Cleveland after initially telling the team he wouldn't.

The Browns are taking heat for bringing in Watson with his legal baggage, but the team feels comfortable with its decision.

"We spent a tremendous amount of time exploring and investigating the opportunity to trade for Deshaun Watson," Browns owners Dee and Jimmy Haslam said in a team news release. "We are acutely aware and empathetic to the highly personal sentiments expressed about this decision. Our team's comprehensive evaluation process was of utmost importance due to the sensitive nature of his situation and the complex factors involved.

"We also understand there are still some legal proceedings that are ongoing and we will respect due process."

Desperate to win, the Browns have gone all in for Watson, sending firstround picks the next three seasons to Houston along with a 2023 thirdrounder and 2024 fourth-rounder. The Texans will part with Watson and a 2024 fifth-round pick.

Cleveland is also giving Watson, who is still facing civil lawsuits, public scorn and possible NFL discipline, a fully guaranteed \$230 million con-

Last week, the Haslams flew to Houston with general manager Andrew Berry and coach Kevin Stefanski and met with Watson to discuss his situation and future. The 26-year-old was also courted by Atlanta, Carolina and New Orleans.

The Browns came away satisfied with Watson's character.

"He was humble, sincere and candid," the Haslams said. "In our conversations, Deshaun detailed his commitment to leading our team; he understands and embraces the hard work needed to build his name both in the community and on the field. ... We are confident in Deshaun and excited about moving forward with him as our quarterback and supporting his genuine and determined efforts."

It's still not known when Watson will be in Cleveland, where fans have been debating the trade for days. The Browns are still working on plans for a possible news conference.

Now that the trade is complete, Watson and the Browns are facing tough questions about their new partner-

For the Browns, he brings hope

along with criticism.

While they become an instant possible Super Bowl contender following another disappointing season, the Browns are also being condemned for taking a player with ongoing legal issues. Nearly two dozen female massage therapists have alleged he assaulted them during rehab sessions.

A grand jury in Texas recently declined to indict Watson on criminal charges, but the civil cases are pending — as is his return to the field.

Watson may face disciplinary action by the NFL, which is conducting an independent investigation about his behavior. Based on precedent, the league could suspend him multiple games for violating its personal con-

Watson's arrival has also ended Baker Mayfield's tumultuous fouryear stay as the Browns' starter. The former No. 1 overall pick asked to be traded last week after learning of Cleveland's pursuit of Watson and

will get his wish. Indianapolis, Seattle and New Orleans are all possible landing spots for Mayfield.

Although Mayfield had a rough 2021 season after injuring his left shoulder in Week 2, the Browns had publicly stated they expected him to come back as their starter this year before

deciding to pursue Watson. As far as the football in concerned, Watson is a major upgrade. He's believed to be one of the league's elite QBs despite not playing last season after requesting a trade. He led the league with 4,823 yards passing in

2020 with 33 touchdown passes. The Browns have completely overhauled their quarterback situation.

Cleveland acquired Watson and has agreed to sign free agent Jacoby Brissett, a former starter in Indianapolis, as his backup. The Browns also agreed to trade veteran backup Case Keenum to the Buffalo Bills on Satur-

And now that they have their quarterback, the Browns are also trying to re-sign free agent defensive end Jadeveon Clowney, who played two seasons with Watson in Houston. Clowney had a solid 2021 with the Browns after signing a one-year deal

New USFL adds 3-point conversions among its rule twists

Three-point conversions, an alternative option for the onside kick and a best-of-three play shootout in overtime are among the different rules for the revitalized USFL.

The new league, which begins play in April, is releasing its rules Wednesday. A copy obtained by The Associated Press explained several twists to the traditional rules in the NFL and college football.

Scoring teams have a third option to attempt an extra point. A successful scrimmage play from the 10-yard line equals three points.

A second option to retain possession after scoring will be converting a

fourth-and-12 from a team's 33. In overtime, each team's offense will alternate plays against the opposing de-

fense from the 2. Each successful scoring attempt will receive two points. The

team with the most points after three plays wins. The subsequent attempts become sudden death if the score is tied after each team runs three plays. The overtime period will extend until a winner is declared.

Other distinctive rules are:

- Two forward passes from behind the line of scrimmage are legal.

- Each coach will be allowed one replay challenge. USFL Replay Command at FOX Sports Control Center in Los Angeles will make all replay decisions.

- All kickoffs will be from the 25. No kicking team member may line up any further back than 1 yard, while the receiving team must have a minimum of eight players in the set-up zone between their 35 and 45. After a kickoff travels 20 yards, the first touch must be by the receiving team. If an untouched kick becomes dead, the ball belongs to the receiving team at that spot.

·On punts, gunners may not line up outside the numbers and they cannot be

double-team blocked until the ball is kicked.

Occasionally, the correct play is missed by declarer because there is a natural aversion to doing it. For this reason, declarer must make every effort to keep an open mind, regardless of how pat a particular situation may seem to be. Take this case where South was in

three notrump and West led a spade. Declarer played the jack from dummy and allowed East's queen to hold. The next spade was likewise refused, and a third spade was taken by the ace.

South now cashed the queen of diamonds, led a club to the ace and played the A-K of diamonds. But when the suit failed to divide 3-3. declarer was finished. The only tricks he could muster were his seven top winners, so he finished Declarer erred by banking every-

thing on an even split of the missing diamonds, about a 36% proposition. This approach made him a nearly 2-1 underdog. South could have nearly doubled

his chances by making the seemingly unnatural play of overtaking the queen of diamonds with the king and cashing the ace. When West's ten appears, the nine is conceded to the jack, assuring declarer of nine tricks. This line of play is far better than

the one South actually adopted. It not only makes the contract when the diamonds divide 3-3, but also whenever the suit breaks 4-2 and the player with the doubleton has either 10-x or J-x. Since with six cards missing, the

doubleton ten or jack will be dealt to one defender or the other 29 times in 100, declarer can thus elevate his chances of bringing in five diamond tricks to about 65%, making him almost a 2-1 favorite to score at least nine tricks.
