BSHA board meeting canceled due to lack of quorum

A meeting of the Big Spring Housing Authority's board of commissioners called for Wednesday afternoon was canceled because none of the commissioners showed up. Members of the BSHA staff and several members of the public braved the triple-digit heat and lack of air conditioning in the BSHA building, the old daycare building adjacent to ABC Park at 1311 W. Fourth Street.

Prior to the posted start time of the meeting — 4 p.m. — BSHA Director Sharon Fritz led members of the media on tours of the building, showing off such deficiencies as water damage and rampant mold.

The meeting was to have included

new location for the BSHA office, and discussion and approval of an engagement letter for David A. Boring, CPA, for an upcoming audit.

The meeting's agenda also included a closed session to discuss personnel matters and contemplated litigation.

It's 4:01 at the Big Spring Housing Authority. The only person here is myself. The board did not show up. We don't have a quorum, so I guess I'm going to adjourn this meeting," Fritz said.

Following the adjournment, those present held a discussion of issues facing the Big Spring Housing Authority. Fritz said elements within the

city government are attempting to close the Big Spring Housing Authority, transferring its vouchers and clientele to

the Abilene Housing Authority office. "I just want people to know that they're trying to transfer

"When I was 17 – Chandra would've been maybe 12 or 13 – we lost our house. "That next morning - I'll never forget this - I got up and went to the bathroom, and I wanted to brush my teeth and I realized I didn't have a toothbrush. I've never forgotten that. That really, for me, put

it into perspective." The pair were taken in by local resident Mary Neil Mansfield and her rodeo celebrity husband, none other than Coy Herman "Toots" Mansfield.

"She picked us up and she bought everything from toothbrushes to tennis shoes. If you hadn't known that had happened to us on that Friday...if you didn't see it in the newspaper, or you weren't in our circle...on Monday at school you would've never known,"

Texas inmate who escaped bus got out of restraints, cage

CENTERVILLE, Texas (AP) - A convicted murderer who escaped from a prison transport bus in Texas last week got out of his restraints and a cage before stabbing the driver, and he is still on the run Wednesday, authorities said.

Gonzalo Lopez, 46, who was serving a life sentence, was being transported to a medical appointment on May 12 in a caged area of the bus designated for high-risk inmates, the Texas Department of Criminal Justice said in statement offering new

As Lopez was being transported, he somehow freed himself from his hand and leg restraints, cut through the expanded metal of the cage and crawled out the bottom, the department said. He then attacked the driver,

Biden warns of 'another tough hurricane season' this year

JOINT BASE ANDREWS, Md. (AP) — President Joe Biden warned Wednesday that the country will likely see "another tough hurricane season" this year, and he pledged that his administration was prepared to respond to the storms and help Americans recover from them.

"We know hurricanes are coming our way. They grow more extreme every season," Biden said before a briefing from top federal officials, including Federal Emergency Management Agency Administrator Deanne Criswell and Secretary of Housing

Biden urged Americans to "pay attention to hurricane warnings and follow the guidance of your local authorities."

Before his remarks, Biden toured a hangar at Joint Base Andrews to view aircraft used to track and respond to hurricanes. One of the planes is used to fly through and above

the storms, capturing data that allow meteorologists to produce more accurate forecasts. "It is really amazing what you all do to protect

us," Biden said.

Last year's worst storm was Hurricane Ida.

this, and I think they need to be contacting their representatives, they need to be contacting whoever they can to keep this program in this town," she said. "Abilene's a good organization, but it's not local, and you don't want to close it down because those vouchers will eventually go away." The job isn't too big for the BSHA to handle, Fritz

emphasized. "We always pass our financials. We've never had

a bad audit. Our financial people that come in, they come from Lubbock. They do Abilene Housing Authority, they do Midland, I think they even do Odessa. They do Lamesa. They do housing authorities. They don't just audit our financials, they audit our tenant files. They go through those files and make sure we're following guidelines. There's never been a finding. Never been a finding, and I've been in this office 17 years. So that's not an issue. If they think it is, they need to come in and I can show them. But they're not going to be here anyway. That board doesn't want to have anything to do with it.'

Fritz said many people that use the BSHA services have limited mobility or lack of transportation, and can't travel to Abilene for Housing Authority

The BSHA board held a meeting Monday in the City Council Chambers during which Blankenburg was elected chairperson and Nabors was elected vice-chairperson.

The meeting also included a motion to fire Diane Yanez, an employee of the Housing Authority, because she is also a member of the Big Spring City Council. Following a closed session on Monday, the item was tabled.

who stopped the bus and got into an altercation with Lopez and they both eventually got off the bus, the department said.

that I had, for a long time, I knew this was going to happen."

At some point the driver was stabbed and wounded in the hand and chest, said Jason Clark, the department's chief of staff. He said the driver's wounds weren't life threatening.

A second officer at the rear of the bus then exited and approached Lopez, who got back on the bus and started driving down the road, the department The officers fired at Lopez and disabled the bus

by shooting the rear tire, the department said. The bus then traveled a short distance before leaving the roadway, where Lopez got out and ran into the

Sixteen prisoners were aboard the bus, but no one else escaped, the department said.

Lopez, who was convicted in 2006 of killing a man along the Texas-Mexico border, escaped in Leon County, a rural area between Dallas and Houston. Several law enforcement agencies are involved in the search, which has included aircraft and teams on horseback and canine teams. Leon County has roughly 16,000 residents, and is

about 50 miles (80 kilometers) north of the state's prison headquarters in Huntsville. Lopez was being transported from a lockup in

Gatesville, more than 100 miles (160 kilometers) west of the area where he escaped, to one in Hunts-

The reward for information leading to Lopez's capture has increased to \$50,000.

Catholic leader blasts Israeli conduct at journalist funeral By LAURIE KELLMAN and AREEJ H

JERUSALEM (AP) — The top Catholic clergyman in the Holy Land on Monday condemned the police beating of mourners carrying the casket of Al Jazeera journalist Shireen Abu Akleh, accusing the authorities of violating human rights and disrespecting the Catholic Church. Latin Patriarch Pierbattista Pizzaballa told reporters at St. Joseph Hospital

in Jerusalem that Friday's incident, broadcast around the world, was a "disproportionate use of force" against a large crowd of people waving Palestinian flags as they proceeded from the hospital to a nearby Catholic church in Jerusalem's Old City. The attack drew worldwide condemnation and added to the shock and outrage over the death of Abu Akleh, who was killed as she covered a shootout in the occupied West Bank.

The police attack, Pizzaballa told reporters, "is a severe violation of international norms and regulations, including the fundamental human right of freedom of religion, which must be observed also in a public space." Leaders and clergy of other Christian churches sat nearby. There was no immediate Israeli response.

Israel and the Palestinians are locked in a war of narratives over Abu Ak-

leh's killing. The reporter, a Palestinian-American, a Catholic and a 25-year veteran of the satellite channel, was shot Wednesday while covering an Israeli military raid in the Jenin refugee camp. She was wearing a blue vest clearly

marked "Press." Abu Akleh was a household name across the Arab world, known for documenting the hardship of Palestinian life under Israeli rule. Palestinian officials and witnesses, including journalists who were with her, tinued to argue over the investigatiton. say she was killed by army fire. The military, after initially saying Palestinian

gunmen might have been responsible, later backtracked and now says it's not clear who fired the deadly bullet.

The United States and United Nations are among the many critics of the police crackdown at the funeral. Israeli police say they agreed on funeral arrangements ahead of time with

Abu Akleh's family, and that a crowd of mourners violated that agreement by marching with the coffin, instead of driving with it, and shouting nationalistic slogans. But Abu Akleh's brother, Anton, disputed those

claims. He said Monday that the family had given the funeral arrangements to Israeli police. He said police did not want slogans or Palestinian

flags. But he said "this is something we cannot con-Anton said police also wanted to know the funeral route, and there was no other agreement. "We want-

ed to put the coffin in the car," he said. "We were going to the car when they attacked us." Israeli police launched an investigation into the conduct of the officers who attacked the mourners, causing the pallbearers to nearly drop the casket. Is-

rael's public broadcaster Kan published what it said

was security camera video showing police bursting into the hospital before the funeral. Meanwhile, Israel and the Palestinians have con-

Cancer is not new to our family. My wife is a

breast cancer survivor, as is her sister, who has been battling stage four cancer for the past eight years. Her cancer is spreading and she is about to start chemo again. My father died of multiple myeloma, cancer of the bone marrow, when he was 53. He bestowed on me a life-long memory of courage, faith and grace. I took $B_{\rm ILL}$ him to visit his friends the week before he died. He was too week to remain standing. He greeted each with a cheerful smile and his natural good humor. But I could see the sadness written in their faces when they witnessed the seriousness of his condition.

My daughter-in-law was diagnosed with breast cancer four years ago while our grandchildren were still at home. Life becomes precious when we are faced with our mortality and the mortality of those we love. Knowing that thousands are traveling a similar journey, I wanted to share a couple of her journal entries.

Battling Cancer

She wrote, "Today was a great day. I woke up v



Lowe HR in 10th gives Rangers 6-5 win and sweep of Angels

ARLINGTON, Texas (AP) — Nathaniel Lowe is starting to feel better at the plate again for the Texas Rangers, and one big swing gave them a series sweep.

Lowe hit a two-run homer on the first pitch in the bottom of the 10th inning and the Rangers, after blowing the lead in the ninth and falling behind in the top of the 10th, beat the Los Angeles Angels 6-5 on Wednesday night.

"Right man, right spot," Rangers manager Chris Woodward said. "The weight was lifted yesterday. Felt confident coming into today and wins the game for us." It was the second game in a row for Lowe to have the go-ahead or

winning RBI late, following a streak of 19 games in a row without driving in a run for the team's player of the month in April when he hit .313. He hadn't had an RBI in May until his go-ahead hit in a seven-run eighth-inning Tuesday night, though he is still mired in a 6-for-64 slump.

The Angels got even at 4 on Jared Walsh's second homer of the game, a two-run shot in the ninth. They went ahead in the top of the 10th on a fielder's choice grounder by Mike Trout, who homered earlier in the game.

That was after Texas, which matched its season high with its fourth win in a row, got solo homers by Brad Miller in the seventh and former Angels outfielder Kole Calhoun in the eighth inning. Lowe's second homer of the season, pulled just inside the right-field pole, gave the Angels their first three-game losing streak this year. "That's huge for morale and confidence. And that's all you want

in baseball, is to go out and play with confidence," Rangers catcher Jonah Heim said. "And if we know we can sweep the team that's in first place, we can do a lot more damage in the division." Heim had three hits and drove in two runs against against An-

gels starter Shohei Ohtani, but the Rangers' switch-hitting catcher struck out with the bases loaded in the ninth against just-in closer Raisel Iglesias (1-2), who then gave up in the homer to Lowe in the

"They played as well. They beat us fair and square. So give them credit that they've been ascending a bit," Angels manager Joe Maddon said "So it's just another example of why our division is so dif-

Heim also wasn't able to handle the low and wide throw from third baseman Andy Ibanez after Trout's grounder in the 10th with Andrew Velazquez charging home from third. Velazquez started the inning on second and went to third on a single by Taylor Ward, now

the big league's top hitter with a .375 batting average.

Dennis Santana (2-1), who allowed the unearned run in the 10th, was the four Texas reliever after Dane Dunning limited the Angels to those two early solo homers and struck out six over six innings.

Texas had loaded the bases against Jose Suarez in the ninth on consecutive one-out singles by Marcus Semien and Corey Seager before a two-out walk to Calhoun. When Maddon got on the mound to make a pitching change, he was ejected after words with home plate umpire CB Bucknor.

Heim hit a grand slam off Ohtani the last time the two-way star pitched in Texas on April 14 and gave up six runs in 3 2/3 innings. This time, Heim had an RBI single in the fourth, and his RBI double in the sixth tied it at 2. Ohtani struck out seven and walked two while allowing two runs

and six hits over six innings. The right-hander also threw two wild pitches, but he still hasn't lost in his five starts.

When Ohtani lost at Texas a week into the season, he was 0-2 through his first two starts after going 9-2 in 23 starts last season. He is 3-0 with a 1.50 ERA since, even with consecutive no-decisions.

LONG DRIVES

Trout led off the fourth with his 11th homer, a line drive into the left-field seats that was almost identical to his homer the previous night, for a 2-0 lead. He leads the AL with 32 runs scored this season and has 999 in his career. ... Calhoun has four homers in four games, and five overall.

TRAINER'S ROOM

Angels: Maddon said INF Matt Duffy's left hand was sore after he was knocked down while playing first base in a collision with Rangers outfielder Adolis Garcia in Tuesday's game. Duffy also had a cut under his eye from getting hit by the thrown ball on the play. "He looks worse than he actually is," Maddon said. Duffy entered Wednesday as a pinch-hitter and grounded out.

UP NEXT

Angels: There is an off day Thursday before opening an nine-game homestand. Oakland visits this weekend, then the Angels have another off day Monday before hosting the Rangers next week.

Rangers: After going 6-3 on their homestand, Texas opens a fourgame series Thursday night at Houston. That will wrap up a stretch of 16 games in 15 days since consecutive rainouts in New York against the Yankees.

Curry's 21 points, 12 boards lead Warriors in Game 1, 112-87

SAN FRANCISCO (AP) — Once Stephen Curry and Klay Thompson slowed down, caught their breath and stopped rushing shots, the Splash Brothers got on a roll that proved too much for Dallas to stop.

Especially because Andrew Wiggins worked end to end to make sure Luka Doncic couldn't get going. Curry had 21 points and a game-high 12 re-

bounds, Golden State held Doncic in check and the Warriors beat the Mavericks 112-87 on Wednesday night for a 1-0 lead in the Western Conference finals.

"Just make him work, that was the main thing," Wiggins said.

Doncic scored 20 points but shot just 6 for 18 and 3 of 10 from deep.

He made back-to-back 3-pointers late in the first half to get his team within 54-45 at the break, but Curry and Thompson heated up and helped the Warriors pull away in the second half.

"A great job. That's it," Doncic said. "They did a great job."

Jalen Brunson scored 14 points but missed all five of his 3s for the surprising Mavs, who stunned the top-seeded Suns in a 123-90 thumping in Game 7 on Sunday in Phoenix.

Game 2 in the best-of-seven series is Friday night at Chase Center, where the raucous, yellow-clad sellout crowd brought back memories of that 2007 "We Believe" Warriors playoff team led by Baron Davis that shocked the No. 1-seeded Mavericks in a six-game first-round upset at Oracle Arena.

That helped propel Golden State back to prominence.

The Warriors reached five straight NBA Finals from 2015-19 but missed the playoffs the past two years before this run.

Wiggins added 19 points, getting Golden State going by making six of his first eight shots on the way to shooting 8 for 17. Jordan

Poole also scored 19 off the bench. Doncic received a scratch across his face early from a first-quarter swipe by Wiggins. The

mark — "makes me look tough," he quipped went from the bridge of the star guard's nose across his right cheek under the eye. Doncic also tugged at his troublesome right shoulder that has been taped previously during these

"They did a really good job. Wiggins picking him up full court," Mavs coach Jason Kidd said. "They went box-and-one, they went zone. We understood coming into the series that we were going to see that. We'll go back and look at the video and see what we can do better."

Stopping Doncic, who was averaging 31.5 points in the playoffs, is the tall task this time after the Warriors already handled two-time reigning MVP Nikola Jokic of Denver in the first round, then Ja Morant early last series before his knee injury.

"I thought Wiggs was fantastic," coach Steve Kerr said. "Doncic is as difficult a cover as there is in this league. ... It's important to make him work. He's so good. Any great player in the league you're trying to limit the damage that they do."

Curry, last season's scoring champ, missed his initial five 3-point tries before connecting with 50 seconds left in the first half. But he got involved other ways by dishing out four assists and grabbing seven rebounds. Then he hit two quick 3s in sparking a 10-2

burst to begin the third for a Golden State squad that eliminated Memphis in a six-game semifinal series. "It is how we play," Curry said. "When you

have that ability to create separation like we did in the third quarter, it's a fun way to play."

Thompson scored all of his 15 points after "I didn't have a field goal in the first half but

that will never discourage me," Thompson said. "I will always hunt my shot." Kevon Looney remained in the starting line-

up for Kerr as the coach made his return to the bench after sitting out the final three games against Memphis with COVID-19.

"It was great to be back. I missed being out there with the guys," Kerr said. "Amazing at-

mosphere here at Chase and we're excited to

keep going."

Looney finished with 10 points, five rebounds and four assists after coming in to start the

Game 6 clincher against the Grizzlies. Kidd's Mavericks couldn't keep up in a drastic contrast of styles featuring the slow-paced Dallas attack and up-tempo Warriors."We would like to play our pace but the Warriors have a unique pace, they're going to get out and put a lot of pressure on your defense in transition," Kidd said. "We have to be cautious of that. We don't want a track meet."

MAVS FINED

Dallas received a \$50,000 fine by the NBA the team's second penalty this postseason

— for "team bench decorum" during the Suns series after players and a member of the coaching staff remained standing for extended time far enough from the bench area that they were "encroaching upon the playing court during game action" during Game 7 against the Suns.

"Just trying to figure out what we did wrong to get the fine," Kidd said. "... Who complained? It was a blowout so I don't think the fans were complaining. I thought the guys did what they were supposed to do. They were cheering on their guys."

The previous fine against the Mavs was for \$25,000 on May 6.

The proposed designated downtown area improvements include reconstruction of approximately four hundred ninety linear feet (490 I.f.) of sidewalk, five hundred and twenty-five linear feet (525 l.f.) of curb and gutter, five (5) ADA ramps, two hundred twenty square yards (220 s.y.) pavers, related pavement repair, replacement of approximately three hundred forty linear feet (340 I.f.) of water line, utility adjustments, related pavement repair, and reconstruction of approximately one hundred sixty linear feet (160 l.f.) of roadway utilizing approximately six hundred square yards (600 s.y.) of material and all associated appurtenances. There are three primary purposes for this notice. First, people who may be affected by activities in floodplain and/or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Commenters are encouraged to offer alternative sites outside of the floodplain and/or wetlands, alternative methods to serve the same project purpose, and methods to minimize and mitigate impacts. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplain and/or wetlands can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplain and/or wetlands, it must

1. One spade. It's true that this hand is very close to an opening bid, and you might therefore feel tempted to bid two spades to show a maximum passed hand. Nevertheless, it's better to bid only one spade even knowing that partner might pass. This is partly because your spade suit is too weak for a jump, and partly because your hand has depreciated in value after partner's opening bid in the suit in which you have a singleton. The one-spade response makes allow-

ance for a possible misfit.

2. Two spades. Here you should let partner know that there is a good chance for game, despite your previous pass. You do this by making a jump-shift response. True, you have only 10 high-card points — just as in the previous hand — but this time you have much better prospects for game, either in spades or in hearts. Strictly speaking, the jump-shift is not forcing, but part-

ner will seldom pass.

3. Four hearts. Considering your excellent trump support and singleton diamond, this hand should now be regarded as worth a full opening bid. An alternative, if you play "splinter bids," is to jump to four diamonds, indicating heart support and a singleton or void in diamonds in a hand that has improved enough to warrant bidding game.

4. Two diamonds. Here you passed a borderline opening bid, but it's still best to avoid trying to compensate for that by now jumping to three diamonds. Partner's heart opening didn't help your hand much, and in fact hurt it slightly. Your response on the two-level indicates at least 10 points and a good diamond suit. If partner passes knowing you might have up to 12 points, the chances are that there is no game.

5. Two clubs. It might not have been your style to pass originally, but let's assume for the moment that someone twisted your arm and you did. Granted that it is tempting to jump to three clubs at this point, you will do better in the long run to restrain yourself and bid only two clubs. It is usually best not to crowd the bidding on hands where there is more than one message to deliver. Therefore, you should leave as much room as possible to show your spades next at a relatively low level.

In 1916, the Saturday Evening Post published its first Norman Rockwell cover; the illustration shows a scowling boy dressed in his Sunday best, dutifully pushing a baby carriage past a couple of boys wearing baseball uniforms.

In 1927, Charles
Lindbergh took off from
Roosevelt Field on
Long Island, New York,
aboard the Spirit of St.
Louis on his historic
solo flight to France.

In 1932, Amelia Earhart took off from Newfoundland to become the first woman to fly solo across the Atlantic. (Because of weather and equipment problems, Earhart set down in Northern Ireland instead of her intended destination, France.)

In 1948, Chiang Kaishek (chang ky-shehk) was inaugurated as the first president of the Republic of China (Taiwan).

In 1959, nearly 5,000 Japanese-Americans had their U.S. citizenships restored after choosing to renounce them during World War II.

In 1961, a white mob attacked a busload of Freedom Riders in Montgomery, Alabama, prompting the federal government to send in U.S. marshals to restore order.

In 1969, U.S. and South Vietnamese forces captured Ap Bia Mountain, referred to as "Hamburger Hill" by the Americans, following one of the bloodiest battles of the Vietnam War.

In 1985, Radio Marti, operated by the U.S. government, began broadcasting; Cuba responded by attempting to jam its signal.

In 2009, in a rare, bipartisan defeat for President Barack Obama, the Senate voted overwhelmingly, 90-6, to keep the prison at Guantanamo Bay open for the foreseeable future and forbid the transfer of any detainees to facilities in the United States.

In 2015, four of the world's biggest banks ,Äî JPMorgan Chase, Citigroup's banking unit Citicorp, Barclays and the Royal Bank of Scotland ,Äî agreed

to pay more than \$5

billion in penalties and plead guilty to rigging the currency markets.

In 2020, President

Donald Trump threat-

ened to hold up federal

funds for two election battleground states (Michigan and Nevada) that were making it easier to vote by mail during the pandemic. Police ticketed seven people for cutting hair during a protest against coronavirus restrictions outside the Michigan Capitol, where about a dozen barbers and hair stylists defied stay-athome orders to give free haircuts.

Ten years ago: A twoday NATO summit hosted by President Barack Obama opened in Chicago. Thousands of protesters marched through downtown Chicago, airing grievances about war, climate change and a wide range of other complaints. Abdel Baset al-Megrahi (AHB'-dehl BAH'-seht AH'-lee ahlmeh-GRAH'-hee), 60, the only man convicted in connection with the bombing of Pan Am Flight 103 in 1988, died in Tripoli, Libya. Robin Gibb, 62, who along with his brothers Maurice and Barry, defined the disco era as part of the Bee Gees, died in London.

Five years ago: President Donald Trump opened a five-stop overseas tour, his first since taking office, receiving a lavish royal welcome in Saudi Arabia.

One year ago: Israel and Hamas announced a cease-fire, ending a bruising 11-day war

that caused widespread

destruction in the Gaza Strip and brought life in much of Israel to a standstill. CNN said it was inappropriate for news anchor Chris Cuomo to have been involved in phone calls with the staff of his brother, New York Gov. Andrew Cuomo, as the governor decided how to respond to sexual harassment allegations. (CNN would fire Chris Cuomo in December 2021 over his role in helping his older broth-

Crews slow New Mexico fires, brace for dangerous conditions

ALBUQUERQUE, N.M. (AP) — More than 2,000 firefighters

battling the largest U.S. wildfire dug back-up fire lines and rearranged fire engines around homes in northeast New Mexico on Wednesday in anticipation of a return to windy, dangerous conditions in the days ahead. After a break in the weather allowed for significant progress

on the ground and from the air in recent days, forecasters issued warnings for high fire danger from southern Nevada through parts of Arizona, New Mexico and Colorado starting Thursday. "The next three days are going to be the giddy-up days," fire

behavior analyst Dennis Burns said Wednesday. "Crews are out there working as hard as they can to get in line

the fire east of Santa Fe stretching northeast toward Taos.

as quickly as possible," he said during an afternoon briefing at

Most of the large fires so far this spring have been in Arizona and New Mexico. The largest has raced across more than 471 square miles (1,220 square kilometers) of forest that many fire managers have described as "ripe and ready to burn" due to a megadrought that has spanned decades and warm and windy

New Mexico Gov. Michelle Lujan Grisham has said damage estimates for homes and structures could reach more than 1,000 by the time all the assessments are done. On Wednesday, no new evacuations were ordered and some

were relaxed. Burns said the biggest new concern was that thunderstorms packing lightning and strong down-draft winds would fuel the fire again Thursday. Bulldozers and hand crews were building contingency lines

near the town of Angel Fire east of Taos to make sure the flames don't reach U.S. Highway 64 within about 25 miles (40 kilometers) of the Colorado line. "If we are fortunate enough to dodge that bullet, the cloud cover

will actually shade out the fuels and moderate the fire behavior a little bit, which is a good thing," Burns said Wednesday. "But tomorrow will be the day to tell."

While the fire encompasses an area more than 1.5 times the size of New York City, fire managers said there are pockets of green within the perimeter that could still burn. "We're trying to go all the way around the edge of the fire and

we want to keep the fire where it is right now," Jayson Coil, an operations chief assigned to the blaze, said Wednesday of using bulldozers to cut wide lines that can block flames. Fire managers also said not all areas have been burned severe-

ly, and crews have been able to protect many homes and struc-

tures by clearing out vegetation and using sprinklers and hose lays to knock down the flames as they approach populated areas. Lujan Grisham spoke with President Joe Biden on Tuesday and underscored the impacts of the fires on communities and the need for ongoing partnership with the federal government as the drought-stricken state recovers and rebuilds from some of the

most devastating wildfires on record in New Mexico. Biden reaffirmed the support of the federal government and said every effort will be made to provide immediate help to people in the impacted communities. He also expressed his gratitude to the first responders, firefighters and other personnel who are battling the blazes and have come to the aid of residents.

Evacuation orders remain in place for residents near a handful of large blazes in New Mexico, Colorado and Texas, where three large fires were reported Tuesday, according to the National Interagency Fire Center. Lujan Grisham has warned that many New Mexico residents,

depending on where they live, should be ready for potential evac-

uations all summer given the likelihood for higher fire danger due to strong winds, warmer temperatures brought on by climate change and forecasts for little to no precipitation. Another fire burning in the Gila National Forest in southern New Mexico had grown more than 57 square miles (148 square kilometers) overnight Tuesday into Wednesday, causing concern

among state officials. Forest roads and trails in the area were closed, but officials said late Wednesday crews made good progress during the day that kept the perimeter from growing.

Buffalo shooter let some people see plans just before attack ing a baseless extremist conspiracy theory

Associated Press Shortly before he opened fire, the white

gunman accused of killing 10 Black people at a Buffalo, New York, supermarket allowed a small group of people to see his detailed plans for the attack, which he had online diary. Discord, the chat platform where 18-vearold Payton Gendron kept the diary, con-

firmed Wednesday that an invitation to access his private writings was sent to the group about a half-hour before Saturday's attack at Tops Friendly Market, which he live-streamed on another online service. Some of them accepted. Gendron's diary and its racist, anti-Semitic entries dated to last November

included step-by-step descriptions of his assault plans, a detailed account of a reconnaissance trip he made to Buffalo in March, and maps of the store that he drew by hand. "What we know at this time is that a private, invite-only server was created by the

suspect to serve as a personal diary chat log," a Discord spokesperson said in a written statement. "Approximately 30 minutes prior to the attack, however, a small group of people were invited to and joined the server. Before that, our records indicate no other people saw the diary chat log in this private server." It wasn't clear if any of the people who

accessed Gendron's diary or saw his livestream did anything to alert the authorities or attempt to stop the attack. Discord said it removed Gendron's diary as soon as the platform became aware of it, in accordance with the company's policies

against violent extremism. Buffalo Police Commissioner Joseph Gramaglia said Monday that investigators were working to obtain, verify and review

Gendron's online postings. Copies of his Discord diary — essentially a transcript of his postings to his private chat log — briefly surfaced elsewhere online after the shooting, along with a 180page screed attributed to him. Both were

laced with white supremacist beliefs echo-

about a plot to diminish the influence of President Joe Biden, visiting Buffalo on Tuesday, repudiated such beliefs, saying:

"Now's the time for people of all races, from every background, to speak up as a majority ... and reject white supremacy." Gendron was arraigned over the weekend on a murder charge; a not guilty plea

Gendron wrote that he originally planned his attack for March 15, the three-year anniversary of Tarrant's Copies of Gendron's diary postings were

shared with The Associated Press by Marc-André Argentino, a research fellow at the London-based International Centre for the Study of Radicalisation and Political Violence. He said it was possible but unlikely the diary could have been altered by someone other than the author. Gendron, in the diary, said he specifical-

ly targeted a store with a predominantly Black clientele, researching spots in Rochester, Syracuse and on Long Island before settling on Buffalo. Prosecutors say he showed up Saturday wearing body armor and armed with an AR-15-style rifle as a helmet-mounted camera streamed to the internet.

Problems with his gun and then a bout with COVID-19 — which he theorized he contracted from a fast-food chicken sandwich poisoned by government agents interview earlier on Wednesday that the prevented him from attacking earlier, he wrote in the diary.






