A soldier is never forgotten. Not by his family, by those whom he served with, or his community. After 51 years, CPL Hernandez was honored for his service - in his hometown - in a special ceremony at Mt. Olive Cemetery. The

ceremony included several memories shared, questions were answered, and long overdue honor was rendered.

The Company commander never signed off on the Purple Heart for Hernandez and the three others who lost their lives that night, but the company made it a point to ensure that honor was given where honor was due. As part of

the tokens of honor presented, an honorable Purple Heart was given to Hernandez's family in honor of his sacrifice.

"Men had to be wounded to be able to receive this award. The Purple Heart is the second highest honor you can receive in the United States military.

First regular council meeting for Mayor Moore scheduled Tuesday

Those wishing to sound off to Big Spring's new mayor in a public forum will have a chance to do so at Tuesday evening's city council meeting.

Newly seated Mayor Robert Moore will preside over his first regular session of Big Spring's council at 5:30 p.m. Tuesday in the City Council Chambers, 307 E. Fourth Street.

Following the meeting's call to order, invocation, and Pledges to the U.S. and Texas flags, the council will hear public comments before delving into two public hearings.

The first hearing concerns tax abatement guidelines, while

the second allow citizens to voice their opinion on the city's proposed annexation of about 5.08 acres north of the intersection of Oak Glen Drive and Holland Grace, a tract comprising six lots in the N/2 of Sec. 8, Blk. 32, Township 1-S, Texas and Pacific Railroad Company Survey.

The council will vote on both items later in the meeting.

Next, City Manager Todd Darden will give his report, including an update on the May 18 Large Item Pickup in District 5, the budget schedule, the planned opening of the Russ McEwen Aquatic Center on June 4, the city's observance of Memorial Day on May 30, recognition of code officers and Street

While our company commander never signed off on it for any of those who died that night, it was one of the things that has bothered us as a company. They deserve; the rule of the Purple Heart declared because the enemy was being fired upon, the round shot was meant to inflict damage to personnel and equipment... We believe they deserve it... Charlie Company, as you can see after 51 years, we follow through," Gary Gilliam said.

Sgt. Rolland Christiansen had the honor of presenting the family with this special award.

"We believe Art deserved it... One of the definitions of Purple Heart says it is not given out in friendly fire missions," Christiansen said. "If the artillery fire was in support of a mission and was fired at the enemy then it can be presented. As Gilliam mentioned, that artillery fire was... Here we are unofficially, we would like to give a Purple Heart to Arthur Hernandez, presented by veterans of Charlie Company 2/506th."

CPL Arthur Hernandez, soldier in the Army's 101st Airborne Division, lost his life on April 1, 1971, in Vietnam during Operation Lam Son 719 in Laos.

"On many occasions, such as this one, the family doesn't get a lot of the information. We are able to provide some of that information. Getting that information out to the family is good for them and good for us," Tom Weides said. "We are here today trying to bring us some peace, as well as the family."

The ceremony included the presentation of several tokens of appreciation, awards and honor. The family was presented with a plaque, air assault wings, Combat Infantry Badge, presentation coin, 101st plaque presentation, 101st emblem, Currahee Emblem, American flag, and the 506th Flag presentation.

For the past 11 years, members of Charlie Company, 2/506th 101st Airborne have gathered to honor their fallen brothers. The band of brothers travel from their homes in California, Washington, Wyoming, Oklahoma, Missouri, Arkansas, Illinois and

Texas, to visit the final resting places of those members who did not make it home. Of the company, there have been 26 who have lost their lives. Over the past several years, the surviving members have made it to the final resting place of 23 of the 26 fallen soldiers.

During the special ceremony, before the crowd dispersed, roll call was taken. Company members answered as their names were called, as CPL Hernandez's name was called the weight of the silence brought a somber moment of remembrance.

"... He is here Sergeant. He lives within us," answered a member of the company.

Following Roll Call, as "Live Brother Live" was read, company members placed a commemorative coin on his headstone and paid their last respects. Following the members of the company, veterans in attendance took a moment and paid their respects to the fallen soldier.

There are no words to truly describe the honor and gratitude that was displayed during the Saturday morning ceremony, but one thing is for sure, a soldier will not be forgotten.

Department workers receiving certifications, an update on the City Employee Appreciation Picnic, and extending sympathy to the family of former Big Spring Mayor Cotton Mize on his passing.

The meeting's consent agenda includes two items: Approval of the minutes of the regular May 10 meeting and the special May 17 meeting; and final reading of a resolution approving the COVID-19 Pandemic Relief Recovery Plan for the City of Big Spring.

The council will consider approval of vouchers tabled at the previous council meeting as well as those for the current reporting period. Tabled vouchers include those for April 25 for \$41,800 and for April 28 for \$399,409.43; while the new vouchers include those for May 12, 2022 for \$499,918.06 and for May 19 for \$1,042,199.80; as well as drafts and manual checks totaling \$49,564.11.

The council will consider one bid award and one consideration of action to request bid proposals. The award is on a 12-inch water line relocation project for \$124,424 submitted by Whitewater Construction Inc. out of Waco - the only bid received on the project; while the RFP under consideration is on sale of the former GEO-operated Interstate Unit prison on Interstate 20.

In New Business, the council will acknowledge receipt of the Big Spring Economic Development Corporation's board minutes from its April 19 meeting.

Next on the agenda is consideration and possible action on a funding request from the Convention and Visitor's Bureau for the Ports-To-Plains Alliance Conference taking place in Big Spring Sept. 14-16. Documentation in the meeting's agenda suggests that the conference could fill 75 hotel rooms during the event.

The next item on the agenda is a resolution specifically granting Big Spring's city manager the authority to negotiate business contracts for the city. The item specifies three items currently before the city: a right-of-way license agreement for a saltwater lines and a water line with Gravity Oilfield Services; negotiations with Immigration Customs Enforcement to operate three detention centers; and negotiation of an economic incentive agreement with

Compute North.

The item would also apply to future contracts.

"Negotiating authority for future City contracts relating to real property interests (including surface and/or mineral interests) and economic development agreements shall be vested (with the city manager or his designee, which may not include an elected official)," according to the resolution.

Next on the agenda, the council will consider approval of tax abatement guidelines.

The city will consider a resolution suspending the June 17 effective date of Oncor Electric Delivery Company's rate change, to allow the city time to study the request.

The city will consider an item granting the city manager the responsibility of establishing city council agendas.

The council will consider granting a partial tax exemption on ad valorem taxes for the 2022 tax year for homestead property.

Next, the council will consider annexation of the six lots mentioned at the opening of this article.

The council will consider an item tabled at a previous meeting, concerning greens fees at the city's municipal golf course for retirees, as well as an ordinance amending the definition of "retiree" in the "Parks, Recreation and Cultural Affairs" section of City Code pertaining to the golf course.

The council will consider action on a "Meet and Confer" agreement between the city and the Big Spring Professional Firefighters' Association.

The council will consider action on an agreement with Tommy Churchwell establishing the exact location of a property line between city property and Churchwell's private property in the Moss Creek Lake area.

The council will consider approval of the appointment of Erin Yeats to the Zoning Board of Adjustment for District 6.

Council members will have the opportunity to offer input prior to the meeting's adjournment.



The Coahoma Bulldogette softball team made a clear statement Saturday afternoon. They are a force to be reckoned with! The seventh ranked Bulldogettes faced off against the twelfth ranked Bushland Lady Falcons in a best of three game series in the 3A region 1 semifinals. Games took place at Lubbock Cooper with game 1 on Friday and games 2 and 3 on Saturday. The stands were packed with Coahoma fans cheering and watching on as the Bulldogettes continue to make history.

The Bulldogettes got it done beating the Lady Falcons on Friday 2-0 and then again on Saturday 7-5, punching their ticket to the regional finals and one step closer to advancing to the state softball tournament. Game 1 saw both teams play great defense, but it would be Coahoma who struck first. Maddison Rodgers started things off for Coahoma in the bottom of the first inning. From that point, Coahoma played great defense to secure the win for game 1.

Coahoma's freshman phenom Hannah Wells pitched a complete game earning the shutout win. Wells would finish the night with 10 strikeouts, 2 hits, and no walks.

Game 2 on Saturday started where it left off in game 1, great defense from both sides. Both Coahoma and Bushland would end the first inning scoreless. Going into the bottom of the second inning Bushland would score 2 runs to give them the lead 2-0. Facing a 3-1 count Wells cranked the ball to right field bringing in Rodgers and Burt for the score and Wells going all the way to third. Wiggins, Warriors dunk Mavericks 109-100 for 3-0 series lead

DALLAS (AP) — Stephen Curry shimmied for the TV crew, Andrew Wiggins shook Luka Dončić with a posterizing dunk and the Warriors are thinking sweep.

Curry scored 31 points, Wiggins' playoff career high 27 points included the dunk that was originally called an offensive foul and Golden State beat the Dallas Mavericks 109-100 Sunday night for a 3-0 lead in the Western Conference finals.

"He's looking like Dominique Wilkins out there," Klay Thompson said of Wiggins after scoring 19 points as the Warriors moved to the brink of the NBA Finals, three years after the end of a five-year run that yielded three championships.

Golden State, which swept Portland in its most recent West finals in 2019 before Toronto won the title, goes for the sweep in Game 4 on Tuesday in Dallas. No team has rallied from 3-0 down to win an NBA playoff series.

"I love the position we're in," Warriors coach Steve Kerr said. "I love the fact that our team came in and got the win tonight. This was the one we felt like we had to get. Coming here up 2-0, you've got to take advantage of your momentum."

Dončić scored 40 and beat the first-quarter buzzer with a 32-footer that got the crowd going with the Mavericks again at home trailing 2-0, as they did against top-seeded Phoenix before winning the West semifinal series in seven games.

But that shimmy-inducing bucket from the young superstar was a blip on an otherwise rough night from 3-point range for the Mavericks, who missed their first seven and finished 13 of 45.

Reggie Bullock and Maxi Kleber, two long-range specialists for Dallas, missed all 12 of their 3s combined and were 0-15 overall. Both went scoreless, offsetting Spencer Dinwiddie's 26 points off the

bench. Jalen Brunson scored 20.

Wiggins' one-handed dunk over Dončić mid-way through the fourth quarter was called a foul because his elbow made contact around Dončić's neck as Dončić jerked backward and fell. But the replay ruling after Kerr challenged was incidental contact, giving Golden State a 93-83 lead.

"I got hit a little bit, but that was impressive," Dončić said. "I'm not going to lie. I saw the video again, and I was like, 'Oh ...' That was pretty incredible. I wish had those bunnies."

About a minute later, Wiggins, who matched his playoff career high with 11 rebounds, moved quickly down the right baseline for a follow dunk on a miss by Curry.

"Just feeling the energy," Wiggins said of his dunk over Dončić. "That's all I see. The main thing when I see the rim. That's all I see. They tried to take it away from me, but ..." Wiggins said, interrupting himself with a laugh before thanking Kerr for the challenge.

Curry scored 11 points in the third quarter, giving the Warriors their biggest lead at 78-64 with a step-back 3 in the final minute and turning to the national TV crew for a close-up view of his shoulder shimmy.

Dončić scored 21 points in the fourth quarter as the Mavericks tried desperately to close the gap, but fell to 2-6 in his three playoff seasons when the 23-year-old, three-time All-Star scores at least 40 points.

One of Dinwiddie's 3-pointers got Dallas within five points with 1:15 remaining, but Jordan Poole answered with one from the left wing just inside the final minute.

The Mavericks, playing past the first round since first-year coach Jason Kidd was the point on the Dirk Nowitzki-led team that won the 2011 title, lost a nine-point lead in the final four minutes of the first half two nights after failing to hold a 19-point

lead on the road in a Game 2 loss.

"This is just the beginning of this journey," Kidd said. "I know you guys have us winning the championship before the season started. And that's a joke if you didn't get it. This is a lot bigger than just this one game or this series. This is huge for our franchise because none of you guys had us here."

WHAT JUST HAPPENED?

The most tense moment of the series came late in the first half after a corner 3 from Curry capped an 8-0 run that put the Warriors in front by a point and helped them to a 48-47 halftime lead. And it left Curry confused.

Curry ran the length of the court with his tongue hanging out after Dallas called timeout. As he circled back toward his bench, Curry walked by Dončić with teammate Juan Toscano-Anderson nearby.

Dončić appeared to take issue with something Toscano-Anderson said and started toward the Golden State bench before officials along with coaches and players from both teams intervened. Meantime, Draymond Green and injured Dallas guard Tim Hardaway Jr. exchanged unpleasant-ries about 45 feet apart.

After the timeout, Curry could be seen saying, "What happened?" and approached Dončić to talk about it. The exchange ended with Green as the peacemaker with Dončić.

HOLDING HIS TONGUE

Green got a technical foul, his second of the series, after an extended conversation with official Marc Davis when he was called for a backcourt violation when he hurriedly tried to step back over the midcourt line to catch a long, unexpected pass from Curry.

Contract Bridge

Hoist with his own petard

East dealer.
Both sides vulnerable.

NORTH

The bidding:

Opening lead — jack of clubs.

Assume you're in four hearts and West leads a club. East cashes the A-K and returns a club, which you ruff. When you next lead a low trump to the ace, East produces the king, and it now seems you must lose two trump tricks to West and go down at least one.

But if you approach the play with the right attitude, you can make the contract. You say to yourself that if things go just right, you might be

able to endplay West, so you start to lay the groundwork in the hope that this is possible.

You play the ace of spades and ruff a spade, then cash the A-K of diamonds and ruff a diamond in dummy. When the diamonds divide 3-3, you are well on the way to getting home safely, because this is now the position:

You next ruff a spade with the eight and then play the jack of diamonds. West is forced to ruff and return a trump from his J-9 into your Q-10, handing you the contract.

The entire operation, once East's heart king falls, is based on the sole hope that West has the distribution in the three side suits that will allow him to be endplayed. This type of reasoning — constructing a lie of the cards that will permit the contract to be made (or defeated, if you are defending) — often snatches victory from the jaws of defeat.

Today in History

Today is Tuesday, May 24, the 144th day of 2022. There are 221 days left in the year.

Today's Highlight in History:

On May 24, 1844, Samuel F.B. Morse transmitted the message "What hath God wrought" from Washington to Baltimore as he formally opened America's first telegraph line.

On this date:

In 1935, the first major league baseball game to be played at night took place at Cincinnati's Crosley Field as the Reds beat the Philadelphia Phillies, 2-1.

In 1937, in a set of rulings, the U.S. Supreme Court upheld the constitutionality of the Social Security Act of 1935.

In 1941, the German battleship Bismarck sank the British battle cruiser HMS Hood in the North Atlantic, killing all but three of the 1,418 men on board.

In 1961, a group of Freedom Riders was arrested after arriving at a bus terminal in Jackson, Mississippi, charged with breaching the peace for enter-

ing white-designated areas. (They ended up serving 60 days in jail.)

In 1962, astronaut Scott Carpenter became the second American to orbit the Earth as he flew aboard Aurora 7.

In 1974, American jazz composer and band-leader Duke Ellington, 75, died in New York.

In 1976, Britain and France opened trans-Atlantic Concorde supersonic transport service to Washington.

In 1980, Iran rejected a call by the World Court in The Hague to release the American hostages.

In 1994, four Islamic fundamentalists convicted of bombing New York's World Trade Center in 1993 were each sentenced to 240 years in prison.

In 1995, former British Prime Minister Harold Wilson died in London at age 79.

In 2006, "An Inconvenient Truth," a documentary about former Vice President Al Gore's campaign against global warming, went into limited release.

In 2011, Oprah Winfrey

taped the final episode of her long-running talk show.

Ten years ago: President Barack Obama doubled down on criticism of rival Mitt Romney's background as a venture capitalist, telling a rally at the Iowa State Fairgrounds there might be value in such experience but "not in the White House." Brian Banks, a former high school football star whose dreams of a pro career were shattered by what turned out to be a false rape accusation, burst into tears as a judge in Long Beach, California, threw out the charge that had sent Banks to prison for more than five years.

Five years ago: Setting past differences and rude comments aside, President Donald Trump and Pope Francis put a determinedly positive face on their first meeting at the Vatican. Ariana Grande suspended her Dangerous Woman world tour and canceled several European shows due to the deadly bombing at her concert in Manchester, England, two days earlier.

One year ago: Tennessee became the latest state to ban teachers from talking about certain aspects of race and racism in public schools. Samuel E.

Wright, who famously voiced "Sebastian the Crab" in Disney's "The Little Mermaid" and had an acting career spanning five decades, died at 72.


