Forsan, Coahoma ISDs plan free/ reduced-price lunch program clared disaster; or

While Big Spring ISD has received a grant again this year allowing it to provide free school meals for its students, Forsan and Coahoma school districts have not. Instead, they are accepting applications for free and reduced-price meals for the upcoming 2022-23 school

Starting this past Tuesday, Forsan began sending out letters to homes of children in the district about eligibility, benefits, and actions parents or guardians need to take to apply for free and reduced-price meals. Applications can also be obtained at 500 W. Main St. in Forsan.

Coahoma ISD will distribute similar letters and applications on Aug. 25. couraged to complete the application online following the information distributed with the registration packet; however, families of new students are asked to complete a paper application. AAA Texas: Lone Star statewide average lowest in US, fuel prices continue to dip

The statewide gas price average in Texas is \$3.64 for a gallon of regular unleaded fuel, according to the AAA Texas Weekend Gas Watch. That price is 14 cents less than on this day last week and is 80 cents more per gallon compared to this day last year. Of the major metropolitan areas surveyed in Texas, drivers in College Station are paying the most on average at \$3.85 per gallon while drivers in the Brownsville-Harlingen area are paying the least at \$3.33 per gallon. The national average price for a gallon of regular unleaded is \$4.14, which is 14 cents less when compared to this day last week and 95 cents more than the price per gallon at this same time last year.

In Big Spring Thursday afternoon, the lowest pump price for a gallon of regular unleaded was \$3.37, at H-E-B.

Several market forces continue to push pump prices lower. On Wednesday, crude oil prices reached their lowest point since Russia's invasion of Ukraine. Crude prices are falling as the energy industry factors in a possible economic slowdown. Additionally, demand for gasoline fell week-to-week and regional supplies increased. Both factors are helping push retail fuel prices lower. In addition, the Organization of the Petroleum Exporting Countries and allies (OPEC+) has agreed to a small boost in crude oil production, which

Two killed in fiery Midland wreck

A two-vehicle collision south of Midland Wednesday morning left both drivers dead, according to a press release issued by the Texas Department of Public Safety. According to the statement, at about 5

a.m. Wednesday, Jose Alferez Castillo, 55, of Midland was driving a 2009 Freightliner truck and trailer south on State Highway 349 about three miles south of Midland and James William Featherston, 38, of Oglesby was driving a 2022 Dodge Ram 2500 east on County Road 140.

The report stated that Featherston failed to yield the right of way at the intersection of the two roads and struck the driver's side of Castillo's truck. Both vehicles came to rest in the east barrow ditch on SH 349. Castillo's truck burned completely, wile the front end of Featherston's pickup burned. Both men were pronounced deceased by Daniel Arrieta, a death investigator for the office of Midland Justice of the Peace Precinct 2 office. Conditions at the time of the accident


Texas Sales Tax Holiday is this weekend Special to the Herald


Texas Comptroller Glenn Hegar is reminding shoppers they can save money on clothes and school supplies during the state's sales tax holiday on Friday, Saturday and Sunday, Aug. 5-7.

State law exempts sales tax on qualified items — such as clothing, footwear, school supplies and backpacks — priced below \$100, saving shoppers about \$8 on

During the annual sales tax holiday, qualifying items can be purchased tax free online or by telephone, mail, custom order or any other means (including in-store purchases) when either the item is both delivered to, and paid for by, the customer during the exemption period; or the customer orders and pays for the item, and the seller accepts the order during the exemption period for immediate shipment, even if delivery is made after the exemption period ends.

Man who stormed Capitol with gun gets longest prison term Dabney Friedrich, who presided over violence and made statements of the president o

WASHINGTON (AP) — A Texas man convicted of storming the U.S. Capitol with a holstered handgun, helmet and body armor was sentenced Monday to more than seven years in prison, the longest sentence imposed so far among hundreds of Capitol riot cases.

Prosecutors said Guy Reffitt told fellow members of the Texas Three Percenters militia group that he planned to drag House Speaker Nancy Pelosi out of the Capitol building by her ankles, "with her head hitting every step on the way down," according to a court filing.

Reffitt's prison sentence — seven years and three months — is two years more than the previous longest prison sentence for a Capitol riot defendant. But it's less than half the length of the 15-year prison term requested by a federal prosecutor,

who called Reffitt a domestic terrorist and said he wanted to physically remove and replace members of Congress.

Reffitt was the first person to go on trial for the Jan. 6, 2021, attack, in which supporters of then-President Donald Trump halted the joint session of Congress for

certifying Joe Biden's 2020 electoral victory. U.S. District Judge

Reffitt's jury trial, also sentenced him to three years of supervised release after his prison term and ordered him to pay \$2,000

in restitution.



Reflections

Weddings and Marriage

Last week our 19-year-old grandson came to visit so he could participate in his best friend's wedding. Weddings are exciting: handsome groomsmen lined up in their tuxedos, the groom

nervously looking for his bride, bridesmaids in matching dresses, the flower girl and ring bearer announcing the bride's entrance, and then, the bride, adorned for her husband. All of this followed by a reception: good food, joyful singing, and dancing. Weddings are an important passage for every generation as they come of age. .

The only public event we attended during the height of Covid in 2020 was the wedding for our young neighbors across the street. We watched them meet, date, fall in love and exchange their vows in

a local church. That was two years ago. Now they come to visit bringing scones and their 4-month-old baby, Charlie. Weddings are events. They can be planned, staged, and often cost tens of thousands of dollars. Marriages, on the other hand, are lifelong relation-

ships that take time, effort, struggle, sacrifice, love

and forgiveness, things that money cannot buy.

We all want marriage to work. We all wish every

marriage would live up to the thrill of the weddings

in which they were formed. No one really knows what goes on in a marriage except the husband and wife who share the marriage bond. Some marriages appear strong and stable to the public eye but are inwardly crumbling.

Last year my wife and I celebrated our fifty-third anniversary. I remember how she appeared beneath her wedding veil at the altar, the tear that formed in her eye when we exchanged our vows. She was nineteen. Some images in the brain never fade. Even though the years have aged us both, her nineteen-year-old beauty remains whenever I look at her.

We were naïve. We had far more to learn than either of us knew. I think it took the first ten years to begin to understand who she really is, and I am still learning. Along the way, she helped me discover who I am.

Our marriage has had its celebrations and its sorrows. We have celebrated the birth of three children and six grandchildren, and we have wept at the graves of our parents. We have known exhilaration and depression, achievement and disappointment. We have traveled the world together and built a home. She nursed me to health after my motorcycle wreck. She is a breast cancer survivor.

Throughout the years we have discovered building blocks that make marriage work. The first is faith. It was our faith in God and His son Jesus that brought us together and kept us together. But faith that merely professes to believe in Jesus would not have been enough. Marriage, more than any other relationship, taught us the importance of living out the things Jesus taught: honesty, trust, respect, humility, confession and forgiveness. Without these elements faith is empty, especially in marriage.

We are still learning the meaning of love and our love is still growing. We are still striving to live out the Bible's definition: "Love is patient, love is kind. It does not envy, it does not boast, it is not proud. It does not dishonor others, it is not self-seeking, it is not easily angered, it keeps no record of wrongs. Love does not delight in evil but rejoices with the truth. It always protects, always trusts, always hopes, always perseveres." (1 Cor. 13).

"Philip findeth Nathanael, and saith unto him, we have found him, of whom Moses in the law, and the prophets, did write, Jesus of Nazareth, the son of Joseph." John 1:45 The Law of Moses never has been

and never will be about the Law. It never has been, nor will it ever be about keeping the ten commandments so that we might be justified, sanctified and blessed. The Law has always been, and will always be about finding Jesus of Nazareth. In John 5:46, Jesus of Nazareth said:

For had ye believed Moses, ye would have believed me: for he wrote of me". The Law of Moses is not

about the ten commandments, it is about finding Jesus of Nazareth. The Law of Moses is not about moral behavior, it is about finding Jesus of Nazareth. The Law takes us by the hand, and leads us far from itself to Jesus of Nazareth; this is the whole purpose of the Law. We know this because Galatians 3:23-25 says: "But before faith came, we were kept under the law, shut up unto the faith which should afterwards be revealed. Wherefore the law was our schoolmaster to bring us unto Christ, that we might be justified by faith. But after that faith is come, we are no longer under a schoolmaster". You see, before faith came, we were locked up behind the prison bars of the Law, away from faith. But now that we are in Christ by faith, we are no longer

under the Law. Galatians 3:11-12 says that the just shall live by faith, and that the Law is not of faith. The Law has nothing to do with faith, therefore, it never produces faith. Furthermore, it is impossible to live by faith under the Law, because the Law is not of faith. Pope promotes Vatican nurse credited with saving his life

The Vatican announced the appointment of Massimiliano Strappetti in a one-line statement issued Thursday. Strappetti, the nursing coordinator of the Vatican's health department, accompanied Francis on a difficult trip to Canada last month.

Francis, 85, last year credited Strappetti with having accurately ascertained an intestinal problem that led to the pope's 10-day hospital stay in July 2021 to remove 33 centimeters (13 inches) of his colon that had narrowed.

"A nurse, a man with a lot of experience, saved my life," Francis told the COPE radio of the Spanish bishops' conference in the months after his

surgery. Francis noted that Strappetti's in-

tervention was the second time a

ROME (AP) — Pope Francis has nurse had saved his life. A nurse in his native Argentina decided in 1957 to double the amount of drugs the future pope, then known as Jorge Mario Bergoglio, was prescribed after part of his lung was removed due to a respiratory infection, he recalled.

Francis has a personal physician, Dr. Roberto Bernabei, who was appointed last year. Bernabei is an internist and geriatric specialist at the Catholic University of the Sacred Heart in Rome.

The pontiff has had a series of health problems in the past year, most sig-

nificantly strained ligaments in his right knee that sharply reduced his mobility. After months of magnetic and laser treatments, Francis can walk short distances with a cane or walker, though he also uses a wheelchair.

WNBA's Griner convicted at drug trial, sentenced to 9 years

KHIMKI, Russia (AP) - U.S. basketball star Brittney Griner was convicted Thursday in Rus sia of drug possession and sentenced to nine years in prison following a politically charged trial that came amid soaring tensions between Moscow and Washington over Ukraine and could lead to a highstakes prisoner exchange between the two world

The 31-year-old Griner, a two-time U.S. Olympic champion and a eight-time all-star with the WN-BA's Phoenix Mercury listened with a blank expression as an interpreter translated the verdict by Judge Anna Sotnikova. The judge also fined her 1 million rubles (about \$16,700) fine.

U.S. President Joe Biden denounced the verdict and sentence as "unacceptable."

"I call on Russia to release her immediately so she can be with her wife, loved ones, friends, and teammates," Biden said, adding that he would continue to work to bring home Griner and Paul Whelan, an American imprisoned in Russia on an espionage conviction.

Outside the court, the U.S. Embassy's charge d'affaires Elizabeth Rood called the verdict "a miscarriage of justice."

Before the unusually swift verdict was reached, an emotional Griner apologized to her family, teammates and the Russian city of Yekaterinburg, where she plays in the WNBA offseason, "for my mistake that I made and the embarrassment that I brought on them."

With her voice cracking, she added: "I hope in your ruling it does not end my life."

A conviction is usually a prerequisite to arrang-

ing a prisoner exchange and also allows Griner to apply for a presidential pardon. Deputy Foreign Minister Sergei Ryabkov said last month that the "necessary judicial procedures" must be complet-

ed before any other steps can be taken.

The disclosure in July that the U.S. government was seeking a prisoner swap involving Griner reflected the growing pressure on the Biden administration to do more to bring her home. The U.S. State Department had earlier declared Griner to be "wrongfully detained" — a charge that Russia has sharply rejected.

Griner, recognized as one of the greatest players in WNBA history, has been detained since Feb. 17 after police said they found vape cartridges containing cannabis oil in her luggage upon landing at Moscow's Sheremetyevo Airport. She was return-

ing to Russia, where she has competed since 2014. When she took the stand at her trial July 7, Griner said: "I would like to plead guilty on the charges against me. But I had no intention of breaking any Russian law." She added that she brought the vape canisters into Russia because she had packed in haste for her flight.

In later testimony, Griner described a confusing scene while being held at the airport, saying an interpreter provided by authorities translated only a fraction of what was being said to her and that officials told her to sign documents, but "no one explained any of it to me." She also said she was not informed of her rights.

Her lawyers introduced evidence that Griner was using the medicinal cannabis for chronic pain and injuries sustained during her career and included a letter from her doctor. Griner testified she was aware that cannabis oil was outlawed in Russia and had not intended to break the law or "plan to smuggle anything into Russia."

Trials in Russia proceed even after admissions of guilt, and there has been speculation her actions were an attempt to move the legal process along in hopes of a possible prisoner swap.

Griner's slow-moving case and her nearly six months behind bars have raised strong criticism among her supporters in the United States, including her wife, Cherelle, that President Joe Biden was not doing enough to win her freedom.

Griner sent a personal appeal to Biden, and more than 1,100 Black female leaders urged the administration to "make a deal to get Brittney back home swiftly and safely and to meet with Brittney's wife Cherelle immediately." Biden later called Cherelle Griner "to reassure her that he is working to secure Brittney's release as soon as possible," the White House said July 6.

Cherelle Griner, who also spoke with Vice President Kamala Harris, later said she was "grateful to the both of them for the time they spent with me and for the commitment they expressed to getting BG home," using her wife's initials.

On July 27, U.S. Secretary of State Antony Blinken said Washington has offered a deal to Russia aimed at bringing home Griner and Whelan in a sharp reversal of previous policy. Details of the proposal were not announced, though a person familiar with the matter said the U.S. has offered to trade convicted Russian arms dealer Viktor Bout for Whelan and Griner. The person insisted on anonymity to discuss an on-

going investigation

Her detention was made public only after Russian troops moved into Ukraine, as relations between Russia and the United States hit new lows after Washington led the West in bringing sanctions

against Moscow. Griner's plight has been highlighted by her supporters at home, including top athletes, especially after little news emerged from her initial weeks of detention in Russia, where she had limited access to officials from the U.S. Embassy. It was only in May that the State Department designated her as wrongfully detained, moving her case under the supervision of its Special Presidential Envoy for Hostage Affairs, effectively the government's chief

hostage negotiator. Elizabeth Rood, the U.S. Embassy's charge d'affaires, has attended the trial in the Moscow suburb of Khimki, where the airport is located, and said that American officials are monitoring her case closely, along with those of all U.S. citizens detained or in prison in Russia.

At the ESPY Awards last month, soccer player Megan Rapinoe referred to Griner as "a political prisoner," and tennis great Billie Jean King said, "First, bring BG home. Gotta do that."

NBA Finals MVP Stephan Curry wore Griner's jersey under his track suit at the awards show and urged "the entire global sports community to continue to stay energized on her behalf. She's one of us, the team of athletes in this room tonight and all over the world. A team that has nothing to do with politics or global conflict."

Griner, a 6-foot-9 center, has 12 of the 15 regular season dunks in WNBA history and set the singleyear record for blocks with 129 in 2014. She led the league in scoring twice. She was a two-time Associated Press college basketball player of the year and led Baylor to a 40-0 season and the 2012 NCAA title. She was the No. 1 pick by Phoenix in the 2013 draft.

1. The bidding clearly indicates hat North has the ace of dianonds, and the club lead has all the earmarks of a singleton. If you were to play a trump at trick two, you'd run the risk of North winning with the ace and putting South on lead with a heart to make the killing club return.

ring, you should cash the ace of spades at trick two and continue with the queen! Assuming South — count them — trump tricks.


follows low, which is highly likely you discard your singleton heart or the spade queen. This play cost you nothing; it merely substitutes spade loser for a heart loser.

North takes the queen with th king but now has no way to put South on lead to get a club return As a result, you get home in a blaze of glory, and North is left to rue doubling you with a hand such as **♠** KJ86 ♥ AK8432 ♦ A3 ♣ 9.

2. By far the best play is to attempt a dummy reversal, which depends essentially on no worse than a 3-1 trump division. This will enabl you to avoid having to rely on spade finesse, which would give you only an even chance of making the grand slam.

Ruff North's heart lead with th jack, play the five of trump to the seven, ruff the six of hearts with the queen, play the eight of trump to the nine and ruff the seven of hearts with the king. Next lead a low club to the king and ruff the ten of hearts with your last trump the ace.

Now cross to the ace of spade and draw the only missing trump with dummy's ten, discarding your jack of spades in the process. Today in History: Aug. 5, Nelson Mandela arrested

Today is Friday, Aug. 5, the 217th day of 2022. There are 148 days left in the year.

Today's Highlight in History:

On Aug. 5, 1981, the federal government began firing air traffic controllers who had gone out on strike.

On this date:

In 1864, during the Civil War, Union Adm. David G. Farragut led his fleet to victory in the Battle of Mobile Bay, Alabama.

In 1884, the cornerstone for the Statue of Liberty's pedestal was laid on Bedloe's Island in New York Harbor.

In 1914, what's believed to be the first electric traffic light system was installed in Cleveland, Ohio, at the intersection of East 105th Street and Euclid Avenue.

In 1936, Jesse Owens of the United States won the 200-meter dash at the Berlin Olympics, collecting the third of his four gold medals.

In 1953, Operation Big Switch began as remaining prisoners taken during the Korean War were exchanged at Panmunjom.

In 1957, the teenage dance show "American Bandstand," hosted by Dick Clark, made its network debut on ABC-TV.

In 1962, South African anti-apartheid activist Nelson Mandela was arrested on charges of

leaving the country without a passport and inciting workers to strike; it was the beginning of 27 years of imprisonment. Movie star Marilyn Monroe, 36, was found dead in her Los Angeles home; her death was ruled a probable suicide from "acute barbiturate poisoning."

In 1964, U.S. Navy pilot Everett Alvarez Jr. became the first American flier to be shot down and captured by North Vietnam; he was held prisoner until February 1973.

In 1974, the White House released transcripts of subpoenaed tape recordings showing that President Richard Nixon and his chief of staff, H.R. Haldeman, had discussed a plan in June 1972 to use the CIA to thwart the FBI's Watergate investigation; revelation of the tape sparked Nixon's resignation.

In 2010, the Senate confirmed Elena Kagan, 63-37, as the Supreme Court's 112th justice and the fourth woman in its history. Thirty-three workers were trapped in a copper mine in northern Chile after a tunnel caved in (all were rescued after being entombed for 69 days).

In 2011, the sun-powered robotic explorer Juno rocketed toward Jupiter on a five-year quest to discover the secret recipe for making planets. (Juno reached Jupiter on July 4, 2016.)

In 2020, authorities said protesters in Portland, Oregon, barricaded about 20

police officers inside a precinct and tried to set it on fire; police used tear gas on the crowd for the first time since U.S. agents sent by President Donald Trump left the city the previous week. A city commission in Minneapolis blocked a November vote on a proposal to dismantle the city's police department in the wake of George Floyd's death.

Ten years ago: A

gunman opened fire,

killing six people at a Sikh temple near Milwaukee before shooting himself dead during an exchange of fire with one of the first officers to respond. The robotic explorer Curiosity blazed through the pink skies of Mars, steering itself to a gentle landing inside a giant crater. Jamaica's Usain Bolt pulled away from the pack and crossed the finish line to claim consecutive gold medals in the marquee track and field event at the Summer Games in London. Britain's Andy Murray cruised past Roger Federer 6-2, 6-1, 6-4 in the men's tennis singles final. Serena and Venus Williams won the women's doubles title.

Five years ago: The U.N. Security Council unanimously approved tough new sanctions against North Korea for its escalating nuclear and missile programs. Eight-time Olympic gold medalist Usain Bolt finished third in the 100-meter dash at the world track championships in London, which marked his farewell from the sport; the winner was American Justin Gatlin.

One year ago: Rich-

ard Trumka, who rose from the coal mines of Pennsylvania to preside over one of the world's largest labor organizations, the AFL-CIO, died at 72. A Texas appeals court upheld the murder conviction of Amber Guyger, a former Dallas police officer who was sentenced to prison for fatally shooting her neighbor in his home.

Strappetti was on hand to help with the wheelchair during Francis' general audience Wednesday.

He coordinates the nurses of the Vatican's small health care system, which provides basic care for Vatican employees and their families.

Strappetti's appointment was announced days after he and a doctor accompanied Francis on his weeklong "penitential pilgrimage" to Canada to atone for the Catholic Church's role in the country's residential schools for Indig-

enous children. Francis always travels with a doctor and nurse who are on call in case he has health problems. Strappetti, for example, was on hand when Francis issued his main apology and received a feathered headdress from Indigenous leaders.

On the flight home from the trip, Francis said he would have to slow down his future travels and maybe resign one day.

"This trip was a bit of a test. It's true you can't do trips in this state, maybe we have to change a bit the style, reduce, pay the debts of the trips that I still have to do and reorganize," he said. But he added that "the door is open" to also resign if he can't carry on.

Alex Jones concedes Sandy Hook attack was '100% real'

AUSTIN, Texas (AP) — For years, bombastic farright conspiracy theorist Alex Jones ranted to his millions of followers that the 2012 Sandy Hook Elementary School shooting was a hoax, that children weren't killed and that parents were crisis actors in an elaborate ruse to force gun control.

Under oath and facing a jury that could hit him with \$150 million or more in damages for his false claims, Jones said Wednesday he now realizes that was irresponsible and believes that what happened in the deadliest school shooting in American history was "100% real."

Jones' public contrition came on the final day of testimony in a two-week defamation lawsuit against him and his Austin-based media company, Free Speech Systems, brought by Neil Heslin and Scarlett Lewis, the parents of 6-year-old Jesse Lewis. Their son was a first grader who was among the 20 students and six teachers killed at the school in Newtown, Connecticut, on Dec. 14, 2012.

"I unintentionally took part in things that did hurt these people's feelings," said Jones, who also acknowledged raising conspiracy claims about other mass tragedies, from the Oklahoma City and Boston Marathon bombings to the mass shootings in Las Vegas and Parkland, Florida, "and I'm sorry for that."

But an apology isn't enough for Heslin and Lewis. They said Jones and the media empire he controls and used to spread his false assertions must be held accountable.

"Alex started this fight," Heslin said, "and I'll finish this fight."

The parents testified Tuesday about a decade of trauma, inflicted first by the murder of their son and what followed: gun shots fired at a home, online and telephone threats, and harassment on the street by strangers, all fueled by Jones and his conspiracy theory spread to his followers via his web-

site Infowars.

A forensic psychiatrist testified the parents suffer from "complex post-traumatic stress disorder" inflicted by ongoing trauma, similar to what might be experienced by a soldier at war or a child abuse victim.

At one point in her testimony, Lewis looked directly at Jones, who was sitting barely 10 feet away. "It seems so incredible to me that we have to do

this — that we have to implore you, to punish you — to get you to stop lying," Lewis told Jones.

Courts in Texas and Connecticut have already

found Jones liable for defamation for his portrayal

of the Sandy Hook massacre as a hoax involving actors aimed at increasing gun control.

Now, Heslin and Lewis are asking the jury in Austin for \$150 million in compensation for defamation and intentional infliction of emotional dis-

tress. They will also ask the jury to assess additional punitive damages.

Jurors began considering damages Wednesday.
Once they determine whether Jones should pay the parents compensation for defamation and emotional distress, it must then decide if he must also pay punitive damages. That portion will involve a

tifying to his and his company's net worth.

Jones' attorney asked the jury to limit damages to \$8 — one dollar for each of the compensation charges they are considering — and Jones himself said any award over \$2 million "would sink us."

At the end of Jones' testimony, Mark Bankston, an attorney for the family, pulled a crumpled dollar bill out of his pocket, showed it to Jones, and put it down in front of the parents.

"The day Sandy Hook happened, Alex Jones planted a seed of misinformation that lasted a decade," parents' attorney Kyle Farrar told the jury in closing arguments. "And he just watered that seed over and over until it bore fruit: cruelty and money."

During his testimony, Jones said he's tried in the

past to back off the hoax claims, but "they (the media) won't let me take it back."

Jones — who has been banned from major social media platforms for hate speech and abusive behavior — has portrayed the lawsuit as an attack on his First Amendment rights and complained that he's been "typecast as someone that runs around talking about Sandy Hook, makes money off Sandy Hook, is obsessed by Sandy Hook."

Eight days of testimony included videos of Jones and Infowars employees talking about the Sandy Hook conspiracy and even mocking Heslin's description in a 2017 television interview that he'd held his dead son Jesse's body "with a bullet hole through his head." Heslin described that moment with his dead son to the jury.

Jones was the only witness to testify in his defense. And he came under withering attack from the plaintiffs attorneys under cross examination, as they reviewed Jones' own video claims about Sandy Hook over the years, and accused him of lying and trying to hide evidence, including text messages and emails about Sandy Hook. It also included internal emails sent by an Infowars employee that said "this Sandy Hook stuff is killing us."

At one point, Jones was told that his attorneys had mistakenly sent Bankston the last two years' worth of texts from Jones' cellphone.

And shortly after Jones declared "I don't use email," Jones was shown one that came from his address, and another one from an Infowars business officer telling Jones that the company had earned \$800,000 gross in selling its products in a single day, which would amount to nearly \$300 million in a year.

Jones has already tried to protect Free Speech Systems financially. The company filed for federal bankruptcy protection last week. Sandy Hook families have separately sued Jones over his financial claims, arguing that the company is trying to protect millions owned by Jones and his family through shell entities.

Sandy Hook lawyer: Jan. 6 panel asked for Alex Jones' texts

AUSTIN, Texas (AP) — An attorney for the parents of a child killed in the Sandy Hook Elementary School massacre who are suing conspiracy theorist Alex Jones over his false claims about the attack said Thursday that the U.S. House Jan. 6 committee has requested two years' worth of records from Jones' phone.

Attorney Mark Bankston told the Texas court where Jones is on trial to determine how much he owes for defaming the parents that the committee investigating the Jan. 6, 2021, insurrection at the U.S. Capitol has requested the digital records.

A spokesperson for the committee declined to comment Thursday.

As Jones testified at the trial on Wednesday, Bankston revealed that the Infowars host's lead attorney, Andino Reynal, had mistakenly sent him the last two years' worth of texts from Jones' cellphone.

Reynal asked Judge Maya Guerra Gamble to declare a mistrial over the mistaken transfer of records and said they should have been returned and any copies destroyed. Gamble rejected the request.

Reynal also accused Bankston of trying to perform "for a national audience." He said the material included a review copy of text messages over six months from late 2019 into the first quarter of 2020.

Bankston said his team followed Texas' civil rules of evidence and that Jones' attorneys missed their chance to properly request the return of the records

"Mr Reynal is using a fig leaf (to cover) for his own malpractice," Bankston said.

He said the records mistakenly sent to him included some medical records of plaintiffs in other lawsuits against Jones

"Mr. Jones and his intimate messages with Roger Stone are not protected," Bankston said, referring to former President Donald Trump's longtime ally.

Rolling Stone, quoting unnamed sources, reported Wednesday evening that the Jan. 6 committee was preparing to subpoena the data from the parents' attorneys to assist in the investigation of the deadly riot.

Bankston said outside of court Thursday that the committee had requested the phone records, but hadn't subpoenaed them. He also said he wasn't familiar with everything that was in the records yet, including whether they include any information that the committee is seeking, because there was so much information in them.

"We don't know (yet) the full scope and breadth," of the material, Bankston said. "We certainly saw text messages from as far back as 2019. ... In terms of what all is on that phone, it's going to take a little while to figure that out."

"The Jan. 6 committee doesn't have any more information about what's on that phone than I do. I don't know if it even covers the time period they are interested in," he said

Jones didn't attend Thursday's court proceedings. But on his Infowars show Thursday, he said the records were from a year before Jan. 6 and had "nothing to do with it."

"And if anything, I say more radical things on air than I do on text messages. And the idea that there's some type of criminal activity on there is preposterous," he said.

The jury in Austin is deciding how much Jones should pay to the parents of a child killed in the 2012 school massacre in Newtown, Connecticut, because of his and Infowars' repeated false claims that the shooting was a hoax created by advocates for gun control. Neil Heslin and Scarlett Lewis, the parents suing Jones, are seeking at least \$150 million in damages.

Last month, the Jan. 6 committee showed graphic and violent text messages and played videos of right-wing figures, including Jones, and others vowing that Jan. 6 would be the day they would fight for Trump.

The committee first subpoenaed Jones in November, demanding a deposition and documents related to his efforts to spread misinformation about the 2020 election and a rally on the day of the attack.

the day of the attack.

In the subpoena letter, Rep. Bennie Thompson, the Democratic chairman, said Jones helped organize the Jan. 6 rally at the Ellipse that preceded the insurrection. He also wrote that Jones repeatedly promoted Trump's false claims of election fraud, urged his listeners to go to Washington for the rally, and march from the Ellipse to the Capitol. Thompson also wrote that Jones "made statements implying that you had knowledge about the plans of President Trump with re-

spect to the rally."

The nine-member panel was especially interested in what Jones said shortly after Trump's now-infamous Dec. 19, 2020, tweet in which he told his supporters to "be there, will be wild!" on Jan. 6.

"You went on InfoWars that same day and called the tweet 'One of the most historic events in American history," the letter continued.

In January, Jones was deposed by the committee in a hourslong, virtual meeting in which he said he exercised his Fifth Amendment right against self-incrimination "almost 100 times."

Texas wildfires continue to erupt; firefighters keep moving

TOLAR, Texas (AP) — One firefighter was injured and two others were treated for heat exhaustion while fighting a wildfire in North Texas that burned almost half a square mile Wednesday, officials said.

The fire near Tolar, about 40 miles

(65 kilometers) southwest of Fort Worth, was completely uncontained as of Wednesday afternoon, according to the Texas A&M Forest Service.

County statement. His condition was not immediately known.

No structures have been reported

damaged in that fire 16 miles (25.75 kilometers) north of the two-week-old Chalk Mountain Fire, which was 96% contained Wednesday after burning 10 1/2 square miles (27 1/3 square kilometers) and destroying 16 homes and

damaging five others.

Meanwhile, wildfires have erupted in Central Texas as hot, breezy weather and extreme drought persist in the area, officials said Wednesday.
