College board approves lower tax rate, \$59.5 M budget

During its meeting Monday, the Howard County Junior College District Board of Trustees formally adopted their 2022-23 budget and property tax

The college's total budget, including budgets for Big Spring, Lamesa and San Angelo campuses, as well as for the SouthWest College for the Deaf, is \$59,528,105.

The district's unrestricted budget is \$39.885.641, of which \$35.667.068 is the Howard College District - the Big Spring, Lamesa and San Angelo campuses. SWCD, which is required to have its own separate budget, will have an unrestricted budget of \$4.218.573.

The budget represents a deficit to the district of \$3,062,912, which is due to projects on the Big Spring, San Angelo and SWCD campuses, according to Howard College President Dr. Cheryl Sparks. Of that total deficit, \$4,218,573 is attributed to the Big Spring, Lamesa and San Angelo campuses, while the remaining \$351,000 is from SWCD.

The property tax rate set by the college this year is \$0.168395 per \$100 valuation. That figure means the college will bring in more revenue than it did last year, but individual taxpayers should see a cut on their tax bill.

While the rate is higher than the nonew-revenue rate of \$0.158455 per \$100 valuation, it is significantly less than last year's tax rate of \$0.236777 per \$100 valuation.

"This adopted tax rate will raise more levy for maintenance and operations than last year's tax rate when compared to this year's No-New-Revenue rate," Sparks said.

Due to a massive increase in the tax

base of Howard County over the past year, despite the increase in revenue the college will see, taxes on individual hommes will decrease.

"Due to the increase in the tax base, the taxes for maintenance and operations on a \$100,000 home will decrease by \$64.07. It would have been by \$74.01 if the No-New-Revenue tax rate had been

BBB Tip: Student loan forgiveness is here. Here's how to avoid scams

The Biden Administration recently announced that the federal government will cancel up to \$20,000 of federal student loans per person. Millions of Americans will be recipients of student loan debt relief; unfortunately, this creates an excellent opportunity for scammers.

As student loan holders navigate the new forgiveness program, con artists will undoubtedly be there to take advantage of any confusion. It happens with any big gov-

ernment initiative, including the COVID-19 vaccine roll-out, eviction moratorium and pandemic relief programs. Always be sure to do your research before sharing any personal in-

Tips to avoid student loan forgiveness scams:

 Get to know the terms of your student loan and the relief program before acting. Always do your research before sharing personal information. Be sure to understand the ins and outs of your specific loan, as well as how student loan relief impacts you. Go straight to official government websites, such as ED.gov and studentaid.gov, for information.

 Never pay money for a free government program. Scammers often trick victims into paying for free government programs – or they claim you can get additional benefits, faster benefits, etc., for a fee. A real government agency will not ask for an advanced processing fee. These are all red flags of a scam.

• Be wary of out-of-the-blue calls, emails or text messages claiming to be from the government. In general, the government will not contact you using these methods unless you grant permission.

· Watch out for phony government agencies or programs. If you speak to someone claiming to be a government representative who is offering you student loan relief, do some research before you agree to anything. Scammers often make up look-alike government websites that sound similar to legitimate agencies or pro-

• Think something seems suspicious? Reach out to the agency directly. If you have any concerns about an alleged government representative's legitimacy, hang up the phone or stop emailing/texting. Then, find the official contact information (look on ED.gov and studentaid.gov or other official sites) and

call to verify. Then, report the suspicious calls or messages. Be careful, even if the information comes from a friend. Even if a close friend or family member you trust sent you the information regarding student loan relief, make sure the claims are real first. During the COVID-19 pandemic, BBB received many reports of hacked social media accounts being used to spread government impostor scams.

Dr. Sparks gave the 28th monthly report on the

college's COVID-19 response status since the start of the pandemic, noting that the college continues to plan for the future.

"We really are moving into just final decisions about how to operate moving forward," she said. "There is some activity in the central Tom Green area, but as far as every campus, we're dealing with those cases as they come in and we're handling them." Sparks said the school remains in the "yellow"

alert status as far as COVID-19. Sparks reported on enrollment and contact hours

for the Summer I and Summer II sessions, noting that, district-wide, the school had shown a slight decrease in enrollment over the summer, although some campuses - including Big Spring - had shown

increases while others had declined.

The board declined to act on a request for proposals on Telehealth Complete Care, as Dr. Sparks noted that staff was not ready to act on the RFP at the time of the meeting.

The board closed a second RFP without accepting any of the bids. The item was for the purchase of a commercial passenger bus. Sparks said college staff will rework the request, and ask the board to reissue it at a later date.

District Special Projects Officer Terry Hansen reported on roofing projects at the Big Spring and SWCD campuses, noting that SWCD's project is complete and, weather permitting, Big Spring's should be complete by the end of September.

TCU could play 3 QBs, Dykes not saying who takes 1st snap

FORT WORTH, Texas (AP) — Max Duggan has started 29 games as TCU's quarterback and Chandler Morris had 531 yards of total offense in his only full game last fall. New Horned Frogs coach Sonny Dykes still hasn't said which of them will take the first snap in the season opener Friday night at Colorado. TCU's initial depth chart lists Duggan or Morris as the No. 1 quarterback.

"I think we're in a good spot," Dykes said Monday. "Obviously, Max Duggan has a significant résumé. He has played a lot of snaps in the last three years here at TCU, has played very well. ... Chandler is the same way. You look at some of the games he played in last year, he played exceptional. So they both have experience and they both have done it."

Dykes expects both Duggan and Morris to play in the opener, as well as Sam Jackson, the redshirt freshman who had a 77-yard completion to Taye Barber on his only pass attempt last season. The coach said he doesn't think it matters

"It's a fun group. I like the guys a lot," Dykes said. "Sam certainly brings a different element to the room. ... I would anticipate all three of them playing, and my expectation is all three of them will play well."

Duggan, the Iowa Gatorade player of the year and a four-star recruit before getting to TCU, has passed for 5,920 yards with 41 touchdowns and 20 interceptions in 32 games overall for the Horned Frogs. The senior has also rushed for 1,433 yards and 19 more scores.

After Duggan played with a fractured foot bone for several games last season, Morris got his first start in a 30-28 win over Big 12 champion Baylor in TCU's first game after Gary Patterson and the school mutually agreed to part ways. Morris threw for 461 yards, ran for 70 and even caught a pass. His 531 total yards were the second-most in school history, but he got hurt in the next

Morris, the former Oklahoma transfer, is still listed as a redshirt freshman after completing 50 of 76 passes for 717 yards and three touchdowns in his four games last year. He had a TD run for the Sooners in their Big 12 championship game victory over Iowa State in 2020.

Senior offensive lineman Steve Avila, a team captain, said the Frogs are confident in whichever quarterback is playing.

"The only thing that we really know is there is a change in voice," Avila

"They all run the offense in their own ways," Barber said. "They all bring different things to the table, and I feel they're all positive."

UGa's Smart faces former assistant Lanning in season opener

ATHENS, Ga. (AP) — When you build a powerhouse program, it's inevitable that others will try to copy your success.

That means hiring people who work for you.

Georgia coach Kirby Smart will see another familiar face on the opposing sideline Saturday when the reigning national champion Bulldogs open the season against No. 11 Oregon.

Smart's former defensive coordinator, Dan Lanning, is now guiding the Ducks. In his head coaching debut, he'll take on the No. 3 Bulldogs in the Chick-fil-A Kickoff game in Atlanta.

"There's definitely some feelings of excitement for me to go play a team I care about and was a big part of for a long time," Lanning said. "But that's not the focus. My job, as well as the players' job, is to focus on the task at hand."

As Smart heads into his seventh season as the Bulldogs' boss, the list of assistants-turned-head coaches is growing.

He is 2-0 against his ex-offensive line coach, Arkansas' Sam Pittman, and last year beat South Carolina's Shame Beamer, who was on Smart's staff in

Now, the 36-year-old Lanning will become the third of Smart's former staffers to take a shot at knocking off the old boss.

There won't be a bunch of warm, fuzzy feelings at

"I don't think the game has anything to do with that," Smart said. "Neither Dan nor I will be worried about each other during the game."

The opener, which will be played before what figures to be a very pro-Georgia crowd at 75,000-seat Mercedes-Benz Stadium, will be an early indicator of where both programs stand.

Georgia is looking to make another run at the national championship despite losing a record 15 players in the NFL draft — five of them first-rounders off a stellar defensive unit that carried the Bulldogs to their first title since 1980.

With the Pac-12 in turmoil and speculation that they could soon be headed to the Big Ten, the Ducks hope to build on the success they had during Mario Cristobal's four-year tenure, which featured a pair of conference championships.

When Cristobal left for Miami, the Ducks quickly turned to Georgia's co-defensive coordinator.

They made a good choice, according to Smart, whose relationship with Lanning goes back to 2015 when both were on Nick Saban's staff at Alabama.

"I had a great relationship with Dan when he worked at University of Alabama, and had a lot of respect for how he went about doing his job," Smart said. "He didn't try to be somebody he wasn't. He didn't try to impress people. He just worked and he grinded, and he really did a good job of just doing what you asked him to do. I always thought he would be successful."

When Smart left for his first head coaching job at Georgia in 2016, he kept an eye on Lanning. The Bulldogs had an opening on their staff two years later and hired him as the outside linebackers

"It ended up being a no-brainer for us to bring Danny in because I knew the value he had," Smart

Lanning was promoted to co-defensive coordinator a year later after Mel Tucker left for Colorado, receiving much of the credit for building one of college football's greatest defenses.

"I knew he was going to do a great job," Smart

Lanning's co-coordinator, Glenn Schumann, is still at Georgia. He'll continue in that role along

with former Florida and South Carolina head coach Will Muschamp.

Smart said it's been a smooth transition, especially because Muschamp was already on the staff as special teams coordinator.

"Dan would be the first to tell you he never would've had the success he had here if not for Glenn Schumann," Smart said. "I felt comfortable Glenn would be able to take it over along with Will. It's great when we have two guys that know the system and two guys that can share that responsibil-

Before he even coached a game, Lanning had to deal with tragedy within his new team.

Tight end and social media star Spencer Webb died last month in an accidental fall at a popular swimming lake. The Ducks will wear a special decal on their helmets this season featuring Webb's No. 4 inside a spider web.

"Our team has a void," Lanning said. "It's something you certainly cannot replace. I've talked to our players about that moment and Spencer, how on your tombstone there's a day you were born and a day when you passed, but what made Spencer special was how he lived that dash in between those two numbers."

In addition to an entirely new coaching staff, the Ducks have a bunch of newcomers on their roster. They brought in 21 players through the transfer portal, 15 of them from Power Five schools.

Lanning has plenty of familiarity with Georgia's defense.

Of course, that works both ways.

"Kirby Smart is not going to play a single snap on Saturday, and neither is Dan Lanning," the Oregon coach said. "It doesn't really matter what I know. It's what my players know and how well they can execute."

Napier has Florida prepared, confident for daunting opener

GAINESVILLE, Fla. (AP) — Billy Napier says his wife was "burning me up" over the weekend with questions about Florida's most daunting season opener in school history.

Napier, thankfully, had all the answers. His players probably would have, too.

The first-year Florida coach has mapped out every aspect of the team's routine heading into his debut Saturday night against seventh-ranked Utah

Walkthrough at the hotel? Check. Pregame meal? Check. Bus ride to the stadium? Check.

Gator Walk among fans? On-field warmups? Celebratory entrance into the Swamp? Check, check, check.

The detail-oriented Napier, who makes his team wear matching white socks for every practice, has planned, plotted and perfected every minute of each day.

"I think preparation is the key to confidence," Napier said.

If so, the Gators should be feeling like 10-point favorites by now.

It remains to be seen how much of a difference all those discussions and dress rehearsals will make when underdog Florida takes the field against the defending Pac-12 champions, who ended last season with a loss to Ohio State in the Rose Bowl.

Florida, meanwhile, finished 6-7 after firing coach Dan Mullen following an overtime loss at Missouri in November.

Athletic director Scott Stricklin hired Napier days later, tasking him with leading the Gators back to prominence after 13 years without a Southeastern Conference or national championship.

One of Napier's first tasks, as cliché as it sounds, was to instill more discipline in a program that clearly lacked it in recent years.

The Gators lost at home to reeling LSU in 2020 because cornerback Marco Wilson tossed an opponent's shoe following a third-down stop, and they ranked 13th in the SEC and 122nd in the country last year in penalties.

"He came in and structured everything," tight end Dante Zanders said. Napier took the same approach for

game dav. "He wants to make sure everything

is prepared so that when it comes down to the game, there's no excuses to where: 'Oh, I didn't know I needed to be here. I forgot this. I left this at home. Or, oh, I forgot that we had meetings at this time," Zanders said.

The Gators have every reason to be amped up for Utah, a 2 1/2-point favorite according to FanDuel Sportsbook.

Florida has lost 10 of its last 16

games, and few outsiders would put

the once-proud program in any category other than rebuilding mode; Napier's team was picked to finish fourth in the SEC's Eastern Division.

"We have a chip on our shoulder this year," punter Jeremy Crawshaw

"We want to prove ourselves. We're coming for everything. ... We knew we didn't play up to our standard last year, but we've come hungry every time, every practice, every lift session, every film session. We're hungry, and we're talking about it."

Florida's opener has been talked about for months.

It marks the first in a series of highprofile games Stricklin has scheduled in recent years, a list that includes North Carolina State, Cal, Colorado, Arizona State, Texas and Notre Dame.

The game is sold out, and more than 10,000 Utah fans are expected to be in Gainesville – maybe even in the Swamp – as the Utes begin defense of their conference title with their highest preseason ranking ever. Napier, meanwhile, is trying to

avoid history.

Florida owns the nation's longest active winning streak in home open-

The Gators last dropped a home opener in 1989, when Mississippi won 24-19 at Florida Field.

Steve Spurrier replaced Galen Hall the following year.

And no first-year Florida coach has lost his debut since Charley Pell in 1979. Hall, Spurrier, Ron Zook, Urban Meyer, Will Muschamp, Jim McElwain and Mullen won their debuts by

an average score of 46-10. Of course, none of those guys opened against a ranked team.

Florida has played just two ranked teams to start seasons — No. 7 Houston in 1969 and No. 15 Miami in 1982 — and won both.

Napier welcomed the challenge and called it a "carrot" for his team.

Nonetheless, he admittedly has felt better about openers before. After all, he was at Louisiana-Lafayette the last four years, and the routine there had become more engrained with every

Napier expects to have jitters, maybe even butterflies and goosebumps, as he jogs into the packed Swamp for his first real game.

No number of mock-ups – or questions from his wife — would help him avoid those.

"I don't think I'm ever going to be beyond that," he said. "I think, as a competitor, football in particular, you work the entire year and you only get so many opportunities to compete.

"I think what I've learned over time is the important part is that how do you get to a place where you are well prepared and you have confidence."

AFC West: tough division with talented group of QBs

DENVER (AP) — The AFC West no longer looks like such a cakewalk for the Kansas City Chiefs now that Tyreek Hill is dashing past defenders in Miami. Not only did the Chiefs shockingly send Patrick Mahomes' top receiver to the Dolphins for a fistful of draft picks, but their rivals all made major moves

in hopes of ending Kansas City's divisional dominance.

— The Chargers invested more than \$70 million on defensive free agents as

they surround QB Justin Herbert with a better roster. They acquired LB Khalil Mack and ex-Patriots CB J.C. Jackson, who had an NFL-high 25 interceptions over the past four seasons. They also made Derwin James the league's highest-paid safety with a four-year, \$76.5 million deal.

— The Raiders hired Josh McDaniels as coach to replace interim Rich Bisac-

cia, who helped lead them to the playoffs for just the second time in 19 years. They also acquired star DE Chandler Jones and traded for star WR Davante Adams, who left Aaron Rodgers to reignite his college connection with Derek Carr, his teammate at Fresno State.

— The Broncos changed head coaches, starting quarterbacks and even own-

ers. Rob Walton paid a global sports record \$4.65 billion for the franchise and second-year GM George Paton replaced Vic Fangio with rookie head coach Nathaniel Hackett before trading five picks and three players to Seattle for Russell Wilson, their sixth opening day starter in six years.

With the Broncos finally solving their quagmire at quarterback, the AFC West now has perhaps the best group of QBs of any division in the league.

"There's a lot to love there in that division," veteran sportscaster Joe Buck said. "It's easily the best division with easily the best quarterback play." It should be more competitive in 2022, too, as the Chargers, Broncos and

Raiders try to snap Kansas City's six-year reign atop the division.

The Broncos haven't won the West since 2015. The previous time the Chargers won it was in 2009, and the Raiders' most recent crown came way back in 2002.

OVER HILL?

The Chiefs can't replace Hill's explosive speed, but they did provide Mahomes with plenty of new playmakers to complement TE Travis Kelce. They signed JuJu Smith-Schuster away from Pittsburgh and Marquez Valdes-Scantling away from Green Bay and used a second-round pick on Skyy Moore of Western Michigan.

"We're going to be different," Mahomes said, "but I think we'll still be able to go out there and have a ton of success."

Maybe, but it's not going to be easy for the Chiefs to host a fifth consecu-

tive AFC championship game. Aside from playing in the toughest division in football, where all four teams have legitimate playoff aspirations, the Chiefs also face the AFC South and NFC West along with the Bills, Buccaneers and Bengals.

TULLY CHARGED

Nobody has had more passing yards, completions and TD throws in his first two years in the NFL than Herbert, and he could take a big leap in production this season now that he's grown more comfortable in the Chargers offense.

"He's just a lot looser than usual. He's just a lot more comfortable. When you come in year one, kind of shy, don't want to talk a lot," wide receiver Mike Williams said. "But now, he's taken control and been himself."

The Chargers' significant defensive upgrades can only help Herbert's bur geoning confidence.

"I'm really excited for this team. I think we are miles ahead of where we were at this point last year," said Herbert, who threw for a franchise-record 5,014 yards and had nine 300-yard passing games last season.

BUCKING BRONCOS Wilson is the Broncos'

Wilson is the Broncos' 11th starting quarterback since Peyton Manning retired, and the new transplant has huddled aplenty with the Hall of Famer who still lives in Denver and was a frequent visitor at training camp.

"We've been talking a lot" Wilson said. "Since I've gotten here, he's kind of

"We've been talking a lot," Wilson said. "Since I've gotten here, he's kind of taken me under his wing in a beautiful way. (Peyton's wife) Ashley (Manning) has taken 'Ci' (Ciara) under her wing in helping with thoughts, schools, this, that and where to eat.

"The thing that Peyton and I both love is football. We can spend all day watching football together," Wilson added. "It's fun to be able to be around arguably the world's greatest who has ever played the game at that position."

And one who's been through what Wilson is about to experience

RAIDERS REDUX

McDaniels gets his second chance as a head coach in the same division where he flamed out in less than two seasons with the Broncos more than a decade ago.

"I feel like I've learned a lot," said McDaniels. "I feel like it's slowed down for me for sure."

A notoriously creative play-caller, McDaniels gets to direct an offense that features an established QB and one of the game's best pass-catching trios. On Football: Could Coach Prime jump from SWAC to big-time?

JACKSON, Miss. (AP) — Sitting on a metal folding chair just beyond the end zone of Mississippi State's practice field, Deion Sanders is alone watching the Bulldogs scrimmage on a muggy spring day. Coach Prime snagged his new offensive coordi-

nator for Jackson State from Bulldogs coach Mike Leach's staff this offseason. On this day, Sanders had made the 90-minute drive to Starkville with a few other members of his staff to study how Mississippi State operates.

"I want to be great," Sanders said the next day, back on campus at JSU. "So when I go to places like I went yesterday, that's for me, too. That's just not for my coaches. I want to see how this is run. I want to see how can I improve practice. I want to see what can I do different or where am I falling short, and I challenged myself to go to another level."

Last season, Sanders' second as Jackson State

head coach, the Tigers went 11-2 and won the Southwestern Athletic Conference. Then Sanders signed two Power Five-level recruits to the HBCU, an unprecedented recruiting feat.

Heading into the 2022 season, Sanders has emerged as maybe the most fascinating potential head-coaching candidate in college football.

Adding to the intrigue is the state of Sanders' old school. Once-mighty Florida State began Year 3 under coach Mike Norvell trying to snap a string of four straight losing seasons.

"I don't look down the street that far. I dominate the moment, man," Sanders told AP.

Recent hiring trends in major college football are working against Sanders jumping straight from

Jackson State to a Power Five conference school.

Just going from the second-tier of Division I football, where Jackson State competes, to the Bowl Subdivision is an increasingly rare move. Making the jump from an HBCU to FBS is even rarer and going from the SWAC to a Power Five school is unheard of.

Then again, Sanders, 55, has always been one-ofone.

Prime Time made cornerback a glamour position during his time at Florida State in the late 1980s. He played 10 years of Major League Baseball while simultaneously being one of the best players in the NFL throughout the 1990s.

"You don't get to become considered the best, running with the rest," Sanders said.

Sanders has discussed job openings with officials from at least three Power Five schools, including Florida State when it hired Norvell in 2019. "Killed it. Nailed all the interviews," Sanders

said.

He impressed at least one athletic director enough

that a preliminary conversation, done as a favor to Sanders' then-agent, led to a second, more formal interview.

Arkansas AD Hunter Yurachek said he went into

his initial meeting with Sanders back in 2019 with no expectations. "I was blown away." Yurachek told AP. "He was

very well prepared. He had done research on our program. He had done research on recruits. He could talk about the SEC."

At that time, Sanders was still coaching at a Dal-

las-area high school that he helped launch. His lack of experience was too much to overcome.

Still, Yurachek considered the potential impact Sandars could have on the recruiting trail in the

Sanders could have on the recruiting trail in the SEC, trying to sway some of the most sought-after high school players in the country away from Alabama's Nick Saban and Georgia's Kirby Smart.

"Can the name Deion Sanders and his presence

in the home of a young man be enticement enough for that young man to come here institution?" Yurachek asked himself.

Apparently so.

Last December, Jackson State was the story of signing day when five-star cornerback Travis Hunter backed off a longtime commitment to Florida State in favor of Sanders and the Tigers. Then in February, JSU signed four-star receiver Kevin Coleman.

recruit was yet another stinging loss for beleaguered Seminoles fans.

Sanders concedes he had a falling out with Florida State after the Bobby Bowden and his longtime defensive coordinator, Mickey Andrews, were nudged into retirement by the school in 2009.

That's all behind him now. The Hunter situation was nothing personal.

"I ain't got no quarrels with Florida State," Sanders said. "Everything is competition. Travis didn't belong to them."

Could a return to Tallahassee be in Sanders' in the near future? It doesn't seem likely.

Norvell has strong support from athletic director Michael Alford, who extended the coach's contract after the 'Noles bounced back from an 0-4 start with a 5-3 finish in 2021.

Even a small step forward in 2022, should be enough for Florida State to stay the course. The Seminoles opened the season with an easy victory against Duquesne last week, but face a much stiffer test Sunday against LSU.

Florida State can't afford to be impatient with Norvell. The school is still paying off Willie Taggart's \$14 million buyout, and another eight-figure payout to a fired coach would be difficult to absorb—especially with Florida State focused on improving outdated facilities and infrastructure.

"We just had to modernize our operation and show investments in the program," Alford said.

Still, fans are more fickle than ever these days. There is a point — 4-8? 3-9? — where the question becomes: Will it cost more in fan and donor apathy to keep this coach than it does to fire him?

The bidding:

West East South

Pass Opening lead — queen of clubs.

The most remarkable part of Sylvia's game was her uncanny ability to distort the most elementary principles of play and twist them to her own advantage, much to the discomfiture of her opponents.

Take the defender's rule of second-hand low, for example. In the actual deal, if a low spade were led from dummy, the normal thing for East to do would be to play low. This type of play is so commonplace that it would not be mentioned here except that Sylvia one day carried the principle a step further.

She was declarer in five diamonds,

and when West led the queen of clubs, Sylvia played the three from dummy! This play might astound some readers, but to Sylvia it was automatic. Hadn't she been taught to play second-hand low? No one had bothered to tell Sylvia that the rule applied to defensive play and not to declarer's.

West was so delighted with the success of his opening lead that he continued with the jack. Sylvia, by this time seeing no sense in following a rule that she didn't understand in the first place, took the jack with the king.

With a losing heart and two losing spades still in her hand, and facing an apparently hopeless assignment, she decided to grab whatever tricks she could. So she ruffed one of dummy's low clubs then played the ace of diamonds and another diamond to the king.

In dummy for the last time, she cashed the ace of clubs, discarding a heart, and next led dummy's last club, discarding a spade. Much to Sylvia's amazement, this last club somehow or other held the trick She thereupon conceded a spade and so made five diamonds.

Subsequent analysis showed that the only way to make the contract was to duck the opening lead! A little knowledge — albeit misapplied — can, it seems, do wondrous



PUBLIC HEARING AND ECONOMIC DEVELOP-MENT PROJECT NOTICE

ADDITION OF WATER SPLASH PAD TO **COAHOMA CITY PARK**

In accordance with the Development Corporation Act, Section 505.160 of the Texas Local Government Code, the Board of Directors of the Coahoma Economic Development Corporation (CDC), a Type B economic development corporation, is providing this published notice of its intent to undertake the following project:

To fund improvements, in accordance with Section 505.152 of the Texas Local Government Code, to the City owned Coahoma City Park, Coahoma, Texas 79511 ("the Project Property") by adding a water splash pad with above ground and in ground spray water features. The CDC intends to fund the water splash pad improvements to the Project Property which is anticipated to be approximately \$250,000. As part of the project, a local civic group, Coahoma Pride has agreed to donate \$60,000 to the project. The total cost of incentives that will be offered by the CDC to the City for this Project (not including the Coahoma Pride donation) will not exceed \$200,000.00.

The CDC will hold a Public Hearing on September 6, 2022, at the Coahoma City Hall, 122 N. 1st Street, at 7:00 p.m. to allow for public comment on this project and the proposed expenditure of Type B Sales Tax funds. After consideration and voting by the CDC, the project will go to City Council for their approval of the expenditure of CDC funds.

The CDC encourages citizens to participate in the public comment and public hearing stages of all CDC projects. Citizens unable to attend meetings may submit their views in writing to Tammy Griffith, City Secretary, for the City of Coahoma by mailing them to P.O. Box 420, Coahoma, TX, 79511. 


