Howard County Commissioners Court approve to host Trunk or Treat on Saturday

On Monday, Oct. 24, the Howard County Commissioners Court held its regular meeting at the Howard County Courthouse in the third floor County Court Room. Howard County Judge Kathryn Wiseman was not present for the meeting but the court still had a quorum. Precinct 3 Commissioner Jimmie Long presided over the meeting in Judge Wiseman's place.

The meeting began with the Commissioners reciting the both the U.S. and Texas pledges. Followed by the pledges the commissioners court allowed for public comment. There was no public comment as no one chose to address the court. With Judge Wiseman out there were no items of business to be presented on her behalf.

The commissioners court then moved on to Howard Country Treasurer Sharon Adams presenting her items of business. Adams presented to the commissioners court her usual items of business which included personnel considerations, the treasurers monthly report for September, and the treasurers quarterly report (3rd Quarter). All items were approved unanimously by the commissioners court.

Following Adams, Howard County Auditor Jackie Olson presented her items next to the court. Olson presented her usual items of business to the court which included the approval of invoices, purchase requests, and budget amendments. All items were approved unanimously by the court. Olson also presented the possible transfer of ARPA funds to the General funds to cover loss revenue and the consideration

of accepting fuel bids.

The transfer of ARPA funds was approved unanimously by the commissioners court. Olson also presented a fuel bid from Park's Fuel which was also approved unanimously.

The next item of business was the consideration of approving additional sick pool leave. The item was presented by Howard County Sheriff Stan Parker on behalf of Irene Buchanan. The item was approved unanimously by the court.

Precinct 1 Commissioner Eddilisa Ray presented her item next for the court. Commissioner Ray asked the court for permission to host a trunk-or-treat on the east side of the Howard County Courthouse on Saturday Oct. 29. Per Commissioner Ray she wanted to provide something for the kids to show that local government can be fun as well.

Per Pct. 3 Commissioner Jimmie Long, no action was needed and instead issued the item as a public announcement that the Howard County Courthouse will have its own Trunk-or-Treat on Saturday Oct. 29 on the east side of the building. The Trunk or Treat will be from 5 p.m. to 8 p.m.

Howard County Road Engineer Brian Klinksiek presented his items of business next which included his normal roadway maintenance update and presented the first reading of naming a road in Precinct 2 off of Larry Tubb Road as "Kent Road."

No action was taken at this time due to it being just the first reading.

There were no additional items of business that were brought up following Klinksiek, Shortly after, the meeting was adjourned.

Hecklers ejected for disrupting Cruz

NEW YORK (AP) — Three hecklers were hustled off "The View" set on Monday after disrupting a live television interview of U.S. Sen. Ted Cruz with what appeared to be a climate change protest.

Two women began shouting "Cover climate now" while the Texas Republican was answering a question. He briefly paused, smiled and then continued talking as the women shouted, most of it indecipherable to a television audience.

"Ladies, ladies, excuse us," host Whoopi Goldberg said when Cruz stopped. "Let us do our job. We hear what you have to say but you've got to go."

The shouting ended after less than a minute after the women, who were not seen on television, were

apparently ejected.

But as the segment headed into a commercial break, a third woman yelled out a comment that was bleeped out for the TV audience.

When the show returned from the commercial, host Ana Navarro apologized to Cruz.

"I'm sorry that this has happened in our house," she said.

The ABC daytime show, which just began its 26th season, has seen its share of hostility among on-air hosts through the years. But it's the first time in memory that it has seen such a demonstration by people in its small studio audience.

Coke sponsorship ires green groups

LONDON (AP) — This year's United Nations climate summit is brought to you by Coke.

Soft drink giant Coca-Cola Co.'s sponsorship of the flagship U.N. climate conference, known as COP27, sparked an online backlash and highlighted broader concerns about corporate lobbying and influence.

The COP27 negotiations aimed at limiting global temperature increases are set to kick off next month in the Red Sea resort town of Sharm el-Sheikh. The Egyptian organizers cited Coca-Cola's efforts to reduce greenhouse gas emissions and key focus on climate when they announced the sponsorship deal in September, which triggered immediate outrage on social media.

Activists slammed the company for its outsized role contributing to plastic pollution and pointed to the deal as an example of corporate "greenwash" - exaggerating climate credentials to mask polluting behaviors. An online petition calling for Coke to be removed as a sponsor has garnered more than 228,000 signatures, while hundreds of civil society groups signed an open letter demanding polluting companies be banned from bankrolling or being involved in climate talks.

Coca-Cola said its participation underscores its ambitious plans to cut its emissions and clean up plastic ocean trash.

Critics say corporate involvement goes against the spirit of the meetings, where tens of thousands of delegates from around the world gather to hammer out global agreements on combating climate change to stop the earth from warming to dangerous levels. This year, the focus is on how to implement promises made at previous conferences, according to the Egyptian presidency. At COP meetings, "the corporate presence is huge, of course, and it's a slick marketing campaign for them," said Bobby Banerjee, a management professor at City University of London's Bayes Business School, who has attended three times since 2011. Over the years, the meetings have evolved to resemble trade fairs, with big corporations, startups and industry groups setting up stalls and pavilions on the sidelines to lobby and schmooze — underscoring how a growing number of companies want to engage with the event, sensing commercial opportunities as climate change becomes a bigger global priority. IBM, Microsoft, Boston Consulting Group and Vodafone also have signed up as sponsors or partners but have drawn less flak for their participation than Coca-Cola. The United Nations Climate Change press office referred media inquiries to the organizers, saying it was a matter between Egypt and the company. The Egyptian presidency didn't respond to email requests for comment.

U.N. Climate Change's website says it "seeks to engage in mutually beneficial partnerships with non-Party stakeholders."

Georgia Elliott-Smith, a sustainability consultant and environmental activist who set up the online petition, said she's calling on the U.N. "to stop accepting corporate sponsorship for these events, which simply isn't necessary, and stop enabling these major polluters to greenwash their brands, piggybacking on these really critical

climate talks."

Environmental groups slammed the decision to let Coca-Cola be a sponsor, saying it's one of the world's biggest plastic producers and top polluters.

They say manufacturing plastic with petroleum emits carbon dioxide and many of the single-use bottles are sold in countries with low recycling rates, where they either end up littering oceans or are incinerated, adding more carbon emissions to the atmosphere. In a statement, Coca-Cola said it shares "the goal of eliminating waste from the ocean" and appreciates "efforts to raise awareness about this challenge." Packaging accounts for about a third of Coke's carbon footprint, and the company said it has "ambitious goals," including helping collect a bottle or can for every one it sells, regardless of maker, by 2030. Coca-Cola said it will partner with other businesses, civil society organizations and governments "to support cooperative action" on plastic waste and noted that it signed joint statements in 2020 and 2022 urging U.N. member states to adopt a global treaty to tackle the problem "through a holistic, circular economy approach." "Our support for COP27 is in line with our science-based target to reduce absolute carbon emissions 25% by 2030, and our ambition for net zero carbon emissions by 2050," the company said by email. Experts say sponsorships overshadow a bigger problem behind the scenes: fossil fuel companies lobbying and influencing the talks in backroom negotiations.

indoors, you know, in closed rooms," said Banerjee, the management professor. At the first one he attended - COP17 in Durban, South Africa, in 2011 he tried to get into a session on carbon emissions in the mining industry, a topic he was researching.

"But guess what? They turned me away, and who walks into the room to discuss, to develop global climate policy? CEOs of Rio Tinto, Shell, BP, followed by the ministers," Banerjee said, adding that a Greenpeace member behind him was also blocked. "This group of people mining companies and politicians – are deciding on carbon emissions."

Elliott-Smith, the environmental activist, attended last year's COP26 in Glasgow, Scotland, as a legal observer to the negotiations. While she's not naive about corporate-political lobbying, she was "really shocked at the amount of corporates attending the conference, (and) of the open participation between CEOs and climate negotiating delegations in these conversations."

In Glasgow, retailers, tech companies and consumer goods brands were signed up as partners, but fossil fuel companies were reportedly banned by the British organizers. Still, more than 500 lobbyists linked to the industry attended, according to researchers from a group of NGOs who combed through the official accreditation list. This year, oil and gas companies might feel more welcome because Egypt is expected to spotlight the region and attract a big contingent from Middle Eastern and North African countries, whose economies and government revenue depend on pumping oil and gas. Egypt historically sided with developing countries resisting pressure to cut emissions further, which say they shouldn't have to pay the price for rich countries' historical carbon dioxide emissions. Ahead of the meeting, U.N. human rights experts and international rights groups criticized the Egyptian government's human rights track record, accusing authorities of covering up a decade of violations, including a clampdown on dissent, mass incarcerations and rollback of personal freedoms, in an attempt to burnish its international image. The country's foreign minister told The Associated Press earlier this year that there would be space for protests. Against this backdrop, "it will be that much easier to censor, prohibit or silence attempts by civil society seeking to hold the process accountable to delivering the needed outcomes," said Rachel Rose Jackson, director of climate research and policy at watchdog group Corporate Accountability. "It will also make the polluter PR and greenwashing surrounding the talks that much more effective."

Prescott knows it's defense 1st for Cowboys despite return

FRISCO, Texas (AP) — Dallas quarterback Dak Prescott's surgically repaired right thumb felt good enough in his return to the field to make some dangerous throws he knows he should have avoided.

As his comfort grows with each week removed from a five-game absence due to the fractured thumb, Prescott will be challenged to remember what kept the Cowboys in contention while he was out: defense.

"The last thing I'm trying to do is put this team in a bad position because I'm overconfident," Prescott said after another defense-driven win, 24-6 over Detroit.

"When you have a defense like this, you have to continue to go through the reads and take a check down here or there, and it will pay off." Prescott, who was fortunate not to get intercepted at least twice, benefitted from the running game and some short fields to turn a 6-3 halftime deficit into a comfortable victory. Dallas forced five turnovers. Even without takeaways, the formula will probably remain the same Sunday for the Cowboys (5-2) in another home game against a sub.-500 NFC North team, Chicago.

and Cooper Rush under center. That certainly wasn't because of offensive dominance - Dallas remains among the worst teams in total yards, passing yards and third-down conversions.

The struggles are uncharacteristic for an offensive-minded franchise, but do give players and coaches hope for bigger things if Prescott can get the offense moving again.

"We are not going to put any limitations on what we can do," Prescott said. "As I said, it's important to grow each and every day. That's what I told the team today. This was a great win, celebrate it and enjoy it but tomorrow we have to come in and get better."

Previously winless Rockets hand Jazz first loss, 114-108

HOUSTON (AP) — Kevin Porter Jr. throw line and grabbed 10 rebounds. scored 26 points and Jalen Green added 25 to lead the previously winless Houston Rockets to a 114-108 victory over Utah on Monday night, handing the Jazz their first loss of the season.

Utah and Portland began the day as the only undefeated teams in the Western Conference, both at 3-0. Houston entered 0-3.

"We needed one, obviously," Rockets coach Stephen Silas said. "And the way we did it where we were fighting, and we had some adversity and we fought back. They tied the game a couple of times, but we didn't break."

The Rockets led much of the way, building a 10-point lead in the first half, but Utah tied it before Eric Gordon's layup gave Houston a 110-108 advantage with 1:23 remaining.

Rockets rookie Jabari Smith Jr., the third overall pick in this year's NBA draft, made all four of his free throws in the last 24.5 seconds to seal it. Smith finished with 21 points, nine rebounds and three blocks.

Porter went 9 for 9 from the free

"We knew they were coming off a back-to-back, so our whole game plan was to make them run," Porter said. "We needed high energy, we needed momentum, and that's what we did."

Green had his third straight 20-point game, shooting 9 of 16 from the field including 4 for 8 from 3-point range.

Seven players scored in double figures for the Jazz, led by Jordan Clarkson's 17 points.

Lauri Markannen had 14, and Kelly Olynyk, Jarred Vanderbilt and Simone Fontecchio each added 13.

"Credit to Houston — they played great, their spacing was great. We did not do a good job of defending without fouling," first-year Utah coach Will Hardy said. "When you play an entire first half a little bit flat, you leave yourself in a situation where things don't go your way and you end up losing the game."

The Rockets led 51-45 following a sloppy first half that featured a combined 23 turnovers and 54 missed shots.

Both teams were shooting under 24% from beyond the arc at halftime.

Houston led 21-18 after the first quarter, paced by Porter's 10 points.

"(Porter) got going early in the first quarter, and once he did that, that got me open a lot more," Green said. "Once we both started getting going, that just opens up a lot more."

The Rockets snapped a four-game home losing streak to Utah in the first leg of a home-and-home set.

Eight of Houston's next nine games are on the road.

Houston nearly blew a double-digit lead for a second time in three games, following a 129-122 loss to Memphis on Friday, when the Rockets led by 16.

Police: Boyfriend at Texas hospital for baby's birth kills 2

DALLAS (AP) - A man fatally shot two Dallas hospital employees over the weekend, opening fire after accusing his girlfriend who had just given birth of infidelity, authorities said.

Jacqueline Pokuaa, a 45-year-old social worker, and Katie Annette Flowers, a 63-year-old nurse, were killed in Saturday's shooting at Methodist Dallas Medical Center, according to police and hospital officials.

Authorities have said Nestor Hernandez, 30, opened fire around 11 a.m. while at the hospital for the birth of a child by his girlfriend. Hernandez, who was on parole from prison and had been granted permission to be at the hospital while wearing an ankle monitor, was shot and wounded by a police officer, authorities said.

"In my opinion, this is a failure of our criminal justice system," Dallas police Chief Eddie Garcia said at a news conference Monday. "A violent individual such as this should not have been on ankle monitor and should have remained in custody."

Hernandez has been charged with capital murder but it wasn't clear Monday if he has an attorney who could speak on his behalf. He was not listed among people being held in the Dallas County jail and authorities said that after the shooting he was treated at Methodist and then taken to another medical faculty for further treatment.

Hernandez arrived at the hospital around 10:20 a.m. to visit the woman in delivery and began to strike her repeatedly in the head with a handgun, Garcia said. According to an arrest warrant affidavit obtained by WFAA-TV, Hernandez started hitting his girlfriend after accusing her of infidelity.

Hernandez then started making "ominous" calls and sending text messages to his family, told his girlfriend that they were both going to die and said "whoever comes in this room is going to die with us," according to the Dallas TV station's account of the affidavit. He shot Pokuaa when she came into the room to attend to the woman, then shot Flowers after she looked in the room upon hearing gunfire, Garcia said.

Hospital police Sgt. Robert Rangel saw Flowers get shot, called for backup and took cover outside the room where Hernandez was reloading his gun, the chief said. When Hernandez emerged, Rangel shot him in the leg and, after a standoff, police took him into custody, Garcia said.

Garcia said the woman Hernandez struck was treated for her injuries and that a newborn child who was in the room was not hurt.

Hernandez was released from prison on parole last October after having been convicted of aggravated robbery, according to Texas Department of Criminal Justice spokeswoman Amanda Hernandez. She said he was given permission to be with his "significant other" at the hospital during her delivery.

Authorities haven't released any information on how Hernandez came to have a gun while on parole for a felony conviction. Methodist Medical System Police Chief Glen Fowler said Monday that the hospital wasn't given any notice of his criminal history or that he was being tracked with an ankle monitor.

"That's not something we normally inquire about for a parent," Fowler said. "This is an extremely horrific, out-of-the-norm situation. I wish that we would have known, but that is not some information that was provided to us beforehand."

Garcia said Hernandez was sentenced to eight years for aggravated robbery, serving six before he was released on parole last year. In March 2022, he was arrested for a parole violation, then in April released to his parole officer. In June, Garcia said, Hernandez was arrested by police in a Dallas suburb for another parole violation, taken to a county jail and then turned over to the custody of Texas prisons, which released him this September with the ankle monitor he was wearing during the shooting.

Dallas County records show that Nestor Hernandez has been arrested repeatedly since 2011, including on charges of aggravated robbery, burglary and the unlawful possession of a firearm by a felon.

US Border Patrol sends migrants places where no help waits

NEW YORK (AP) — When Wilfredo Molina arrived in the U.S. from his native Venezuela, he told border agents he wanted to go to Miami but didn't have an address. They directed him to what he thought was a shelter in midtown Manhattan but turned out to be a gray office building.

"It was a fake building. I didn't understand what it was," he said.

Molina was among 13 migrants who recently arrived in the U.S. who agreed to share documents with The Associated Press that they received when they were released from U.S. custody while they seek asylum after crossing the border with Mexico. The AP found that most had no idea where they were being sent — nor were they expected by anyone at the addresses listed on their paperwork.

Customs and Border Protection, which oversees the Border Patrol, did not respond to repeated questions about families and individuals interviewed and the addresses assigned to them.

But the snafus suggest a pattern of Border Patrol agents, particularly in Texas, sending migrants without friends or family in the United States to offices that get no notice. The places often don't have space to house migrants. Yet because those addresses appear on migrants' paperwork, important to the highest level ever recorded in a fiscal year. In the 12-month period that ended Sept. 30, migrants were stopped 2.38 million times, up 37% from 1.73 million times the year before and surpassing 2 million for the first time.

The year-end numbers reflect deteriorating economic and political conditions in some countries, the relative strength of the U.S. economy and uneven enforcement of Trump-era asylum restrictions.

Many are immediately expelled under the asylum restrictions, a public health order known as Title 42, which denies people a chance at seeking asylum on grounds of preventing the spread of COVID-19.

But others — including people from Cuba and Nicaragua, with which the U.S. has strained relations — are released with notices to appear in immigration court or under humanitarian parole. Those migrants must tell agents where they will live, but many can't provide an address.

"It almost seems as though, at the border, officials are simply just looking up any nonprofit address they can or just looking up any name at all that they can and just putting that down without actually ever checking whether that person has mentioned it, whether there's beds or shelter at that location, or whether this is even a location that can provide legal assistance," said Lauren Wyatt, managing attorney with Catholic Charities of New York. "So clearly, this is not the most effective way to do this." New York after taking one of El Paso's buses, says the address in her documents is for an El Paso church that wasn't expecting migrants and where she slept just one night. Now she worries immigration notices might be sent there.

Hundreds of immigrants have shown up at one of the offices for Catholic Charities of New York with documents listing the address. Wyatt said the group complained and the government promised to put an end to the practice by Aug. 1 — something that "obviously, hasn't happened."

The group also has received more than 300 notices to appear in immigration court for people the organization does not know, Wyatt said. It's also received deportation orders for migrants who failed to appear in court because their notices were sent to a Catholic Charities address.

Victor Quijada traveled with relatives last month to Denver after border agents sent the Venezuelan family to an American Red Cross office building. Once there, they were referred to a city shelter that also turned them away. They eventually found a shelter that took them in for a few days, but they felt unsafe.

"It was tough what we had to go through; from the things we had to eat to being on the streets an experience I wouldn't wish on anyone," Quijada said.

Chang, from the Colorado Housing Asylum Network, eventually took the family into her home and her organization helped them lease an apartment. She said she knows of several migrants assigned to addresses of groups that can't help them. "The five families that I've worked with in the last three months, all five were picked up off the street, literally sitting on the sidewalk with children," she said. The building in midtown Manhattan where Molina went is an International Rescue Committee refugee resettlement office, but it provides only limited services to asylum-seekers there, said Stanford Prescott, a spokesman for the group. Only one of the IRC's U.S. offices — in Phoenix operates a shelter for asylum-seekers and most stay less than 48 hours. Yet its Dallas and Atlanta offices also have been listed on migrants' documents. "We are deeply concerned that listing these addresses erroneously may lead to complications for asylum-seekers who are following a legal process to seek safety in the U.S.," Prescott said.

notices may later be sent there.

"We believe that Border Patrol is attempting to demonstrate the chaos that they are experiencing on the border to inland cities," said Denise Chang, executive director of the Colorado Hosting Asylum Network. "We just need to coordinate so that we can receive people properly."

Addresses on documents shown to AP included administrative offices of Catholic Charities in New York and San Antonio; an El Paso, Texas, church; a private home in West Bridgewater, Massachusetts; and a group operating homeless shelters in Salt Lake City.

A Venezuelan family that came to the American Red Cross' Denver administrative offices was referred to multiple shelters before someone volunteered to take them in. Migrants who came to New York ended up in shelters, hotels or temporary apartments that the city helped them find and pay for.

A surge in migration from Venezuela, Cuba and Nicaragua brought the number of illegal crossings Most of the migrants interviewed in New York had hopped on taxpayer-funded buses that Texas and the city of El Paso have been sending regularly to the northeast city.

Republican Govs. Ron DeSantis of Florida, Greg Abbott of Texas and Doug Ducey of Arizona also have been sending migrants released at the border to Democratic strongholds, including Chicago, Washington, D.C., and Martha's Vineyard, Massachusetts. They have been criticized for failing to notify local officials of plans. Republicans say they are highlighting issues with President Joe Biden's immigration policies.

The Biden administration recently agreed to accept up to 24,000 Venezuelans at U.S. airports if they apply for asylum online with financial sponsors, similar to how Ukrainians have been admitted since Russia's invasion. Mexico has said it will take back Venezuelans who cross the border into the U.S. and are expelled under Title 42 authority.

Arizona governor puts more containers along Mexican border

PHOENIX (AP) — The state of Arizona has begun installing shipping containers along another section of the U.S.-Mexico border to fill gaps that aren't covered by a border wall.

The move announced by Republican Gov. Doug Ducey on Monday to install stacks of containers in Cochise County in south-eastern Arizona came two weeks after federal officials told him to remove containers he had

placed along the border in southwestern Arizona.

Ducey sued in federal court on Friday, asking a court to allow the state to keep more than 100 double-stacked containers topped with razor wire in place near the community of Yuma, which sits near the California border. It also mentions U.S. Forest Service land where the new containers are being placed hundreds of miles (kilometers) to the east.

The containers near Yuma were placed in August to fill gaps in the border wall as Ducey ratcheted up political posturing against what he called the inaction of the Biden Administration in stopping migrants from entering the state from Mexico. tainers is aimed at a 10-mile (16-kilometer) section of the border. Ducey said it would take more than 2,700 of the 60-foot-long (18-meter-long) shipping containers to fill the gap.

Taste and adjust the salt, sugar and lemon juice as needed. The salad should be slightly tart. Make the tadka: Place the cayenne in a little pile on top of the salad. Do not stir it in yet. Heat the oil in a small skillet or butter warmer over high heat. When it begins to smoke, add the mustard seeds, covering the pan with a lid or spatter screen. As soon as the seeds stop sputtering, pour the oil over the cayenne. Stir the dressing in and serve at room temperature or cold.

Today's Highlight in History:

On October 26th, 2020, Amy Coney Barrett was confirmed to the Supreme Court by a deeply divided Senate, with Republicans overpowering Democrats to install President Donald Trump's nominee days before the election and secure a likely conservative court majority for years to come. President Park Chunghee was shot to death by the head of the Korean Central Intelligence Agency, Kim Jae-kyu.

To be a good bridge player, one must be willing to make assumptions about the layout of the unseen cards, even if the desired layout seems unlikely at best. To do otherwise would be self-defeating.

Here is a typical case. Let's say you're West and lead the queen of spades against South's threenotrump contract. Declarer wins with the ace as partner contributes the discouraging deuce. Declarer now leads a club, which you duck,

and play thus far), you must assume that he does not have the ace or jack, because if he has either of those cards, you can't defeat the contract.

Once your thinking brings you this far, the rest is easy. With the Q-10-6-3 of hearts in the dummy, you can work out that you can't score four heart tricks if you lead either the king or the four first, assuming declarer plays correctly.

So, by the process of elimination, you are compelled to shift to the nine of hearts at trick four. If you do that, declarer cannot prevent you from scoring four successive heart tricks regardless of what he does, and so finishes down one. On this date:


