

# Once key, US newspaper editorial endorsements fade away

NEW YORK (AP) — Newspaper endorsements are fading away as prizes to be nabbed by political campaigns, the practice a victim of both the news industry's troubles and the era's bitter politics.

Earlier this month, newspapers controlled by Alden Global Capital said they would no longer endorse candidates for president, governor and the U.S. Senate. The newspapers in the hedge fund's portfolio include dozens of dailies like the Chicago Tribune, New York Daily News, Boston Herald, Orlando Sentinel and San Jose Mercury News. They're not alone. The days

when a prominent endorsement would quickly make it way into a campaign ad or voters would clip out an editorial to take into the voting booth seem destined for history. "I do think you can make the

argument in many cases that they've outlived their usefulness because of the increased polarization and the skepticism of media in general," said Carol Hunter, executive editor of the Des Moines Register. "I don't think that's a healthy trend. But I think that's reality."

For all the effort that news organizations have made in crafting compelling endorsements, there have always been questions about whether those arguments have much influence, particularly in high-profile races.

At no time was that more evident than 2016, when 57 of the biggest newspapers endorsed Hillary Clinton and two picked Donald Trump, according to the American Presidency Project at the University of California, Santa Barbara. "None of the above," with five, did better than the eventual president.

At a time when newspapers are scratching for readers, executives wonder whether they should bother.

"Picking a candidate in this environment may alienate more readers than it persuades," the New York Daily News wrote in announcing the new policy, which means the tabloid will sit out the governor's race between Democrat Kathy Hochul and Republican Lee Zeldin.

Of the country's 100 biggest newspapers by circulation, 92 endorsed a presidential candidate in 2008. By 2020, only 54 made a choice, according to UCSB. There's no such reliable accounting in smaller races. But given that there are 2,500 fewer newspapers in the U.S. than there were in 2005, it stands to reason there are a lot fewer endorsements.

That absence "is yet another

loss for grassroots democracy," said Penelope Muse Abernathy, a Northwestern University professor who catalogs the decline in local news. At a time of unpopularity for

the press, many people don't like

being told what to do, said Poynter Institute media business analyst Rick Edmonds. For the newspapers, "there's a little bit of 'don't rock the boat' there," Edmonds said. "There are

ways to be respectful in a formal editorial. Make a point, but not in a condescending or dismissive In an internal memo earlier this year, leaders of the Gannett

newspaper chain noted that editorials were frequently cited as a reason people canceled subscriptions. Surveys said opinion pages were among their least-read content, and tied to problems in credibility and trust.

Some readers have difficulty distinguishing between news and opinion, or flat-out don't believe that a paper's editorial stance doesn't affect its news coverage, said Hunter, whose Iowa newspaper is owned by Gannett.

Gannett didn't ban political endorsements, but strongly advised its more than 220 newspapers to cut back on national opinion and focus on local issues. The Des Moines Register's opinion pages, for example, now run twice a week. The Register is being selective in its choices this fall, weighing in on the Iowa governor's race and a referendum on guns. But the state's top newspaper won't endorse in federal races, including U.S. Sen. Chuck Grassley's bid for an eighth term.

The McClatchy newspaper chain also didn't ban presidential endorsements. But it said the newspapers would not make a choice in races where its editors could not interview candidates — effectively putting it out of the business of presidential endorse-

One of its newspapers, the

Charlotte Observer, said it would make endorsements in "competitive and notable" races where it could conduct extensive search and interviews, North Carolina Opinion Editor Peter St. Onge wrote in a column.

Many news organizations simply have fewer people to do the work. Sixty percent of journalists working at newspapers in the United States have lost jobs since 2005, Abernathy

Staffing is indeed an issue at the Register, Hunter said. The newspaper is unable to cover the state's federal delegation the way it used to, and wants to devote resources to local news, she said. Many politicians view the

dwindling state of endorsements with a collective shrug. News organizations were once seen as objective, but Republican consultant Alex Conant said many voters his candidates are trying to reach consider newspapers as partisan as politicians.

"Editorial boards used to be an important validator," Conant said. "But they're not that important any more."

When he was running Marco Rubio's presidential campaign in 2016, Conant encouraged his client to meet with the editorial board at the Register, the dominant newspaper in the crucial early caucus state of Iowa.

If Rubio were running for president now, Conant said, he wouldn't bother with it.

Hunter said it hasn't been decided whether the Register would endorse anyone running for president in the 2024 caucuses. A lot will depend on access to the candidates, she said.


In the book "News Hole," University of Virginia professor Jennifer Lawless and George Washington University's Daniel Hayes show how congressional candidates are getting much less news coverage than they used to.

That's also the case for many elections further down the ballot, for local judge or school board, where endorsements had been one of the few places to learn about candidates. In many cases, these races are now nationalized: Voters are left to evaluate candidates as extensions of national parties instead of as neighbors, Abernathy said.

had a grease fire and the only thing that kept us from an uncontrollable fire was the fire extinguisher that we had handy. Flames shooting up from your stove or grill are a frightening experience, but you can avoid disaster! It's also important to know how to use one.

The National Safety Council recommends this

acronym, PASS to remember the steps of fire extinguisher use:

- **Pull** the pin.
- **Aim** low at the base of the fire.
- **Squeeze** the handle slowly.
- **Sweep** the nozzle side to side.

Have an escape plan. Practice fire drills with your family and make sure everyone knows where to go depending on where the fire is in the home. Have at least two ways to get out of the house, too. Set a meeting place for everyone. In the event

of a house fire, do not try to salvage items before leaving the house. Personal effects can be replaced, but lives cannot. Instead, keep valuable documents in a fireproof box for recovery later. Keep valuable documents in a fireproof box for recovery later.

Remember, it's always better to be proactive than reactive and it's best to alleviate hazards and have a plan in place in times of peace than in times of chaos. Utilize the above tips to reduce the risk for catastrophe or at least minimize the damage.

# State police: Uvalde officers' probe to be over by year-end The commission oversees state police and is a board of four members, all

AUSTIN, Texas (AP) — A criminal investigation looking into the hesitant police response to the Uvalde school massacre that killed 19 children and two teachers will be finished by the end of the year, Texas' state police chief said Col. Steve McCraw, the head of the Texas Department of Public Safety,

said at a public meeting in Austin that the Texas Rangers' findings would be turned over to prosecutors "within two months." But he offered no indication whether any of the nearly 400 officers who waited more than 70 minutes before confronting a gunman at Robb Elementary School on May 24 would

"The criminal investigation is looking at police officers, plain and simple,"

He also defended the Texas state police troopers in the face of widening scrutiny. There were 91 state troopers at the scene. Several Uvalde families demanded his resignation during the meeting.

McCraw's appearance before the state Public Safety Commission provided the first update of the Uvalde investigation in weeks, although little new information was revealed. Families of many of the children killed in the attack have spent months accusing the Department of Public Safety of slowwalking the investigation, withholding information and trying to minimize its responsibility.

appointed by Republican Gov. Greg Abbott, a longtime supporter of McCraw. The board did not ask McCraw any questions about Uvalde.

The meeting came a week after the department fired one of seven troopers subject to an internal investigation into their actions during one of the deadliest classroom shootings in U.S. history. Jesse Rizzo, whose 9-year-old niece Jacklyn Cazares was among the victims,

said misleading and false comments from authorities about the police response has compounded the small town's grief and eroded trust in law enforcement.

"The aftermath that came after that was absolutely unacceptable, hurtful, painful," Rizzo said. "Every single time seemed like lie after lie, disinformation." McCraw on Thursday apologized for the department originally saying that

the gunman had been able to gain access to the school because a teacher had propped open an exterior door with a rock. The teacher had gone back and shut the door, but it did not lock.

But McCraw insisted his department "did not fail the community," drawing condemnation from the assembled Uvalde families.

"If you're a man of your word then you would retire," Brett Cross, the uncle of 10-year-old victim Uziyah Garcia, told McCraw. "But unfortunately it doesn't seem like you're going to do that because you keep talking in circles.'

Another of the state troopers under internal investigation was Crimson Elizondo, who resigned and later was hired by Uvalde schools to work as a campus police officer. She was fired less than 24 hours after outraged parents in Uvalde found out about her hiring.

Many times it was about our homework as we sat at the dining table after school. I loved it when I would ask my dad questions

I remember one such time when we were going on vacation and my job was sitting in the front seat keeping Daddy awake. I talked and talked and talked so much, that he offered me a nickel if I could be quiet for just five minutes. I got a piece of paper and started writing my questions down so I could ask them when the five minutes was up.

Daddy said, "And no fair writing notes either."

I looked at him and hurriedly said, "I'm not!!" Well, needless to say, I lost that nickel.

But you know when I get to Heaven I have a whole lot of questions to ask God. One such question is, "How does God not have a beginning?" "Why would someone so perfect as Jesus, die for someone as so imperfect as I am?" "How can eternity last forever and ever?" "Why did God want to make man if He knew man

There are many things in the Bible





It's actually the same answer that applies to every decision we all make every moment. The free will to choose. When Sinatra sang, "I did it my way" he was making a rebellious declaration for most of the entire human race. It's the arrogant and aggressive proclamation about not caring what God says about sin, I live by my own rules.

Most of us know of someone that is entangled in some type of habit, crav ing, fixation, weakness, compulsion, or dependency. These behaviors are the result of how individuals attempt to deal with whatever is seemingly overwhelming them. LUBBOCK - It's official the Big Spring Steers cross country team is headed back to the UIL State cross country meet for the second year in a row. The Steers qualified for state this year after finishing second as a team at the Class 4A Region I meet in Lubbock this past Monday. The Steers qualified to state last year after finishing third at the regional meet and would go on to finish fourth overall at last year's state meet.

This year the expectations are little bit higher as the Steers have been considered to be one of the few top contenders for the Class 4A State title. All season long the Steers have been ranked in the top three in the state for Class 4A and after qualifying to the state meet this past Monday it puts them one step closer to potentially capture its second state title in school history.

Big Spring's head cross country coach Brandon Clemmons took a deep breath after the race and was all smiles once the results were posted and made official. "You know I've been telling myself I've done my job to get these boys and girls ready for this and they've done their job as well putting in the hard work to get here. It's just time to go out, compete and make it happen." coach Clemmons said before the races.

"Now that its official I can stop stressing for a bit and maybe stop making my hair turn gray." coach Clemmons said jokingly. "In all seriousness I'm proud of the kids today so we're going to enjoy this and after today we'll start getting ready for state." Clemmons added.

The Canyon boy's team, which has 4A all season long, won the Region I fourth with 107 points.

Leading the way for the Steers was once again seniors Adrian Solis and Isaac Gonzales. Solis finished 9th overall with a time of 16:30.50 and not too far behind was Gonzales who finished 10th overall with a time of 16:31.20. Rounding out the rest of the Steers team were sophomore Diego Rios 15th place (16:56.40), senior Agustin Salgado 17th place (17:03.20), senior Kevin Quezada 25th place (17:12.50), senior Jordan Mitchell 47th place (17:56.50), and senior Enrique Calderon 52nd place (18:01.10).

In addition to the Steers qualifying for the state meet, Big Spring freshman Bergan Pinkley qualified as the lone Lady Steer runner for state. Pinkley finished 24th overall with a time of 12:52.60. Pinkley qualified as she was part of the next top ten individuals group not on a qualifying team. The Lady Steers cross country team also competed as a team at the regional meet on Monday as well, but finished 15th overall out of 24 teams.

Despite not qualifying as a team, coach Clemmons was still happy with the Lady Steers performance as most of the team set new PR's. "We're a really young team this year and to see them advance to regionals this season is a sign we're headed in the right direction." coach Clemmons said. "I think the girls have realized this season that there is potential to build a pretty good team that could be contenders over the

next few years." Clemmons added. Rounding out the rest of the Lady Steers runners were freshman Luna Jimenez 48th place (13:30.60), freshman Kandace Gonzales 75th place (14:06.60), senior Elaina Arrendondo 92nd place (14:29.90), freshman Nadia Gonzales-Cruz 131st place (15:31.20), senior Felicity Yanez 136th place (15:37.60), and junior Analisa De Los Santos 139th place

(15:42.30).Both the Steers and Pinkley will have a week to get ready to compete at the UIL State Cross Country meet next Friday in Round Rock. The meet will be held at Old Settlers Park. Pinkley will run at 8:30 a.m. while the Steers are set to run at 9 a.m.




